You are hereby notified that the Planning and Land Use Management (PLUM) Committee of the Los Angeles City Council will hold a public hearing on **Tuesday, September 17, 2019** at approximately **2:30 PM** or soon thereafter in the John Ferraro Council Chamber, Room 340, City Hall, 200 North Spring Street, Los Angeles, CA 90012 (entrance on Main Street), to consider the following: Categorical Exemption pursuant to California Environmental Quality Act (CEQA) Guidelines, Section 15332, Article 19 (Class 32), and related CEQA findings, report from the Los Angeles City Planning Commission (LACPC), and an Appeal filed by Esperanza Martinez, United Teachers Los Angeles, on behalf of parents and students living near the proposed project site, from the determination of the LACPC in approving the following: 1) a Conditional Use to permit the operation of a public school in the [Q]R4-1 Zone (restricted to R2 uses); 2) a Determination to permit area deviations in association with a Conditional Use request as follows: a. A minimum 0-foot front yard setback in lieu of the otherwise required 15-feet along the Grape Street frontage; b. A minimum 0-foot side yard setback in lieu of the otherwise required six-feet along the 102nd Street frontage; 3) a Zoning Administrator's Determination to permit a fence or wall height of eight-feet in lieu of the permitted 3.5-feet within the required front yard; and 4) a Site Plan Review for a change of use which results in a net increase of 1,000 or more daily trips; for the construction of a new three-story, 32,245 square foot, 22-classroom public charter middle school, with a covered multipurpose room, one level of basement parking for 31 automobiles, 90 bicycle parking spaces, an on-site drop-off and pick-up area, and a 8,457 square foot outdoor play yard, with the school serving 512 students in grades 5-8, and to include an eight-foot tall concrete wall along the northern perimeter and eight-foot tall wrought-iron security fence with perforated paneling elsewhere along the perimeter of the site except where gates or the classroom building would be located; for the properties located at 10103, 10105, 10111 and 10115 South Grape Street, subject to Conditions of Approval.
