

Propose New Salary Scale For All School Principals

HICKSVILLE—Members of the School Board are studying a proposed increase in salaries for district school principals suggested by Joseph Cawley at the regular meeting, Friday night. He said he would offer the motion this Thursday night at a special meeting after board members have an opportunity to study his proposition.

The new scale would become retroactive to Sept. 1 under Cawley's plan. It provides a new scale from \$6,000 to \$8,500 in eight steps for elementary principals, \$8,500 to \$9,000 in eight steps for junior high and \$7,500 to \$10,000 for senior high in eight steps.

He said the scale had been recommended by the Citizen's Advisory Committee on education. Adoption of the new salary schedule, he continued would mean an additional cost of 20 cents per year for a taxpayer with a home assessed for \$4,000.

Emil Szendy requested School Attorney Bestram Crans to consider whether such an increase in salaries could be made retroactive in view of the budgeted amount for the current school year.

At the request of Attorney Crane, Mrs. Edna K. Sutton, the board president, named the committee which will go to the State Education Commissioner at Albany in the question of hazard factors and student transportation. She named the committee as Szendy, Cawley together with

BETHPAGE—Forty-five attended the first general meeting of the Chamber of Commerce held at Broadway School, here Monday, Sept. 20th. The meeting was opened by Betty Mazzara, Temporary President, and a report was given of the progress made thus far. Mazzara stated that the Constitution and by laws had been adopted and the unit was now incorporated.

Frank Toole of Corydon M. Johnson Co. suggested a brochure be made to depict the advantages for both business and industry to locate in Bethpage.
