The proposed dwellings are unacceptable in principle as it is has not been demonstrated that the proposed dwellings can be accommodated without causing harm to the character and appearance of the surrounding townscape and results in the loss of an open space that contributes to the character of the area contrary to Policies SET 01 and DES 01 of the Test Valley Borough Local Plan 2006.
- 02. No on-site provision of public recreational open space is proposed. There is deficiency within the ward of Children's Play Space. No contribution is secured in lieu of on site provision to mitigate for the additional burden that will be placed on the existing public recreational open space. As such the proposal is considered contrary to Policy ESN22 of the Test Valley Borough Local Plan 2006 and the adopted Supplementary Planning Guidance, Infrastructure and Developer Contributions (February 2009).

The proposed dwellings are unacceptable in principle as it is has not been demonstrated that the proposed dwellings can be accommodated without causing harm to the character and appearance of the surrounding townscape and results in the loss of an open space that contributes to the character of the area contrary to Policies SET 01 and DES 01 of the Test Valley Borough Local Plan 2006.
- 02. No on-site provision of public recreational open space is proposed. There is deficiency within the ward of Sports Ground and Children's Play Space. No contribution is secured in lieu of on site provision to mitigate for the additional burden that will be placed on the existing public recreational open space. As such the proposal is considered contrary to Policy ESN22 of the Test Valley Borough Local Plan 2006 and the adopted Supplementary Planning Guidance, Infrastructure and Developer Contributions (February 2009).
