- 1. Paragraph xxx of the 5YHLS sets out that the Borough was attributed an annual average housing supply monitoring target of a minimum 641 units per annum in the 2016 London Plan. The small site capacity element of the target is 352 units per annum for the Borough.
- 2. As specified in paragraph XX of the 5YHLS 2019 an assessment has been made of the contribution that small sites (<0.25ha) have made to housing delivery from 2010/11 2017/18. This data represents the most up-to-date data when the 5YHLS was compiled in line with the observations made by the Inspector who reported on the 'Dylon' decision (APP/G5180/W/16/3144248) as made reference to in paragraph xxx of the Council's 5YHLS. The small site allowance is derived by taking an average of small site completions (new build, conversions and changes of use) during the eight year period and removing 90% of new build completions built on garden land. The latter methodology largely reflects that used in the 2013 SHLAA (pages 69 to 72, Appendix 1 and Appendix 7) to calculate the small site capacity for each borough as endorsed by the Inspector into the examination of the Further Alterations to the London Plan.</p>
- 3. Paragraph xxx of the 5YHLS makes reference to the reasoning for including unit completions from the use of permitted development rights.
- 4. The small site allowance methodology results in 247 units per annum (1235 units over the five year period). In addition to this a small uplift of 130 units over the five year period has been add to the figure of 1235 units. Paragraph XXXX of the 5YHLS sets out the Council's reasoning behind this uplift.
- 5. The inclusion of approximately 1380 units is considered deliverable, taking into account advice set out in paragraph 70 of the NPPF, paragraph ID 3-024 of the PPG and paragraph 3.19A of the London Plan.
- 7. The methodology used does not reflect that of the GLA's 2017 SHLAA small site allowance methodology that forms the evidence base for the 2017 Draft London Plan. The Draft London Plan (December 2017) is currently under examination.
- 8. The small site allowance figure has changed from 1139 units in the 2017 5YHLS to 1380 units in the 2019 5YHLS. One of the main reasons for the change relates to the reduction of small sites listed in Appendix 1 of the 2019 5YHLS. In 2017 there were approximately 258 units listed and in 2019 there are 65 listed (not including sites accommodating <9 units). This amounts to a 193 unit difference, largely due to the completion of a number of small sites in the last financial year (i.e. Oxford House (14 units), Berwick House (21 units), Orpington Police Station (83 units) and 165 Masons Hill (23 units).
- 10. Paragraphs 2.33 to 2.36 of the 2017 5YHLS make reference to the fact that only sites that have commenced [accommodating 9+ units] are included in the

supply. There are currently 250 units from this source of supply in the Borough's residential pipeline. It is considered therefore, that including this source in the small allowance calculation, will not result in double counting with the conservative prior approval allowance of 200 units over the five year period.

11. The inclusion of approximately 1380 units is considered deliverable, taking into account advice set out in paragraph 70 of the NPPF, paragraph ID 3-024 of the PPG and paragraph 3.19A of the London Plan. Set out below are the figures used to calculate the small site allowance of 1380 units.
