Dear Ms. Boyd:

On November 18, 2011 the Federal Communications Commission ("FCC") released its *USF/ICC Transformation Order* in WC Docket No. 10-90 et al. With that Order, the FCC began a transition to a national framework for certification of Eligible Telecommunications Carriers ("ETCs") and set forth a standard set of information that all ETCs must file with the FCC by July 1st of each year. The Order also required ETCs to provide the same information to the respective state commissions.

The annual ETC reporting requirements are contained in 47 C.F.R. § 54.313 of the FCC's rules. For the reporting of the data and certifications required by 47 C.F.R. § 54.313 and 54.422, the FCC has developed a reporting template, Form 481, to be utilized by ETCs.

ETCs that accepted the Connect American Fund Phase II ("CAF II") state-level commitment are required to report certain CAF II related information by July 1, 2016. Because the CAF II milestones are tracked at a total state level, for states where CenturyLink has multiple Study Areas, all CAF II related reporting will be found only on the Form 481 of the Study Area Code designated by USAC.

Attached are the public and confidential versions of the Form 481 as filed by CenturyLink with the FCC. The following information is CONFIDENTIAL and CenturyLink submits the enclosed Motion for Protective Treatment to maintain the confidentiality of this data.

1. The outage information in response to § 54.313(a)(2).

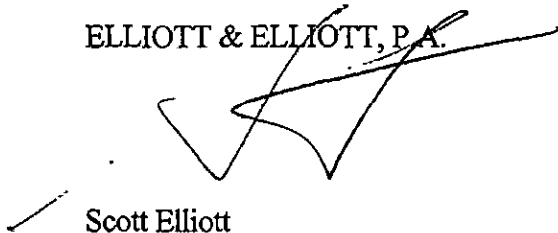
2. The detailed broadband speed availability information at the exchange level provided in response to 54.313(a)(7).

MOTION FOR PROTECTIVE TREATMENT

United Telephone Company of the Carolinas LLC d/b/a CenturyLink ("CenturyLink") by its attorneys and pursuant to S.C. Code Ann. § 39-8-10, *et seq.*, and all other applicable rules, statutes and regulations, hereby files this Motion for Protective Treatment ("Motion") for the accompanying materials. By this Motion, the CenturyLink seeks protective treatment by the South Carolina Public Service Commission ("Commission") of certain commercially-sensitive materials attached to this submission as Trade Secret.

In support of this Motion, the CenturyLink provides the following:

I. Description of Confidential Information

3. CenturyLink has been designated as an eligible telecommunications carrier (“ETC”) by the Commission and, pursuant to Commission Regulation 103-690.1, submits an annual certification to the Commission every year. The purpose of the annual certification is to verify that CenturyLink is in compliance with Section 254(e) of the Telecommunications Act and to request that the Commission submit a letter to the FCC and the Universal Service Administration Company (“USAC”) that CenturyLink is eligible to receive federal universal service support in accordance with Section 254(e) and 47 C.F.R. § 54.314.

4. On November 18, 2011, the Federal Communications Commission (“FCC”) released the *USF/ICC Transformation Order*.¹ Among other matters, the FCC modified the reporting processes and the substantive requirements associated with federal universal service support received by ETCs. On August 6, 2013, the FCC released an Order, DA 13-707, identifying the reporting requirements contained in 47 C.F.R. § 54.313 that are now approved and applicable.² The FCC also released the required reporting template, FCC Form 481, for use by all ETCs. With respect to ETC certification matters, these FCC Orders still require the state commissions to undertake applicable notifications to USAC and the FCC regarding state ETCs so that the ETCs continue to receive federal universal service funding.

5. The Orders require CenturyLink to submit additional information to the FCC as part of the ETC certification process, beyond what was submitted in past years. While the FCC orders cited above do not appear to mandate copying this Commission with ongoing FCC ETC filings, CenturyLink determined in an abundance of caution to submit a copy of its South

Carolina filing to this Commission to facilitate this Commission's ability to certify to the FCC and USAC that CenturyLink is eligible to receive federal universal service support.

6. The attached certification includes three (3) categories of information that is confidential: network outage reporting information, broadband speed information, and Connect America Fund ("CAF") Phase II capital expenditure information. CenturyLink requests that this information be treated confidentially by the Commission.

II. Grounds for Claim of Confidentiality

7. The network outage reporting information provided as part of CenturyLink's ETC certification forms should be exempted from public disclosure due to the highly sensitive, security-related nature of these data and its potential value to individuals seeking to impede or disable communications networks. This highly confidential outage reporting information is not publicly available, and is the subject of efforts by CenturyLink to maintain its secrecy. This Confidential Information is exempt from public disclosure under Exemption 4 of the Freedom of Information Act, 5 U.S.C. § 552(b)(4). *See In the Matter of new Part 4 of the Commission's Rules Concerning Disruptions to Communications*, ET Docket No. 04-35, Report and Order and Further Notice of Proposed Rulemaking, FCC 04-188, ¶ 3 (released August 19, 2004). *See also* 47 C.F.R. § 4.2. Since the FCC has determined that outage reports filed under Part 4 of its rules are to be filed on a confidential basis and not available for public disclosure, it is reasonable for this Commission to treat such information reported in CenturyLink's ETC certification similarly.

8. In addition, CenturyLink would be substantially harmed if confidential network outage information were made available without restriction or was released as public information. The release of this information would allow competitors to derive economic value by gaining knowledge of CenturyLink's operations and operating results and thereby placing

CenturyLink at a competitive disadvantage. As such, the CenturyLink's outage information is a "trade secret" as that term is used in South Carolina Trade Secrets Act. *S.C. Code Section 39-8-20(5)*. Competitors could use the confidential information to gain a competitive advantage over CenturyLink in the marketplace in general or in certain areas within CenturyLink's markets. Meanwhile, CenturyLink is not privy to the same details about its competitors' businesses and would therefore be harmed by release of this data. Moreover, limiting disclosure of confidential information will not prejudice the rights of any entity, nor will such limitation frustrate the intended purpose of this filing or the prompt and fair resolution of any proceeding that may arise out of this filing.

9. Similarly, CenturyLink would be substantially harmed if confidential network broadband speed data at the exchange level were made available without restriction or was released as public information. The release of this information would allow competitors to derive economic value by gaining knowledge of CenturyLink's operations and operating results and thereby placing CenturyLink at a competitive disadvantage. As such, the CenturyLink's broadband speed data is a "trade secret" as that term is used in South Carolina Trade Secrets Act. *S.C. Code Section 39-8-20(5)*. Competitors could use the confidential information to gain a competitive advantage over CenturyLink in the marketplace in general or in certain areas within CenturyLink's markets. Meanwhile, CenturyLink is not privy to the same details about its competitors' businesses and would therefore be harmed by release of this data. Moreover, limiting disclosure of confidential information will not prejudice the rights of any entity, nor will such limitation frustrate the intended purpose of this filing or the prompt and fair resolution of any proceeding that may arise out of this filing.

10. Additionally, CenturyLink would be substantially harmed if capital expenditure

information for CAF II program were made available without restriction or was released as public information. The release of this information would allow competitors to derive economic value by gaining knowledge of CenturyLink's network investment levels thereby placing CenturyLink at a competitive disadvantage. As such, this type of network investment information is a "trade secret" as that term is used in South Carolina Trade Secrets Act. *S.C. Code Section 39-8-20(5)*. Competitors could use the confidential information to gain a competitive advantage over CenturyLink in the marketplace in general or in certain areas within CenturyLink's markets. Meanwhile, CenturyLink is not privy to the same details about its competitors' businesses and would therefore be harmed by release of this data. Moreover, limiting disclosure of confidential information will not prejudice the rights of any entity, nor will such limitation frustrate the intended purpose of this filing or the prompt and fair resolution of any proceeding that may arise out of this filing.

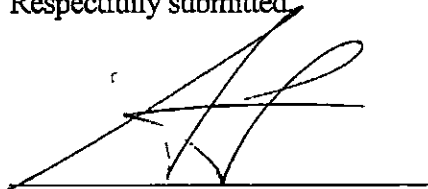
CONCLUSION

11. The network outage, broadband speed, and CAF II capital expenditure information included in attached ETC certification materials, for which Confidential Treatment is sought, is both proprietary and competitively-sensitive. The substantial and direct harm that could be caused to CenturyLink as a result of any disclosure is real and not speculative. Moreover, to date, no other jurisdiction or governmental agency has required CenturyLink to make this information available to the public. For all these reasons, these categories of information should be protected from public disclosure by the Commission.

WHEREFORE, CenturyLink respectfully requests that the South Carolina Public Service Commission grant this Motion for Protective Treatment with respect to the network outage, broadband speed, and CAF II capital expenditure information included as part of the enclosed ETC certification.

<1210> Terms & Conditions of Voice Telephony Lifeline Plans

CenturyLink, Inc. has over 100 local exchange carriers (LECs) that serve as eligible telecommunications carriers (ETCs) providing Lifeline discounts on local telephone service for qualifying low-income customers in thirty-seven states. Each LEC's tariff or local terms of service contain the terms and conditions of voice telephony service plans generally available to CenturyLink residential customers. Lifeline provides discounts on CenturyLink residential service plans that include voice telephony service. Lifeline discounts provided to qualified recipients include the \$9.25 per month federal discount plus state discounts, if available. Tribal Lifeline recipients receive an additional federal Lifeline discount of up to \$25 per month. Eligible residents residing on Tribal lands in areas where CenturyLink receives universal service high-cost support can also receive a Tribal Link Up credit of not more than \$100 against one customary service initiation fee at a primary residence.

CenturyLink's flat-rated residential service plans provide unlimited local calling. Lifeline discounts also may be applied to local residential service plans that include a certain amount of local minutes or calls at a flat-rate and then have additional charges for minutes or calls beyond those included in the plan. Lifeline discounts may be applied to bundled service packages that include voice telephony services, such as bundles with internet service and/or video service. Lifeline discounts may also apply to voice service plans that include optional calling features such as caller ID, call waiting, and voicemail.

Toll service is available to customers receiving Lifeline discounts in the same manner that it is available to non-Lifeline customers. Toll limitation service is available to Lifeline customers at no charge.
