CAC

The CAC discussed how to address a complaint from a resident on Sleight Plass Road about trail users trespassing and littering. They will ask the Highway Department about signage. Town Board Discussion

Mr. Bell asked the Board if they would consider amending the Town Code regarding drivethrough facilities in Town Center. Mr. Luna stated that he would vote against any change to that portion of the Code, citing the request for a kiosk in the Dunkin Donuts parking lot. Mr. Jessup and Mr. Ryan both stated that to their knowledge, no-one has ever been in favor of banning drive-through services in Town Center. Mr. Bell asked Mr. Comatos to draw up the necessary resolution.

Mr. Bell stated the current Part-time Code Enforcement Officer, Dominic Benedetti will be leaving and there is a need to replace his position with a position title which is compatible with the DC Civil Service list. The position title of Deputy Building Inspector is not common in this area and therefore would limit the number of qualified candidates. The position title of Municipal Code Enforcement Inspector would encompass a larger list of candidates. The Board agreed that the position title should be for a Full-time Municipal Code Enforcement Inspector.

Mr. Jessup seconded by Mr. Baright moved to adjourn at 7:30 pm. The motion carried.

The Professional Consultant, Arcadis CE, Inc., for the UPS distribution facility on Firemans Way has represented to me that they have an interest to proceed with an out of district sewer agreement. Arcadis has stated that the UPS is currently performing a pump and haul at that facility.

I have inquired directly to my last point of contact for UPS, with Arcadis copied, and I have not received confirmation from the Property Owner. I had explained that the Manchester Sewer District was being considered by the Town Board this summer. I was also hoping to get the status of their septic confirmed by the Property Owner. I have asked Arcadis to provide me the same confirmation from their Client. To date, I have not heard back from any UPS representative.

Arcadis is proceeding with working on design. In the event that UPS does intend to proceed, I am requesting that the Town Board open an escrow account for this out of district agreement with a starting balance of \$2000. Their connection would involve a very long run of sewer main and manholes, therefore review by the Town's Engineer will also be required early on.
