submitted herewith and identified as Exhibit J.

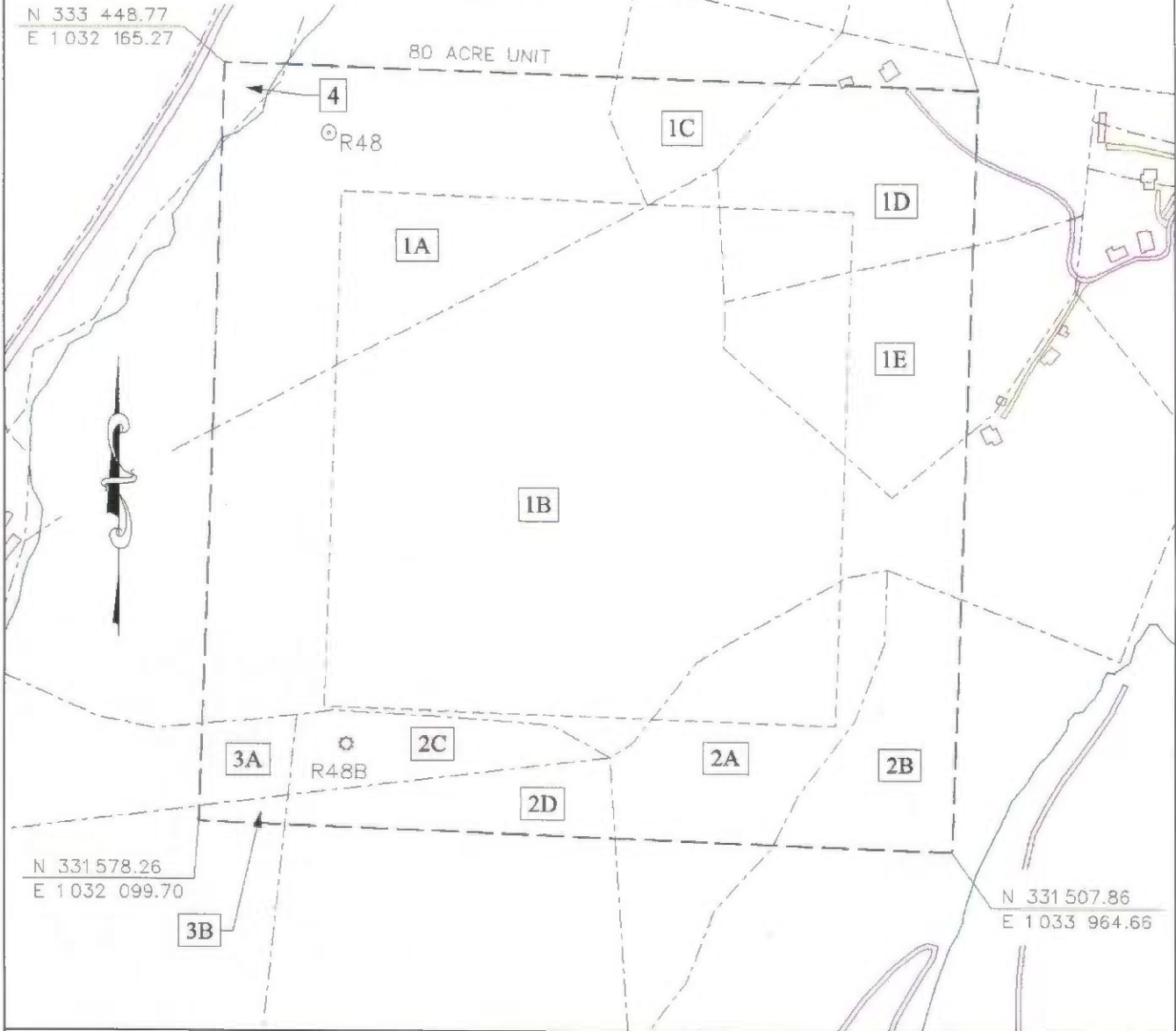
