Describe your firm's willingness to meet Japanese and U.S. Forces Japan international travel and quarantine requirements to participate in a bidders' site visit, tentatively planned on/about ~~15 December 2021~~ **11 February 2022**. **Currently, U.S. Force Japan does not have the ability to support international travelers and interested parties will be required to abide by Japanese immigration policies.** As with all site visits, the U.S. Government will not reimburse potential bidders/offerors for any/all costs incurred. The Government of Japan makes no distinction between vaccinated and unvaccinated travelers in its COVID-related entry requirements. Vaccination status has no impact on an individual's eligibility to travel to Japan, and Japan's quarantine restrictions apply regardless of vaccination status. While subject to change, the current requirements are below.

- a. A PCR test within 3 days of travel is required to enter the country of Japan. Printed results must be taken on the aircraft. Additionally, you should bring the memo that explains test results for airline personnel in English and Japanese.
- b. All travelers arriving to Japan are required to self-quarantine at their home or other location for 14 days. Currently the Government of Japan requires international travelers to quarantine for at least three days in a Government of Japan-provided facility upon entry into Japan, then complete the remainder of their quarantine period at home or designated residence. Travelers who arrive without proper documentation of a negative COVID-19 test will be denied entry to Japan. Additional PCR tests may be mandated upon arrival in Japan.

United States Forces Japan bases have instituted a number of restrictions based on local conditions. Many restrictions are specific to individual bases or areas. These restrictions are updated frequently to reflect the local pandemic situation. Please check both Government of Japan and the Okinawa III MEF websites for updates on travel and quarantine measures.
