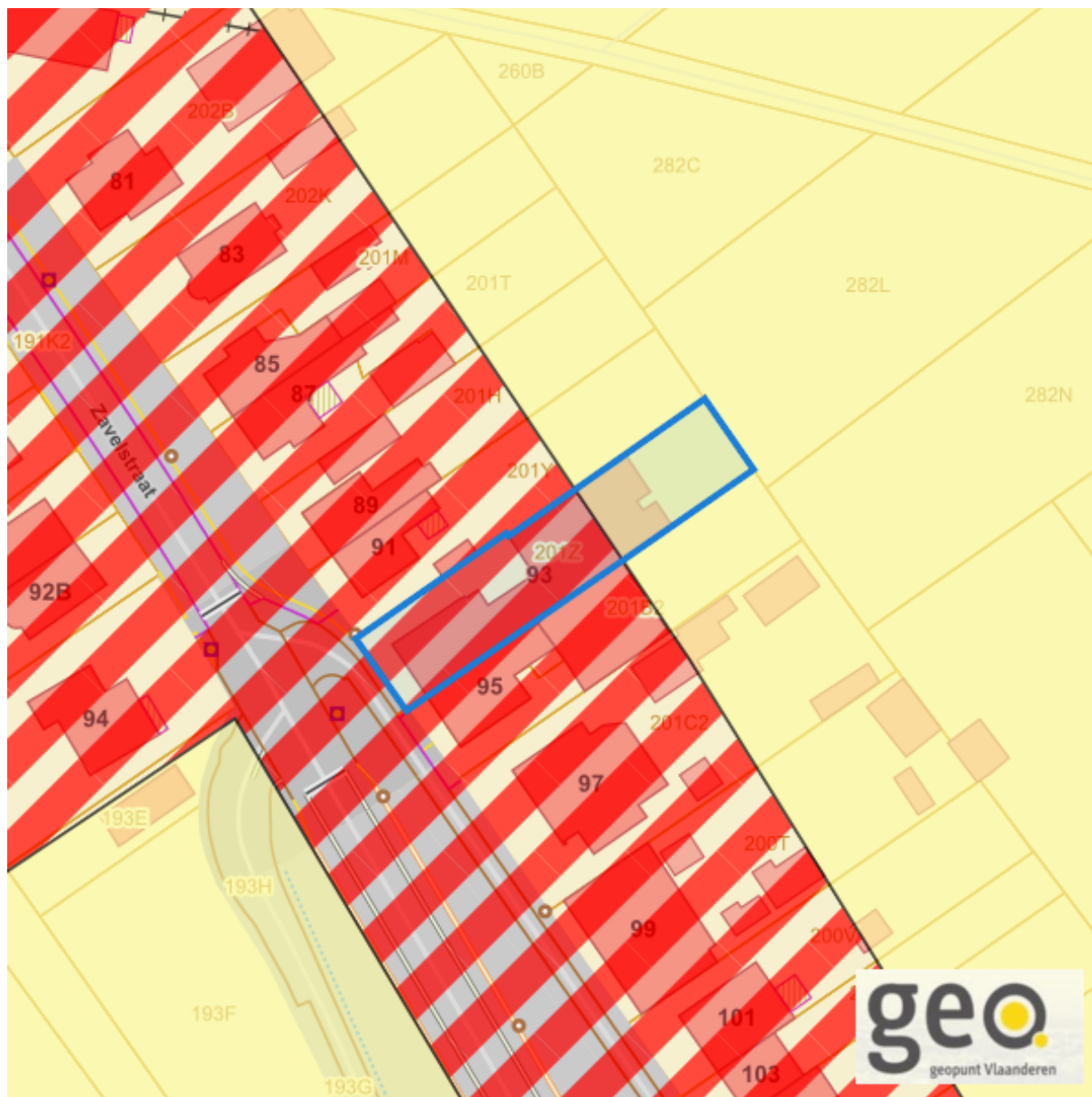

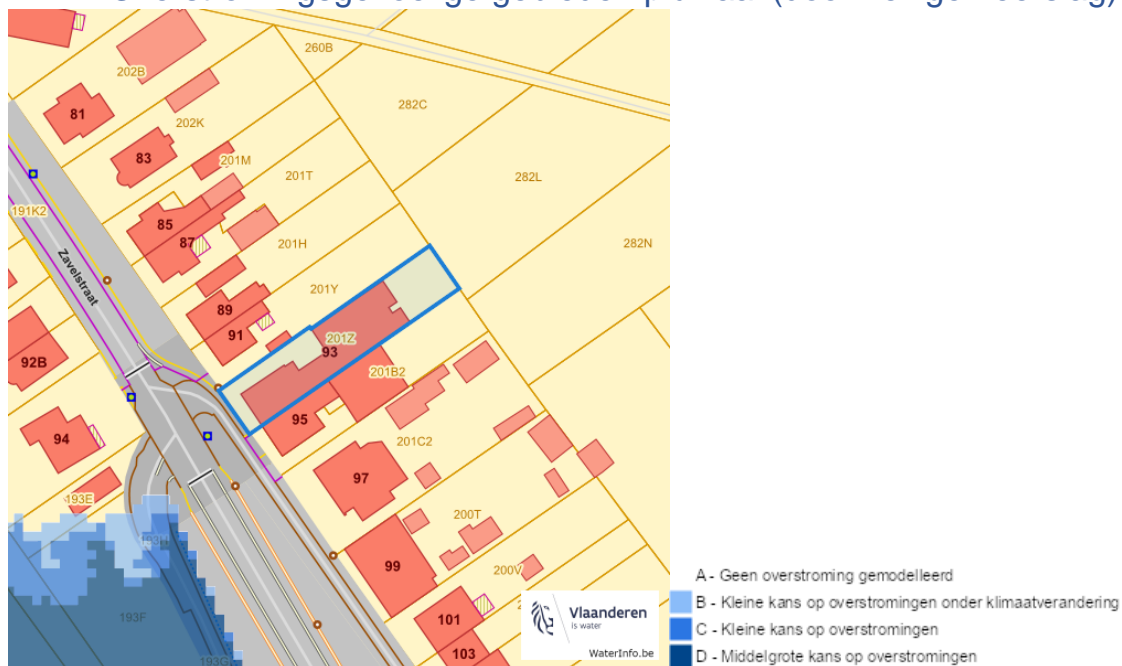

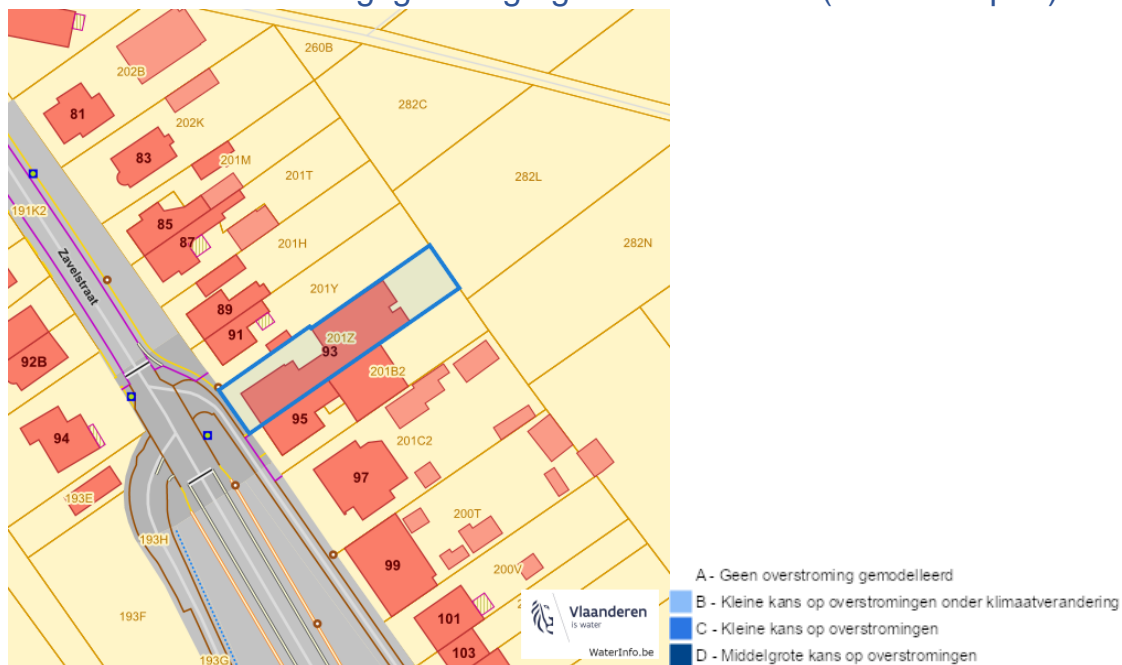

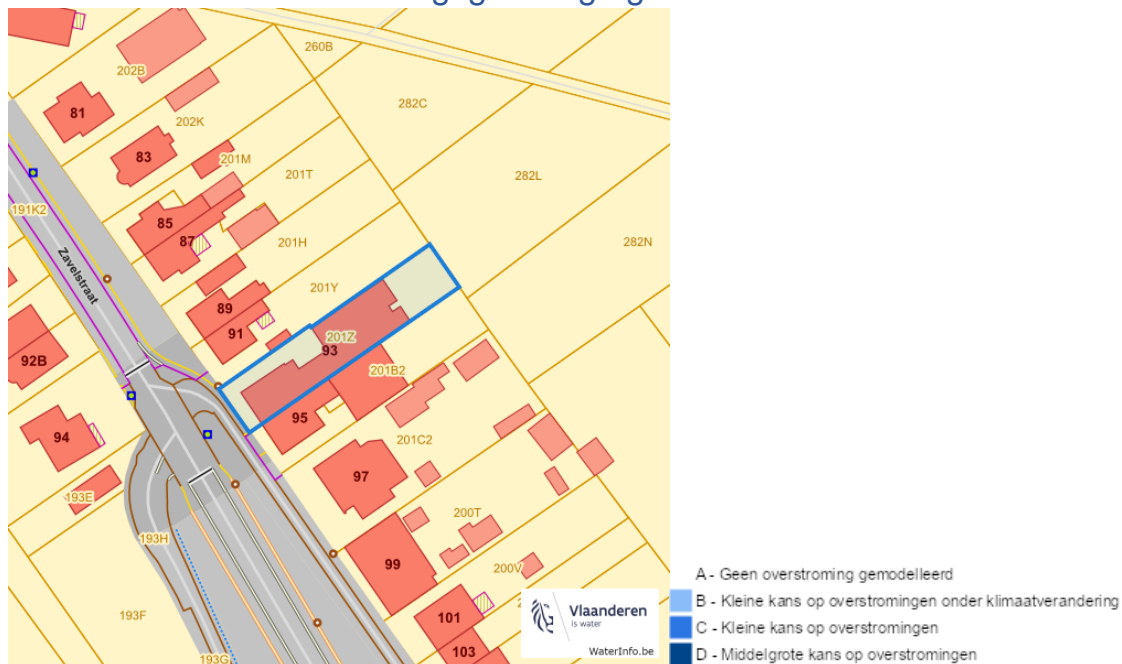
Overstromingsgevoelige gebieden pluviaal (door hevige neerslag)



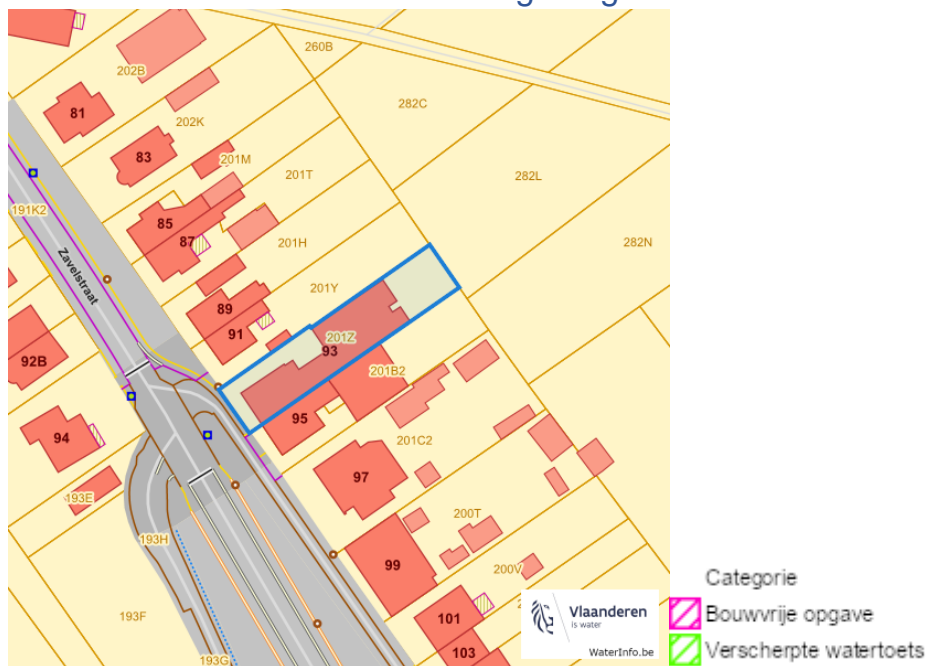
Overstromingsgevoelige gebieden fluviaal (uit waterlopen)



Overstromingsgevoelige gebieden vanuit de zee

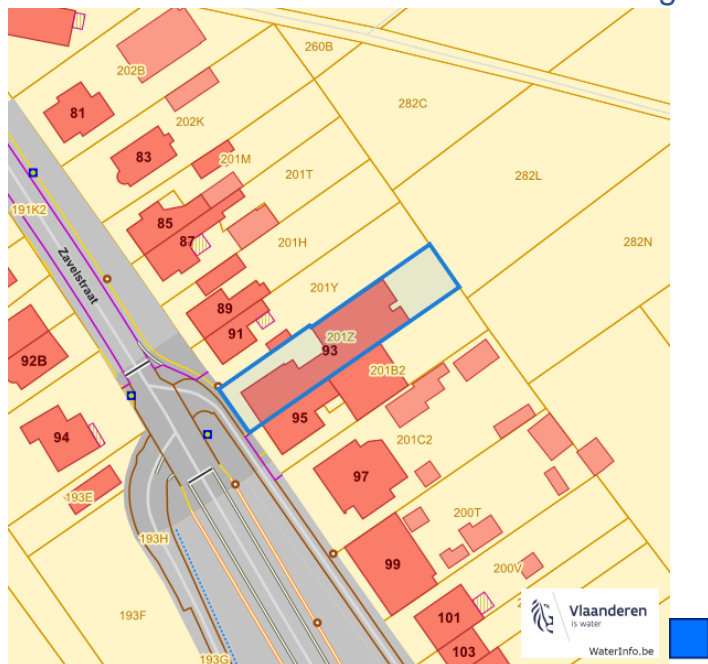

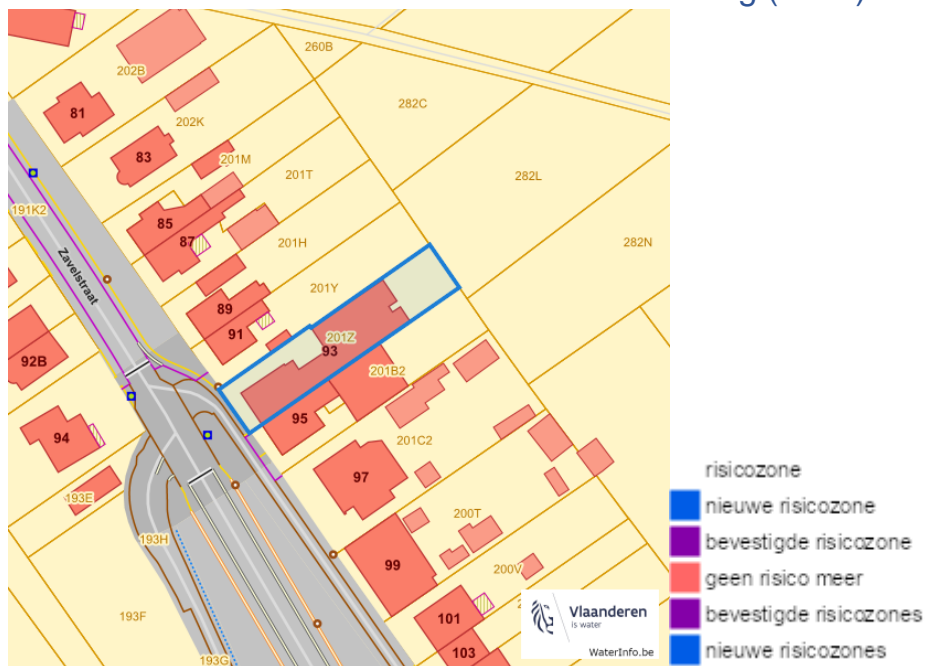

Recent overstromde gebieden (2017)



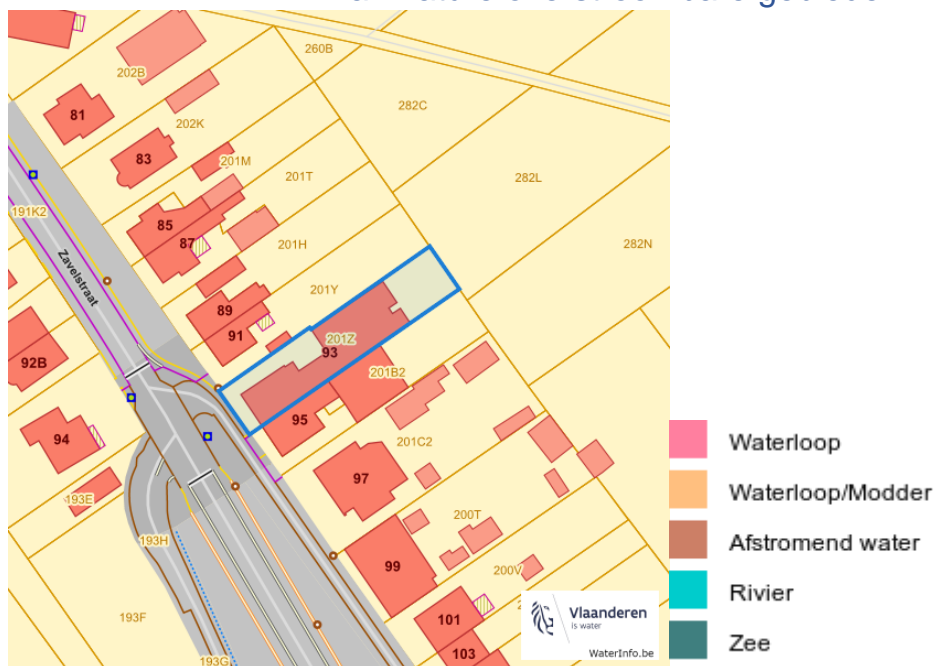
Risicozones overstrooming (2017)

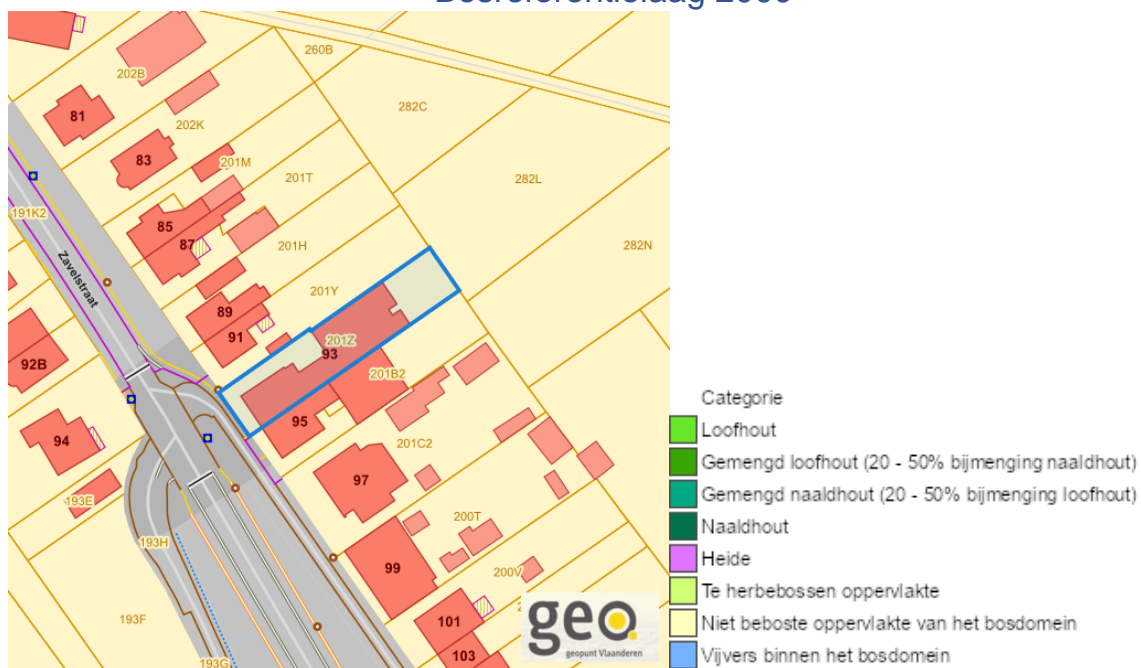

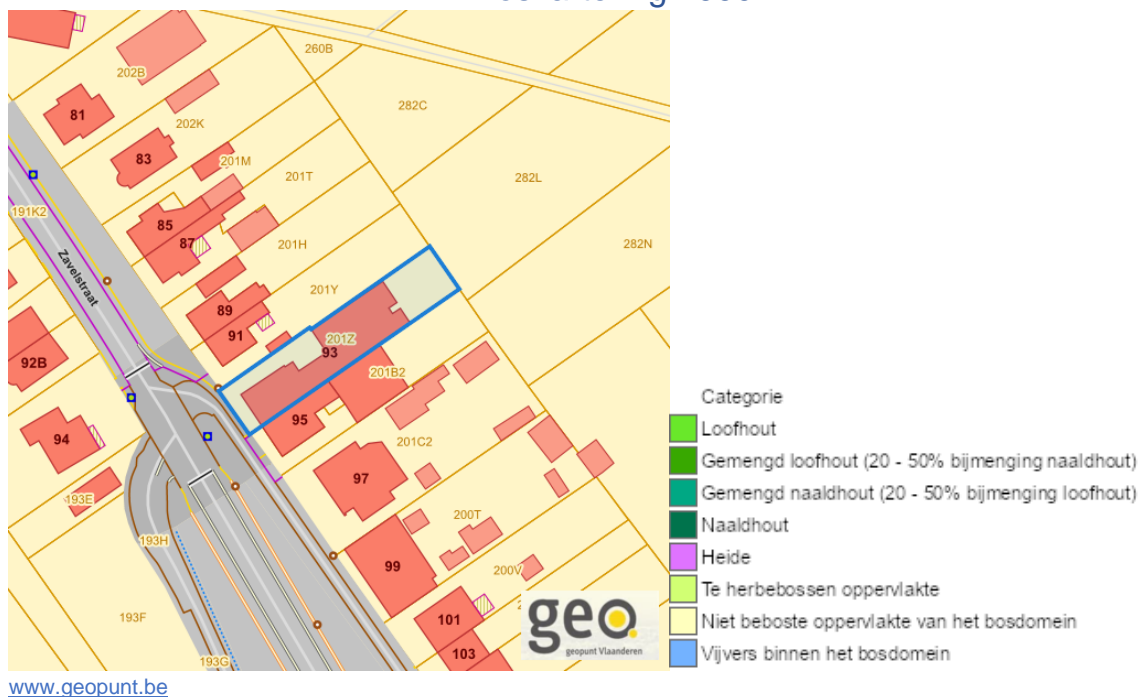


Groenkaart Vlaanderen (2021)

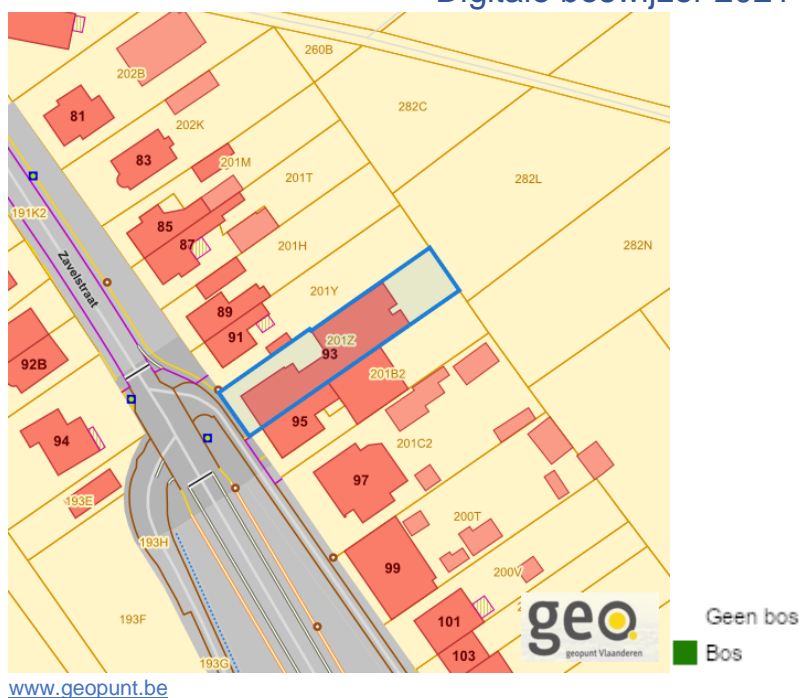

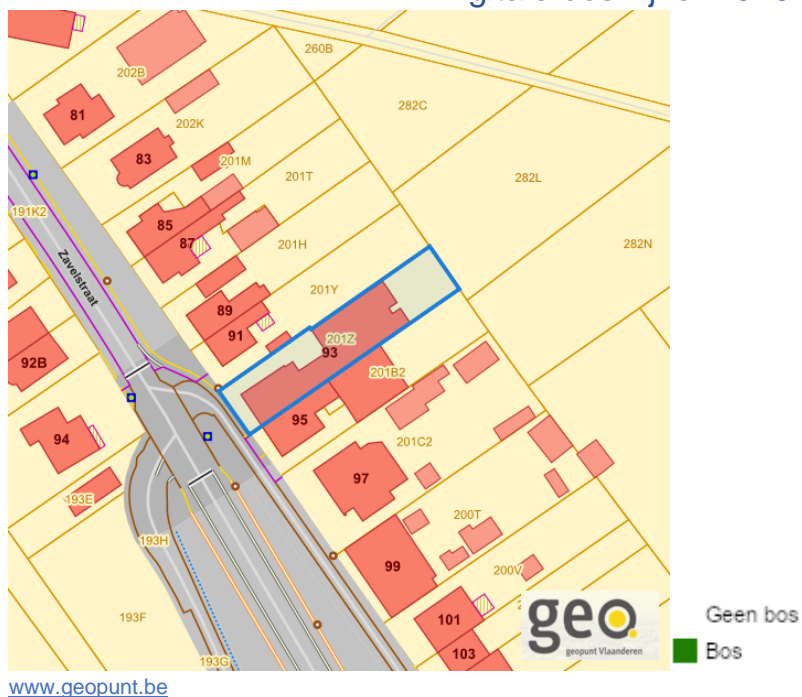

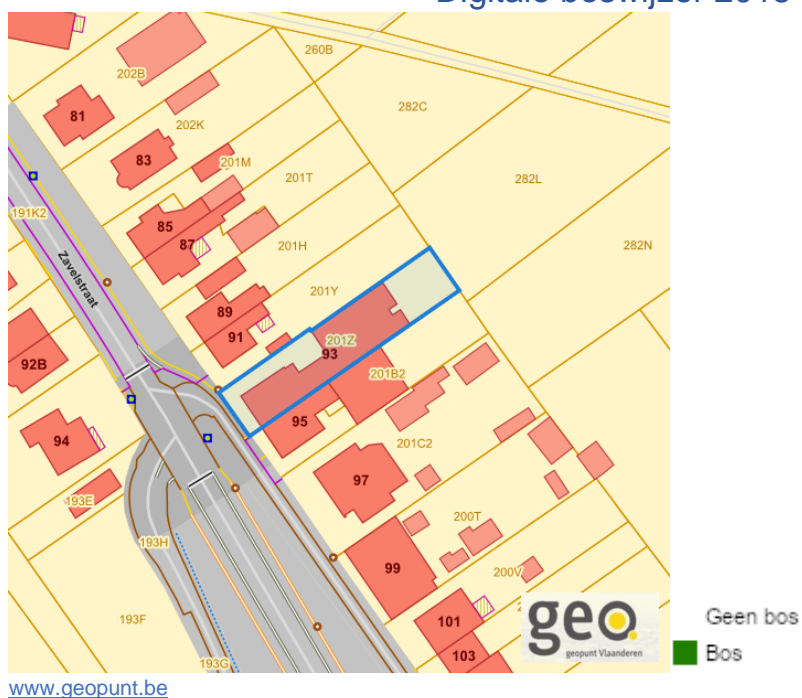

Digitale boswijzer 2018



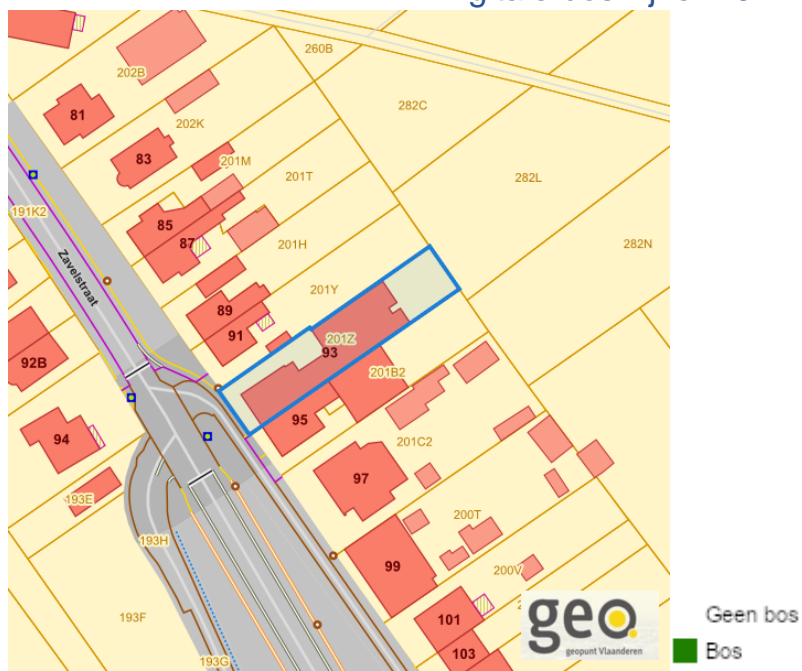

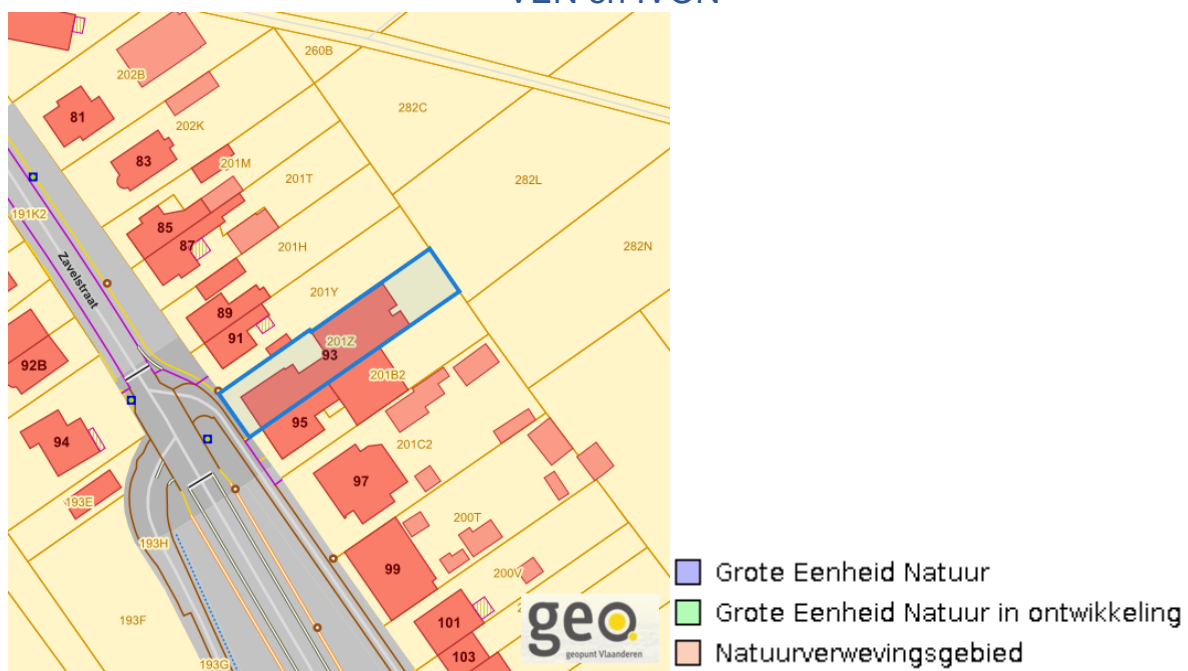

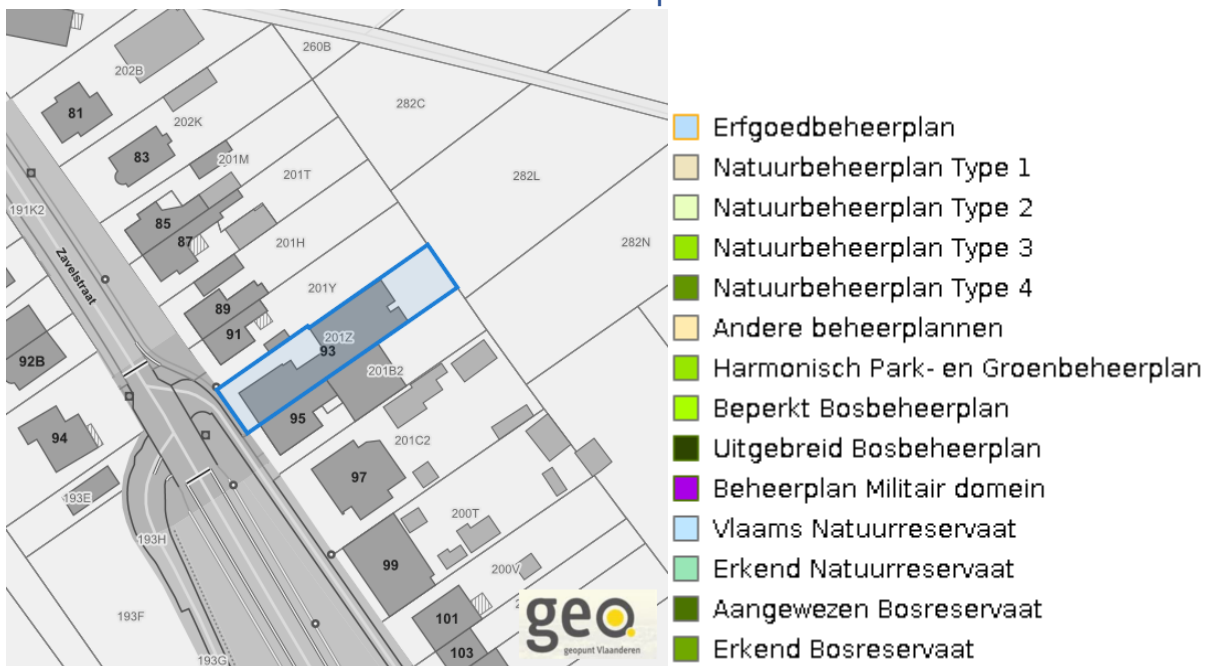

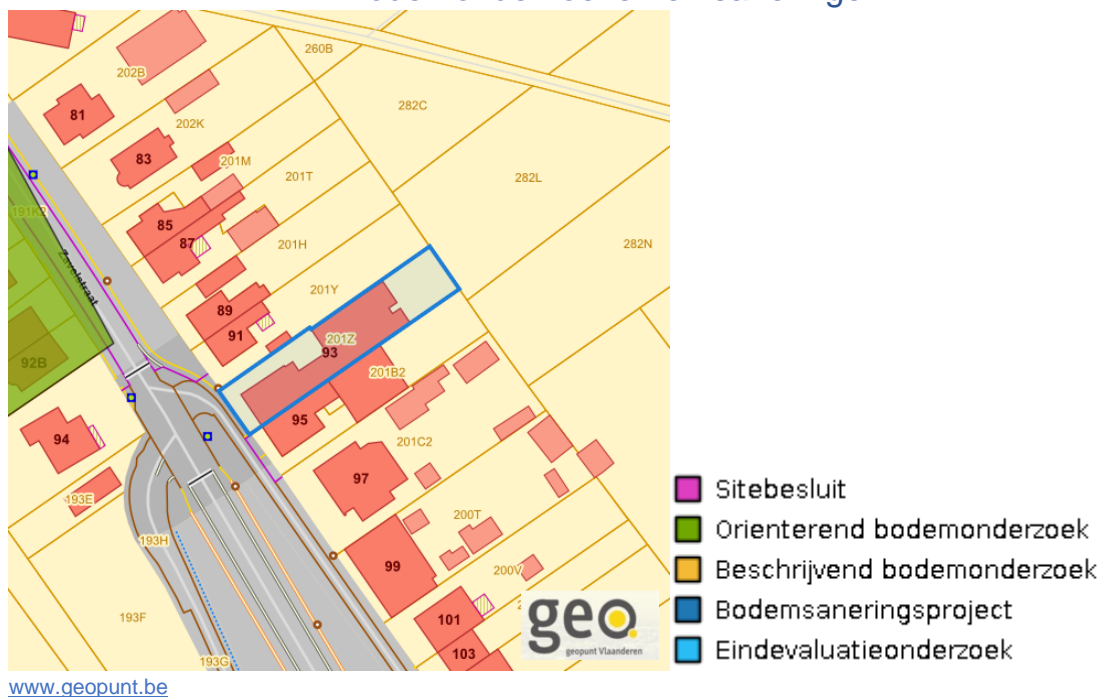

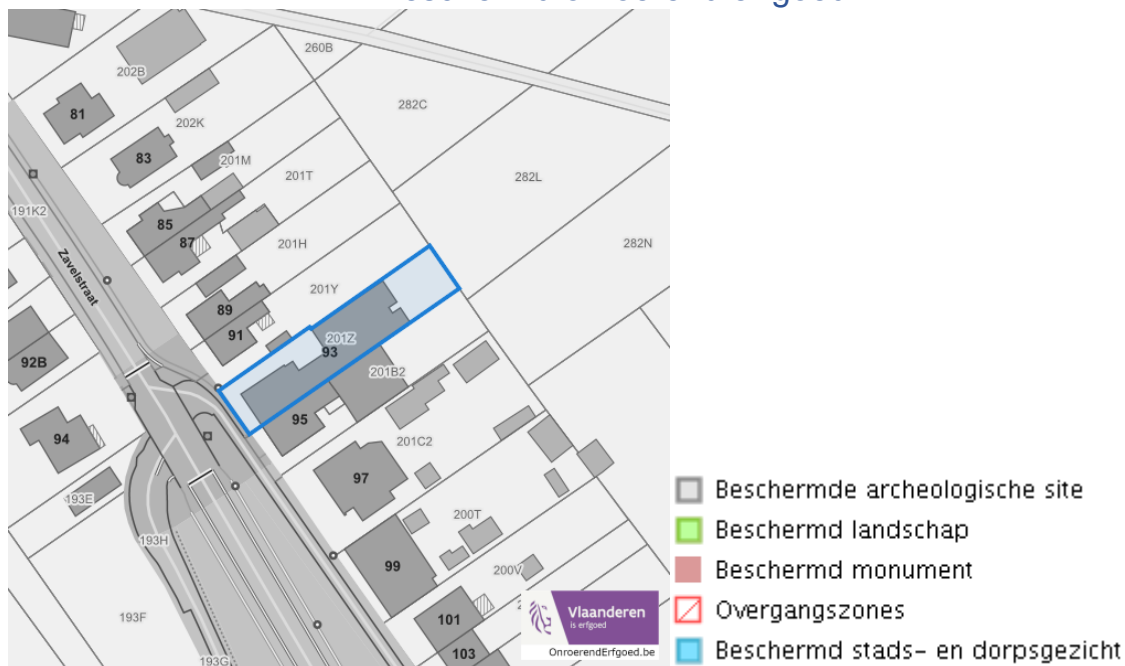

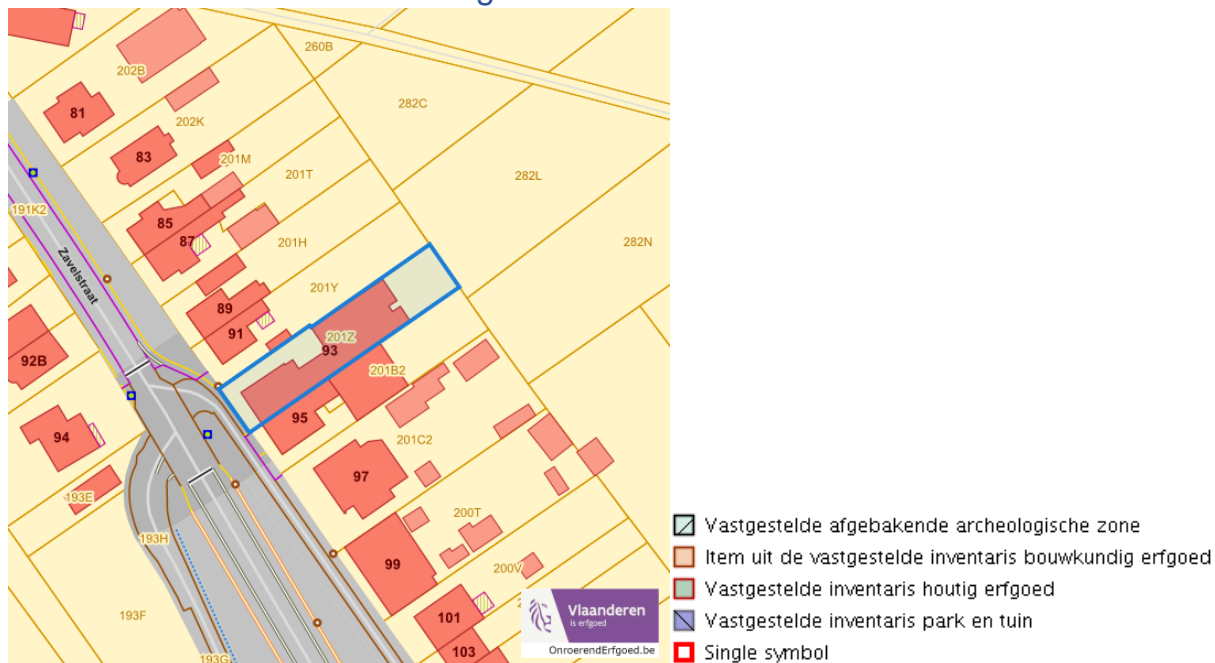

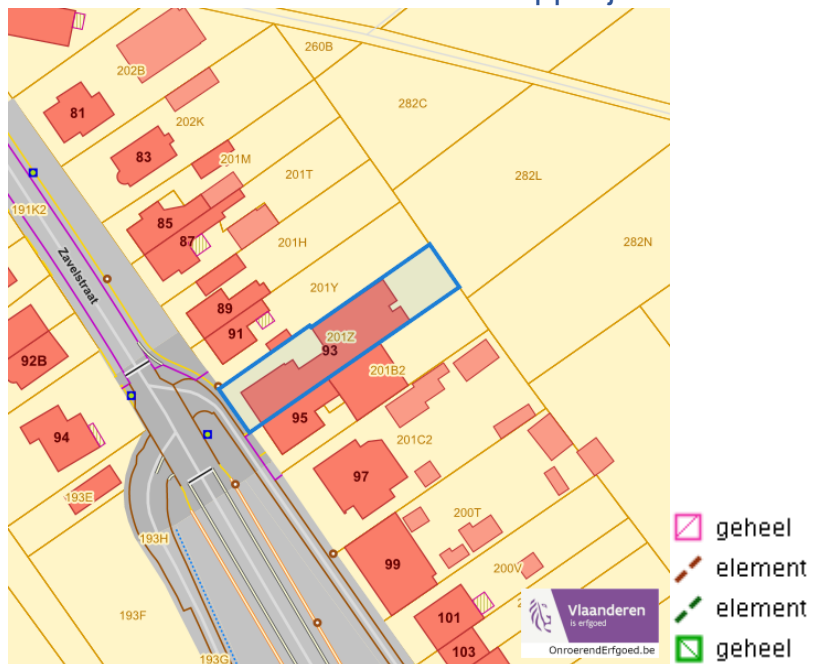

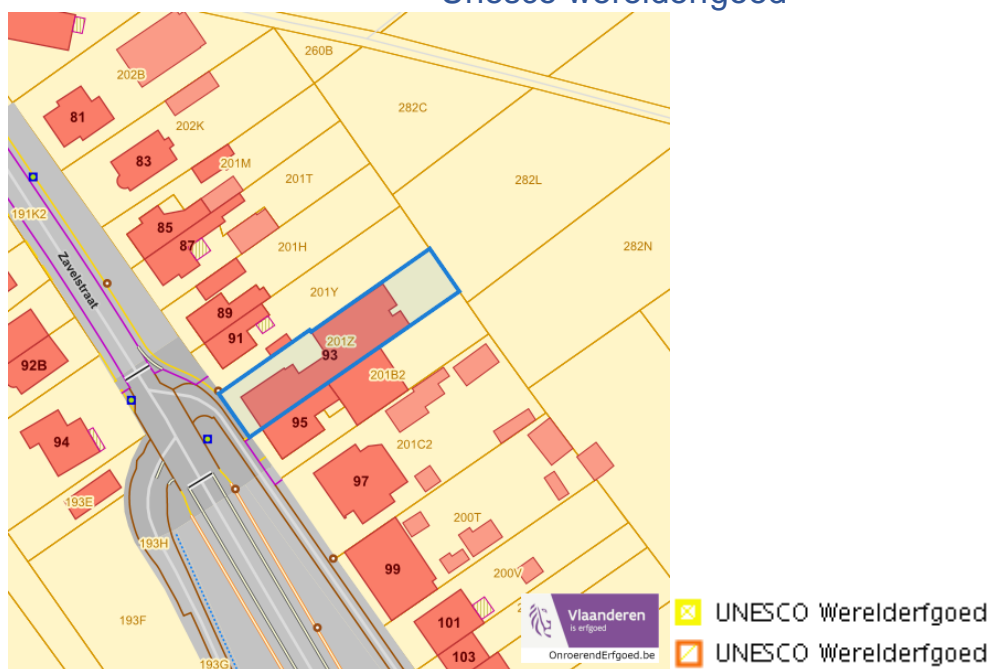

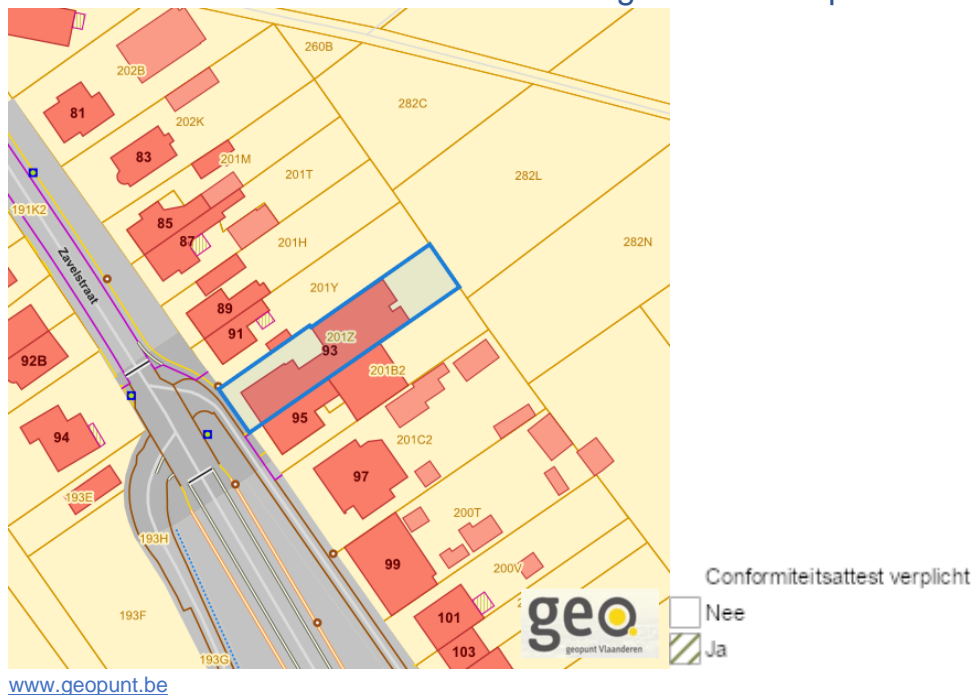
