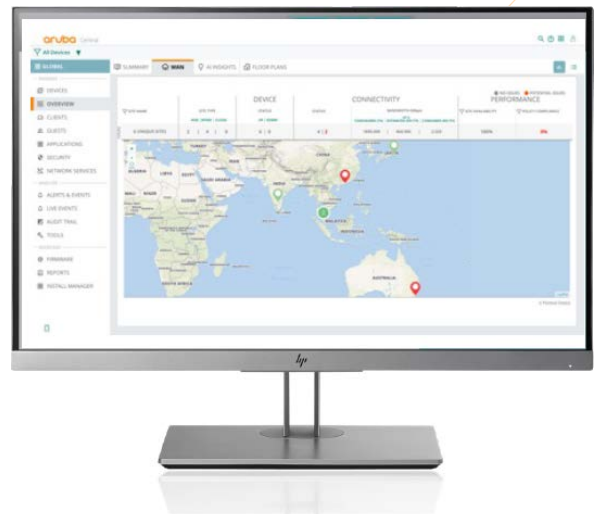

## Process steps for trade in

- ✔ Submit your NGQ quote for your new Central purchase
- ✔ Once approved, please log your trade in request at [www.hpe.com/eu/tradein](http://www.hpe.com/eu/tradein)
- ✔ Include your **NGQ/ I.Q 2.0 Quote ID** in the trade in request, as well as your **Support Contract ID**
- ✔ The named country approver (usually the Category Manager) receives notification on new applications and reviews eligibility, resulting in:
  - Approved application
  - Escalated for 2nd level approval if needed (Country Manager / Geo Lead)
  - Rejected request
- ✔ After purchase of the new products, the application is converted to a trade-in request & additional information is validated (order info, invoice etc)
- ✔ Payment is prepared and issued after a final approval

## Participants

- ✔ Channel Partners to raise applications to participate before purchase of the new Aruba product

## Products

Purchase of a Central product is a pre-requisite to participate with the program per the defined list of eligible products

## Trade in teams

- ✔ Applications are reviewed by Aruba and confirmed with the final refund allowance. Refunds proposed before Aruba approval are not binding!
