The Division of Investigation, U. S. Department of Justice, is charged with the duty of investigating violations of the laws of the United States and collecting evidence in cases in which the United States is or may be a party in interest.

The Division does not have investigative jurisdiction over violations of Counterfeiting, Narcotic, Customs, Immigration, or Postal Laws.

However, the Division of Investigation will immediately institute investigations of alleged violations of Federal Laws other than those listed above.

The following list indicates some of the major violations over which the Division has investigative jurisdiction:-

National Motor Vehicle Theft Act

National Bankruptcy Act

White Slave Traffic Act

Impersonation of Government Officials

Larceny of Goods in Interstate Commerce

Cases involving transportation in interstate or foreign commerce of any persons who have been kidnapped

Theft, Embezzlement or Illegal Possession of Government Property

Antitrust Laws

National Bank and Federal Reserve Act Violations, such as embezzlement, abstraction or misapplication of funds

Crimes on any kind of Government reservation, including Indian Reservations or in any Government building or other Government property

Neutrality violations, including the shipment of arms to friendly nations

Frauds against the Government

Perjury, embezzlement, or bribery in connection with Federal Statutes or officials

Crimes on the high seas

The location of persons who are fugitives from justice by reason of violations of the Federal Laws over which the Division has jurisdiction, of escaped Federal prisoners, and parole and probation violators.

It will be appreciated if information in the possession of law-enforcement officials concerning the above listed violations is promptly forwarded to the Special Agent in Charge of the nearest field office of the Division of Investigation, U. S. Department of Justice. If the information indicates that immediate action is necessary, telegrams marked "Government Rate Collect" or telephone calls will be accepted. The address of each of the Field Offices of this Division appears on the inside back cover of this bulletin.



The need for comprehensive and enthusiastic cooperation among all law enforcement officials--local, State, and Federal--has always been and will continue to be the keynote and principle of the Division of Investigation of the Department of Justice. NOTICES

The Division at this time desires to invite the attention of all contributors to the arrangement which it has perfected with the Superintendents of Identification Bureaus to exchange criminal identifying data with foreign countries in the cases of persons in whom the Division and the said Superintendents may be mutually interested.

A tabulation of the fingerprints submitted by interested law enforcement officials would apparently indicate that this service is not being utilized to the fullest possible extent. When it is desired to inquire relative to a criminal record believed to exist in a foreign country, it is necessary only that two copies of the fingerprint card of the individual concerned be forwarded to the Division with a notation to the effect that inquiry should be made of a certain specified foreign bureau. It is suggested also that in the cases of all fingerprints referred to the Division for international exchange, a photograph of the subject, if obtainable, the date and place of birth with the address of parents and the mother's maiden name be supplied to facilitate the establishment of an identification.

All contributors are invited to make liberal use of the arrangement.

INTERESTING IDENTIFICATION

TWO BROTHERS IDENTIFIED THROUGH FUGITIVE BULLETIN AS
WANTED FOR ROBBERY.

On February 8, 1934, a communication was received in the Division of Investigation to the effect that two brothers, Dave and Tom Reese were wanted by the Police Department and the Sheriff's Office, Ottumwa, Iowa, for armed robbery. A search of the Division's files at that time revealed that each of these persons had been arrested on several occasions and that one had served a sentence in the State Reformatory at Anamosa, while the other had been committed to the State Penitentiary at Fort Madison, Iowa. The usual fugitive notices concerning these two persons were inserted in the bulletin, "Fugitives Wanted By Police", published by the Division for April, 1934.

Information has been received in the Division of Investigation from the Police Department, Pasadena, California, reporting the arrest and the identification of these two fugitives in that City on March 29th through the medium of the information contained in the fugitive bulletin. The advice furnished by the Pasadena officials relative to this matter is as follows:

"On March 26th, two men held up a poker game in a local hotel and escaped with about a hundred and fifteen dollars. These men were known as William Woodrow and Jack Moriss. Our Detectives traced them to a motor stage depot, where it was learned they were headed for Gallup, New Mexico. The authorities at Gallup were notified and on March 27th, the two men together with a woman companion were taken into custody there.

"On March 29th, while extradition proceedings were under way, Moriss and Woodrow slugged the jailor in Gallup and escaped. They were apprehended later the same day and on April 3rd were returned to Pasadena. On the same day the April issue of the 'Fugitives Bulletin' was received and a comparison of fingerprints revealed that Woodrow and Moriss were wanted in Ottumwa, Iowa, for armed robbery, under the names of Tom Reese and David Reese."

The letter from the Pasadena officials further indicated that Woodrow and Moriss endeavored, falsely, to confess to several murders in another city to which they evidently hoped to be sent for prosecution. It is reported that these persons are being tried at Pasadena and if acquitted that they will be sent to Ottumwa to face charges there.

It is felt by the Division of Investigation that the value of the fugitive bulletins has been greatly enhanced through the insertion of reproductions of finger impressions. The case cited herein is an illustration of the efficacy of this practice.

INTERESTING IDENTIFICATION

BANK BANDIT KILLED BY OFFICERS IDENTIFIED
AS FORMER CONVICT

On April 21, 1934, the Division of Investigation received a telegram from the Chief of Police at Lincoln, Nebraska, giving a detailed classification analysis of the fingerprints of an unidentified bank bandit who had been shot and killed by officers at Lincoln on April 20, 1934. With the assistance of the comprehensive information furnished in this telegram, the Division conducted a search of its identification files and tentatively identified the unknown deceased as Aubrey Ray, who, in 1928, had been sentenced to serve terms of 99 years, 5 to 99 years and 5 to 99 years, concurrently, in the Texas State Penitentiary at Huntsville, charged with robbery with firearms. The files further revealed that Ray had been received at the same institution in 1927 to serve a prior term of robbery with firearms but that he had effected his escape after he had been incarcerated for about two months.

Advice as to the findings of the Division's technical experts in this matter was forwarded to the Chief of Police at Lincoln, Nebraska, on April 21st by telegraph. When the actual finger impressions of the deceased were received in the Identification Unit on April 23rd, it was found through a comparison of the impressions that the identification effected in this case was correct.

The Division of Investigation is called upon in many instances to identify persons who are shot and killed while they are engaged in the commissions of crime and in many cases establishes identifications of such individuals as former convicts or as persons wanted for escape while serving terms for prior offenses.
