

Preface

The two Financial years 2015-16 and 2016-17 showed tremendous improvement in the implementation of the MGNREGA in the State. The labour budget approved by MoRD during the two Financial years are **170.39 lakh** and **200 lakh** persondays respectively. Achievement stood at **198.88 lakh** persondays which surpassed the approved projection touching **116.72**% in 2015-16 and **282.2 lakh** persondays which is **141.1**% of the approved persondays in 2016-17.

Funds made available to the State during the FY 2015-16 was **Rs. 286.56 crore** out of which the expenditure was **Rs. 279.80 crore**. Of this, **Rs. 193.57 crore** was utilized for clearing backlogs of the previous financial year. The actual utilization during the year was **Rs. 69.11 crore** on wages and material, **Rs. 17.10 crore** on Administrative expenses and **Rs. 0.02 crore** for the implementation of Sansad Adarsh Gram Yojana (SAGY). An amount of **Rs. 15.00 crore** was also utilized from the State Corpus Funds for meeting the wage payments.

During FY 2016-17, the funds made available to the State was **Rs.1006.2948** crore while the expenditure was **Rs. 847.03** crore.Out of this, **Rs.418. 41** crore was utilized for clearing backlogs of the previous financial year. Actual utilization during the year was **Rs. 349.83** crore on wages and material, **Rs. 25.89** crore on administration and **Rs. 97.75** crore for Delay Payments. An amount of **Rs. 15** crore was refunded to the State Scheme and an amount of **Rs. 36.60** crore to the State Corpus Fund. Furthermore, **Rs. 37.65** crore was taken as a loan from the State Corpus Fund for meeting the wage payments.

In an attempt to strengthen the capacity of the Village Employment Councils (VEC) on record maintenance and functioning of Electronic Fund Management System (eFMS), trainings have been made an integral part of the implementation process in the State. Through the efforts of State Rural Employment Society (SRES) and the State Institute of Rural Development (SIRD), numerous trainings were conducted for the stakeholders across the State.

Social Audit was given special emphasis by the MoRD. In view of this, the Meghalaya Society for Social Audit & Transparency(MSSAT) which is an independent society was set up by the Community and Rural Development Department (C&RD), Government of Meghalaya to conduct Social Audits of flagship programme of the Department of Rural Development, Ministry of Rural Development (MoRD), i.e., for Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS).

The MIS is online for all the 39 blocks. The year 2015-16 saw the implementation of the Electronic Fund Management System (eFMS) in 5 blocks of the East Khasi Hills District in order to speed up the payment to the beneficiaries. This was scaled up to 100% eFMS universalisation by 1st December. 2016.

The FY 2015-16 ended with a liability of **Rs. 414.60 crore** which was met from the funds released during FY 2016-17 and the FY 2016-17 accrued a liability of **Rs. 410.02 crore** which was met from the funds released during FY 2017-18.

THE MAHATMA GANDHI NATIONAL RURAL EMPLOYMENT GUARANTEE ACT

Introduction

The MGNREGA is not merely a programme that is being implemented in the State, but it is the backbone of Rural Development. True to its objectives, the Act provides livelihood security to the rural households especially during the lean season. Through the program, transformation is seen across the landscape of the villages in the form of footpaths, roads, footbridges, community washing facilities, water conservation, playgrounds, etc. Besides the wage earned, the assets created serve the needs of the people in all areas of intervention.


Out of all of these, Rural connectivity has always been a priority for the VECs considering the difficult terrain and inaccessibility in the villages. With proper connectivity, it is envisaged that other areas such as agriculture can be developed.

With the shifting of focus to livelihood activities, the VECs have ventured out of the usual pattern and took up construction of sheds for piggery, poultry,goatery and cattle rearing. This has not only provided infrastructure to the individual households, but has also provided them an opportunity to create sustainable livelihood activities particularly for the youths.

The year 2015-16 saw the implementation of Electronic Fund Management System (eFMS) for the payment of all MGNREGA related expenses. It was implemented in the pilot district, i.e., East Khasi Hills District; in 5 blocks out of the total of 8. An amount of **Rs. 2.22 crore** was initialized for this purpose. These five blocks are Mylliem, Mawsynram, Mawryngkneng, Mawkynrew and Khadarshnong-Laitkroh.

In 2016-17, the rolling of 100% EFMS was carried out for the state from 1st December 2016 for payment of all wages and material expenses under MGNREGA. The total amount of transaction under EFMS is Rs. 204,13,33 lakhs.

During the years, the Meghalaya Society for Social Audit and Transparency (MMSAT) was created to look after the Social Audit in the entire State. MSSAT is an independent society set up by the Community and Rural Development Department, Government of Meghalaya, as per instructions of the MoRD to conduct Social Audits of flagship programme for Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS). At present, MSSAT has been entrusted with the mandate to conduct social audits of Indira Awaas Yojana (IAY), a flagship scheme of the Ministry of Rural Development which since inception has been providing assistance to BPL families who are either houseless or having inadequate housing facilities for constructing a safe and durable shelter. The area of operation of the Society is extend to the whole state of Meghalaya.



Training & Capacity Building during Financial Year 2015-16

MGNREGA has set a landmark by placing the community as a principal implementing agency to implement the scheme. The Act mandated planning and implementation from the Village level. The community is given the responsibility to plan, implement and execute works for their own development. The MGNREGA is a complex programme and peoples' rights and entitlements have to be safeguarded and timelines have to be met. It is necessary to ensure that training is a continuous affair and not a one-time activity. Training of different stakeholders play a very important role in deciding the success of any scheme. It is, therefore, imperative to generate awareness, provide regular training to different stakeholders on different aspects in order to meet the aims and objectives of the scheme. The need to make the VECs and Block level staffs fully aware of the operational guidelines, procedures for implementation, execution of works, monitoring, evaluation and data management is necessary for smooth implementation of the scheme.

In the absence of Panchayati Raj Institutions, the Village Employment Council and the Area Employment Council were formed to function as village level implementing agencies. They have been identified as the principal agencies for the implementation of MGNREGA. It is, therefore, imperative to build the capacities of the village level functionaries for effective implementation of MGNREGA so that the rights and entitlements of the people can be safeguarded as per its mandate. The training programmes are focused on providing book-keeping skills as well as awareness on the rights, entitlements and Social Audit.

Some of the findings of the field visits of the Commissioner & Secretary, C&RD Department are:-

1. There is a shortage of technical staff in most of the Blocks. Fresh instructions have been given to districts to appoint Technical Assistants as per the required number worked out as per the formula. The number of Technical Assistants recruited after giving instruction is 42.

2. The format, size, cost, colour code and material used for the signboard vary from Block to Block and District to District. The correct specification has been thoroughly designed and was circulated to all districts.

3. Poor quality works due to non-utilization of materials. To improve the quality of the projects undertaken, the Blocks have been instructed to facilitate community participation and utilization of materials as per norms to ensure that better quality assets are generated. Districts have been requested that wherever required, materials should also be included for the projects to be undertaken to ensure that the projects implemented are durable and satisfactory. 4. It is observed that there is a frequent change of the VEC functionaries even though they have not completed 3 years in office. This frequent change leads to slackness in record maintenance and in work execution. It is advised that the frequency in VEC leadership should be discouraged. Replacement in VEC functionary can only be made upon the completion of the tenure or if there are serious allegations of misappropriation and failure to effectively discharge their duties.

5. Signboards found stacked at the Block office in WGH district. Orders were issued to immediately distribute the signboards to VECs for installation at worksites.

6. Usages of labour displacing machineries were observed in few Blocks. Instruction was given to desist such practices.

7. VEC needs constant capacity building to evolve as a strong community institution. It is felt that we were focused more on technical aspects but not on promoting leadership of the institution.

Shared goals during the visits are:-

- 1. Creation of 'durable assets' with focus on water and rural connectivity.
- 2. Focus on 'Bottom 20' to provide individual livelihood assets to the poorest in the village.
- 3. Mobilization of Job Card holders into SHGs and facilitating of increase savings through the wages earned.
- 4. Convergence with Agriculture, Horticulture, Animal Husbandry and Veterinary, MBDA to create sustainable livelihood and assets.

Policy intervention brought in:-

 Amendment in the State Scheme for improving administration and implementation of the Scheme in bigger VECs.

Social Audit & Public Hearing During Financial Year 2015-16

With the creation of the Meghalaya Society for Social Audit and Transparency (MSSAT) in FY 2015-16, sole responsibility was given to the society to conduct social audits of its flagship programme for Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS). The conducting of Social Audits is carried out by various Non Government Organisation (NGOs) for generating awareness and encouraging people to analyse the implementation of the Act.

d. Commission from the Post Office: This case was reported from Mynsngat & Moolyngkdein VEC, Thadlaskein block, West Jaintia Hills District where commission was taken by P.O. Master.

e. No documents/lost documents: These cases have been reported in south Garo & North Garo Hills District. This happens mostly due to change of office bearers.

f. Use of JCB: Reported in Tikrikilla C&RD Block, West Garo Hills District.

Management Information System Financial Year 2015-16 & 2016-17

Management Information System (MIS) of 2015-16

The Management Information System has made data transparent and available in the public domain to be equally accessed by all. The village level household database has internal checks for ensuring consistency and conformity to normative processes. Overall management of MGNREGA has been through the MIS. This has enabled proper review of performances of the various Districts and Blocks in the State, thereby, allowing us to take corrective measures in the form of various training and awareness programmes conducted at Districts and Blocks.

The Electronic Fund Management System (eFMS) was implemented this financial year for the payment of all MGNREGA related expenses. It was implemented in the pilot district of East Khasi Hills District in 5 blocks out of the total of 8. An amount of Rs. 2.22 crore was initialized for this purpose. These five blocks are Mylliem, Mawsynram, Mawryngkneng, Mawkynrew and Khadarshnong-Laitkroh. The system will then be implemented in the remaining blocks in the following Financial Year of 2016-17. The eFMS streamlined the process of transferring the wages directly to the beneficiaries accounts, thereby eleminating unnecessary time consuming processes. The Financial Year 2015-16 saw the disbursment of an amount of Rs. 2.17 crore to the beneficiaries through the eFMS.



Regular reviews and trainings on the MIS was conducted by SRES. The MIS playing a pivotal role in the monitoring and evaluation of the programme along with ensuring maximum transparencey, trained human resources under MGNREGA and a robust ICT infracture is always an important parameter for the performance. Management Information System (MIS) of 2016-17

Various new reports were incorprated in the MIS and the explaination of such reports was given to the trainees.

During the current financial year, trainings on Geo-MGNREGA were also organised at Shillong and Tura for their respective district and block level officials.

(Cont from Edit)...grass-roots. This may be called 'redistribution of wealth' to boost the rural economy. Corruption at any level cannot be condoned. But when the whole country is at a loss on how to deal with multi-billion dollar corruption involving top leaders and high officials of the country, corruption in thousands and lakhs of rupees in the villages is only a corollary, not a failure of the NREGS. There is no magic wand to conjure up development, or eradicate corruption.

The good things that the NREGS has brought about besides the construction of durable community assets are: It has paved the way for attitudinal change among the people to accept positive democratic elements in grassroots governance; it has taught the village leaders to maintain records of various transactions in official procedures of public administration. Recently the VEC's are instructed to open bank accounts for each job card holder through which payments shall be made. This would initiate the rural people to banking.

The scheme has also made rural folks more assertive to demand for their rights and to complain against wrongdoings. Last but not the least, even if corruption cannot be totally prevented, the wealth gained out of it, does not go to the coffers of the super rich but is injected into the rural economy, and this would indirectly create employment too. NREGS should stay for the sake of these good things. If any defect is found in its implementation, it is not the fault of the scheme but because of the general trend of the Indian society. Thanks to Prof Debroy and to Prof B Panda for their enlightening arguments, and thanks also Mr K.N. Kumar for his enthusiasm about the scheme in spite of some defects because without enthusiasm any scheme would have been buried before its birth.

Garo Hills makes best use of MGNREGS

WILLIAMNAGAR: While the Mahatma Gandhi Na-tional Rural Employment Guarantee Scheme (MGN-REGS) is marred by scams and controversies in Khasi Hills, the villagers of Williamnagar under East Garo Hills are making the best benefit out of the Union Government scheme in improving the connectivity of inaccessible villages of East Garo Hills.

One third of the popula-tion of Samanda C&RD Block reside on southern side of Simsang River and this area is sandwiched between Durama Hills and Simsang River.

The only way for the people of this area to reach Williamnagar is to cross the Simsang River and the river allows crossing it by vchi-

cle for only four months in a year and rest of the year the only way to cross the river is by traditional boat called "ring" in local language. Since an under construc-

tion bridge is eluding them for past 30 years, every day hundreds of vegetable vendors, students, teachers, patients and others find it quite a challenge to cross the river. However, after inception of MGNREGS, the VECs across the river took up many useful works to improve communication and 5 VECs came together and decided to construct a suspension footbridge jointly and approached the District Administration.

The Meghalaya Integrat-ed Basin Development and Livelihood Promotion Program (MIBDLP) supported the project by way of providing the Critical Gap

Funding and also getting the project technical vetted by IDFC. East Garo Hills Deputy

Commissioner Vijay Kumar Mantri said that the Meghalaya Integrated Basin Development Livelihood Programme is contributing 18.5% of the Project Cost under Convergence. The rest of the project

cost is being funded by MGNREGS and community contribution.

Reacting to a query, he said that the project has made 80% physical progress and will be completed by the end of September.

It is learn that the proposed bridge will be of great help for the inhabitants of other side of Simsang river as it will greatly help vegetable sellers and students who have to come to Wilgar in a boat





Implementation of MGNREGA during 2015-16




Average Persondays provided per HHs








Graph 1: Comparison of Persondays Provided per HHS for 2014-15, 2015-16 & 2016-17 against the National Average
