These vehicles were manufactured by Newmar Corporation between April 14, 2014 and June 20, 2014.

Effected Population Assessment

100% of the vehicles identified above may contain defective equipment.

Defect Description

The 2014 Dutch Star motorhome headlight wiring harness installed by Newmar may have been manufactured out of specification resulting in the possibility of the headlights and fog lights to turn on and off when they have been activated by their individual dash switches. Under normal operation, the headlights and fog lights function as indicated by the individual dash switches. However, if one of the headlight circuit breakers in the driver's side front compartment, were to fail (remain open and non-functional) the headlights and fog lights will cycle off and on.

Newmar Corporation has filed recall serving notice of their intent to recall these defected wiring harnesses.
