Affected vehicles are identified in OASIS and FSA VIN Lists.

REASON FOR THIS SAFETY RECALL

In the affected vehicles, driveline vibration may occur when driving above 75 mph. The vibration may or may not be perceptible to the driver. Continued operation of the vehicle above 75 mph may fracture the transmission and/or driveline components. This could result in a loss of motive power without warning while driving, or unintended vehicle movement in park without the parking brake applied, increasing the risk of injury or crash.

SERVICE ACTION

Dealers are to remove the original two-piece driveshaft and install a three-piece driveshaft following the Technical Information. This service must be performed on all affected vehicles at no charge to the vehicle owner.

OWNER NOTIFICATION MAILING SCHEDULE

Owner letters are expected to be mailed the week of May 15, 2017, announcing that parts and a repair procedure are available. Dealers should repair any affected vehicles that arrive at their dealerships, whether or not the customer has received a letter.

PLEASE NOTE:

Federal law requires dealers to complete this recall service before a new vehicle is delivered to the buyer or lessee. Violation of this requirement by a dealer could result in a civil penalty of up to \$21,000 per vehicle. Correct all vehicles in your new vehicle inventory before delivery.

OASIS ACTIVATION

OASIS was activated on March 28, 2017.

FSA VIN LISTS ACTIVATION

FSA VIN Lists were available through https://web.fsavinlists.dealerconnection.com on March 28, 2017. Owner names and addresses will be available by May 29, 2017.

NOTE: Your FSA VIN Lists may contain owner names and addresses obtained from motor vehicle registration records. The use of such motor vehicle registration data for any purpose other than in connection with this recall is a violation of law in several states, provinces, and countries. Accordingly, you must limit the use of this listing to the follow-up necessary to complete this recall.

SOLD VEHICLES

- Owners of affected vehicles will be directed to dealers for repairs.
- Immediately contact any of your affected customers whose vehicles are not on your VIN list but are identified in OASIS. Give the customer a copy of the Owner Notification Letter (when available) and schedule a service date.
- Correct other affected vehicles identified in OASIS which are brought to your dealership.
- Dealers are to prioritize repairs of customer vehicles over repairs of new and used vehicle inventory.

STOCK VEHICLES

- Correct all affected units in your new vehicle inventory before delivery.
- Use OASIS to identify any affected vehicles in your used vehicle inventory.

DEALER-OPERATED RENTAL VEHICLES

A new law prohibits a Rental Company from selling, renting or leasing vehicles subject to a safety or compliance recall. This could impact dealer-operated rental fleets of 35 vehicles or more, including FRAC, LRAC, and DDR vehicles. Please see EFC04833 for details and consult your legal counsel for legal advice.

TITLE BRANDED / SALVAGED VEHICLES

Affected title branded and salvaged vehicles are eligible for this recall.

ADDITIONAL REPAIR (LABOR TIME AND/OR PARTS)

Additional repairs identified as necessary to complete the FSA should be managed as follows:

- For vehicles within new vehicle bumper-to-bumper warranty coverage, follow existing warranty and policy guidelines for related damage claims. No SSSC approval is required for these vehicles:
 - o Ford vehicles 3 years or 36,000 miles
- For vehicles outside new vehicle bumper-to-bumper warranty coverage, submit an Approval Request to the SSSC Web Contact Site prior to completing the repair.

CERTAIN 2017 MODEL YEAR F-450/F-550 4X4 VEHICLES WITH 205" WHEEL BASE AND 4.88 AXLE RATIO — THREE-PIECE DRIVESHAFT CONVERSION

OVERVIEW

In the affected vehicles, driveline vibration may occur when driving above 75 mph. The vibration may or may not be perceptible to the driver. Continued operation of the vehicle above 75 mph may fracture the transmission and/or driveline components. This could result in a loss of motive power without warning while driving, or unintended vehicle movement in park without the parking brake applied, increasing the risk of injury or crash. Dealers are to remove the original two-piece driveshaft and install a three-piece driveshaft following the Technical Information.

SERVICE PROCEDURE

- 1. Remove the two-piece rear driveshaft. Please follow the Workshop Manual (WSM) procedures in Section 205-01.
- 2. Remove and discard the original center bearing support bracket. See Figure 1.



NOTE: See Figure 2 for the correct driveshaft bearing support bracket locations.

- 3. Install the two *new* driveshaft bearing support brackets and eight *new* driveshaft bearing support bracket attaching nuts (four on each bracket). See Figure 2.
 - Tighten nuts to 23 Nm (17 lb-ft).



4. Install two *new* driveshaft bearing support spring nuts to both *new* driveshaft bearing support brackets. See Figure 3.



NOTE: Installing the *new* three-piece driveshaft requires the aid of an assistant.

- 5. Install the front section of the driveshaft. See Figure 4.
 - a. Install the two *new* driveshaft front bearing support bolts.
 - b. Install the two new U-joint straps.
 - c. Install the four *new* U-joint strap bolts.
 - Do not fully tighten the front bearing support bolts U-joint strap bolts at this time.



- 6. Install the rear two sections of the driveshaft. See Figure 5.
 - a. Install the two *new* driveshaft rear bearing support bolts.
 - b. Install the four new U-joint straps.
 - c. Install the eight *new* U-joint strap bolts.
 - Do not fully tighten the rear bearing support bolts and U-joint strap bolts at this time.



- 7. Tighten the twelve U-joint bearing strap bolts (front, center, and rear) to 63 Nm (46 lb-ft). See Figures 4 and 5.
- 8. Verify the bearing support bolts are in the middle to mid-front of the bearing support bracket slots, and the bearing supports are perpendicular to the center line of the driveshaft.
- 9. Tighten the four bearing support bolts (two on each driveshaft bearing support bracket) to 70 Nm (52 lb-ft). See Figures 4 and 5.
