Robert E. Helm was born in Brightwaters, Long Island on May 24, 1939 and received his early education there. He attended Syracuse University and earned his bachelor of arts degree in political science in 1960. He was awarded an LL.B. degree summa cum laude from the Syracuse University College of Law in 1962.

# The Professional Service Corporation

On May 19, 1970, Governor Rockefeller approved a bill, effective immediately, which will have a significant and lasting effect on the various professions in this state. The bill (Senate Bill No. 8052-A; Chapter 974 of the laws of 1970), sponsored<sup>1</sup> by Senator Anthony B. Gioffre in the Senate and Assemblyman John H. Terry in the Assembly,<sup>2</sup> will permit the formation of professional service corporations in New York, making this State the 49th to permit professionals to incorporate or form associations treated as corporations for tax purposes.

The bill permits one or more professionals to form a professional service corporation. Although other corporations will only be permitted to practice a single profession, the bill includes a provision, added at your Association's request, which permits architects, landscape architects, engineers and land surveyors to join together in a single corporation.

Since the bill has an immediate effective date, most of the professionals in this State will be considering the possibility of incorporation, during the next several months. Obviously, the decision to incorporate can only be made after a full consideration of all relevant facts, and then only with the advice and consultation of a qualified attorney and accountant. While an article of this type can never serve as a substitute for individualized, professional advice, it is hoped that the following discussion of the advantages and disadvantages of corporate practice will prove of assistance to the members of the New York State Association of Architects, Inc.

## Advantages of Corporate Practice:

**A. Non-tax.** Among the advantages generally listed which favor the corporate form of practice are centralized management, perpetual life, transferability of interest and limited liability.

1. **Centralized management** — Most partners in an existing partnership are acutely aware of the shortcomings of the partnership form of doing business. Although the act of incorporation cannot cure poor management practices, the availability of the corporate "management shell", including a Board of Directors and named officers with designated duties, will, of necessity, have a beneficial impact on management practices.

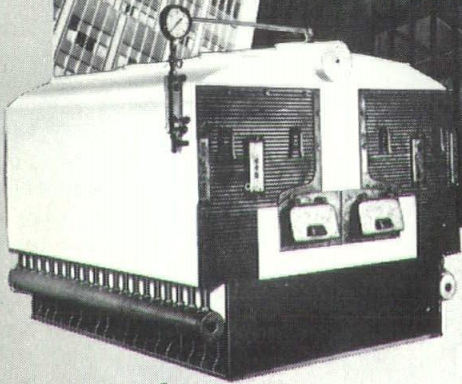
2. **Perpetual life** — The corporate entity is unaffected by the death of a shareholder (except, perhaps, in a single shareholder corporation). Although the corporation or other shareholders will be required to redeem the shares owned by the deceased shareholder within six months, corporate practice can otherwise continue without interruption.
3. **Transferability of Interest** — Since ownership in the corporation is evidenced by stock certificates, ownership changes will be generally less complicated than similar changes in an existing partnership. It should be noted, however, that the Statute does impose various restrictions on the transferability of ownership interests (including the approval of a majority of the other shareholders), but most of these restrictions can be modified in the bylaws or by shareholder agreement.
4. **Limited liability** — Although the bill continues the professional's personal liability for his own acts, or the acts of other professionals under his "responsible charge", the professional otherwise will not be personally liable. This is a distinct advantage over the partnership form of practice, since one partner presently is fully and personally liable for the acts of all other partners, even though he did not perform any services in the case involved.

## B. Tax

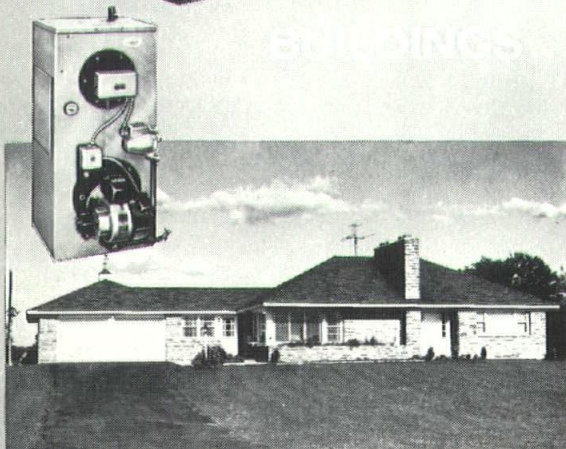
1. **General** — Aside from the pension and profit-sharing plans hereafter discussed, there are many fringe benefits which may be provided corporate employees with "before tax" dollars. Although not all professionals will wish to provide all of these benefits, it is important that each of the following possible benefits be considered at the time the corporation is formed.
  - (a) \$5,000 death benefit which is excludable from federal income and estate tax.
  - (b) Group term life insurance may be provided by corporation up to a \$50,000 face amount without taxable income to the employee; taxes on face amounts in excess of \$50,000 are at bargain rates.
  - (c) Corporation may establish "non-qualified" deferred compensation plans for all employees or only for shareholders.
  - (d) \$100 weekly may be excluded from income as "sick pay".
  - (e) Tax free medical reimbursement for employees and dependents.
  - (f) Lower tax rate on income retained in the corporation and the corporate 85% dividend exclusion.

2. **Tax pension and profit-sharing plans** — While the other tax benefits are not insignificant, the major tax advantage in the corporate area results from the more liberal rules governing pensions and profit-sharing plans. Under "qualified" plans, the employer's contribution is deductible when made, and the income earned on

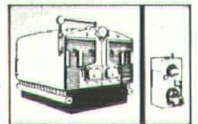

such contributions is tax free until distributions are made at retirement.

Many professionals looked forward with great anticipation to the enactment of the Keogh legislation in 1962. That legislation permitted self-employed persons (including partners) to establish qualified pension and profit-sharing plans for the benefit of themselves and their employees. This anticipation was followed by great disappointment for many professionals, especially architects and engineers, when they discovered that the cost of establishing such retirement plans was prohibitive due to the serious restrictions contained in the Keogh Act. Aside from the 10% or \$2500 rule on deductible contributions to the owner-employee, most partnerships were forced to establish the same proportional benefits for all employees even though they were already contributing to such employees' social security retirement benefits. In other words, the law effectively prevented the owner from making a proportionately lower contribution for the first several thousand dollars (up to the social security wage base) of the employee's salary in recognition of the fact that the employer was already providing retirement benefits for that portion of the salary through social security.

Furthermore, distributions to owner-employees (partners) could not commence until age 59½, all employees had to be covered after three years of service, and benefits had to be fully vested under the Keogh legislation. Moreover, distributions, to owner-employees, even if taken in a single lump sum, were taxable as ordinary income, rather than as capital gains as was the case with corporate plans (note: That part of the distributions which is equal to the total employer contributions made in tax years commencing January 1, 1970 will be taxable as ordinary income under the 1969 Tax Reform Act). Finally, distributions from a Keogh plan were taxable in the employee's estate, whereas corporate plan distributions were generally exempt from the estate taxes where no payment was made directly to the estate.

Unlike the law governing most Keogh plans, the statutory provisions governing corporate pension and profit-sharing plans, in addition to more liberal administration and tax benefits, have always permitted the employer, in determining retirement contributions or benefits, to take into consideration the amount which the employer contributes towards social security. Although these rules are highly technical in nature, they basically permit an employer to exclude an employee who is earning below the social security wage base, or

to provide a proportionately higher retirement benefit for higher paid employees. For example, a corporate pension plan could provide for an annual retirement benefit equal to 30% of an employee's wages in excess of \$6000, while at the same time providing no retirement benefit for the first \$6000 in wages. On the other hand, the corporate pension or profit-sharing plan could call for contributions equal to 6% of wages in excess of \$6000, and no contribution for wages below \$6000. The process of taking social security benefits into consideration in establishing pension and profit-sharing plan benefits is known as "integration". The theory of "integration" is to permit each employee to receive retirement benefits, based on his total wages, which are proportionate to the benefits he would have received if social security benefits were based on full compensation (at present, social security benefits are computed at a maximum of \$7800).

It should be pointed out that the corporate employer is not required to exclude persons earning under \$6000 or \$7800. Indeed, the employer need not integrate his pension and profit-sharing plan, and could provide the same proportionate benefits for all employees. Furthermore, he could provide benefits at a certain level for the first \$6000 in income, and then provide benefits at a proportionately greater level for income in excess of (e.g., benefits could be 10% of wages for the first \$6000 and 40% of wages in excess of \$6000).

Of course, the fact that architects and engineers, unlike other professionals, have a relatively high ration of "common-law" employees to professional owners will still make the establishment of pension and profit-sharing plans more expensive than for other professional service corporations. However, it is quite possible, and indeed, likely, that architects who formerly rejected a Keogh plan because of its costs may find that a corporate pension and profit-sharing plan is both feasible and desirable.

Finally, your state Association is presently giving consideration to the establishment of a statewide pension and profit-sharing plan for architects (and perhaps for others who can join in the professional service corporation). The creation of such an Association "plan" would reduce the "set-up" costs of such plans for the individual firms, and would assure the development of a plan which maximized the benefits to the profession. Therefore, any architect who is considering incorporation should check with his state Association to determine if and when such plan will be established.

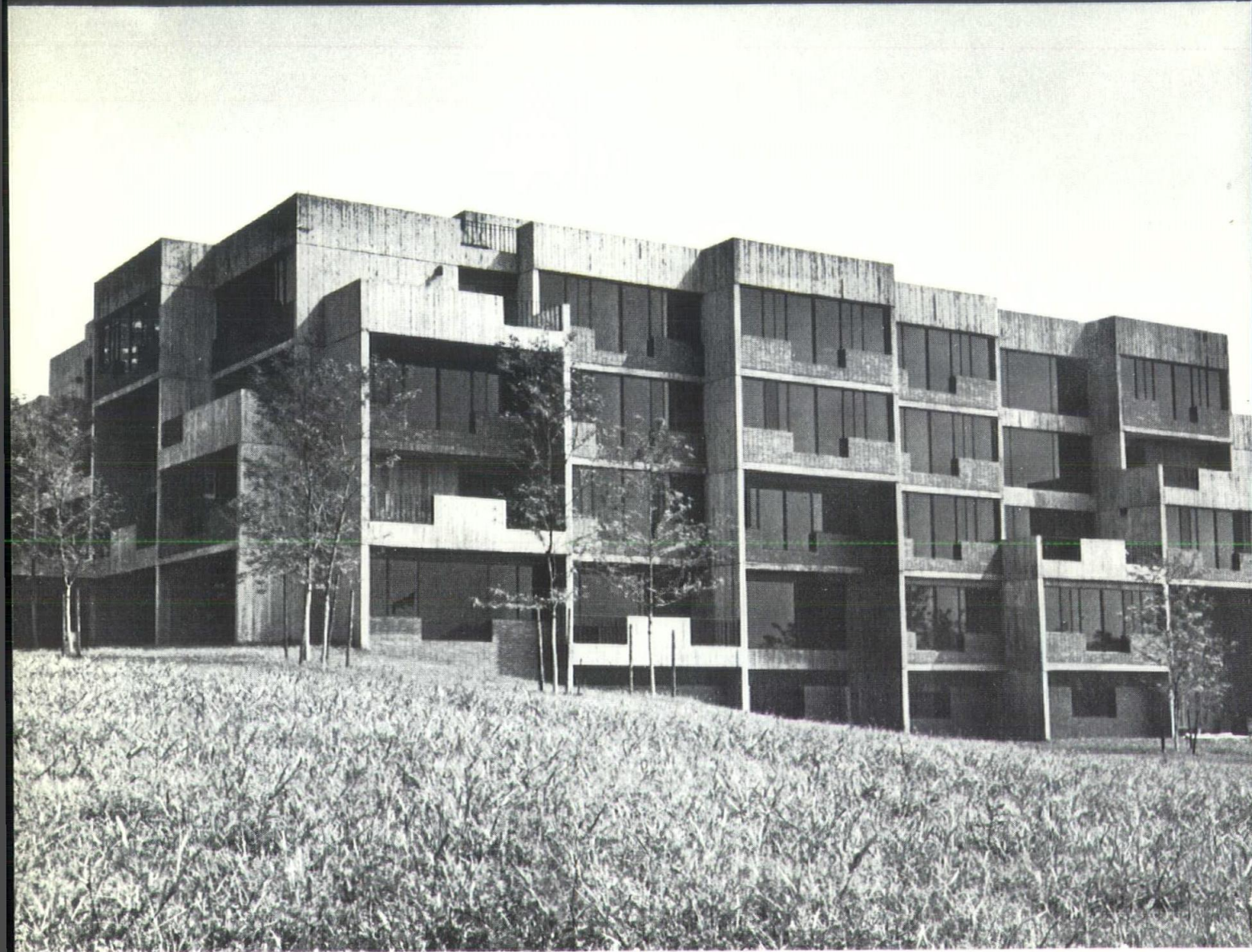

### Disadvantages of Corporate Practice.

Obviously, one of the initial "disadvantages" of corporate practice is the cost involved in establishing the corporation and winding up the existing partnership. However, the tax-savings from incorporation may more than offset such costs, and may even do so in the first full year of corporate practice.

Aside from the initial incorporation costs, conducting business in the corporate form undoubtedly will result in increases in the annual costs of legal and accountant services. This is not because the accountant and attorney will be charging a higher fee for his corporate clients, but rather because the wise corporate practitioner will wish to avail himself of a yearly "check-up" to assure that he continues to qualify for the many tax and other advantages of corporate status.

Of course, there will be a slight increase in the social security taxes paid on behalf of owner-employees who, since the total tax rate will be 4.8% for the corporation and 4.8% for the employee (total of 9.6% of \$7800) rather than the self-employed rate of 6.9%. Since the corporations social security contribution will be deductible, however, the effective after tax increase in social security rates will be approximately 1.5% of \$7800, or \$117 per year.

Other costs may be a slight increase in Workmen Compensation rates (if the old partnership rating cannot be preserved), the imposition of the minimum \$100 New York State corporate franchise tax, and the filing of other fees at the time of incorporation (less than \$100). Another "disadvantage" is that the bill amends the **New York** Tax Law to save the State "harmless" from revenue loss. These amendments, in effect, mean that there will be no substantial advantage from the New York State tax view-point for the new corporation. However, as noted above, the new corporation will enjoy all of the normal Federal tax benefits which are applicable to corporations.

Another consideration is the possibility that the federal law may be changed with respect to pension and profit-sharing plans. At the last session of Congress an unsuccessful attempt was made to impose some of the Keogh restrictions on the pension and profit-sharing plans of professional service corporations. Reportedly, one of the major reasons why this attempt failed was that the Treasury Department is presently in the midst of a study on pension and profit-sharing plans in general. Many tax practitioners anticipate that, as a result of this study, additional restrictions may be placed on corporate pension and profit-sharing plans, and that some of the restrictions on Keogh plans may be removed. Indeed, it is possible that future legislation will tend to equalize the benefits available under both types of plans.

### Conclusion:

As one who has been close to the development of the professional corporation legislation in this State, I am of the general opinion that the advantages of corporate practice far outweigh the disadvantages. However, I must emphasize that this is a **general** opinion, and it therefore will not be valid under all facts and circumstances. Since the decision to incorporate may well be one of the most important business decisions to be made by the professional, it should be made only after a thorough exploration of all of the issues with the professional's attorney and accountant. Finally, if the decision is to incorporate, and if a "custom" pension and profit-sharing plan is to be developed, the professional and his attorney should not overlook the possible advantages of retaining the services of one of the many qualified pension consulting firms in this State.

## GOVERNOR ROCKEFELLER SIGNS PROFESSIONAL SERVICE CORPORATION BILL INTO LAW

May 19, 1970

MEMORANDUM filed with Senate Bill Number 8052-A, entitled:

"AN ACT to amend the business corporation law, the judiciary law and the tax law, in relation to authorizing members of professions to form professional service corporations and the taxation of such professionals and such corporations"

No. 131  
(Chapter 974)

### A P P R O V E D

This bill will accord professionals in the State of New York the same rights to incorporate as now authorized in all of the other states in the Union, except Wyoming.

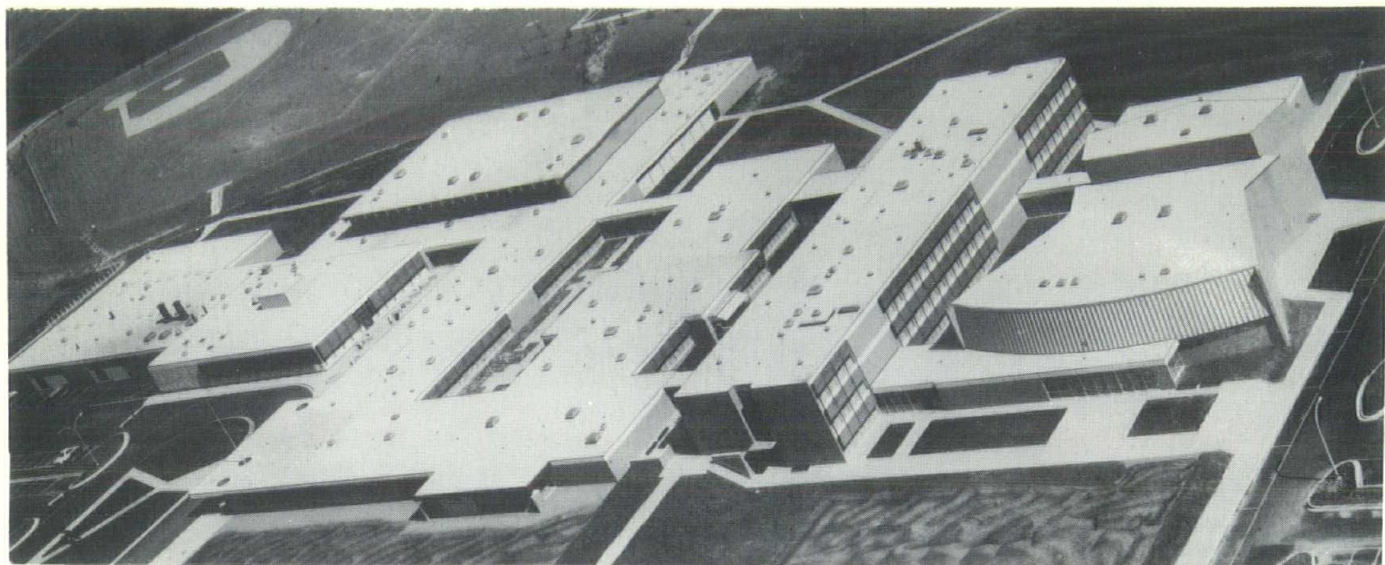
Pursuant to the measure, professionals will be able for the first time to utilize the corporate form of business to permit them to organize their activities more efficiently and to make available to them and to their employees Federal tax benefits now accorded to executives and employees in all other business endeavors. This bill, which was reviewed with the Department of Taxation and Finance to insure that it would have no net effect on State tax revenues, was passed with strong bi-partisan sponsorship and support.

Strong support for this measure has come from members of the Bar, the New York State Medical Society, the New York State Association of the Professions, Inc., the New York State Nurses Association, the New York State Society of Certified Public Accountants, the New York State Association of Architects, Inc., Commerce and Industry Association of New York, the New York State Society of Professional Engineers, Inc., the Dental Society of the State of New York, the New York Chapter of the American Institute of Architects, the New York State Veterinary Society, the Podiatry Society of the State of New York, the Department of Taxation and Finance and the Chiropractic Association of New York, Inc.

The bill is approved.

# AN ACT

To amend the business corporation law, the judiciary law and the tax law, in relation to authorizing members of professions to form professional service corporations and the taxation of such professionals and such corporations

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The business corporation law is hereby amended by adding thereto a new article, to be article fifteen, to read as follows:

## ARTICLE 15 PROFESSIONAL SERVICE CORPORATIONS

Section 1501. Definitions.

1502. Corporations organized under other provisions of laws.

1503. Organization.

1504. Rendering of professional service.

1505. Professional relationships and liabilities.

1506. Purposes of incorporation.

1507. Issuance of shares.

1508. Directors and officers.

1509. Disqualification of shareholders, directors, officers and employees.

1510. Death or disqualification of shareholders.

1511. Transfer of shares.

1512. Corporate name.

1513. Business corporation law applicable.

1514. Annual statement.

1515. Regulation of professions.

Sec. 1502. Corporations organized under other provisions of law. The provisions of this article shall not apply to corporations heretofore or hereafter duly organized under any other provision of law.

Sec. 1501. Definitions. As used in this article, unless the context otherwise requires, the term: (a) "licensing authority" means the regents of the university of the state of New York or the state education department, as the case may be, in the case of all professions licensed under title eight of the education law, and the appropriate appellate division of the supreme court in the case of the profession of law.

(b) "Profession" includes any practice as an attorney and counselor-at-law, or as a licensed physician, and those occupations designated in title eight of the education law.

(c) "Professional service" means any type of service to the public which may be lawfully rendered by a member of a profession within the purview of his profession.

(d) "Professional service corporation" means a corporation organized under this article.

(e) "Officer" does not include the secretary or an assistant secretary of a corporation having only one shareholder.

Sec. 1503. Organization. (a) Notwithstanding any other provision of law, one or more individuals duly authorized by law to render the same professional service within the state may organize, or cause to be organized, a professional service corporation for pecuniary profit under this article for the purpose of rendering the same professional service, except that one or more individuals duly authorized by law to practice professional engineering, architecture, landscape architecture, or land surveying within the state may organize, or cause to be organized, a professional corporation for pecuniary profit under this article for the purpose of rendering such professional services as such individuals are authorized to practice.

(b) The certificate of incorporation of a professional service corporation shall meet the requirements of this chapter and (i) shall state the profession or professions to be practiced by such corporation and the names and residence addresses of all individuals who are to be the original shareholders, directors and officers of such corporation, and (ii) shall have attached thereto a certificate or certificates issued by the licensing authority certifying that each of the proposed shareholders, directors and officers is authorized by law to practice a profession which the corporation is being organized to practice and, if applicable, that one or more of such individuals is authorized to practice each profession which the corporation will be authorized to practice.

(c) A certified copy of the certificate of incorporation and of each amendment thereto shall be filed by the corporation with the licensing authority within thirty days after the filing of such certificate or amendment with the department of state.

(d) A professional service corporation, other than a corporation authorized to practice law, shall be under the supervision of the regents of the university of the state of New York and be subject to disciplinary proceedings and penalties, and its certificate of incorporation shall be subject to suspension, revocation or annulment for cause, in the same manner and to the same extent as is provided with respect to individuals and their licenses, certificates, and registrations in section two hundred eleven and title eight of the education law relating to the applicable profession.

(e) A corporation authorized to practice law shall be subject to the regulation and control of, and its certificate of incorporation shall be subject to suspension, revocation or annulment for cause by, the appellate division of the supreme court and the court of appeals in the same manner and to the same extent provided in the judiciary law with respect to individual attorneys and counselors-at-law. Such corporation need not qualify for any certification under section four hundred sixty-four of the judiciary law, take an oath of office under section four hundred sixty-six of such law or register under section four hundred sixty-seven of such law.

(f) The order of suspension, revocation or annulment of the certificate of incorporation of a professional service corporation pursuant to subdivisions (e) and (f) of this section shall be effective upon the filing of such order with the department of state.

Sec. 1504. Rendering of professional service. (a) No professional service corporation may render professional services except through individuals authorized by law to render such professional services as individuals.

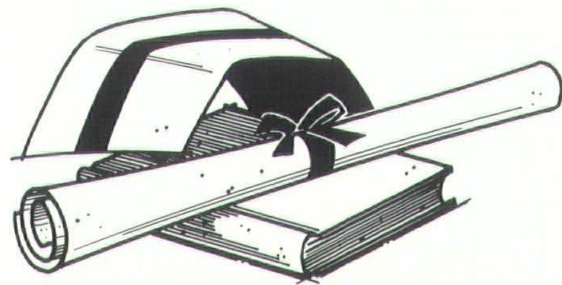

(b) Each final plan and report made or issued by a corporation practicing professional engineering, architecture, landscape architecture or land surveying shall bear the name and seal of one or more professional engineers, architects, landscape architects or land surveyors, respectively, who are in responsible charge of such plan or report.

(c) Each report, diagnosis, prognosis, and prescription made or issued by a corporation practicing medicine, dentistry, podiatry, optometry, ophthalmic dispensing, veterinary medicine, pharmacy, nursing, physiotherapy or chiropractic shall bear the signature of one or more physicians, dentists, podiatrists, optometrists, ophthalmic dispensers, veterinarians, pharmacists, nurses, physiotherapists, or chiropractors, respectively, who are in responsible charge of such report, diagnosis, prognosis or prescription.

(d) Each record, transcript, report and hearing report prepared by a corporation practicing certified shorthand reporting shall bear the signature of one or more certified shorthand reporters who are in responsible charge of such record, transcript, report, or hearing report.

(e) Each report and statement prepared by a corporation practicing public accounting or certified public accounting shall bear the signature of one or more public accountants or certified public accountants, respectively, who are in responsible charge of such report or statement.

(f) Each opinion prepared by a corporation practicing law shall bear the signature of one or more attorneys and counsellors-at-law who are in responsible charge of such opinion.

(g) In addition to the requirements in subdivision (b) through (f), inclusive, each document prepared by a corporation which under the rules, regulations, laws or customs of the applicable profession is required to bear the signature of an individual in responsible charge of such document, shall be signed by one or more such individuals.

Sec. 1505. Professional relationships and liabilities. (a) Each shareholder, employee or agent of a professional service corporation shall be personally and fully liable and accountable for any negligent or wrongful act or misconduct committed by him or by any person under his direct supervision and control while rendering professional services on behalf of such corporation.

(b) The relationship of an individual to a professional service corporation with which such individual is associated, whether as shareholder, director, officer, employee or agent, shall not modify or diminish the jurisdiction over him of the licensing authority and in the case of an attorney and counsellor-at-law, the other courts of this state.

Sec. 1506. Purposes of incorporation. No professional service corporation shall engage in any business other than the rendering of the professional services for which it was incorporated; provided that such corporation may invest its funds in real estate, mortgages, stocks, bonds or any other type of investments.

Sec. 1507. Issuance of shares. A professional service corporation may issue shares only to individuals who are authorized by law to practice in the state a profession which such corporation is authorized to practice and who are or have been engaged in the practice of such profession in such corporation or a predecessor entity. No shareholder of a professional

service corporation shall enter into a voting trust agreement, proxy, or any other type agreement vesting in another person, other than another shareholder of the same corporation, the authority to exercise voting power of any or all of his shares. All shares issued, agreements made, or proxies granted in violation of this section shall be void.

Sec. 1508. Directors and officers. No individual may be a director or officer of a professional service corporation unless he is authorized by law to practice in this state a profession which such corporation is authorized to practice and is either a shareholder of such corporation or engaged in the practice of his profession in such corporation.

Sec. 1509. Disqualification of shareholders, directors, officers and employees. If any shareholder, director, officer or employee of a professional service corporation who has been rendering professional service to the public becomes legally disqualified to practice his profession within the state, he shall sever all employment with, and financial interests (other than interests as a creditor) in, such corporation forthwith or as otherwise provided in section 1510. All provisions of law regulating the rendering of professional services by a person elected or appointed to a public office shall be applicable to a shareholder, director, officer and employee of such corporation, in the same manner and to the same extent as if fully set forth herein. Such legal disqualification to practice his profession within this state shall be deemed to constitute an irrevocable offer by the disqualified shareholder to sell his shares to the corporation, pursuant to the provisions of section 1510 or of the certificate of incorporation, bylaws or agreement among the corporation and all shareholders, whichever is applicable. Compliance with the terms of such offer shall be specifically enforceable in the courts of this state. A professional service corporation's failure to enforce compliance with this provision shall constitute a ground for forfeiture of its certificate of incorporation and its dissolution.

Sec. 1510. Death or disqualification of shareholders. A professional service corporation shall purchase or redeem the shares of a shareholder in case of his death or disqualification pursuant to the provisions of section 1509, within six months after the appointment of the executor or administrator or other legal representative of the estate of such deceased shareholders, or within six months after such disqualification, at the book value of such shares as of the end of the month immediately preceding the death or disqualification of the shareholder as determined from the books and records of the corporation in accordance with its regular method of accounting. The certificate of incorporation, the bylaws of the corporation or an agreement among the corporation and all shareholders may modify this section by providing for a different period of purchase or redemption, or an alternate method of determining the price to be paid for the shares, or both. If the corporation shall fail to purchase or redeem such shares within the required period, a successful plaintiff in an action to recover the purchase price of such shares shall also be awarded reasonable attorneys' fees and costs. Limitations on the purchase or redemption of shares set forth in section five hundred thirteen shall not apply to the purchase or redemption of shares pursuant to this section. Nothing herein contained shall prevent a corporation from paying pension benefits or other deferred com-

compensation to or on behalf of a former or deceased officer, director or employee thereof as otherwise permitted by law.

Sec. 1511. Transfer of shares. No shareholder of a professional service corporation may sell or transfer his shares in such corporation except to another individual who is eligible to have shares issued to him by such corporation. Nothing herein contained shall be construed to prohibit the transfer of shares by operation of law or by court decree. No transferee of shares by operation of law or court decree may vote the shares for any purpose whatsoever except with respect to corporate action under section nine hundred nine and section one thousand one. Any sale or transfer, except by operation of law or court decree or except for a corporation having only one shareholder, may be made only after the same shall have been approved by the board of directors, or at a shareholders' meeting specially called for such purpose by such proportion, not less than a majority, of the outstanding shares as may be provided in the certificate of incorporation or in the bylaws of such professional service corporation. At such shareholders' meeting the shares held by the shareholder proposing to sell or transfer his shares may not be voted or counted for any purpose, unless all shareholders consent that such shares be voted or counted. The certificate of incorporation or the bylaws of the professional service corporation, or the professional service corporation and the shareholders by private agreement, may provide, in lieu of or in addition to the foregoing provisions, for the alienation of shares and may require the redemption or purchase of such shares by such corporation at prices and in a manner specifically set forth therein. Reference to the restrictions on sale and transfer provided for in this section shall be noted conspicuously on all certificates representing shares issued by a professional service corporation. Any sale or transfer in violation of such restriction shall be void.

Sec. 1512. Corporate name. (a) Notwithstanding any other provision of law, the name of a professional service corporation may contain any word which, at the time of incorporation, could be used in the name of a partnership practicing a profession which the corporation is authorized to practice, and may not contain any word which could not be used by such a partnership. Provided, however, the name of a professional service corporation may not contain the name of a deceased person unless:

(1) such person's name was part of the corporate name at the time of such person's death; or

(2) such person's name was part of the name of an existing partnership and at least two-thirds of such partnership's partners become shareholders of the corporation.

(b) Such corporate name shall end with the words "Professional Corporation" or the abbreviation "P. C." The provisions of paragraph one of subdivision (a) of section three hundred one shall not apply to a professional service corporation.

Sec. 1513. Business corporation law applicable. This chapter, except article thirteen, shall be applicable to a professional service corporation except to the extent that the provisions thereof conflict with this article. A professional service corporation may consolidate or merge only with another corporation organized under this article and only if all the professions practiced by

such corporations could be practiced by a single corporation organized under this article.

Sec. 1514. Annual statement. Each professional service corporation shall, on or before the first day of July of each year, furnish a statement to the licensing authority listing the name and residence address of each shareholder, director and officer of such corporation and certifying that all such individuals are authorized by law in this state to practice a profession which such corporation is authorized to practice. The statement shall be signed by the president or any vice-president of the corporation and attested to by the secretary or any assistant secretary of the corporation.

Sec. 1515. Regulation of professions. This article shall not repeal, modify or restrict any provision of the education law or the judiciary law regulating the professions referred to herein except to the extent in conflict herewith.

Sec. 2. Section four hundred ninety-five of the judiciary law is hereby amended by adding thereto a new subdivision, to be subdivision six, to read as follows:

6. This section shall not apply to a corporation organized under article fifteen of the business corporation law.

Sec. 3. Section two hundred ten of the tax law is hereby amended by adding thereto a new subdivision, to be subdivision one-b, to read as follows:

1-b. The computation specified in clause three of paragraph (a) of subdivision one shall not apply to a corporation organized under article fifteen of the business corporation law.

Sec. 4. Subparagraph three of paragraph (b) of subdivision three of section two hundred ten of such law, as last amended by chapter four hundred twenty-one of the laws of nineteen hundred sixty-two, is hereby amended to read as follows:

(3) dividing the result so obtained by the total of its investment capital invested during such period in stocks, bonds and other securities (other than obligations of the United States and its instrumentalities and obligations of the state of New York, its political subdivisions and its instrumentalities); provided, however, that in case any investment capital is invested in any stock, bond or other security during only a portion of the period covered by the report, only such portion of such capital shall be taken into account; and provided further, that if a taxpayer's investment allocation percentage is zero, interest received on bank accounts, on obligations of the United States and its instrumentalities and on obligations of the state of New York, its political subdivisions and its instrumentalities shall be multiplied by its business allocation percentage; provided, however, that with respect to corporations organized under article fifteen of the business corporation law, the investment allocation percentage shall be one hundred percent; and

Sec. 5. Subsection (b) of section six hundred twelve of such law is hereby amended by adding thereto three new paragraphs, to be paragraphs seven, eight and nine, to read as follows:

(7) In the case of a taxpayer who is a shareholder of a corporation organized under article fifteen of the business corporation law, the amount which is deductible by such corporation under paragraphs one, two or three of subsection (a) of section four hundred four of the internal revenue code for its taxable year ending in or with such taxpayer's taxable year for con-

tributions paid in behalf of such taxpayer minus the maximum amount which would be deductible for federal income tax purposes by such taxpayer under section sixty-two (7) of the internal revenue code or any amendment thereto, if such taxpayer were a self-employed individual. In the case of a taxpayer on whose behalf contributions are paid under more than one plan to which this paragraph applies or under a plan, contributions to which on his behalf are subject to the limitations provided in section four hundred four (e) of the internal revenue code, this paragraph shall apply with respect to the aggregate of the contributions paid on his behalf under all such plans.

(8) In the case of a taxpayer who is a shareholder of a corporation organized under article fifteen of the business corporation law, the amount which is required to be paid as a tax by such corporation pursuant to section thirty-one hundred eleven (a) of the internal revenue code with respect to the wages of such taxpayer for the calendar year ending in or with such taxpayer's taxable year.

(9) In the case of a taxpayer who is a shareholder of a corporation organized under article fifteen of the business corporation law, the amount which is deductible for federal income tax purposes by such corporation for contributions to purchase life, accident or health or other insurance for such taxpayer for its taxable year ending in or with such taxpayer's taxable year except for the amount includable by such taxpayer in gross income for federal income tax purposes and except for the amount attributable to contributions to purchase insurance to reimburse such taxpayer for expenses incurred by him for medical care, as such term is defined in section two hundred thirteen (e) of the internal revenue code, of such taxpayer, his spouse and his dependents.

Sec. 6. Subsection (c) of section six hundred twelve of such law, is hereby amended by adding thereto a new paragraph, to be paragraph twelve, to read as follows:

(12) The amount necessary to prevent the taxation of amounts properly included in New York adjusted gross income in prior taxable years in accordance with paragraph seven of subsection (b).

Sec. 7. Section six hundred fifty-eight of such law is hereby amended by adding thereto a new subsection, to be subsection (f), to read as follows:

(f) Professional service corporations. The tax commission may prescribe regulations and instructions requiring corporations organized under article fifteen of the business corporation law to make and file returns of information, on or before February twenty-eighth of each year, as to the amounts which a shareholder of such corporation must add to his federal adjusted gross income pursuant to paragraph seven, eight and nine of subsection (b) of section six hundred twelve. Every such corporation shall furnish to each such shareholder, on or before such date, a written statement as prescribed in such paragraphs and such other information as the tax commission shall prescribe.

Sec. 8. This act shall take effect immediately but sections three, four, five, six and seven shall apply to all taxable years ending after December thirty-first, nineteen hundred sixty-nine.

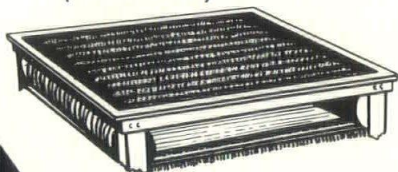

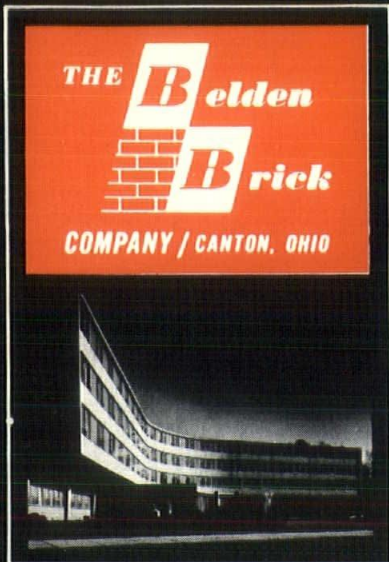
