**SECTION 3.** The City Council hereby supports Congressional Resolution H.R. 786, and joins other cities in calling on Congress and the Biden administration to demand: an immediate ceasefire; an immediate release of all hostages; urgent safe passage and delivery of substantial and sufficient humanitarian aid to Gaza; and a lasting political resolution that protects the lives, health, and security of all innocent civilians.



WHEREAS, violence begets violence, and without a plan for peace, innocent people in Gaza, Israel and the West Bank will continue to be injured and killed; and

WHEREAS, between October 7, 2023, and today, armed violence has claimed the lives of tens of thousands of civilians, including children, and tens of thousands more have been wounded; and

WHEREAS, without immediate restoration of basic necessities, and delivery of adequate humanitarian aid without delay, hundreds of thousands of lives, especially of vulnerable children, are at imminent risk due to multiple public health crises; and

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Port Townsend that we condemn violations of international law, including both the October 7, 2023, Hamas attack on Israeli civilians and the Israeli military's response affecting the 2.3 million Palestinian civilians (nearly half of whom are children) living in Gaza since then.

**BE IT FURTHER RESOLVED** that the Port Townsend City Council affirms its commitment to combat Antisemitism, Islamophobia, and anti-Palestinian, anti-Arab, and anti-Israeli bigotry, its support for the people of both Israel and Palestine to live in peace and security, and the right of all people to live, learn, work, play, pray, travel, and engage in peaceful protest, all without threats, intimidation, or death.

**BE IT FURTHER RESOLVED** that the Port Townsend City Council will remit a copy of this resolution to the federal government urging Congress and the President to work toward an immediate ceasefire for all parties, a lasting peace, and an end of violence supported by American dollars and to urge the U.S. government to immediately stop sending arms to the warring parties and to instead send vitally necessary supplies to create the basic conditions that might make a ceasefire sustainable.

#### SUBSTITUTE RESOLUTION

#### Resolution in support of "uniting for peace"

WHEREAS, Chapter I of the United Nations Charter states that the purpose of the United Nations is "to maintain international peace and security, and to that end: to take effective collective measures for the prevention and removal of threats to the peace, and for the suppression of acts of aggression or other breaches of the peace, and to bring about by peaceful means, and in conformity with the principles of justice and international law, adjustment or settlement of international disputes or situations which might lead to a breach of the peace;" and

WHEREAS, Chapter I of the United Nations Charter further states that the purpose of the United Nations is "to develop friendly relations among nations based on respect for the principle of equal rights and self-determination of peoples, and to take other appropriate measures to strengthen universal peace;" and

WHEREAS, the United Nations General Assembly shall act if the Security Council, "because of lack of unanimity of the permanent members, fails to exercise its primary responsibility for the maintenance of international peace and security in any case where there appears to be a threat to the peace, breach of the peace, or act of aggression;" and

WHEREAS, the UN General Assembly convened an emergency meeting in which 153 out of 186 member nations voted in favor of adopting a resolution demanding "immediate humanitarian ceasefire" in Gaza, the "immediate and unconditional release of all hostages," and "ensuring humanitarian access"; and

WHEREAS, more than 26,700 Palestinians have been killed in Gaza in over 100 days since October 7, 2023, including over 10,000 children, and more than 65,600 Palestinians have been injured in the same period; and

WHEREAS, since October 7, 2023 over 1,200 Israelis have been killed and 240 Israeli hostages were taken by Hamas; and

WHEREAS, more than 85% of the population in Gaza, nearly 1.9 million people, have been displaced since the Israeli bombardments began on early October 7, 2023; and

WHEREAS, entire neighborhoods, infrastructure, hospitals, schools, and places of worship have been destroyed contributing to the erasure of Palestinian communities and culture; and

WHEREAS, a poll released by Data for Progress on December 5, 2023 states that 61% of all likely voters in the United States, and 76% of Democratic voters support a permanent ceasefire and de-escalation of violence in Gaza; and

WHEREAS, cities across the United States, including San Francisco, California; Minneapolis, Minnesota; Seattle, Washington; St Louis, Missouri; Detroit, Michigan; Atlanta, Georgia; Akron, Ohio; Wilmington, Delaware; Providence, Rhode Island; and Richmond, California have passed resolutions calling for ceasefire; and

WHEREAS, the Chicago Sun Times Editorial Board released a publication on December 13, 2023 titled "A cease-fire in Israel-Hamas war is a next step to ending the bloodshed," which elaborates public favor for ceasefire and calls for our local elected officials to support ceasefire in line with public demands; and

WHEREAS, a lasting ceasefire is critical to the release of all hostages and building a foundation for a lasting peace; and

WHEREAS, the impacts of violence are particularly felt by our Palestinian and Jewish communities as the Chicagoland area is home to the largest Palestinian population in all of the United States and the 5th largest Jewish population in the world; therefore

BE IT RESOLVED, that we, the members of the Chicago City Council, support the United Nations implementation of "Uniting for Peace," which called an emergency session of the General Assembly which voted in favor of "immediate humanitarian ceasefire" in Gaza; and

BE IT RESOLVED, that we, the Chicago City Council, do hereby call for a permanent ceasefire to end the ongoing violence in Gaza; call for humanitarian assistance including medicine, food, and water, to be sent into the impacted region; and the immediate and unconditional release of all hostages; and

BE IT RESOLVED, that we, the members of the Chicago City Council, call for the creation of plans to protect civilian populations in the region, in particular to support the needs of women, children, persons with disabilities, and the elderly; and



WHEREAS, all human life is precious, and the targeting of civilians, no matter their religion or ethnicity, is a violation of international humanitarian law; and,

WHEREAS, between October 7 and November 13, 2023, armed violence has claimed the lives of over 11,000 Palestinians, of which at least 4,000 are children, and over 1,400 Israelis, including children, and wounded thousands more; and,

WHEREAS, this conflict is perpetuating a dangerous and costly lack of access to basic human needs in Gaza, such as food, water, medical supplies, and more, which are indispensable for the survival of the civilian population; and,

#### A RESOLUTION CALLING FOR PEACE AND IN OPPOSITION TO WAR.

#### The City Council of the City of Eugene finds that:

**A.** All human life is precious, and the targeting of civilians – no matter their faith or ethnicity – is a violation of International Human Rights.

**B.** We all struggle with feelings of anguish, anger, loss, and despair over the appalling violence erupting in Israel and Gaza. The cruelty of the October 7 attacks on Israeli civilians including the seizure of hostages by Hamas, and the subsequent onslaught by the Israeli government on civilians in Gaza are horrifying and the loss of innocent lives caused by this war is unacceptable.

C. On November 27, 2023, the City of Eugene reaffirmed our State and Federal Legislative Policies including the following Equity and Inclusion items (partial list):

1. Eugene supports initiatives that affirm the promotion of rights included in the International Declaration of Human Rights.

2. Eugene supports legislation that condemns all forms of hate, xenophobia, racism, white supremacy, Anti-Semitism, Islamophobia, homophobia, transphobia, ableism, sexism, and other forms of bigotry. This includes timely condemnation of actions against certain groups in relation to specific events.

**3.** Eugene supports legislation that protects refugees, regardless of citizenship status.

**D.** On September 25, 2023, Eugene Mayor Lucy Vinis officially rededicated the City of Eugene as a city of Peace, providing inspiration and honoring International Peace by "commemorating and strengthening the ideal of peace, both within and among nations and peoples."

E. We have a moment to stand for peace, with clarity about the depth of pain and the challenge of compromise that is required.

F. The United States holds immense diplomatic power to save Israeli and Palestinian lives.

G. Our friends and neighbors who are Jewish and Muslim – Israeli and Palestinian – face a surge in anti-Semitism, anti-Arab and anti-Muslim hate speech and crimes. Peace begins with us, not with accusations or diminishment of the suffering on either side, but as a community that shares their grief and extends our hands and hearts in compassion.

#### NOW, THEREFORE,

#### BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EUGENE, a Municipal Corporation of the State of Oregon, as follows:

<u>Section 1</u>. The City Council urges the Biden-Harris administration to immediately call for and facilitate de-escalation and continued ceasefire peace talks to end the current violence and to promptly send adequate humanitarian assistance to all innocent persons in the region affected by this war.

WHEREAS, on October 16, 2023, Akron City Council passed a resolution condemning the October 7th attack on Southern Israel, which killed roughly 1,200 individuals and resulted in the seizure of roughly 200 hostages; and

WHEREAS, the 10/16/23 City Council resolution affirmed Akron's status as a welcoming community for those of the Jewish faith and any other faith and encouraging Akron residents to offer support and condolences to the Jewish community; and

WHEREAS, on October 27, 2023, the United Nations General Assembly adopted a major resolution on the Gaza crisis on October 27, 2023. The resolution called for an "immediate, durable and sustained humanitarian truce leading to a cessation of hostilities" and demanded that all parties "immediately and fully comply" with obligations under international humanitarian and human rights laws, "particularly in regard to the protection of civilians and civilian objects." The resolution also urged the protection of humanitarian personnel, persons hors de combat, and humanitarian facilities and assets, and to enable and facilitate humanitarian access for essential supplies and services to reach all civilians in need in the Gaza Strip. The General Assembly also called for the "immediate and unconditional release" of all civilians being illegally held/detained or imprisoned, demanding their safety, well-being and humane treatment in compliance with international law. The resolution was passed with 120 members in favor, 14 against, and 45 abstentions; and

WHEREAS, since October 7, more than 12,500 Palestinians, more than 4,000 of whom are children, have been killed because of this violence, and more than 1,000,000 Palestinians have been displaced; and

WHEREAS, the citizens of Akron wish to decry any and all acts of violence and express their deepest condolences to all those affected by this tragedy; and

WHEREAS, the City of Akron is committed to encouraging and uplifting both the Akron Palestinian & Jewish communities and their communities at large; and

WHEREAS, there have been many dehumanizing incidents of anti-Palestinian, anti-Muslim, and antisemitic violence and rhetoric within the United States; and

WHEREAS, many members of our Akron-area community are impacted by the ongoing conflict, including members of our Palestinian community, our Muslim community, our Jewish community, and many others.

The Council of the City of Akron envisions a two-state solution, bringing an end to the occupation and illegal settlement activity by Israel and clear recognition of Israel's right to exist by all governing Palestinian parties, recognizing the legitimate desire and need for Palestinian self-determination, as well as the legitimate desire and need for Israelis and Palestinians to live in safety and security.

Section 6. That this resolution is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health, safety and welfare for the reason that it is immediately necessary for this Council to express its support for victims of the war in Israel and Palestine, and provided this resolution receives the affirmative vote of two-thirds of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.

Whereas, Palestine has been occupied by Israel since 1948, and, as November 18<sup>th</sup>, 2023, Israel has been bombing Gaza for 42 days; and

Whereas, defense contractors with a large local presence, including the Boeing Company, stand to profit from the increased sales of weapons that lead to more civilian deaths in Gaza; and

Whereas, hundreds of thousands of people around the world, tens of thousands in Washington State, and hundreds of individuals in Bellingham have participated in rallies and actions calling for an immediate ceasefire in Gaza; and

Whereas, the relatives of a number of Bellingham's Palestinian community members have been killed by the Israeli bombardment since October 7<sup>th</sup>, 2023; and

Whereas, the UN General Assembly adopted a resolution calling for an immediate and sustained humanitarian truce on October 26<sup>th</sup>, 2023; and

Now, therefore, be it resolved by the City Council of the City of Bellingham, Washington:

#### PROCLAMATION AFFIRMING THE CITY OF COTATI'S SUPPORT FOR AN ISRAELI-PALESTINIAN CEASEFIRE AND PERMANENT RESOLUTION TO THE CONFLICT

WHEREAS, since the founding of the United Nations (UN) following World War II, the UN has issued numerous resolutions and worked towards the vision of the two-State solution where two democratic States, Israel and Palestine, live side by side in peace within secure and recognized borders, consistent with international law and relevant UN resolutions, including the importance of unifying the Gaza Strip (Gaza) with the West Bank under the Palestinian Authority; and

WHEREAS, in March 2023, the Israeli government lifted the ban on Israeli settlements in previously evacuated areas in the northern West Bank area, further complicating the UN goal of a contiguous, independent Palestinian state and deepening the on-going conflict<sup>1</sup> and

WHEREAS, the latest round in the long history of violence between Israel and the Palestinians began on October 7, 2023 with the incursion of Palestinian armed groups into Israel at multiple locations adjacent to Gaza, resulting in the deaths of Israelis and the taking of hostages, many of which are still being held by armed Palestinian groups; and

WHEREAS, in response, Israel initiated a large scale and on-going military incursion into Gaza, with the initial stated aims of rescuing the hostages and destroying Hamas; and

**WHEREAS**, on October 16, 2023, House Resolution (HR) 786 was introduced in the United States House of Representatives calling for the "... Biden administration to immediately call for and facilitate deescalation and a cease-fire to urgently end the current violence... " and "... promptly send and facilitate the entry of humanitarian assistance into Gaza."; and

WHEREAS, since October 7, 2023, the UN Security Council has issued two resolutions on this conflict:

1. Resolution 2712 (November 15, 2023) demanding that all parties comply with their obligations under international law with regard to the protection of civilians, especially children; calling for extended humanitarian pauses in the violence for humanitarian aid; and calling for the immediate and unconditional release of all hostages held by Hamas and other groups, especially children;

2. Resolution 2720 (December 22, 2023) demanding that all parties to the conflict comply with their obligations under international law, including international humanitarian law, including with regard to the conduct of hostilities and the protection of civilians and civilian objects, humanitarian access, and the protection of humanitarian personnel and their freedom of movement; demanding that all parties to the conflict allow, facilitate and enable the immediate, safe and unhindered delivery of humanitarian assistance at scale directly to the Palestinian civilian population throughout Gaza, and immediately allow safe, unhindered, and expanded humanitarian access and to create the conflict allow and facilitate the use of all available routes to and throughout the entire Gaza, including border crossings for the provision of humanitarian assistance; demanding the immediate and unconditional release of all hostages, as well as ensuring humanitarian access to address medical needs of all hostages; demanding the provision of fuel to Gaza at levels that will meet requisite humanitarian needs;

WHEREAS, on December 12, 2023, the UN General Assembly adopted a resolution in an emergency session demanding an "immediate humanitarian ceasefire", the immediate and unconditional release of all hostages as well as "ensuring humanitarian access"; and

WHEREAS, Israel and Palestinian armed groups agreed to a temporary truce from November 24-November 30, 2023 to allow 50 women, children and teenagers under the age of 19 taken hostage by Hamas to be freed in return for 150 Palestinian women and teenagers in Israeli detention, as well as an agreement to allow more emergency aid and fuel into Gaza; and

WHEREAS, Between October 7 and January 2, 2024, armed violence has claimed the lives of approximately 22,000 Palestinians<sup>2</sup> and over 1,200 Israelis<sup>3</sup>, and wounded thousands more; and according to the Ministry of Health in Gaza, an estimated 1,900,000 Palestinians (85% of Gaza) has been internally displaced since October 7; and

WHEREAS, hundreds of thousands of lives are at imminent risk of death, famine and life-threatening diseases in Gaza without a sustained ceasefire and unimpeded large scale humanitarian relief; and

**WHEREAS**, the sustained conflict, as well as the larger Israeli-Palestinian conflict, is creating a humanitarian catastrophe that is only deepening; and

WHEREAS, in addition to the violence that we have seen in Israel and Gaza, Amnesty International has reported an escalation in violence in the West Bank; and

WHEREAS, there are increasing concerns that the conflict in the West Bank will also spill over regionally, including increased attacks on civilian shipping in the Red Sea by armed

groups in Yemen and an increase in cross border attacks into Israel by armed groups in Lebanon; and

WHEREAS, the City Council of the City of Cotati finds that all loss of life and the human suffering that this conflict has caused is tragic and an immediate cessation of hostilities and a permanent solution to this crisis must be one of the top foreign policy priorities of the United States; and

WHEREAS, the City Council of the City of Cotati finds that all parties to this conflict must adhere to their obligations under international law, including international humanitarian law and international human rights law; and

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Cotati joins the United Nations, world leaders, religious leaders, and citizens of the world everywhere in calling for an immediate ceasefire and an end to all armed hostilities by all sides; and

**BE IT FURTHER RESOLVED** that the City of Cotati supports U.S. Congress Resolution HR 786 and joins other cities in calling on our Congressional Members to demand: an immediate ceasefire; release of all hostages, the unrestricted entry of humanitarian assistance into Gaza; the restoration of food, water, electricity, and medical supplies to Gaza; and respect for international law; and

**BE IT FURTHER RESOLVED** that the City of Cotati, consistent with long standing UN action, supports a solution where two democratic States, Israel and Palestine, live side by side in peace within secure and recognized borders, consistent with international law and relevant UN resolutions; and

**BE IT FURTHER RESOLVED** that the City of Cotati opposes any Israeli policy that continues the expansion of Israeli settlements in the West Bank or Gaza, as this inflames tensions, continues the violence and pushes a two-state solution further out of reach; and

**BE IT FURTHER RESOLVED** that a permanent solution to this crisis must be one of the top foreign policy priorities of the United States to reduce human suffering and promote peace in the region; and

**BE IT FURTHER RESOLVED** that the City of Cotati opposes all forms of anti-Semitism, Islamophobia, racism, and bigotry and advocates for the dignity and safety of residents in every community; and

**BE IT FURTHER RESOLVED** that a copy of this resolution be sent to Sonoma County's Supervisors, the Mayors and Council members of each of its incorporated cities, California State Assemblymembers, Representatives, and Governor, and United States' Representatives, Senators, Vice President, and President urging them to take immediate action to use their position and influence to end this conflict and work towards a permanent peace between Israel and the Palestinians.

WHEREAS, we acknowledge that this Resolution is outside of the City of Ojai's municipal code and direct jurisdiction but sometimes we are called to make statements outside of our normal purview; and

WHEREAS, all human life is precious and Ojai's commitment as an International City of Peace calls on elected officials to promote peace for all people, no matter their faith or ethnicity, in accordance with International Humanitarian Law; and

WHEREAS, the City of Ojai condemns the recent rise of Antisemitic, Islamophobic, and xenophobic attacks in our county and across the nation; and

WHEREAS, on October 7, 2023 in a coordinated attack, Hamas and other terrorist Palestinian groups invaded Israel, raping women and killing 1,200 people and took 240 hostages, including infants and children; and

WHEREAS, according to the Gaza Ministry of Health, an agency of the Hamas-controlled government, 29,000 Palestinians living in Gaza have been killed by Israeli Defense Forces. The ministry does not distinguish between civilians and combatants. Israel reports that it has killed over 11,000 Hamas and Islamic Jihad fighters. In addition, thousands more Gazans are missing and over 1.5 million civilians have been displaced from their homes and are without access to electricity, drinking water, and medical care for the thousands who have been wounded; and

WHEREAS, millions of people are at risk if a ceasefire is not achieved and humanitarian aid is not delivered without delay; and

WHEREAS, Israel, the United States Government, the International Court of Justice and many others have called upon Hamas and others to release the hostages they hold; and

WHEREAS, international organizations like Amnesty International, the World Health Organization, the US Agency for International Development, the International Rescue Committee, Doctors without Borders, and many others have called for a ceasefire in order to prevent the further loss of life and to ensure international humanitarian law; and

WHEREAS, the majority of Americans support a ceasefire (1), and want to see the U.S. leverage its diplomatic relationships "to prevent further violence and civilian deaths."(2); and

**WHEREAS**, the City of Pomona has a longstanding commitment to advocating for compassion, peace, social justice, safety and fostering a mutual respect and understanding for all people, regardless of religion, race or nationality; and

WHEREAS, the City of Pomona pursues a responsibility to uphold the values of inclusion, diversity and equity; and

WHEREAS, the ongoing conflict in The Middle East that began on October 7, 2023 has resulted in the tragic loss of many thousands of innocent civilian Israeli and Palestinian lives, and increasing reports of AntiSemitic, Islamophobic, Anti-Jewish and Anti-Arab incidents; and

WHEREAS, on October 7, 2023, Hamas launched a terrorist attack causing the deaths of over 1,200 Israelis and the capture of innocent civilians as hostages, and

**WHEREAS**, in response, the State of Israel has engaged in a bombing campaign targeting Hamas terrorists operating within civilian populations including hospitals, schools, etc. of the Gaza Strip, resulting in the deaths of many thousands of innocent Palestinians; and

WHEREAS, many of our community members have suffered from an alarming rise in Antisemitism and Islamophobia; and

**WHEREAS**, the City of Pomona stands firmly on the foundations of peace, unity, respect, understanding and the universal value and preciousness of all lives: and

**WHEREAS**, our Pomona's core value of engaged compassion recognizes that it is only through action and application of our values that we can promote true peace and stand against the perpetuation of violence by rejecting silence, apathy, and hopelessness; and

**WHEREAS**, the City of Pomona as a local government organization can contribute to the collective efforts of a global society to promote a culture of peace, understanding, and cooperation, creating a ripple effect that extends beyond local borders;

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1**. The City Council of the City of Pomona hereby unequivocally and without prejudice, condemns; terrorist acts; every form of avoidable, unnecessary, unlawful violence that results in the death, injury, displacement, or mortal endangerment of innocent civilians;

intolerance, racism and xenophobia, including Antisemitic, Islamophobic, Anti-Arab, and Anti-Jewish sentiments, rhetoric, and attacks in our region, nation and across the world; and specifically the terrorist actions of Hamas of October 7, 2023 and the violent acts committed by extremist Israeli settlers in the West Bank.

**SECTION 2**. The City Council of the City of Pomona hereby supports Congressional Resolution H.R. 786, and joins other cities in calling on Congress and the Biden administration to demand: an immediate ceasefire; an immediate release of all hostages Hamas took on October 7, 2023; urgent safe passage and delivery of substantial and sufficient humanitarian aid to Gaza; and a lasting political resolution that protects the lives, health, and security of all innocent civilians.

Resolution supporting a permanent ceasefire in Palestine and Israel, the return of all captives, and the delivery of humanitarian aid; and affirming opposition to antisemitism, Islamophobia and anti-Arab bigotry with the aim of achieving a just and lasting political solution.

Whereas, all human life is precious, and the targeting of civilians is a violation of international humanitarian law; and

Whereas, over 1,200 Israelis were killed on October 7<sup>th</sup>, over 20,000 Palestinians have been killed since October 7<sup>th</sup> 2023, as of January 2, 2024, and people of other nationalities have been killed; and

Whereas, continued hostilities have forced 85% of Palestinians in Gaza and 5-10% of Israelis to flee their homes; and

Whereas, hundreds of thousands of lives are at imminent risk without an immediate permanent ceasefire, restoration of basic necessities, and delivery of adequate and unconditional humanitarian aid without delay to the Palestinian people; and

Whereas, more than one hundred Israeli captives are held by Hamas and more than 7,000 Palestinian captives are held without due process under Israeli martial law; and

Whereas, the United States government and our elected leaders hold immense diplomatic power to save Palestinian and Israeli lives, and US law requires that foreign military aid not be used in the contravention of international law; and

Whereas, the United States provides ongoing military aid to Israel, of which approximately \$748,000 annually came from taxpayers in Iowa City, as well as humanitarian aid to Palestine, of which approximately \$31,000 annually came from Iowa City taxpayers during the period from 2017 to 2022; and

Whereas, the majority of nations in the UN have voted in favor of a ceasefire resolution, and millions of people worldwide, including residents of Iowa City, have joined in peaceful protests since October 7 to amplify this call; and

Whereas, Islamophobia, anti-Palestinian/anti-Arab bigotry, and antisemitism have risen significantly across the United States, and around the world, with direct impacts on communities – from synagogues and mosques to schools, universities, homes, offices, and places where communities gather, as well as at protests and rallies; and

Whereas, all of these forms of bigotry, violence, and oppression serve to divide our communities and weaken our efforts to achieve collective safety, justice, and true multi-ethnic, multi-racial, multi-religious democracy here and everywhere.

Now, therefore, be it resolved by the City Council of the City of Iowa City that:

- 1. The City of Iowa City unequivocally condemns both the attack on October 7, 2023 by Hamas, and the killing of civilians in Gaza and West Bank by the state of Israel; and
- 2. The City of Iowa City affirms its commitment to combat anti-Palestinian/anti-Arab bigotry, antisemitism, and Islamophobia; and
- 3. The City of Iowa City affirms its support for all people in Palestine and Israel to live in peace, justice,

and security; and

- 4. The City of Iowa City affirms its support for the rights of all people, including residents of Iowa City, to live, learn, work, play, worship, and engage in peaceful protest, all without intimidation, coercion, or the threat of violence; and
- 5. The City of Iowa City asks our congressional delegation to support all resolutions and legislation that match the values stated throughout this Iowa City resolution, especially those that aim to alleviate the urgent humanitarian disaster in Gaza, such as US House Resolution No. 786; and
- The City of Iowa City affirms first-amendment rights of citizens to criticize government or government policy, and affirms that criticism of governments in Israel and Palestine is not inherently antisemitic or anti-Arab; and

## FULL TEXT AND DESCRIPTION

Whereas, the Medford City Council recognizes and affirms the sanctity, preciousness, and equality of all human life;

Whereas, on October 7th, 2023, the terrorist group Hamas killed over 1,200 Israeli residents, took over 240 hostages, committed horrific atrocities, displaced families, and wreaked untold grief and trauma upon the civilian population of Israel;

Whereas, since October 7th, Hamas is estimated to have fired more than 12,000 rockets into Israel, killing 15 civilians and injuring over 700;

Whereas, since those horrific attacks, the ongoing military campaign and blockade has created a humanitarian crisis of catastrophic proportions in Gaza;

Whereas, since October 7th, the Israeli Defense Forces have killed over 26,000 Palestinians in Gaza, injured over 62,000, and more than 85% of all residents have been displaced;

Whereas, the ongoing military campaign has had a massive toll on civilians in Gaza, with UNICEF describing the Gaza Strip as the "world's most dangerous place to be a child," and reporting that 40% of all deaths in Gaza have been deaths of children;

Whereas, Gaza has been hit by more than 22,000 airstrikes, resulting in the destruction of over 70% of all homes and schools, and most of its civilian infrastructure, including electricity, communications, water, sewer and sanitation systems, with the World Health Organization reporting that all Gazan hospitals have been destroyed or seriously damaged, exacerbating the humanitarian crisis;

Whereas, the near-total siege on Gaza has prevented the delivery of lifesaving humanitarian aid;

Whereas, the World Food Program has reported that all 2.2 million people in Gaza are facing crisis

levels of food insecurity; that one in four Gazans is facing catastrophic hunger; and that without an end to bombardment and resumption of humanitarian aid, famine will spread quickly across the population;

Whereas, humanitarian organizations report that on average, 250 Palestinians die each day from hunger, disease, exposure and airstrikes, a scale of death exceeding any other recent armed conflict;

Whereas, Hamas continues to hold Israeli civilians hostage, which is a war crime;

Whereas, Israel continues to detain Palestinians who have never been charged with or convicted of a crime, including scores of children;

Whereas, on October 26, 2023, the United Nations General Assembly adopted a resolution calling for an "immediate, durable and sustained humanitarian truce" between Israeli forces and Hamas militants in Gaza, and numerous international humanitarian organizations have similarly called for a sustained ceasefire;

Whereas, the previous ceasefire from November 24 to November 30, 2023 allowed for the release of hostages and allowed emergency aid and fuel to enter Gaza;

Whereas, many members of the Medford community are suffering from trauma, grief, shock and fear, compounded by increased incidents of Islamophobia, antisemitism, and anti-Palestinian racism, both nationally and locally;

Whereas, members of the Medford community, including Palestinians and Jews, are speaking out for peace in Israel and Palestine and in support of a permanent, bilateral ceasefire and a return of all hostages;

Now, therefore, be it resolved:

That the Medford City Council unequivocally condemns the terrorist attacks by Hamas on October 7th, 2023, and all subsequent attacks, by all parties, on civilians;

That the Medford City Council supports an enduring, bilateral ceasefire in Israel and Gaza and the immediate return of all hostages;

That the the Medford City Council supports the lifting of the blockade and the uninhibited provision of life-saving humanitarian aid to Gaza;

That the Medford City Council affirms the inalienable right of all people to live in peace, free from fear of harm and prejudice;

That the Medford City Council unequivocally condemns all xenophobic violence, attacks and rhetoric, and affirms the inalienable right of all people to know safety and acceptance regardless of their religion, race, ethnicity, nationality, or skin color;

That the Medford City Council urges the Biden Administration, Senate, and Congress to exert the full extent of their power, influence and funding to bring about an enduring ceasefire, the uninhibited provision of humanitarian aid, and the release of all hostages and detained innocents;

That a copy of this resolution be sent to each member of Medford's federal delegation and to President Biden as an urging to use their power and influence to bring about a sustained and enduring ceasefire so as to protect and honor all human life.

**WHEREAS**, the Red Lake Tribal Council is the duly elected governing body of the Red Lake Band of Chippewa Indians; and the Tribal Council has the authority and the responsibility to provide for the safety, health and welfare of its members; and

WHEREAS, the Tribal Council is aware of the current military actions in the West Bank and Gaza Strip involving the Islamic Resistance Movement Hamas and the Israeli government military, which has greatly intensified since October 7, 2023, and which has resulted in the loss of many lives on both sides, and which has caused the survivors on both sides to suffer untold humiliating indignities; and

WHEREAS, the Tribal Council was informed that the current state of Israel was created in 1948 from lands that were forcefully dispossessed from the Palestinian people at the behest of western powers, primarily Great Britain and the United States; and that ever since, the state of Israel has been maintained through the financial and military support of western states, primarily the United States; and

WHEREAS, the Tribal Council was informed that throughout the history of "the Palestinian-Israeli conflict," the United States has consistently maintained pro-Israel policies, and has completely disregarded the fundamental rights of the Palestinian people; and

WHEREAS, the Tribal Council was informed that so far in the current war the United States has fully supported the actions of the Israeli military against the Palestinians, despite the fact that the Israeli military actions have been extreme, and have caused the deaths of countless civilians and the merciless destruction of virtually all Palestinian property; and

WHEREAS, the Tribal Council was informed that the current disregard for the life and wellbeing of the Palestinian people is evident in the United States' decision to get directly involved in the unfolding conflict by financing it, arming the Israeli military, vetoing any United Nations Security Council resolution calling for a ceasefire, and even sending aircraft carriers to the region in support of the Israelis; and

**WHEREAS**, the Tribal Council was informed that the United States has fully embraced Israel's genocidal aggression which has been carried out primarily on Gaza, and has approved of the complete blockade that has cut off electricity, water, food, and medicine, and has justified the daily slaughter of countless Palestinian civilians; and

WHEREAS, the Tribal Council was informed of the parallels between "the Palestinian-Israeli conflict" and the plight of Native Americans at the hands of the United States, which began as soon as Columbus landed on Native lands in 1492, and which has continued in one form or another ever since; and

WHEREAS, like the fledgling American government that marked Natives as uncivilized so that their rights to their lands could be undermined, the Israelis similarly deny political rights to the Palestinians, which directly undermines their rights over Palestinian lands; and

WHEREAS, the Tribal Council recognizes that the colonialism, occupation, and apartheid practices now being imposed on the Palestinians as having similarities to the practices that the colonists imposed on Natives in America from the time of first contact through the present; and the Tribal Council further recognizes that such practices are contrary to the stated standards of international law; and

WHEREAS, the Tribal Council was reminded that the apartheid regime in South Africa refused to recognize the clear directives of international law until the international community intervened and imposed sanctions against it and boycotted it; and that similarly the Israeli government is not likely to recognize the clear mandates of international law until the international community intervenes and imposes sanctions against Israel. Now

**THEREFORE BE IT RESOLVED,** the Red Lake Tribal Council calls on the Israeli government to implement a cease fire, and withdraw its troops from the West Bank and Gaza Strip; and that the Israeli government revoke all laws discriminating against the native Palestinian population; and that the Israeli government implement United Nations Resolution 194, which allows for the return of Palestinian refugees; and

## Resolution Supporting a Permanent Ceasefire and Preventing Loss of Human Life in the Middle East.

**WHEREAS**, we the Moorhead Human Rights Commission work to ensure the safety, health, dignity, and freedom of people every day. We follow the lead of more than 48 other cities in calling for a ceasefire because what happens internationally impacts our constituents locally. We believe in the shared humanity of all people and affirm it as a common value held by Moorhead residents and leaders; and

**WHEREAS,** the ongoing bombardment in the Gaza Strip comes in the context of the 75-year displacement of Palestinians, a 56-year military and settler occupation in Gaza and the West Bank, and the 17-year blockade of Gaza. In 2016, the United Nations Security Council found Israel's settlement activity constituted a "flagrant violation" of international law; and

**WHEREAS**, the Gaza Strip, one of the most densely populated places on Earth, has been repeatedly referred to by human rights groups, including Amnesty International and Human Rights Watch, as "the world's largest open-air prison" even prior to this conflict; and

**WHEREAS**, the Palestinian people are now facing a humanitarian crisis. Human rights organizations such as Amnesty International and Human Rights Watch have reported that Israel has been engaging in collective punishment. This collective punishment includes shutting off all access to electricity, drinking water, food, medical supplies, and humanitarian aid. The UN warns 2 million Gazans will soon run out of drinking water and all medical care.

**WHEREAS**, the World Health Organization warns that amid increasingly dysfunctional healthcare and sanitation systems, disease could kill more people than bombs; and

**WHEREAS,** Palestinians in Gaza now face severe hunger and famine due to besiegement, bombings, and hostilities. According to the UN, the entire population in the Gaza Strip (about 2.2 million people) is classified in IPC Phase 3 or above (Crisis or worse). This is the highest share of people facing high levels of acute food insecurity that the IPC initiative has ever classified for any given area or country. At least one in four households (more than half a million people) are facing catastrophic conditions (IPC Phase 5, Catastrophe/Famine), comprising 80% of all people globally at IPC Phase 5; and

WHEREAS, according to a November 2023 United Nations Human Rights Office of the High Commissioner press release, UN experts stated, "Many of us already raised the alarm about the risk of genocide in Gaza." "We are deeply disturbed by the failure of governments to heed our call and to achieve an immediate ceasefire. We are also profoundly concerned about the support of certain governments for Israel's strategy of warfare against the besieged population of Gaza, and the failure of the international system to mobilize to prevent genocide."; and

**WHEREAS,** Palestinians living in Gaza are being killed at an unprecedented rate. Over 30,000 Gazans – including at least 12,500 children – have been killed in 144 days, meaning 1 child in Gaza is killed every 17 minutes. Over 337 medical workers and over 122 journalists have been killed. Proportional to population, the death toll in Gaza is the equivalent of about 4.5 million American deaths. In addition, over 70,000 Gazans are wounded, and over 8,000 are missing under the rubble; and

WHEREAS, the Government of The State of Israel has bombed civilian entities indiscriminately, destroying or damaging at least two-thirds of all homes in northern Gaza; 23 hospitals and 141 medical

facilities; 70% of schools; over 100 places of worship; bakeries; refugee camps; roads; and other essential infrastructure. This has destroyed access to food, clean water, healthcare, shelter, and sanitation essential to human life and caused mass displacement of as many as 90% of Gazans; and

**WHEREAS,** the World Health Organization, United Nations, Save the Children, Amnesty International, Human Rights Watch, the European Union, His Holiness Pope Francis, more than 120 countries have called for a ceasefire to end the violence and suffering in the Gaza Strip. Doctors Without Borders has advocated for, "a total ceasefire and the unconditional supply of humanitarian aid, including access to food, fuel, and water. The survival of people in Gaza depends on this"; and

**WHEREAS,** on Thursday, January 11, 2024, and Friday, January 12, 2024, the International Court of Justice (ICJ) at the Hague held public hearings in the case brought forward by South Africa against Israel for alleged violations of the Genocide Convention on the Prevention and Punishment of the Crime of Genocide during its operations in Gaza. South Africa's application alleges that, "acts and omissions by Israel... are genocidal in character, as they are committed with the requisite specific intent... to destroy Palestinians in Gaza as a part of the broader Palestinian national, racial and ethnic group." South Africa's actions to receive provisional protections of the people of Gaza are supported by several countries and over 1,000 organizations worldwide. The ICJ's preliminary ruling issued on Friday January 26, 2024, found it plausable Israel was committing genocide and orders Israel to "take all measures within its power to prevent the commission of all acts within the scope of Article II of the Genocide Convention."

#### Now, Therefore, Be It Resolved by The Moorhead Human Rights Commission:

The Moorhead Human Rights Commission affirms:

1. Condemnation towards all acts of violence committed against civilians of any kind. The Moorhead Human Rights Commission expresses sympathy for the civilian victims and all those affected by the horrific violence, including victims of the Oct. 7 attack and all subsequent Palestinian civilian deaths.

2. Moorhead's status as a welcoming community for those of Jewish and Islamic faiths and any other religions.

3. Standing firmly against the rise of and all acts of racially motivated violence and hate crimes perpetrated against our Jewish, Muslim, Palestinian, and Arab constituents here in Moorhead and around the United States; and

4. The right of self-determination of all peoples, recognizing the legitimate desire and need for Palestinian self-determination, as well as the legitimate desire and need for Israelis and Palestinians to live in safety and security.

That the Moorhead Human Rights Commission supports our State and Federal delegations and the Biden Administration using their authority to:

1. Advance a full, immediate, and permanent ceasefire, along with urgently needed humanitarian aid as a necessary step towards lasting peace.

2. Support conditioning U.S. military funding to the State of Israel on the basis that Israel fully complies with international law to prevent contributing to the humanitarian catastrophe, loss of life, and illegal occupation.

3. Ensure the release of civilians being held illegally or imprisoned on both sides of the conflict, including the approximately 130 Israeli hostages taken by Hamas and the thousands of Palestinians held indefinitely without cause and trial in Israeli prisons.

**BE IT FURTHER RESOLVED**, that the Moorhead Human Rights Commission is hereby directed to provide a copy of this Resolution to Moorhead's elected representatives to the Moorhead City Council, Minnesota State Legislature, Governor Walz, Minnesota's elected representatives to the United States House of Representatives and United States Senate, and the Office of President Biden.

#### RESOLUTION CALLING FOR A CEASEFIRE IN GAZA AND IMMEDIATE RELEASE OF ALL HOSTAGES

- WHEREAS, On October 7, 2023, Hamas launched an unprecedented attack against Israel, taking over 200 hostages and resulting in the deaths of 1,200 Israelis; and
- WHEREAS, The Cabinet of Israel subsequently formally declared war against Hamas, and the Israeli Defense minister ordered a "complete siege" on Gaza<sup>1</sup>; and
- **WHEREAS**, Since the war began, Gaza has endured "collective punishment"<sup>2</sup> and been largely cut off from humanitarian aid. According to the United Nations Human Rights Council, 1.5 million Palestinians have been internally displaced<sup>3</sup>, and the lack of safe drinking water, food, fuel, electricity, and medical care has created a humanitarian disaster; and
- WHEREAS, As of November 12, the war against Hamas has destroyed much of the civilian infrastructure within Gaza, including hospitals, and resulted in the deaths of over 11,000 Palestinians, with roughly 68% of the casualties being women and children, according to the United Nations Office for the Coordination of Humanitarian Affairs<sup>4</sup>; and
- **WHEREAS**, The current war between Israel and Hamas marks the most significant escalation in decades, and continued escalation could result in a larger regional conflict with devastating consequences; and
- WHEREAS, The Detroit City Council believes all sovereign nations in pursuit of self-defense must comply with international humanitarian law regardless of geographic context; and
- **WHEREAS,** The Detroit City Council agrees that no human should be deprived of water, food, healthcare and medical supplies, energy (e.g. fuel and electricity), and other basic needs, and decries the deprivation thereof; and
- WHEREAS, The Detroit City Council condemns all acts of violence aimed at Israeli and Palestinian civilians, and mourns the loss of all civilian lives and hostages; and
- WHEREAS, The Detroit City Council is gravely concerned and recognizes that a lasting resolution can only be achieved by peaceful means and diplomacy; NOW, THEREFORE BE IT
- **RESOLVED**, The Detroit City Council calls for an immediate, durable, and sustained ceasefire to protect and save human lives, which allows for humanitarian aid and the unhindered provision of goods to civilians throughout Gaza which are indispensable to their survival as required by international humanitarian law; **NOW**, **BE IT FURTHER**
- **RESOLVED**, As part of the ceasefire, the Detroit City Council also calls for the unconditional release of all civilians who are being illegally held hostage, demanding their safety, well-being, and humane treatment in compliance with international law; **NOW**, **BE IT FINALLY**

#### Agenda Summary

In support of an enduring ceasefire in Gaza.

#### Official Text

- *WHEREAS*, The Somerville City Council recognizes that all human life is precious, regardless of race, religion, or nationality; and
- *WHEREAS*, Since the horrific Hamas attacks of October 7, 2023, in which over 1,200 Israelis were killed and more than 240 taken hostage, over 24,000 Palestinians have been killed and over 60,000 wounded, including enormous numbers of children; and
- *WHEREAS*, The ongoing military campaign and blockade of Gaza has caused a catastrophic humanitarian crisis, including the displacement of approximately 1.9 million people (85% of Gaza's population), the near total destruction of the healthcare system and civilian infrastructure, with the World Health Organization reporting that all Gazan hospitals have been destroyed or seriously damaged, and nearly 2.2 million people at "imminent risk of famine," according to the United Nations; and
- *WHEREAS*, Our Federal delegation has been outspoken on this issue, including MA-7 Congresswoman Ayanna Pressley who has been a leading advocate for a ceasefire, who recently wrote "[L]et us recommit ourselves to the belief that life is precious through demanding a ceasefire, which is the best way to save lives, return all hostages, and deliver the humanitarian aid desperately needed in Gaza,"; and
- *WHEREAS*, Massachusetts Senator Ed Markey recently wrote "We must also resume the ceasefire that allowed for desperately needed humanitarian aid to get into Gaza and that facilitated the release of 105 hostages so that all hostages taken by Hamas on October 7 are freed"; and
- *WHEREAS*, Massachusetts Senator Elizabeth Warren wrote, in response to the temporary ceasefire of November 2023, that the continuing military campaign "has resulted in a humanitarian

catastrophe, the deaths of thousands of civilians in Gaza, and endangered the region's long-term stability...I've repeatedly urged the Israeli government to stop the bombing in Gaza, and I've pressed for massive humanitarian aid for civilians. Hamas must release the remaining hostages and stop its attacks. The Israeli government should not resume bombing in Gaza, which would be a grave strategic and moral mistake"; and

- WHEREAS, On October 26, 2023, the United Nations (UN) General Assembly adopted a resolution calling for an "immediate, durable and sustained humanitarian truce" between Israeli forces and Hamas militants in Gaza, and numerous international humanitarian organizations have similarly called for a sustained ceasefire; and
- *WHEREAS*, Members of the Somerville community, including Palestinians, Israelis, Muslims, Jews, and others, are experiencing trauma, grief, shock and fear, compounded by increased incidents of Islamophobia, antisemitism, and anti-Palestinian racism, both nationally and locally; NOW, THEREFORE, BE IT



#### **Informal Resolution**

Expressing Sympathy for the Ongoing Human Suffering Caused by the Current Conflict in the Middle East; Condemning Violence Against Civilians of any Kind; Affirming Dayton's Status as a Welcoming Community for Those of the Jewish and Islamic Religions, and Any Other Religion; Calling for a Cease-Fire and a Swift End to the War, and Encouraging Dayton Residents to Offer Support and Sincere Condolences to Members of Our Community Affected by The Ongoing Violence and Loss of Life.

WHEREAS, on October 7, 2023, Hamas militants infiltrated the security buffer that the State of Israel government established around the Gaza Strip, in an attack that resulted in more than 1,200 Israeli civilian deaths, many others injured, and at least 240 taken hostage; and

WHEREAS, since October 7, more than 18,000 Palestinians, including more than 4,000 children, have been killed in the Israeli counterattack (according to the Gaza Ministry of Health) and more than 1,700,000 Palestinians have been displaced; and

WHEREAS, on October 27, 2023, The United Nations General Assembly adopted a resolution which called for an "immediate, durable and sustained humanitarian truce leading to a cessation of hostilities" and called for the "immediate and unconditional release" of all civilians being held illegally held/detained or imprisoned.

WHEREAS, all human life is precious and the targeting of civilians no matter their faith or ethnicity is a violation of international law; and

WHEREAS, the continuing death and detention of civilians as a weapon of war serves only to fan the flames of generational hatred, making a lasting peace even more difficult, and

WHEREAS, the world community has created institutions such as the International Criminal Court and the International Court of Justice that determine guilt and innocence according to universally accepted principles and likewise have the specific aim of limiting the use of violence to resolve disputes, and WHEREAS, this Commission recognizes that December 10, 2023 marked the 75<sup>th</sup> anniversary of the Universal Declaration of Human Rights, which guarantees the fundamental rights and freedoms of all, and

WHEREAS, the Human Relations Council (HRC) of the City of Dayton has been a leader in the promotion of civil rights and continues to promote equity, engagement, and the dignity of all; and

WHEREAS, Dayton is one of only five cities in the United States to have an official Sister City relationship with both Israeli and Palestinian communities, and active and fruitful Sister City relationships exist between Dayton and Holon, and Dayton and Salfit, and therefore has a unique voice in this conflict, and

WHEREAS, Dayton has a strong reputation as a city that promotes peace and cultural appreciation, as well as being a city that encourages peaceful dialogue among people in conflict, including our region hosting the successful talks that ended the war in Bosnia and Herzegovina in 1995; and

WHEREAS, The City of Dayton looks upon the recent seven-day ceasefire and the corresponding return of a number of hostages as a promising first step towards a resolution, and

WHEREAS, the Dayton City Commission has long opposed all forms of hate, including both Islamophobia and anti-Semitism, and affirms its support for the Israeli and Palestinian people, and all people around the world, to live in peace and security; and

WHEREAS, the City of Dayton is committed to encouraging and uplifting both the Dayton Muslim and Jewish communities, as well as those communities in other locations, and

WHEREAS, many members of our Dayton community are impacted by the ongoing conflict, including members of our Palestinian Muslim, Palestinian Christian, our Jewish community, and many others; therefore,

### BE IT RESOLVED BY THE COMMISSION OF THE CITY OF DAYTON:

Section 1. That this Commission hereby expresses our deepest sympathy for the civilian victims and all those affected by the horrific violence of this war.

Section 2. That this Commission condemns all acts of violence committed against civilians, in Gaza, in Israel, and around the world.

Section 3. That the City of Dayton condemns the many dehumanizing incidents of antisemitic and anti-Muslim violence and rhetoric, especially those occurring within the United States.

Section 4. That this Commission hereby affirms Dayton's status as a welcoming community for those of the Jewish and Muslim faiths, and all other religions, and encourages Dayton residents to offer support and condolences to members of these communities.

Section 5. That the City of Dayton urgently calls for a cease-fire with the release of all civilians being illegally held or imprisoned on both sides of the conflict, along with the establishment of humanitarian aid corridors in order to preserve human life.

Section 6. That the City of Dayton calls for all Palestinians and Israelis to abide by international law. The Commission envisions a two-state solution, including clear recognition of each state's right to exist, and recognizing the legitimate desire and need for both Palestinian and Israeli self-determination, as well as the legitimate desire and need for Israelis and Palestinians to live in safety and security.

Section 7. That the City of Dayton, given its commitment to and past history of contributing to international peace, stands ready to once again assist in any diplomatic solution that prevents the further loss of life.

#### RESOLUTION SUPPORTING A CEASEFIRE AND AN END TO VIOLENCE BETWEEN ISRAEL AND PALESTINE

WHEREAS, the City of Durham is home to people of diverse nationalities, ethnicities, and faiths for whom the current conflict in the Middle East has a real and personal impact; and

WHEREAS, all human life is precious, and all people, both in Durham and abroad, have a right to be respected and feel safe; and

WHEREAS, on October 7, 2023, an act of terror was perpetrated by Hamas against civilians in Israel, resulting in the death of almost 1,200 people as well as the continued detainment of more than 100 hostages, whose communities, including our own, still await their release; and

WHEREAS, since October 7, 2023, disproportionate retaliation by the Israeli Government in the form of bombing of Gaza and a limiting of most humanitarian aid has claimed the lives of at least 28,000 Palestinians, injured at least 67,000 Palestinians, displaced most of the Palestinian population of Gaza, and has put thousands more people at risk of death from starvation, unsanitary conditions, and lack of healthcare; and

WHEREAS, the United States Federal Government holds significant diplomatic and appropriations powers to save Israeli and Palestinian lives.

NOW THEREFORE, BE IT RESOLVED that the City of Durham:

- 1. Urges the Biden administration to call for and facilitate de-escalation and a sustained, bilateral ceasefire;
- 2. Urges the Biden administration to send and facilitate the immediate entry of humanitarian assistance into Gaza at the scale required;
- 3. Calls for the release of all hostages held in Gaza;
- 4. Calls for the release of all people unjustly held in the region;
- 5. Calls for an end to U.S. military aid to the Netanyahu government;
- 6. Urges the Biden administration and international community to work toward long-term solutions that afford safety and dignity to all people in Israel, Palestine, and the region, and which foster just and representative government for both Palestinians and Israelis.

BE IT FURTHER RESOLVED the City of Durham supports all of its Palestinian, Israeli, Muslim, and Jewish residents and condemns antisemitic and Islamophobic rhetoric and attacks.

BE IT FURTHER RESOLVED that the Durham City Council asks the City Clerk that copies of this Resolution be quickly forwarded to the President of the United States and our Congressional Delegate, Valerie Foushee.

- **WHEREAS:** The City of Lawrence is advocating for peace, understanding, and cooperation in the Middle East, particularly between Palestine and Israel. In the spirit of being a welcoming, equitable, and inclusive community, we reaffirm our commitment to rejecting all forms of racial and religious bigotry in our community, which includes Islamophobia and Antisemitism; and,

BE IT RESOLVED by the Rent Stabilization Board of the City of Berkeley as follows:

WHEREAS, November 12<sup>th</sup> to18<sup>th</sup> was United Against Hate Week, an event started in Berkeley in 2017;<sup>1</sup> and

**WHEREAS,** on October 7<sup>th</sup>, Hamas launched an attack that killed approximately 1,200 people in southern Israel,<sup>2</sup> including hundreds of civilians, and took over 200 hostage;<sup>3</sup> and

WHEREAS, in the weeks since October 7<sup>th</sup>, over 14,000 Palestinians have been killed by Israeli armed forces in Gaza,<sup>4</sup> amounting to 1 in 200 Gazans,<sup>5</sup> the vast majority civilians;<sup>6</sup> and

WHEREAS, more than 6,100 of those killed in Gaza have been children,<sup>7</sup> or one child killed every ten minutes according to the World Health Organization,<sup>8</sup> leading Save the Children to declare that in just three weeks the number of children killed in Gaza surpassed the annual number of children killed in global conflict zones since 2019;<sup>9</sup> and

**WHEREAS,** in addition to the thousands dead, over 1.5 million Gazans face forced displacement and homelessness;<sup>10</sup> and

WHEREAS, as many as 200,000 Israelis have fled or evacuated towns bordering Gaza and Lebanon;<sup>11</sup> and

**WHEREAS,** Israel has cut off electricity, water, food, medicine, and aid to Gaza, leading Oxfam to conclude Israel is using starvation as a weapon of war;<sup>12</sup> and

WHEREAS, attacks by the Israeli army and settlers armed by the Israeli government against Palestinians in the West Bank have skyrocketed,<sup>13</sup> including the forcible depopulation of entire villages;<sup>14</sup> and

**WHEREAS**, the mass killing of civilians in Gaza,<sup>15</sup> the restriction on water, food, medicine, fuel, and aid to Gaza,<sup>16</sup> and the targeted violence and displacement of Palestinians in the West Bank<sup>17</sup> amount to a clear and ongoing campaign of collective punishment by Israel against the Palestinian people, a war crime wherein a group of people is punished for a crime committed by individual members of the group;<sup>18,19</sup> and

**WHEREAS,** UN officials have said that the totality of the violence being committed in Gaza and the "discernibly genocidal and dehumanizing rhetoric coming from senior Israeli government officials" "point to a genocide in the making;"<sup>20</sup> and

**WHEREAS,** the conflict occurring today did not begin on October 7th, but rather is a continuation of the dispossession, oppression, occupation, and apartheid that the Palestinian people have been subject to by the state of Israel for decades;<sup>21</sup> and

WHEREAS, the Gaza Strip, one of the most densely populated places on Earth, has been repeatedly referred to by human rights groups as "the world's largest open-air prison" even prior to this conflict due to ongoing, unbearable living conditions imposed by the state of Israel,<sup>22</sup> including a 16-year full air, land and sea blockade, the strict prohibition of Palestinians from leaving and entering the territory freely, and severe limitations on the availability of drinking water, electricity, and medicine;<sup>23</sup> and

WHEREAS, on June 17, 2021 the Berkeley Rent Stabilization Board adopted Resolution 21-12, becoming the first public elected body in the nation to recognize Israeli apartheid against Palestinians as documented by myriad human rights groups and call for an end to American financial and political support for the dispossession and occupation of the Palestinian people;<sup>24</sup> and

**WHEREAS**, despite this ongoing oppression, the United States has sent more than \$130 billion in military aid to Israel to date, currently \$3.8 billion annually,<sup>25</sup> with virtually no

conditions or accountability,<sup>26</sup> and has increased the transfer of lethal aid during Israel's assault on Gaza;<sup>27</sup> and

**WHEREAS,** Islamophobic, antisemitic, and anti-Palestinian hate crimes have increased sharply in frequency since October 7th,<sup>28</sup> including the violent assault of tenant Hanaan Shahin and the murder of her six-year-old son Wadea al-Fayoume by their landlord in Chicago;<sup>29</sup> and

**WHEREAS,** on November the 24th, Israel and Hamas began a temporary ceasefire to allow for the exchange of some hostages and entrance of some humanitarian aid;<sup>30</sup> and

WHEREAS, truly Uniting Against Hate requires us to combat hate both at home and abroad.

**NOW, THEREFORE, BE IT RESOLVED,** that the Berkeley Rent Stabilization Board honors United Against Hate Week and recognizes and upholds the dignity and equality of all people, regardless of religion, ethnicity, race, or heritage and opposes racism, antisemitism, Islamophobia, colonialism, and ethno-nationalism in all their forms; and

**BE IT FURTHER RESOLVED,** that the Berkeley Rent Stabilization Board mourns the death of all civilians on October 7th and in the weeks since, Palestinian and Israeli, and opposes the forced displacement that has resulted from this conflict; and

**BE IT FURTHER RESOLVED,** that the Berkeley Rent Board calls on all people to recognize that Hamas and the state of Israel are distinct from the Palestinian and Israeli people and Muslim, Arab, and Jewish people across the globe, and that everyday Jews and Palestinians in the United States are not responsible for the actions of Hamas and the state of Israel; and

**BE IT FURTHER RESOLVED,** that the Berkeley Rent Stabilization Board reiterates that discrimination in housing against tenants or applicants on the basis of race, religion, creed, heritage or national origin is illegal and will not be tolerated, and that harassment, intimidation, or violence against tenants or landlords on the basis of their identity or beliefs is reprehensible and illegal in the City of Berkeley; and

**BE IT FURTHER RESOLVED,** that the Berkeley Rent Stabilization Board welcomes the temporary ceasefire and limited exchange of hostages, but finds that it is entirely insufficient to restore peace, and so calls for Berkeley's elected representatives to demand:

- an immediate and permanent ceasefire and respect for international law;
- the unrestricted entry of humanitarian aid and emergency medical assistance into Gaza;

- the restoration of food, water, fuel, and electricity to Gaza;
- the release of all hostages held by Hamas & Israel, including the thousands of Palestinians being indefinitely detained in Israeli prisons without trial;<sup>31</sup>
- an end to all U.S. military aid to Israel;
- the development of a lasting peace that addresses the root causes of the current conflict which lie in decades of institutionalized oppression, occupation, and apartheid; and

**BE IT FURTHER RESOLVED,** that the Berkeley Rent Stabilization Board endorses the Ceasefire Now Resolution submitted by Representative Cori Bush and others,<sup>32</sup> and thanks our Congresswoman Barbara Lee for cosponsoring that vital statement;<sup>33</sup> and

**BE IT FURTHER RESOLVED,** that the Berkeley Rent Stabilization Board stands in solidarity with the Palestinian people as they face the war crime of collective punishment and the looming threat of expulsion from Gaza, an act of ethnic cleansing; and

**BE IT FURTHER RESOLVED** that a copy of this resolution be sent to Assemblymember Buffy Wicks, State Senator Nancy Skinner, Governor Gavin Newsom, Congresswoman Barbara Lee, Senators Laphonza Butler and Alex Padilla, President Joe Biden, and Vice President Kamala Harris.
