# AMENDMENT TO MEMORANDUM OF UNDERSTANDING Between East Bay Center for the Performing Arts And Albany Unified School District October 1, 2010

This Amendment to the Memorandum of Understanding dated September 1, 2010, between the **East Bay Center for the Performing Arts** (EBCPA) and **Albany Unified School District** (AUSD) covers after school programming to be managed by the East Bay Center for the Albany Unified School District. It does not alter or change any of the provisions of MOU.

The East Bay Center will manage after school classes at Cornell, Marin, and/or Ocean View Elementary Schools as requested by the district, individual schools, teachers and/or other individuals and organizations. Once a request for an after school class is submitted the EBCPA and AUSD will jointly decide if the class is to be offered. These after school classes may be open to all grades at the three schools, although specific classes may be restricted to targeted and/or appropriate grade levels (e.g., 4<sup>th</sup> & 5<sup>th</sup> grade instrumental music) at the discretion of the instructor and with the approval of EBCPA and AUSD.

In addition to responsibilities outlined in the previous MOU, EBCPA responsibilities include:

- The EBCPA will assist the teacher in publicizing the class.
- EBCPA will keep enrollment lists and bill parents and collect payment.
- Billing will be done 6 times a year (in conjunction with billing cycles for the Enrichment program.)
- Teachers will be considered faculty of EBCPA and will be paid at faculty rates.
- Teachers will be covered by the EBCPA liability insurance and will be cleared through LiveScan fingerprinting, have TB testing, and will have taken classes in Child Abuse reporting.
- EBCPA will NOT have staff on site for after school classes.
- EBCPA retains the right to cancel classes if enrollment drops.
- EBCPA is NOT responsible for where children go after class.

#### Teacher responsibilities:

- Individual teachers will be responsible for liaising with individual school site leadership to secure rooms for the class.
- The length and duration of the class will be at the discretion of the instructor.

- Teachers (in conjunction with school sites) are responsible for where children go upon dismissal.

AUSD and/or individual school responsibilities include:

- Securing parent volunteers when children need to be walked from one school site to another.
- School sites (in conjunction with teachers) are responsible for where children go upon dismissal.

Rates for classes will range from \$7 to \$11 per class depending on the length of the class and materials.

All programming is subject to review by the Albany Unified School District. All good faith efforts to fulfill the commitments stated above shall be made and recognized. Any changes to this Amendment shall be made in writing and agreed to by all parties.

## BACKGROUND INFORMATION:

The Division of the State Architect (DSA) requires that specific materials inspection and special testing be performed to ensure the construction of the Albany High School Aquatic Center is consistent with the DSA approved project plans.

Three qualified and reputable special testing firms were asked to provide rate sheets and an estimated total project price to perform the required services for the project. A fixed fee amount cannot be provided due to the nature of the work and the uncertainty of the number of tests and re-tests required. The following are the responses to the proposal request:

Firm

Consolidated Engineering Laboratories (CEL)	Provided rate sheet \$25,853 total estimated cost
Wallace-Kuhl and Assoc.	Provided rate sheet, but no total cost
Kleinfelder Inc.	Did not respond

A review of the two rate sheets, shows that hourly rates are comparable between CEL and Wallace-Kuhl. CEL's total estimated project cost of \$25,853 is reasonable and well under the Aquatic Center's budget of \$74,042 for special testing and inspection.



- I. FEES: The estimated contract price is based on the best information made available to CEL at the time the estimate was performed. If subcontractors perform more quickly than scheduled, Client will receive a cost savings for testing. If, however, subcontractors' schedules are extended or delayed, Client may receive a resulting increase in costs for testing. Client recognizes that the additional services rendered herein under this Proposal are schedule driven and are mandated by the scheduling and staffing of the contractor(s). Should Items and quantities alter from estimates outlined herein, CEL shall be entitled to compensation for services rendered. In addition, Client recognizes that, on occasion, due to the schedule of the contractor or relevant subcontractors, occasional overtime may be required. CEL typically will have no notice of this until the day the said overtime occurs. Client agrees to compensate CEL for such overtime. Any estimated quantities contained herein are estimates only and Client agrees to payment for services rendered in excess of the estimated quantities and/or cost figures as described herein. Fees for CEL's services will be billed on a time and expenses basis at the unit rates quoted and CEL shall submit biweekly invoices for services rendered and for reimbursable expenses incurred. Invoices are due within 30 days from receipt. Past due invoices are subject to a finance charge of 1% per month or the maximum rate permitted by law.
- II. <u>FINAL AFFIDAVIT</u>: The first invoice from CEL shall include the estimated cost to prepare the Final Inspection Report. #### **BACKGROUND INFORMATION:**

The Division of the State Architect (DSA) requires that specific geotechnical inspection and testing be performed to ensure the construction of the Albany High School Aquatic Center is consistent with the DSA approved project plans.

Three qualified and reputable special testing firms were asked to provide rate sheets and an estimated total project price to perform the required services for the project. A fixed fee amount cannot be provided due to the nature of the work and the uncertainty of the number of tests and re-tests required. The following are the responses to the proposal request:

Firm	Cost
Geosphere Consultants Inc.	Provided rate sheet \$28,260 total estimated cost
Wallace-Kuhl and Assoc.	Provided rate sheet, but no total cos
Kleinfelder Inc.	Did not respond

A review of the two rate sheets shows that hourly rates are comparable between Geosphere and Wallace-Kuhl. Geoshpere's total estimated project cost of \$28,260 is reasonable and under the Aquatic Center's budget of \$74,042 for special testing and inspection. It should be noted that Geoshpere Consultants, Inc. prepared the DSA required Soils Report for the project.

Geosphere Consultants Inc. has prepared this proposal to provide geotechnical testing and monitoring services during construction phase operations for the Albany High School Aquatic Center. The project will consist of the construction of a new Aquatic Center on the campus of Albany High School in Albany, California. The new facility will be constructed in place of an existing indoor pool facility at the south side of the campus. The new facility will encompass the entire existing footprint and extend somewhat to the north and east of the existing facility. There are extensive utilities adjacent to the proposed project as well as structures to the west. The new facility will include two pools, one indoor and one outdoor.

Geosphere prepared a Geotechnical Engineering Study report for the subject project (Reference 1). The project includes abandonment of existing underground utilities, demolition of existing buildings, mass grading, subexcavation and subsequent placement of select fill under pools and flatwork, spread footing foundation excavations, pier excavations, retaining wall and utility trench backfilling, and pavement section preparation. Mass grading will consist of subexcavation and recompaction in the pad area along with cut and fill grading to produce the finish grades. The foundation excavations will include both conventional spread footings and drilled piers. This proposal is based on a review of the civil, pool construction, and structural plans (References 2 and 3), review of the above referenced report and subsequent letter recommendations, conversations with the Project Manager, Mr. David Burke, experience on similar projects, and our current understanding of your needs.


#### SCOPE OF SERVICES

#### SOILS COMPACTION AND FOUNDATION EXCAVATION INSPECTION

Testing and inspection will be performed during site grading, utility trench backfill (both for new and removed lines), flatwork preparation, placement of select fill for the pools and flatwork subgrades, and pavement preparation.

- Observation and testing of building pad grading;
- Observation and testing of pavement and concrete hardscape section preparation, including subgrade, and baserock;
- Observation and testing of new underground utility trench backfilling;
- Laboratory testing, including maximum density determinations and materials acceptance testing;
- Foundation excavation inspection, including pier inspections;
- Project management and consultation, including responses to submittals and RFI's, and preparation of summary forms and reports required by DSA.

Field testing will be performed using a nuclear gauge to determine the relative compaction of the soil in conformance with American Society for Testing and Materials ASTM D2922 and ASTM D3017.

#### **ON-GOING CONSULTATION DURING CONSTRUCTION**

As the Geotechnical Engineer-of-Record for this project, we anticipate that on-going consultation services may be required. We suggest including additional time for consultation during the construction process.

Geosphere proposes to utilize Principal, Senior, and Technician level personnel on this project. Geosphere's engineering staff will provide supervision of the soil technicians, foundation observation, daily field report review, and consultation during construction.

In summary, our services during construction would include:

- Geotechnical engineering consultation during construction, as required;
- Observation and testing during mass, building pad, and pool subgrade grading;
- Observation and testing during pavement and exterior concrete hardscape preparation;
- Observation and testing during utility trench backfilling;
- Foundation excavation observations;
- · Project coordination and field daily reports review during construction;
- Final Summary Letter of our observations and testing for construction of the project;
- Preparation of the required DSA forms

The Estimated Time and Materials fees for these services are summarized on the attached.

Our estimate is based on the assumed task lengths and services listed above and the actual fees could be more or less depending on the actual services required. Our services will be billed portal to portal. Any offsite improvements for the project are not included in this estimate. Project schedules are not available at this time and we have based this estimate on the preliminary assumptions of the time generally required for this type of project. We recommend that Geosphere be given the opportunity to revise this proposal when the construction schedules are available.

Geotechnical dispatching will be handled by Mike Wissink out of the San Ramon office. Special inspection dispatching will be handled by CEL's Materials dispatch out of San Ramon. **Geosphere** recommends that a preconstruction meeting be held between us and the Contractors prior to the commencement of grading, and underground utility activities. It is recommended that **Geosphere** collect onsite soil samples at least 48-hours prior to the first compaction testing request to ensure maximum density/optimum moisture determinations are ready during testing. Otherwise, providing compaction test results to the onsite team will be delayed slightly while the laboratory prepares the samples.

A proposal for Materials Testing and Inspection will be provided under separate cover.

#### **BACKGROUND INFORMATION:**

The Fiscal Crisis and Management Assistance Team (FCMAT) was created by legislation in 1992 as an independent and external state agency. FCMAT's mission is to provide proactive and preventive fiscal, business and management services that help local educational agencies comply with fiscal accountability standards and incorporate best practices.

FCMAT has performed more than 700 reviews for K-12 school districts, county offices of education, community colleges and charter schools.

In light of State budget cuts that will likely reduce county supported special education services and thus likely increase expenditures in special education, staff would like an independent review of the special education delivery system to determine if cost efficiencies can be implemented with the goal being to provide additional services to students.

## FISCAL CRISIS & MANAGEMENT ASSISTANCE TEAM STUDY AGREEMENT October 12, 2010

The FISCAL CRISIS AND MANAGEMENT ASSISTANCE TEAM (FCMAT), hereinafter referred to as the Team, and the Albany Unified School District, hereinafter referred to as the District, mutually agree as follows:

#### 1. <u>BASIS OF AGREEMENT</u>

The Team provides a variety of services to school districts and county offices of education upon request. The District has requested that the Team provide for the assignment of professionals to study specific aspects of the District operations. These professionals may include staff of the Team, County Offices of Education, the California State Department of Education, school districts, or private contractors. All work shall be performed in accordance with the terms and conditions of this Agreement.

In keeping with the provisions of AB1200, the County Superintendent will be notified of this agreement between the District and FCMAT and will receive a copy of the final report. The final report will be published on the FCMAT website.

#### 2. <u>SCOPE OF THE WORK</u>

A. <u>Scope and Objectives of the Study</u>

The scope and objectives of this study are to:

- 1. Conduct a comprehensive review of the special education delivery system and determine how the program can be more cost efficient. The review will include recommendations to reduce the level of contributions from the unrestricted general fund and continue to sustain the quality of services and meet the legal requirements of the program.
- 2. Evaluate the effectiveness of the staffing process for certificated staff and classroom aides including class size ratios and provide recommendations, if needed.
- 3. Review the district's implementation of the Response to Intervention Model (RTI) and provide recommendations, if any.

- 4. Review District Student Study team process and make recommendations to improve efficiency.
- 5. Review nonpublic school and nonpublic agencies placements and make recommendations on cost containment.
- 6. Review legal services costs and usage and make recommendations on how to effectively work with parents to reduce legal services. This component will also include recommendations on collaborative solutions on how to work together in an effort to further reduce the need for costly mediation and due process hearings and avoid litigation.

#### B. <u>Services and Products to be Provided</u>

- 1) Orientation Meeting The Team will conduct an orientation session at the School District to brief District management and supervisory personnel on the procedures of the Team and on the purpose and schedule of the study.
- 2) On-site Review The Team will conduct an on-site review at the District office and at school sites if necessary.
- Exit Report The Team will hold an exit meeting at the conclusion of the on-site review to inform the District of significant findings and recommendations to that point.
- 4) Exit Letter The Team will issue an exit letter approximately 10 days after the exit meeting detailing significant findings and recommendations to date and memorializing the topics discussed in the exit meeting.
- 5) Draft Reports Sufficient copies of a preliminary draft report will be delivered to the District administration for review and comment.
- 6) Final Report Sufficient copies of the final study report will be delivered to the District administration following completion of the review.
- 7) Follow-Up Support Six months after the completion of the study, FCMAT will return to the District, if requested, to confirm the District's progress in implementing the recommendations included in the report, at no cost. Status of the recommendations will be documented to the District in a FCMAT Management Letter.

#### 3. **PROJECT PERSONNEL**

The study team will be supervised by Anthony L. Bridges, CFE, Deputy Executive Officer, Fiscal Crisis and Management Assistance Team, Kern County Superintendent of Schools Office. The study team may also include:

Other equally qualified consultants will be substituted in the event one of the above noted individuals is unable to participate in the study.

#### 4. <u>PROJECT COSTS</u>

The cost for studies requested pursuant to E.C. 42127.8(d)(1) shall be:

- A. \$500.00 per day for each Team Member while on site, conducting fieldwork at other locations, preparing and presenting reports, or participating in meetings.
- B. All out-of-pocket expenses, including travel, meals, lodging, etc. The District will be invoiced at actual costs, with 50% of the estimated cost due following the completion of the on-site review and the remaining amount due upon acceptance of the final report by the District.

Based on the elements noted in section 2 A, the total cost of the study is estimated at \$13,900.

C. Any change to the scope will affect the estimate of total cost.

Payments for FCMAT services are payable to Kern County Superintendent of Schools - Administrative Agent.

- C. The District Administration will review a preliminary draft copy of the study. Any comments regarding the accuracy of the data presented in the report or the practicability of the recommendations will be reviewed with the Team prior to completion of the final report.

In accordance with Government Code Section 66006 (b), the Albany Unified School District must provide an annual accounting of the Capital Facilities Fund for the collection and accounting of Developer Fees.

Government Code Section 66006 (b) requires local agencies, including school districts, which collect developer fees, to provide an annual accounting of those fees within 180 days of the close of each fiscal year.

Each accounting must include:

- 1. The amount of the fee;
- 2. The beginning and ending balances of the account;
- 3. The amount of the fees collected and the interest earned during the fiscal year;

#### **CST Content Cluster Data Results**

We analyzed the data over the last four years to determine areas of strengths and weakness in our instructional program. The data indicates that we have a balanced program in both language arts and math where we focus our instruction across all strands. In math, the mean percent correct across strands consistently fell in high 70% to high 80% range. In English Language arts, the data indicated areas of strengths and areas needing focus. The mean percent correct ranged from low 70% to high 80%. Writing Strategies and Written Convention content clusters are strands where scores are generally lowest. Word Analysis, Literature Response & Analysis and Reading Comprehension are strands where scores are generally higher.

2009-2010 Goals focused on English Language Learners, African American, Hispanic/Latino, Socially Economically Disadvantaged and Students with Disabilities

**CST ELA Data** – 75% proficient or above for all students; **CST Math Data** – 85% proficient or above for all students

Ocean View had a 4-point drop from the 08-09 school year from an API of 917 to 913. Ocean View did not meet ELA and math site goals for improving scores 3% across all subgroups. However, when viewing subgroups for Annual Measurable Objectives (AMOs) we noted the following for 2010:

 77.8% of African American or Black scored at or above proficient for ELA and math (this marked a first time for seeing such data for this subgroup.) As well we noted within subgroups many students moved significantly within a level such as basic or below.







# TEMPORARY CONSTRUCTION EASEMENT AND AGREEMENT

THIS AGREEMENT is made this \_\_\_\_\_\_ day of \_\_\_\_\_, 2010, by and between the ALBANY UNIFIED SCHOOL DISTRICT, a Public Corporation, hereinafter referred to as "Grantor", and, the CITY OF ALBANY, a municipal corporation, hereinafter referred to as "Grantee".

WHEREAS, Grantor is the owner of the real property situate in the City of Albany, County of Alameda commonly known as APN 066-2692-022-05, and more particularly described in the grant deed from the Regents of the University of California to Albany Unified School district recorded on the 19<sup>th</sup> day of June, 1974 as Image 3708 Reel 866 Alameda County Records (hereinafter the "Land");

WHEREAS, by separate document Grantor has granted to Grantee a permanent easement to construct, operate and maintain a paved public path (hereafter referred to as the "Bikeway") adjacent to Buchanan Street from the intersection of Jackson Street to the westerly property line of said Land; and

WHEREAS, in order to construct Bikeway, Grantee and its authorized agents, employees and Contractors require a Temporary Construction Easement (hereafter "TCE") upon that portion of Land shown and designated as "TCE AREA" on Exhibit "A", attached, for the purpose of installing temporary fencing, storing materials and equipment during construction, constructing graded conforms to landscaping and pavement, and restoring existing improvements immediately adjacent to the Bikeway.

- 1. Grantor hereby grants to Grantee TCE for the express purpose of installing temporary fencing, storing materials and equipment during construction, excavating and constructing graded conforms to landscaping and pavement, and restoring existing improvements immediately adjacent to the Bikeway.
- 2. TERM: The term of TCE shall begin upon commencement of construction within TCE Area and expire upon completion of Bikeway improvements and restoration of TCE Area by Grantee.
- 3. Grantee shall comply with all applicable laws, ordinances and regulations, including but not limited to all applicable regulatory, environmental and safety requirements at Grantee's sole cost and expense.
- 4. Grantee shall not use, deposit or permit the use or deposit of any hazardous material or toxic waste or other harmful substances on any real property of the Grantor.
- 5. Grantee shall not materially interfere with the use by and operation and activities of Grantor on its property, and Grantee shall use such routes and follow such procedures on Grantor's property as result in the least damage and inconvenience to Grantor.

Grantee shall be responsible for any damage to Grantor's property or that of third parties resulting from any exercise of the rights herein granted, including but not limited to soil erosion, subsidence or damage resulting therefrom. Grantee shall promptly repair and restore to its original condition any of Grantor's property, including, but not limited to, roads, utilities, irrigation system, buildings and fonces that may be altered, damaged or destroyed in connection with the exercise of the TCE.

TCE is made on the express condition that Grantor is to be free from all liability by reason of injury or death to persons or injury to property from whatever cause arising out of Grantee's, agents', officers', employees', invitees'(including contractors), or licensees' exercise of rights granted pursuant to TCE or use of the TCE Area or of the improvements or personal property of Grantee thereto or thereon, including any liability for injury or death to the person or property of

Grantee, its contractors, agents, officers, members, employees, invitees, or licensees or to any property under the control or custody of Grantee during the term of TCE. Grantee hereby covenants and agrees to defend and indemnify Grantor, its officers, employees, agents, invitees and guests and save them harmless from any and all liability, loss, costs, or obligations on account of, or arising out of, any such injury or losses caused or claimed to be caused by the exercise of TCE or use of TCE Area by Grantee, however occurring, other than those caused solely by the willful or negligent acts or omissions of Grantor.



**<u>RECOMMENDATION</u>**: Conduct 2<sup>nd</sup> reading and approve Board Policy 3312 – Contracts (Business and Operations)

#### **Business and Noninstructional Operations**

#### **CONTRACTS**

Whenever state law invests the Board of Education with the power to enter into contracts on behalf of the district, the Board may, by a majority vote, delegate this power to the Superintendent or designee. To be valid or to constitute an enforceable obligation against the district, all contracts must be approved and/or ratified by the Board. (Education Code 17604)

(cf. 3300 - Expenditures and Purchases) (cf. 3314 - Payment for Goods and Services) (cf. 3400 - Management of District Assets/Accounts)

All contracts between the district and outside agencies shall conform to standards required by law and shall be prepared under the direction of the Superintendent or designee.

(cf. 2121- Superintendent's Contract) (cf. 4312.1 - Contracts) (cf. 9124 - Attorney)

When required by law, contracts and subcontracts made by the district for public works or for goods or services shall contain a nondiscrimination clause prohibiting discrimination by contractors or subcontractors. The nondiscrimination clause shall contain a provision requiring contractors and subcontractors to give written notice of their obligations to labor organizations with which they have a collective bargaining or other agreement. (Government Code 12990)

The Superintendent or designee may enter into contracts on behalf of the district for amounts up to the limits prescribed in Public Contract Code, up to \$15,000, without prior approval from the Board. Contracts will be submitted to the Board for ratification within 60 days. (Education Code 17605)

<u>The Superintendent or designee shall be authorized to approve contracts for professional services, which are exempt from formal bidding, up to an amount not to exceed \$25,000 without prior approval from the Board. (Education Code 17605)</u>

The district shall not enter into a contract that prohibits a school employee from disparaging the goods or services of the contracting party. (Education Code 35182.5)

#### **Contracts for Electronic Products or Services**

The Board shall not enter into a contract for electronic products or services that requires the dissemination of advertising to students, unless the Board: (Education Code 35182.5)

1. Enters into the contract at a noticed, public hearing of the Board.

#### **CONTRACTS** (continued)

2. Makes a finding that the electronic product or service is or would be an integral component of the education of students.

3. Makes a finding that the district cannot afford to provide the electronic product or service unless it contracts to permit dissemination of advertising to students.

#### (cf. 1325 - Advertising and Promotion)

- 4. As part of the district's normal, ongoing communication to parents/guardians, provides written notice that the advertising will be used in the classroom or other learning center.
- 5. Offers parents/guardians the opportunity to request in writing that their child not be exposed to the program that contains the advertising. Any request shall be honored for the school year in which it is submitted, or longer if specified, but may be withdrawn by the parents/guardians at any time.

# **RECOMMENDATION:**

Review and discuss the 2010-11 State Budget Update

Enrollment growth continues to be funded at \$465.44 per ADA. Unfortunately, the final agreement did not provide funding for the first phase of the Behavioral Intervention Plan (BIP) mandate and, in fact, attempts to negate the mandate through budget trailer bill language that says that BIP services are already required under existing federal law. This provision is likely to face a legal challenge.

The final agreement provides authorization and funding for the estimated \$70 million Special Disability Adjustment (SDA) through 2011-12 and sunsets the authorization on July 1, 2011. School agencies also received a reprieve from efforts to shift county mental health mandates to school agencies (AB 3632). The agreement provides funding to county mental health for prior-year mandates but nothing in the budget year, leaving the future of the mandate up in the air. Finally, special education continues to be excluded from the flexibility provisions that allow school agencies to spend categorical program funding for other purposes.

# **School Facilities**

The Office of Public School Construction (OPSC) reports that, as of August 25, 2010, about \$4.9 billion from Propositions 1D, 55, and 47 remains available for apportionment, as noted on the following chart:

**DEFERRED MAINTENANCE** – The Deferred Maintenance Program matching requirements of one-half of 1% of district expenditures are not required for 2008-09 through 2012-13.

#### ROUTINE RESTRICTED MAINTENANCE

ACCOUNT – The flexibility provision continues, which allows districts to reduce required contributions into routine restricted maintenance accounts from 3% of General Fund expenditures to 1% in 2008-09 through 2012-13. School districts that maintain their facilities in good repair are exempt from the 1% requirement.

#### LEGISLATION AFFECTING SCHOOL FACILITIES – AB 211 (Chapter 430/2010) requires all newly constructed classrooms funded under the Leroy F. Greene School Facilities Act to be equipped with Title 24-compliant locks that will enable the

classrooms to be locked from the inside. This bill impacts any new construction project submitted to the Division of the State Architect on or after July 1, 2011.

AB 635 (Chapter 438/2010) requires an architect, engineer, or roofing consultant to disclose financial relationships with persons in connection with a K-12 or community college roofing project, and to complete and sign a certification stating they will not receive or give financial incentives in connection with the roofing project contract. The bill also imposes a \$1,000 civil penalty for a false certification.

AB 2048 (Chapter 541/2010) closes a loophole relating to the collection of school impact fees on commercial development projects. The bill clarifies that nongovernmental commercial health facilities are subject to school impact fees by prohibiting the Office of Statewide Health Planning and Development from issuing permits until school districts certify that fees have been paid.

# Lottery Funds

Lottery funds are seemingly immune to the economic environment. Lottery sales increased in 2009-10, which is continuing into the 2010-11 fiscal year. The projected revenues for schools increased from \$1.088 billion to \$1.103 billion. The increase to school agencies will result in a projected amount of \$130 per 2009-10 annual ADA. Under the revised projection, the allocation is \$112.50 per annual ADA unrestricted and \$17.50 per annual ADA for Proposition 20 restricted funding.

# **Dartboard Factors**

The SSC Financial Projection Dartboard factors presented below are developed by SSC with input from independent state agencies and private economic consulting firms, based on the latest information available. These factors are provided to assist school agencies with preparing their upcoming budgets and multiyear projections.

# **State Budget**

The enactment of California's 2010 State Budget has the distinction of being the latest in the state's history. Almost 100 days late, it surpassed the previous 85-day record set in 2008.

Similar to past years, the final Budget includes rosier state and federal revenue projections, the sale of state properties, additional borrowing, and suspension of the Proposition 98 minimum guarantee to close the \$19 billion shortfall.

The major surprise in the final agreement was the restoration of virtually all of the proposed school funding cuts proposed in the May Revision. The enacted Budget includes a restoration of the \$1.5 billion cut to revenue limits, rescission of cuts to child care programs, recognition of an outstanding Maintenance Factor, and even some funding for prior-year mandates. The trade off for this welcome news was the suspension of Proposition 98, an additional \$1.7 billion apportionment deferral to schools, and uncertainty over whether the agreement can be sustained in this and future years. In addition, the final package includes a two-year delay of a corporate tax break that had been set to take effect in 2011 and an agreement to place another "rainy day fund" proposition on the 2012 ballot.

# **Proposition 98**

Proposition 98 is designed to establish the minimum funding level for K-14 education from one year to the next. Since the onset of the recession in December 2007, state revenues have fallen dramatically and the Proposition 98 guarantee has been driven downward. For 2010-11, the Governor's May Revision proposed a Proposition 98 guarantee of \$48.4 billion, a reduction of \$1.5 billion from the 2009-10 guarantee. The final Budget for 2010-11 instead suspends Proposition 98 to \$49.7 billion, a reduction of \$4.3 billion from the constitutional minimum funding level. Actual K-14 spending, however, will be closer to \$52.5 billion, in large part because of a new apportionment deferral totaling \$1.9 billion (K-14 total) and other resources that do not count as a Proposition 98 expenditure.

MAINTENANCE FACTOR – The 2010-11 Budget Act recognizes an outstanding Maintenance Factor obligation (money the state owes schools) of \$9.5 billion at the end of the current fiscal year, reflecting the additional \$4.3 billion current-year suspension and an estimated \$6 billion paid toward the Maintenance Factor in 2009-10 and 2010-11.

# **Unrestricted Funding**

**REVENUE LIMIT REDUCTION** – The \$1.5 billion reduction to revenue limits, originally targeted at district administration in the January Governor's Budget but amended at the May Revision, is eliminated in the final Budget. The Department of Finance had estimated that the \$1.5 billion cut would have resulted in a revenue limit reduction of about 3.85% for all districts.

**COST-OF-LIVING ADJUSTMENT (COLA)** – The final Budget acknowledges the statutory COLA of -0.39% (approximately -\$24/ADA for elementary districts, -\$29/ADA for high school districts, and -\$25/ADA for unified districts), but the reduction to revenue limits is neutralized through a change in the deficit factor instead of a cut.

**DEFICIT FACTORS** – The deficit factor is reduced from 18.355% proposed in the May Revision to 17.963%, which eliminates the effects of the negative statutory COLA of -0.39%.

APPORTIONMENT DEFERRALS – The final Budget increases the apportionment deferral by \$1.7 billion for K-12 education and \$189 million for community colleges. For K-12 education, this results in total deferrals of approximately \$7 billion.

MANDATES – The final Budget provides \$300 million for mandate reimbursements, with \$100 million allocated to 2010-11 claims and \$200 million designated for prior-year claims to be paid to all districts on the basis of an equal amount per ADA. In addition, the Budget eliminates the state's obligation to pay for the Behavioral Intervention Mandate and the Science Graduation Mandate, an action which will likely be challenged in the courts.

CHILD CARE REDUCTIONS - The Governor's proposal to eliminate the CalWORKs program and delete the associated funding for child care is rejected in the final Budget. Approximately \$1.2 billion was added to fund the child care program in 2010-11.

# **Federal Funding Update**

There are two sources of one-time federal funds in 2010-11 – Education Jobs Act funding (new) and the final 10% of State Fiscal Stabilization Funds (SFSF) due to LEAs. SFSF may be used to support a broad range of operational needs by LEAs. Education Jobs Act funding may only be used to support compensation expenses for school-level operations, which include, but are not limited to, site-level school administrators, teachers, counselors, librarians, custodians, and others involved with site-level services.

# **Categorical Programs**

There are no major changes to state categorical programs for 2010-11 compared to 2009-10. The Budget leaves unaddressed the future of flexibility options introduced in recent years. The following table provides an overview of the various options and their timeline for continuation.

The cuts to child care programs proposed by the Governor as part of the May Revision are not included in the Budget. There are some adjustments in the level and type of funding provided that allow for the continuation of the level of services, but reimbursement rates for unlicensed child care providers will be reduced.

#### BACKGROUND INFORMATION:

The Education Jobs and Medicaid Assistance Act of 2010 (PL111-226) is federal legislation that provides one-time funding to school districts nationwide to retain, restore, add or otherwise compensate school personnel

From the California Department of Education's website:

#### Use of Funds

LEAs may use Ed Jobs funds to compensate employees for any period after August 10, 2010, the date of enactment of the Act. Funds must be expended by September 2012.

LEAs must use the funds at the school site level for compensation and benefits and other expenses, such as support services, necessary to retain existing employees; to recall or rehire former employees; and, to hire new employees in order to provide early childhood, elementary, or secondary educational and related services. This includes salaries, performance bonuses, health insurance, retirement benefits, incentive for early retirement, pension fund contributions, tuition reimbursement, student loan repayment assistance, transportation subsidies, and reimbursement for child care expenses. Funds may be used to restore reductions in salaries and benefits or to implement increases. They also may be used to eliminate furlough days.

In addition to teachers, employees supported with Ed Jobs funds may include, among others, principals, assistant principals, academic coaches, in-service teacher trainers, classroom aides, counselors, librarians, secretaries, social workers, psychologists, interpreters, physical therapists, speech therapists, occupational therapists, information technology personnel, nurses, athletic coaches, security officers, custodians, maintenance workers, bus drivers, and cafeteria workers.

Funds may not be used for: (1) administrative expenditures related to the operation of the superintendent's office or the LEA's board of education, including the salaries and benefits of LEA-level administrative employees; and (2) expenditures for fiscal services, LEA program planners and researchers, and human resource services.

# FINANCIAL INFORMATION:

Each school district's portion of the \$1.2 billion total will be based on their proportionate share of the total state revenue limit funding. The California Department of Education released preliminary allocations based on 2009-10 revenue limits. The final allocation will be made based on the 2010-11 revenue limit information, to be certified in June 2011.

Albany Unified School District's allocation is estimated to be \$713,323. The district should receive a preliminary allocation equal to 90 percent, \$641,991, within the next few months.

Until a State budget is adopted, it is unknown how these funds will impact overall revenue and whether State revenue will be reduced accordingly.

# BACKGROUND INFORMATION:

The Superintendent requests that the Governing Board discuss the parameters and process that they would like to use in the upcoming Board Study Session on student equity in kindergarten through grade 5. Using the following Board Policies that reference 'equity" and "equal educational opportunities", the Superintendent recommends that **during the study session of November 16, 2010**, Board members, staff and parents give input on a working definition of equity as it applies to an Albany student's educational experience.

BP 3290

The Board of Education may accept any bequest or gift of money or property on behalf of the district. While greatly appreciating suitable donations, the Board discourages any gifts which may directly or indirectly impair its commitment to providing equal educational opportunities for all district students.

BP 5000 Students

The Board is fully committed to providing equal educational opportunities

The Superintendent suggests that the Governing Board may wish to consider the following concepts as the process for the study session is developed:

- 1. Equity of *resources* (supports, finances, taxes)
- 2. Equity in *process* (the school experience, program, content, access)
- 3. Equity of outcomes (learning achieved, impacts on later life)

The Superintendent recommends that disparities of equity be outlined and quantified **<u>during the study session of November 16, 2010.</u>** Staff will provide data on ethnicity, English language learners, poverty rate and academic performance. Staff will also provide data on distinct funding, site donations and any other data requested by the Governing Board.
