As of issuing this statement, stock replenishment for concerned products will be phased out. No additional feature development will be made for the discontinued product.

- **Discontinuation date**
 - **August 31, 2022**

The **forecasted final date** that the discontinued product/s can be purchased from Axis. Please note that an unforeseen increase in demand can cause products to be out of stock before the discontinuation date. Any excess stock after this date, can be available for purchase until stock runs out by decision from product management. N.B., products ordered *after* the discontinuation date might come with limitations in the HW warranty, please update yourself on the warranty applicable for any orders placed *after* the discontinuation date.

- **Hardware and RMA service offered until**
 - **August 31, 2028**

Axis will continue to give hardware and RMA service for 6 years after the discontinuation date. As long as the product is within the warranty period and it is not warranty void, the warranty terms for RMA still apply. If the warranty period has expired, the Out of Warranty price list applies. Axis RMA service will be based on the discontinued product as the primary alternative. When this is not possible, the replacement product will automatically be the alternative stated in the table above.
