

# TRI-CITY RUBBLE SITE AGREEMENT December, 2020-November, 2021

This contract made and entered into this 1st Day of December, 2020, by and between the City of Deadwood, a political subdivision of the State of South Dakota, the City of Lead, a political subdivision of the State of South Dakota, and Central City, a political subdivision of the State of South Dakota (hereinafter referred to as "CITIES") and Adams Salvage Recycling & Recovery, LLC (hereinafter referred to as "ADAMS").

### 1) BASE TERMS:

- i) For the purposes of operating a Type IIB Solid Waste Disposal Site (hereinafter "Rubble Site") on behalf of CITIES.
- ii) The term of this contract shall be for a period of one year from the date set forth above and shall expire on November 30, 2021. CITIES do hereby grant to ADAMS an option to renew the contract for one additional one year period, upon ADAMS giving 30 days written notice prior to the end of the contract term. The annual renewal rate for each renewal term will be determined, changed or adjusted by mutual agreement, in writing, of the parties. If the parties cannot agree on appropriate terms for the renewal term within 15 days of the expiration of the original term, the option to renew will be rescinded. The other terms and conditions of this contract will continue in effect unless changed in writing by agreement of the parties.
- iii) The annual rate to be paid to ADAMS during the term of the agreement will be determined, changed or adjusted by mutual agreement, in writing, of the parties on an annual basis. If the parties cannot agree to the annual rate prior the end of each year of the contract the annual rate to be paid to ADAMS shall remain the same for the next year of the contract. The other terms and conditions of this contract will continue in effect unless modified in writing by agreement of the parties.

### 2) <u>CITIES' OBLIGATIONS:</u>

- i) CITIES shall approve any fee rates charged by ADAMS. Once set, the fee schedule may not be modified without the consent of CITIES;
- ii) CITIES assumes hazards of damage or destruction of any of the improvements now on the real property or to be placed thereon. CITIES agrees to maintain and carry at all times fire and extended coverage insurance on all of the structures of the said premises to the full insurable value thereof;
- iii) ADAMS may place two (2) buildings on the Rubble Site for its use and operation at ADAMS' expense. In the event of termination of this Agreement, CITIES agree to reimburse ADAMS the sum of \$10,000.00 if both buildings have been installed and are being used for operation by ADAMS at the time of

termination of the Agreement. If the buildings are no longer being used for operations by ADAMS, CITIES will compensate ADAMS in the amount of \$3,000.00 for both buildings. If constructed, both buildings will remain on the Rubble Site property following termination of this Agreement.

### 3) ADAMS' OBLIGATIONS:

- i) To operate the Rubble Site in accordance with the terms set forth herein;
- ii) To abide by all applicable laws and permit requirements of the operation of a Type IIB Solid Waste Disposal Site, and ensure that all operations are in compliance with all local, state and federal laws, rules, regulations and permits or leases covering the same. ADAMS shall be available for any inspections by federal, state or local authorities.
- iii) ADAMS shall be responsible for disposing of tires including costs of disposal on an annual basis. No tires shall become a permanent part of the Rubble Site.
- iv) ADAMS shall maintain a complete record keeping system, including but not limited to income statements, accounts receivable and daily usage logs. ADAMS shall provide a written quarterly report to CITIES on usage, quantity waste disposal, income and expenses. These records shall also be made available to CITIES as CITIES' request for review.
- v) ADAMS Shall provide all necessary equipment for operation and maintenance of the Rubble Site. ADAMS is responsible for the year-round maintenance of all roads within the Rubble Site as well as access to and from the Rubble Site from Yellow Creek Road.

### 4) MECHANIC'S OR CONSTRUCTION LIENS:

 ADAMS shall not subject the Rubble Site to any mechanic's, materialmen or construction liens of any kind unless specifically approved in writing by CITIES.

### 5) INDEMNIFICATION:

- i) During the entire term of the contract, ADAMS shall indemnify and hold harmless CITIES against any and all claims, debts, demands or obligations which may be made against ADAMS or against ADAMS' title in the Rubble Site arising out of or in connection with any alleged act or admission of ADAMS or any person claiming under, by or through ADAMS.
- ii) If it becomes necessary for ADAMS to defend any action seeking and imposing liability, ADAMS will pay CITIES all costs of court and attorney fees incurred by CITIES in effecting such defense in addition to any other sums which CITIES may be called upon to pay by reason of the entry of a judgment against ADAMS.
- iii) This indemnification is applicable only to ADAMS' operation and management of its rubble she, according to all federal, state, and local laws and regulations. ADAMS shall obtain comprehensive general liability insurance to cover the activities of ADAMS undertaken herein with the general

limits of said coverage being Two Million arid no/100s Dollars (\$2,000,000.00), or a combination of general liability policies totaling Two Million and no/100s Dollars (\$2,000,000.00). CITIES shall be added as an additional insured on said policy(ies) and shall present proof of such insurance to the CITIES.

### 6) **DEFAULT**:

- i) If at any time a default shall be made by ADAMS in the performance of any obligation of ADAMS herein set forth, then it shall be lawful for CITIES to declare the contract term ended and to reenter upon the Rubble Site and take possession of the same under the terms and conditions herein provided.
- ii) If the default occurs, and if CITIES shall so elect, they may declare this contract term ended by giving ADAMS thirty (30) days written notice specifying the event causing the default and ADAMS shall have thirty (30) days, after the date of receiving the notice, to cure such default.
- iii) If not timely cured, this contract shall terminate; if timely cured, this contract shall continue.

### 7) HOURS OF OPERATION:

- i) The Rubble Site shall be open for use by the public Mondays through Saturdays during regular business hours (8:00 AM to 4:00 PM). The Rubble Site will be closed for normal holidays.
- ii) In the event of inclement weather (high winds, heavy rain or snow), ADAMS may decide to close the Rubble Site for public safety

### 8) FREE DUMPING:

- i) Residents of CITIES and of Lawrence County shall be allowed free dumping four times per year, generally:
  - (1) Near the end of March (free dump weekend);
  - (2) Mid-May (spring clean-up week);
  - (3) Late September (free dump weekend), and
  - (4) Early November (free dump weekend).

### **9) FEES:**

i) Fees shall be established by contract addendum and agreed to by both CITIES and ADAMS. Tipping fees may be adjusted pursuant to mutual agreements with CITIES and ADAMS, exclusive of these contract terms. CITIES will approve the rate of the fees.

### 10) SITE USAGE:

- i) CITIES have exclusive rights to harvesting timber, minerals and other Rubble Site natural resources. ADAMS shall coordinate with CITIES to facilitate these operations as deemed necessary by CITIES.
- ii) ADAMS may, with the approval of CITIES, engage in other appropriate,

lawful and permitted activities for income generation at the Rubble Site.

iii) ADAMS shall ensure the operations of the Rubble Site are conducted in a safe, efficient and professional manner.

### 11) TERMINATION:

i) At the termination of this contract, ADAMS will peaceably and quietly deliver possession of the Rubble Site to CITIES.

### 12) QUIET ENJOYMENT:

i) CITIES covenant and agree with ADAMS that so long as ADAMS keeps and performs all of the covenants and conditions by ADAMS to be kept and performed hereunder, ADAMS and his successors in interest shall have quiet and undisturbed and continued possession of the Rubble Site, free from any claims by CITIES or any persons or entities claiming thereunder.

### 13) FORCE-MAJEURE:

i) In the event that CITIES or ADAMS shall be delayed, hindered in or prevented from the performance or any act required hereunder by reason of strikes, lockouts, labor troubles, inability to procure materials, failure of power, restrictive governmental laws or regulations, the act or failure to act of either party for said reason shall be excused for the period of delay necessitated by the above without either party being held accountable for the same.

### 14) CONSENT NOT TO BE UNREASONABLY WITHHELD:

 Whenever the contract requests any consent, permission or approval which may be required or desired by ADAMS pursuant to the provisions hereof.

### 15) WRITTEN MODIFICATIONS:

 No modifications, release, discharge, amendment or waiver of any provisions hereof shall be of an force or effect unless reduced to writing and executed by both parties,

### 16) LAWS:

i) The laws of the state of South Dakota in force and effect at the date of the execution of this contract shall govern and control the interpretation and application of this contract except where new laws or regulations mandate a modification to this contract in order to continue to perform the duties and obligations of either party hereunder, which the parties shall not unreasonably withhold consent to such modification pursuant to any new law or regulation mandating the modification hereto.

- Rental fee includes utilities, water, sewer, heat, air-conditioning, electricity and a parking spot. TENTANT is responsible for TENANT'S own telephone and internet expenses.
- 4. This Agreement is for July 1, 2020 through June 30, 2021. It may be terminated by either party hereto upon thirty (30) days written notice.
- 5. The Agreement depends upon the continued availability of appropriated funds and expenditure authority from the Legislature for this purpose. If for any reason the Legislature fails to appropriate funds or grant expenditure authority, or funds become unavailable by operation of law or federal funds reductions, this Agreement will be terminated by the State. Termination for any of these reasons is not a default by the State nor does it give rise to a claim against the State.

Notices or communications to or between the parties shall be deemed to have been delivered when mailed by first class mail, provided that notice of default or termination shall be sent by registered or certified mail, or, if personally delivered, when received by such party.

- 8. In the event that any court of competent jurisdiction shall hold any provision of this Agreement unenforceable or invalid, such holding shall not invalidate or render unenforceable any other provision hereof.
- 9. All other prior discussion, communications and representations concerning the subject matter of this Agreement are superseded by the terms of this Agreement, and except as specifically provided herein, this agreement constitutes the entire agreement with respect to the subject matter hereof.

#### Welcome to the 2021 Road Grub Throwdown

The all-new 2021 Road Grub Throwdown fires up at the Deadwood Events Complex August 6-10. It's a large venue including a football field, two baseball diamonds, and a rodeo corral. The 2021 rally will be a big one as society uncorks following the pandemic issues we all face, and with that much space, clearly, the plan is to go as big as the rally itself.

Road Grub Throwdowns are food competitions held at some of the largest motorcycle and car events in the country, complete with exhibitor areas. They're an ideal opportunity for every brand in the motorcycle and powersports industry to reach new customers because the appeal isn't limited to just gearheads. Everybody eats and enjoys quality outdoor cooking. The events are also perfect for food, beverage, and outdoor brands to reach a huge audience in central locations in just a few days.

A Road Grub Throwdown centers around the popular competition format of 10-15 contestants cooking food on a time limit, to be judged by a panel of three celebrity judges. The panel consists of two culinary professionals and a well-known powersports industry professional. The theme for each day changes; one day may be chili, one may be hot wings. Mixed into the heat of competition is the bodacious personalities tied to motorcycling- the will be an event series to both watch AND taste!

For the inaugural year during the Black Hills Rally, there'll be two different classes for the food competitions: Pro Stock (HOG vs IMOG teams) and Run What Ya Brung (open to the general public).

#### Pro Stock: HOG vs IMRG

Rivalries die hard and stoke attention like nothing else. How fun would it be to have a Harley vs Indian event? Two teams of five, each cooking on individual grills, compete for both individual and team prizes. The team with the highest point total wins the day's big prize, while the three individual HOG and IMRG competitors win individual prizes as well. The team with the highest total for the entire five days wins the Grand Prize and a trophy they'll have to defend next year if they want to keep it, a la Stanley Cup.

Prize opportunities include sponsor activations and give-aways. Optional incentives include winning teams receiving a one-year discount for that company's products for the entire HOG or IMRG membership. Example: the third place finisher for day one is a HOG member. He or she wins a high-end chef knife set from KAI Knives. For the next twelve months, all other HOG members get a 10% discount on the purchase of KAI Knives. It's very win-win at minimal cost to all companies involved and will increase brand visibility to customers who already exhibit premium brand loyalty

Given the size and variety of open space available to us, activation opportunities are significant and flexible to sponsoring brands' needs. Possibilities include HOG and IMRG bar areas open to members only. Beverage companies would be welcome to sponsor each one and there could be member-only gift bags, shirts, and special Road Grub Throwdown pins and patches as well. For one of the nights, we might plan on holding a members-only VIP dinner in the chuck wagon area as well. Premiums that reflect both the party and the community of riders attending.

Future plans include adding a Harley-Davidson vs Indian competition to our 2022 event, with famous pit masters as team leaders in our Top Fuel division. The winning company of that event would take home a trophy similar to the one above. For instance, if H-D and Yoder Smokers and Indian and Traeger are still collaborating, that sets up the two pellet smokers competing as well.

# Run What Ya Brung

Ten lucky people sign up online to compete in one of our other daily cooking competitions. Judging works exactly like the Pro Stock. You decide which battle(s) you want to fight so if you're really feeling froggy, you're more than welcome to enter multiple competitions. The top three competitors for each daily competition win cash and prizes. Additionally, the top three one-day scores for the Throwdown win grand prizes as well.

## **Charity Fundraising**

Riders are a generous lot. We want to raise money for charity at the Throwdowns, either local causes or national ones or both. Because the first Throwdown in Deadwood gives us ready access to working with its casinos, we will to team up with them for charity poker tournaments on their premises after hours. We also have plenty of time and space for stage raffles, charity food and beverage events, and we're open to other ideas that speak to sponsoring brand values and exclusive activations as well.

## **Bike Shows and Geocaching Ride**

There is nothing like checking out cool motorcycles with a full belly, so we will hold a vintage motorcycle show next to the corral area, near where our chefs will be cooking the VIP chuck wagon dinners and breakfasts. It's a natural fit for the Old West-meets-early-motorcycling element to our Deadwood experience. We'd also tie that into a 25-mile loop of geocaching or poker run locations for prizes too. Each location would have some historic significance to the area and participants would need to post hastagged photos on Instagram to qualify for the prizes - increasing both social media visibility and tracking of the promotions. Tying in with the Motorcycle Cannonball would be a natural fit and speaks not only to classic bikes - but those who really ride them as they were intended. Other bike show opportunities include sidecar, chopper, and perhaps even stoking new classes such as electric and alternative takes.

As we expand, we are inviting renowned bike builders into the mix by giving them each a grill to customize in their signature styles at the end of our year one event. They'd have one year to customize it as they see fit. At the 2022 Sturgis event, the finished grills would be judged in a show bike style competition on one day. On the next, each builder team would have to battle it out in a cooking competition.

# Exhibitors, Demos, and the VIP Experience

If all of that's not enough to stoke the competitive spirit, check out demos by our sponsors, spotlights on local restaurants, and browse all the killer kitchen and grilling toys and items in the surrounding exhibitor area.

For sponsors and exhibitors, Road Grub Throwdowns are the perfect vehicles for marketing and selling products both within and outside of the world of powersports. Many powersports consumers are outdoor chefs themselves who also love to travel. The shows reach across culinary, beverage, powersports, and outdoor industries all in one place at one time. All at events with built-in attendances reaching as high as 450,000 people in a week. Currently our list of interested celebrity judges from the worlds of barbecue, cast iron cooking, and hot sauce include <u>Brent Bolton</u>, <u>John "CaJohn" Hard</u>, <u>Ray "Dr BBQ" Lampe</u>, and <u>Vic Clinco</u>. Additionally, there will be daily rotating celebrity judges from the motorcycle world, and sponsor representatives added in for additional value.

#### Schedule:

For the Black Hills Rally, since it's Deadwood, we're having an authentic chuck wagon experience only with fine dining-level cuisine and period-inspired cocktails each morning and evening. For our Daytona show in 2022, it will be pirate themed with seafood. The 2022 Vegas show will draw on the city's mob roots. Here is the proposed daily schedule for the 2021 event in Deadwood.

#### Daily Schedule Friday-Tuesday:

- 9 am opening; VIP breakfast
- 9:30 am: Competitor meeting
- 10-12:00 pm: HOG vs IMRG Competitor cooking and turn-in.
- 12-12:30 pm: Competition judging

- 5:45-6:15 pm: Cocktail-making competition. The day's winner gets their entry added to the drink menu for the rest of the show, plus a daily grand prize and the top three spots get prize money.
- 6:30 pm-7:00 pm: The day's awards presentation and closing.
- 7:30 pm-9:30 pm: VIP dinner

In addition, there will be DJ music and sponsor demos on stage during the cooking times. More attractions are being added all the time; all with the goals of keeping the crowd happy and entertained.

#### **Exhibitor Booth Fees**

A 10x10-foot booth for the 2021 Road Grub Throwdown costs \$600 for three days or \$800 for five days. Exhibitors are welcome to purchase more than one booth. Re: Request approval for purchase of new vehicle

With the implementation of License Plate Reader technology for the City's new parking management system, the Parking and Transportation Committee recommends the purchase of a new vehicle solely dedicated for the use of "LPR". The current vehicle used for parking enforcement is a 10 year old secondhand patrol vehicle, a 2011 Dodge 1500 Truck. Due to its size, it's very difficult to maneuver in the tight and narrow spaces, such as the Broadway Ramp and some of our public streets. A new vehicle makes our staff more efficient and also more professional.

Parking and Transportation recommends purchasing a new vehicle, a 2021 allocated budgeted item within the Parking Management, not to exceed \$30,000 at state bid.
