## 81. Presentation by Barnardos on the Crediton Children's Centre

A representative of Barnardos working with the Devon Children's Services gave a presentation to the Council on the role, goals, organisation and composition of the Crediton Children's Centre and its relation to the rest of the District Children's Service.

It was agreed with the representative that an article would be included in a forthcoming Council newsletter and that the Children's Centre would provide information leaflets to the Council.

Councillors Adams & Wright arrived.

### 82. Public Question Time

#### 83. Chairman's Announcements

The Chairman informed Councillors that the Mayor's Chain of Office had been returned and looked as though an excellent refurbishment had been done. Councillor Scarbrough arrived.

#### 84. Town Council Minutes

The minutes of the Town Council Meeting held on 22 July 2008 were received and approved as a correct record.

# 85. Matters Arising

*Minute 66:* Councillors noted that a meeting was going to be held the following day, Wednesday 17 September 2008, concerning the future of the public toilets in Crediton.

# 86. General Purposes Committee Minutes

- a) The minutes of the General Purposes Committee meeting held on 2 September 2008 were received and noted.
- b) The recommendations of the General Purposes Committee held on 2 September 2008 were approved.

## 87. Matters Arising

Minute 61: It was noted that the Bus Terminus at QECC will need physical alterations made to it's layout.

Minute 54: It was noted there is no money currently allocated to the proposed bench at Union Terrace.

Councillor Brown arrived.

# 88. Planning

a) Planning Decisions

Noted. Decisions notified by the planning authority are appended.

Councillor Nation arrived.

b) Planning Applications

Comments made in respect of planning applications considered at this meeting are appended.

c) Planning Applications and Items for Determination week ending Tuesday 16 September 2008.

None.

d) Satellite Dishes

It was brought to the attention of members that a large number of satellite television aerials had appeared, without planning permission, within the town centre's Conservation Area. It was proposed that the Council write to the Planning Authority to review all such dishes on listed buildings within the Conservation Area and have those that have been in situ for less than four years without planning permission removed. It was accepted that dish aerials that had been up for more than four years could not be removed. This was agreed.

# e) Paper Planning Applications

A letter from Mid Devon District Council was tabled informing Parish and Town Councils that paper plans for planning applications would continue to be sent to local councils and would not be withdrawn.

#### 89. Finance

#### a) Schedule of Accounts

Councillor Nation declared a prejudicial interest & left the meeting.

The schedule of accounts, numbers 002841 to 002858 amounting to £10,902.95 was approved.

# b) Donation Requests

There were two donation requests received by the Council:

- i) WRVS requested financial assistance with Devon Home Library Service project Members noted that Council policy was not to provide financial support to National charities and consequently it was agreed not to make a donation to this project.
- ii) Crediton Church Corporation requested financial support for the church footpaths restoration project. Some disquiet was expressed over the request for funds for what is primarily a maintenance project. It was also concluded that there was insufficient funds in this year's budget. It was agreed to defer consideration of this request until the budget review process for next year.

# c) Financial Update

The Assistant Town Clerk updated members on the current budget expenditure. It was noted that no significant savings had been identified at the present and that Council expenditure was on budget.

# 90. Councillor Reports

a) Hospital Campaign Group

The Town Council's representative reported that the group met last Friday, 12 September 2008 with the first attendance of representatives of the Devon NHS PCT & Devon Partnership Trust. Although there was disappointment with lack of address of loss of respite facilities prior to closure of beds in Boniface Ward at the Hospital, it was reported that day clinics were beginning.

# a) Town Plan

Councillor Brookes-Hocking noted that the County Council Parking Survey Review had still not been published. A meeting with Newcombes Housing Association was also reported upon. It was noted that the Housing Association is duty bound to gain suitable market return on investments such that near or full market value would have to be paid for the property. However, the District Council does not have their own valuers, and it would thus be expensive to get a valuation. As car-parking is a key issue to town planning, it may be possible for the Economic Develop Budget to be used to move the project forward in the hiatus in development of the site.

# b) Crediton Festival 2009

The Council's representative had not attended the last meeting and there was no report.

# c) Skatepark

Councillor Wright reported that the project was progressing with the skatepark equipment currently being manufactured. It was noted that there was still a shortfall in funding which the Council has been requested to assist with.

# d) Quality Status

Councillor Hughes updated members on the current requirements for Quality Status outlined in the training course undertaken. It was noted that there are, nationally, 600 Quality Status Councils, 28 of them in Devon.

## **SPECIFIC AGENDA ITEMS**

#### 91. Crediton Children's Centre

There were no requests or matters arising from the presentation.

#### 92. Town Council Website

It was agreed to defer this item to Part 2 due to commercially sensitive information.

#### 93. CCTV

It was agreed to defer this item to Part 2 due to security considerations.

# 94. Draft Proposals for Unitary Local Government

The Council supported the views expressed in letters received from Brampford Speke and Upton Pyne Parish Councils requesting that the Boundary Committee for England include those parishes in the proposed Community Board area for Crediton and not Exeter.

Debate took place on the views held by the Crediton hub town parishes concerning unitary status and the structure of the proposed Community Boards. After having considered the draft response from the Devon Association of Parish Councils, members proceeded to discuss the Council's own response to the Boundary Committee's proposals.

The Council unanimously agreed to respond to the consultation by indicating that the Town Council strongly supported the proposal for a single unitary authority, which included Exeter within it, on the proviso that:

- 1. Town and parish councils are able to play an active role in the Community Boards and
- 2. That adequate funding and resources are put in place to support their expanded role.

Members opposed the two unitary authority solution, regarding a 'Greater Exeter', as financially unfeasible and severely detrimental to the rest of rural Devon.

# 95. Town Guide

- a) It was noted that the Town Guide would be published in the New Year and, possibly even before Christmas, although this was considered unlikely. The proofs should arrive shortly with the Council.
- b) The current, updated, version of the map was tabled. Members suggested a number of corrections to the map which were passed to the Council's Town Guide Working Group representative.

# 96. Land Registration

Councillor Nation declared a prejudicial interest & left the meeting

It was reported that the three allotment sites had been registered but that this had exhausted the budget for this year. It was also noted that the progress of the Devon Unitary Government review was increasing the potential importance of the correct recording of Council property. It was agreed to allocate £900- from financial reserves to register three more Council properties, namely Stoney Park, People's Park and the War Memorial if possible.

Councillor Nation re-entered the meeting.

#### 97. Devon Local Inolvement Network (LINk)

The invitation to join the DEVON Involvement Network, (LINk), was noted. It was

recommended that the LINk proposal be referred to the Crediton Hospital Campaign Group, who may be interested.

# 98. Market Street Disabled Parking Bays

A proposal to request moving of the disabled parking bays in Market Street was felt to be better addressed to the Crediton Access Group for consultation prior to further resolution.

# 99. Church Street Pedestrian Safety

The issue of pedestrian safety in Church Street, opposite the entrance to Newcombe's Meadow was debated. It was noted that the view of approaching cars was impaired when crossing from the East side to the West. Additionally, it was noted that the roadside barrier at the park entrance, that has created a refuge for pedestrians, had been removed some time ago and not replaced. Members were informed that speedhumps were now easier and cheaper to install than when this issue had previously been discussed. It was agreed to write to the County Council, copied to the Count Council Member, addressing the concerns for road safety at this point of Church Street.
