SCOPE OF WORK

***McAfee* SOFTWARE LICENSES - MAINTENANCE AND SUPPORT**

1. SCOPE OF WORK

PetroSA currently makes use of *McAfee* software licenses within its business. The *McAfee* software licenses are PetroSA's security standard and is installed on all PetroSA's desktops, laptops and servers. This software is essential to protect PetroSA against malicious software being distributed throughout the organization.

As with most of the software used within PetroSA, maintenance and support is required. PetroSA therefore requires to have access to the latest version of *McAfee* software and to receive the necessary maintenance and support, thereby updating its *McAfee* software licenses.

2. REQUIREMENTS

- A South African based *McAfee* reseller must extend the following licenses for one (1) year, renewable for a further one (1) year period.
- ***Please note PetroSA will not pay the subscription fees two (2) years in advance and will only pay the subscription fees on an annual basis.***
- Kindly cater for all costs in your quotation. The start date of the subscription renewal will be 29 December 2021.

- Below is the *specification* for our licenses required by PetroSA in order to have its *McAfee* licenses extended, maintained and supported.
- The service providers must provide a new Grant Letter upon award of the contract. “Grant Letter” means a confirmation notice letter issued by the OEM.
