## MAJOR CASES

---

Among the thousands of cases handled by JND and its founders are some of the largest administrations in our country's history. Here, we share the details of some of our most important matters.

### **In re Blue Cross Blue Shield antitrust litigation**

Master File No.: 2:13-CV-20000-RDP (N.D. Ala.)

JND was appointed as the notice and claims administrator in the \$2.67 billion Blue Cross Blue Shield antitrust settlement. JND has already disseminated notice, both by U.S. mail and email to over 100 million potential class members. We built a secure, mobile-enabled, ADA-compliant website where individuals and entities can securely submit their claims, and supporting documentation, electronically. To date we have received more than 8 million claims. Our phone center has been staffed with as many as 250 operators to handle extensive and complex questions from class members. In short, this is one of the most complex and high profile class action settlement administrations in over a decade.

### **In re Equifax Inc. customer data security breach litigation**

Master File No.: 17-md-2800-TWT (N.D. Ga.)

JND was appointed settlement administrator for this complex data breach settlement valued at \$1.3 billion with a class of 147 million individuals nationwide. JND handled all aspects of claims administration, including the development of the case website which allowed for online claim submissions. In the first week alone, more than 10 million claims were filed. The case has received more than 18 million claims – the most ever in class action practice. Overall, the website received more than 200 million hits and the contact center handled well over 100,000 operator calls.

### **In re oil spill by the oil rig "Deepwater Horizon" in the Gulf of Mexico, on April 20, 2010**

No. 2179 (MDL) (E.D. La.)

The Deepwater Horizon class action settlement is one of the largest settlements of all time, having paid out more than \$10 billion. The administration was extensive, with thousands of representatives from dozens of different companies playing a role. One of the most significant aspects of the program was the Hammond, Louisiana center, which was the site of the entire back office for all intake and outgoing mail, claim prep and data entry support. Jennifer and Neil built out and staffed this brand-new

40,000 square foot center in two months. We had more than 200 employees at the center, at times working shifts around the clock to meet the demands of the program. As the program's hub, the Hammond center was visited several times by claims administrator Pat Juneau, and by the District Court Judge and Magistrate – who described it as a "shining star of the program". Our team also was responsible for call center operations, with hundreds of agents assisting class members, as well as making all check distributions to class members with valid claims.

### **Cobell v. Salazar**

No. 96 CV 1285 (TFH) (D. D.C.)

As part of the largest government class action settlement in our nation's history, Jennifer Keough and Neil Zola worked with the U.S. Department of Justice to implement the administration program responsible for identifying and providing notice to the two distinct, but overlapping, settlement classes.

As part of the notice outreach program, Jennifer participated in multiple town hall meetings held at Indian reservations located across the country. Due to the outreach program, over 80% of all class members were provided notice. Under our supervision, the processing team processed more than 480,000 claims forms to determine eligibility. Less than one half of 1 percent of all claim determinations made by the processing team were appealed.

Jennifer was called upon to testify before the Senate Committee for Indian Affairs, where Senator Jon Tester of Montana praised her work in connection with notice efforts to the American Indian community:

*"... The administrator has done a good job, as your testimony has indicated, [discovering] 80 percent of the whereabouts of the unknown class members."*

### **USC Student Health Center settlement**

No. 18-cv-04258-SVW (C.D. Cal.)

JND was approved as the settlement administrator in this important \$215 million settlement that provided compensation to women who were sexually assaulted, harassed and otherwise abused by Dr. George M. Tyndall at the USC Student Health Center during a nearly 30-year period.

JND designed a notice effort that included mailed and email notice to potential class members, digital notices on Facebook, LinkedIn and Twitter, an internet search effort, notice placements in USC publications/eNewsletters, and a press release. The team also worked with USC staff to ensure notice postings around campus, on USC's website and social media accounts, and in USC alumni communications, among other things.

We ensured the establishment of an all-female call center, fully trained to handle delicate interactions, with the goal of providing excellent service and assistance to every woman affected. JND staff also handled all lien resolution work for this case.

### Loblaw card program

JND was selected by major Canadian retailer Loblaw and its counsel to act as program administrator in its \$300 million voluntary remediation program as a result of a price-fixing scheme by some employees of the company, involving bread products. The program offered a \$25 card to all adults in Canada who purchased bread products in Loblaw stores between 2002 and 2015.

Some 28 million Canadian residents were potential claimants. JND's team built an interactive website that was capable of withstanding hundreds of millions of "hits" in a short period of time; built, staffed and trained a call center with operators available to take calls twelve hours a day, six days a week; oversaw the vendor in charge of producing and distributing the cards; designed and oversaw fraud prevention procedures; and handled myriad other tasks related to this high-profile and complex project. To date we have handled more than 4.5 million program registrations.

### FTC v. Reckitt Benckiser Grp. PLC

No. 19CV00028 (W.D. Va.)

The JND team designed a multi-faceted notice program for this \$50 million opioids settlement, resolving charges by the FTC that Reckitt Benckiser Group PLC violated antitrust laws by thwarting lower-priced generic competition to its branded drug Suboxone.

The plan reached 80% of potential claimants nationwide, and a more narrowed effort extended reach to specific areas and targets. The nationwide effort used a mix of digital, print, and radio broadcast through Sirius XM. Extended efforts included local radio in areas defined as key opioid markets and an outreach effort to medical professionals approved to prescribe Suboxone in the U.S., as well as to substance abuse centers, drug abuse and addiction info and treatment centers, and addiction treatment centers nationwide.

This is one of more than three dozen matters we are handling for the FTC. JND is one of only three contracted vendors for the FTC, which trusts us with its complex matters.

### In the Matter of GTV Media Group, Inc.

Proc. File No. 3-20537

GTV is a \$455 million SEC Fair Fund, one of the largest SEC Fair Funds in the past several years. The vast majority of potential claimants are investors living in China, creating many sensitivities and complications. Compounding the issues is that the SEC required an expedited program, with payments going out within five months of the approval of the Plan of Allocation. JND was required to develop the plan as well as all notice materials, including the website, in both English and Chinese. The media notice campaign similarly had to be tailored to reach investors in China. JND hired Mandarin-speaking staff members to facilitate the communication between JND and the claimants. Our CFO, Flora Bian, is a native Mandarin speaker and has been instrumental in assisting with certain complex questions and translation efforts.

Because we are dealing with unregistered common stock and digital assets for this matter, most of the documentation provided to us includes voluminous agreements and/or digital payment receipts for thousands of transactions. This is not typical evidence in a securities matter and we were required to train our team on these intricacies, while working with the SEC to understand how these investors acquired these securities. This is one of several dozen matters JND is working on with the SEC as one of their authorized vendors.

### In re Navistar MaxxForce Engines Mktg., Sales Practices and Prods., (January 3, 2020)

No. 14-cv-10318 (N.D. Ill.):

The Navistar litigation resulted in a \$135 million settlement on behalf of truck owners throughout the United States. The most complicating factor here was the number of claims filed by third-party claim preparers on behalf of vehicle fleets. In short, every claim submission involved thousands of pages of documentation, all of which had to be reviewed and audited to confirm adherence to the settlement agreement and plan of allocation. Also compounding the complexity is the fact that both sides invoked the right to review claims to try to raise or lower the claim rate in their favor. As per the settlement agreement, JND was the arbiter of these disagreements and was required to mediate disputes between the parties about various claims.

Part of JND's responsibility pursuant to the court's direction was to ensure that class members had ample opportunity to submit claims. Through our efforts, more than 66% of eligible vehicles claimed here — a very high rate for a class action. We were also charged with following up on the distribution of proceeds to make sure that claimants cashed their checks. Through our efforts, over 99% of all monies ended up being cashed.
