North Star Mohican Casino Resort of Bowler, WI, is soliciting competitive proposals from qualified firms ("Proposer") to provide equipment and professional services to install and configure new hardware / software needed to replace our existing HP 3PAR server / SAN environment. Services will be provided in a manner that meets or exceeds the minimum system requirements as outlined per Scientific Games server system architecture document.

#### **PURPOSE AND AGREEMENT**

North Star Mohican Casino Resort is seeking proposals from qualified companies to serve as industry experts to review, validate and propose industry leading technology solutions for the replacement of our gaming floor Casino Management System (CMS) architecture. This RFP is expected to result in contractual agreements between North Star Mohican Casino Resort and the Proposer as may be negotiated with Proposer based on the RFP process. The term of the agreement resulting from this RFP will be conditional based on needs of North Star Mohican Casino Resort.



Propose a solution for either repairing our existing HP 7904 switching configuration or replacing
the HP 7904 switches that currently exist in our environment. The current HP 7904 switches serve
as a connecting point between the MDF and IDF3 rooms. This connection was to provide a
redundant connection; however, the connection is not configured properly as it exists today.
Below is a diagram of the original build from 2015



- Any proposed changes will require final build approval from Scientific Games, which North Star Casino will submit for approval.
- Proposer must meet all contractual and implementation timelines upon award of contract resulting from this RFP.
