Community Safety

- There has been another spate of criminal damage at NHC managed public toilets in Howard Park Gardens and Norton Common, Letchworth. CCTV cameras are in operation at HPG and investigation is ongoing.
- Another large quantity of butchered meat products have been fly tipped in North Herts on the Letchworth/Baldock border. This time it is a large number of hessian sacks containing pigs' ears. Enquiries ongoing with the National Farmers Union and other local authorities.
- This weekend (15th January) there is the VAWG SAFE event at Hitchin Town Hall, starting at 2pm.

<u>Health & Wellbeing /Safeguarding briefing January 2023</u>

- The Healthy Hub drop-ins in are now scheduled to the end of March 2023.
 Further information can be found HERE
- This month we launch our new Winter Warmer Homework club based in Royston for adults and their children. The Healthy Hub team will be there on hand with drinks, snacks a warm space, free activities and a welcoming space. Running on Tuesdays at the Royston Catholic Church between 3-5pm.
- New safeguarding team Lisa McDonnell and administrative assistant Lisa McDonald, have been in post for a month and are starting to introduce themselves to relevant service areas & managers. Lisa McDonnell also attended a multi-disciplinary County meeting with the Service Director to meet partners for a Safeguarding Adult Review.
- Funding applications have been submitted to the lottery for physical activity programmes for older people and physical and mental health project for men in the Jackmans Active Local area.
- Successful bid to Health Protection Bid with Mind Mid Herts for outreach mental health service – project scoping starts Jan 23.

Throughout December and January, the team have been busy coordinating various partnership networks and events and the provision of ongoing Community and Member support:

- Finalising arrangements for the Holocaust Memorial Day 2023; finalising programme, receiving drafts from speakers, working on poetry competition.
- Liaising with Helping Herts Homeless and Keystage Housing on a potential project in 2024.
- Exploring the possibility of launching a VHSE group to support refugees recently arrived in Baldock.
- Coordinating and launching North Herts Heroes (Chair's Awards).
- Collating, sharing and signposting information regarding Warm Spaces with community groups.
- Support for events including Baldock and Letchworth Festival – to provide an overall North Herts Summer of Arts & Culture' and ongoing Snowman Trail (on until 20th January 2023).
- Meeting with Hitchin Allotment Association to discuss ideas around green and growing network group.
- Approval of revised Council's Climate Change Strategy and updated Council achievements and additional proposed actions.
- Approval of the revised Council's Equality Strategy with new equality objectives.
- Promoting the Sustainable Warmth scheme to residents via social media, posters, and mailouts.
- Meeting with CDA Herts to discuss needs in rural areas and ways of working together.

Democratic Services

Committee Services

- The newest member of the Team, Eleanor Hopcraft joined on 3 January 2023 as a Committee, Member and Scrutiny Officer, filling one of the three vacant Officer posts.
- The remaining two Officer roles are currently being advertised, due to close on Tuesday 24 January 2023, with interviews on Tuesday 7 February 2023.
- The vacant Apprentice role had nine applications, of which six were invited for an interview, to take place on Tuesday 10 and Friday 13 January 2023.
- Meeting support for some January meetings has been provided by other colleagues within the Council.
- Ongoing Auditel issues in the Council Chamber did not seem to occur as much during December. Discussions are taking place regarding business resilience in the event of future issues with the AV system, which will ensure the meetings can still proceed effectively.

Electoral Services

- Following the publication of the revised electoral register on 1 December, we have been working on the distribution of the new register to all eligible recipients who have requested a copy. Most have now been sent with a few outstanding to be distributed.
- Nominations are open for the upcoming Hitchin North County by-election on Thursday 9 February 2023. We are therefore making preparations including booking polling stations, proofing poll cards, making staffing arrangements and liaising with candidates and agents.
- Preparation work for elections to be held in May 2023 are also well underway – polling station bookings have all been secured and we are in the process of checking facilities where necessary. Initial staffing plans are also being drawn up and we are undertaking some project work on elections fees and equipment.
- We are continuing with our work to prepare for the incoming Elections Act 2022 changes. We have attended training sessions in recent weeks on the process for issuing Voter Authority Certificates to prepare for 'go live' on 16 January and have now have advance access to the system to familiarise ourselves with this. We have been liaising with the communications team to ensure that relevant coms are issued after the election in February and in the meantime that a page with relevant information is available to the public.

2 MINUTES - 22 SEPTEMBER, 8 NOVEMBER AND 19 DECEMBER 2022

RESOLVED: That the Part 1 Minutes of the Meetings of the Committee held on 22 September, 8 November and 19 December 2022 be approved as a true record of the proceedings and be signed by the Chair.

3 NOTIFICATION OF OTHER BUSINESS

There was no other business notified.

4 CHAIR'S ANNOUNCEMENTS

- (1) The Chair advised that, in accordance with Council Policy, the meeting would be audio recorded:
- (2) Members were reminded that this Council had declared a Climate Emergency. This was a serious decision and meant that, as this was an emergency, all of us, officers and Members had that in mind as we carried out our various roles and tasks for the benefit of our District.
- (3) The Chair drew attention to the item on the agenda front pages regarding Declarations of Interest and reminded Members that, in line with the Code of Conduct, any Declarations of Interest needed to be declared immediately prior to the item in question.
- (4) The Chair clarified the rules of debate for Members.
- (5) The Chair advised that a comfort break would be taken at a suitable time in the proceedings, if required.
- (6) The Chair noted that the date of this Civic Reception had been moved to Sunday 19 March 2023.

5 PUBLIC PARTICIPATION

There was no public participation at this meeting.

In the absence of Councillor Moody, Councillor David Levett asked the question.

7 NOTICE OF MOTIONS

There were two motions submitted in accordance with Standing Order 4.8.12.

(A) Motion on Proportional Representation

RESOLVED: That Council:

- (1) Call upon the UK Government to commit to changing electoral law to permit the introduction of a PR system of voting in any reforms to local government presented to Parliament.
- (2) Instruct the Leader of the Council to write to North Hertfordshire District Council's three MPs to ask them to call for a change to electoral law to permit a PR system of voting and promote the matter for debate in Parliament.
- (B) Motion on Urgent unlocking the potential of local High Streets

RESOLVED: That Council will:

- (1) Write to the Government to urge it to scrap business rates and replace them with a system which is fit for purpose and which levels the playing field between bricks and mortar businesses and online retail giants.
- (2) Campaign to devolve funds like the Towns Fund, Levelling Up Fund, UK Shared Prosperity Fund and other national funding pots, to give local communities, councils and regions the ultimate say in how it is spent in their area.
- (3) Continue to take local action to revive our high streets, including:
 - a. Make any data that the Council can lawfully make public on ownership of high street properties public and in an accessible format, so that community groups seeking to buy empty shops through a community share offer have the information they need to do so.
 - b. Proactively contact landlords of vacant premises (and work with Chambers of Commerce, Landlord Associations and BID managers) to explore 'meanwhile use' options and/or encourage alternative rental models (e.g. turnover rather than market rent) to enable new co-operatives, SMEs, social enterprises and 'community owned' businesses to open their doors on the high street.

8 ITEMS REFERRED FROM OTHER COMMITTEES

8a) Referral from Finance, Audit and Risk Committee on 7 December 2022 – Annual Review of the Contract Procurement Rules

RESOLVED: That Council considered and adopted the proposed changes to the Contract Procurement Rules.

Thursday, 19th January, 2023

REASON FOR DECISION: The Contract Procurement Rules (CPR's) are part of the Constitution (under Section 20) and must be regularly reviewed and updated as part of the Council's governance and procurement review processes, contributing to the Council's system of effective internal control.

8b) Referral from Cabinet on 13 December 2022 – Second Quarter Investment Strategy (Capital and Treasury) Review 2022/23

RESOLVED: That Council noted the position of Treasury Management activity as at the end of September 2022.

REASON FOR DECISION: To ensure the Council's continued compliance with CIPFA's code of practice on Treasury Management and the Local Government Act 2003 and that the Council manages its exposure to interest and capital risk.

8c) Referral from Cabinet on 13 December 2022 – Council Tax Reduction Scheme 2023/2024

The Chair advised that this item would be taken with Agenda Item 9.

9 COUNCIL TAX REDUCTION SCHEME 2023/2024

RESOLVED: That council:

- (1) Noted that a full review of the Council Tax Reduction Scheme had taken place and that consultation with the public and Major Precepting Authorities had taken place.
- (2) Noted the aim of the review had been to introduce a new scheme that will:
 - enable us to increase the overall level of support for the lowest income households;
 - reduce the administrative burden placed on the Council following the introduction of Universal Credit and;
 - make the scheme easier for our customers to understand and calculate entitlement.
- (3) Approved the adoption of a new banded scheme for working age applicants from 01 April 2023.
- (4) Approved the use of the Council Tax Hardship Grant to fund a discretionary scheme to provide additional transitional support where appropriate and that decisions regarding Discretionary support are delegated to the Service Director Customers in consultation with the Executive Member for Finance and IT.
- (5) Noted that the new scheme may increase the costs from those of the current scheme, any increase will be split between the Council and its Major Precepting Authorities. The Council's share is expected to be around 12.5%.

REASON FOR DECISIONS: To ensure that the Council has a fit for purpose Council Tax Reduction Scheme that:

- Provides the greatest support to the lowest income households.
- Reduces the administrative burden that has been placed on the Council since the introduction of Universal Credit (UC).
- Is simple to understand, meaning that customers will be able to calculate entitlement and assess the impact of potential changes in circumstances.

10 REVIEW OF MEMBERS' ALLOWANCES SCHEME

RESOLVED: That Council:

- (1) Considered the report and recommendations of the IRP, as attached as Appendix A of the submitted report.
- (2) Agreed the Members' Allowances Scheme for 2023/2024 as set out in Appendix B of the submitted report, subject to the removal to restrict to only one Special Responsibility Allowance.
- (3) Agreed the increase to the Independent Person and Reserve Independent Persons allowances as detailed in 4.9 of Appendix A and 8.11 of this report.
- (4) Agreed the allowance to the Independent Non-Voting Member on the Finance, Audit and Risk Committee as detailed in 4.7 of Appendix A and 8.12 of this report.
- (5) Expressed appreciation to the IRP for their work over the last 4 years.

REASON FOR DECISIONS: To ensure that the Council meets its statutory requirements of an annual review and adoption of the scheme.

11 ELECTORAL SERVICES - SCALE OF FEES 2023/2024

RESOLVED: That the Council agreed the Scale of Fees for 2023/2024 as set out in Appendix A.

REASON FOR DECISION: To enable the Council to remunerate the Returning Officer and the staff employed to carry out tasks during electoral events and to be open and transparent regarding other payments.

12 CONSTITUTIONAL AMENDMENT REPORT

RESOLVED: That Council approved the amendments detailed in Appendix A, subject to the removal of proposed changes to Section 8 of the Constitution regarding the Planning Control Committee.

REASON FOR DECISION: To reflect good decision making practice and keep the Constitution up to date.

13 PENSION POOLING WITH ORPHANED BODIES

RESOLVED: That Council approved that North Hertfordshire District Council (as the relevant Admitted Body) be pooled with the following Orphaned Employers: Letchworth Garden City Town Council, Veolia ES Services team and Hitchin Markets.

REASONS FOR DECISION:

- (1) All of the Orphaned Employers (based on the 2019 valuation) have over 100% funding, which is better than the Council's funding position. Therefore, it is probably in the Council's best interest to be pooled with them.
- (2) In the case of Letchworth Garden City Town Council, Hertfordshire County Council (HCC) (as the Hertfordshire LGPS administrator) have legal advice that we are required to be pooled with LGCTC.

Mini forest planted in Hitchin thanks to Rotary

2,000 trees were planted at Swinburne Recreational Ground by around 75 volunteers at the weekend (Saturday 14 and Sunday 15 January), thanks to the Rotary Club of Hitchin Tilehouse.

Planned for over a year, the club wanted to create a mini forest in the town – a bit bigger than the size of a tennis court – which local people got involved with planting, to help raise environmental awareness and leave a lasting amenity. The small whip sized trees were planted by making a slit in the ground and adding a supporting cane tied to a biodegradable tree guard.

The dense fast-growing native woodland requires low management and maintenance after the first two years and no chemicals or fertilisers will be used. The rich biodiversity can attract a wider range of animal and plant species within its first three years. Restoring and improving biodiversity is our strongest natural defence against climate change.

Tim Ray, Rotary President, said: "It was a fabulous weekend and great to get it all done so quickly thanks to so many lovely and interesting people getting stuck in. And thanks to the council for their support and collaboration. Thankfully we didn't actually get too wet, just muddy!"

Sarah Kingsley, Place Director, added: "A massive thank you to the Rotary and all the volunteers, the mini forest looks great. The trees will store more and more carbon as they grow, and with the increased biodiversity, the area is another win for our fight against climate change."

St Mary's tree replaced

A new weeping willow has been planted (18 January) to replace the large tree which fell over in Hitchin's St Mary's churchyard last year.

The council provides grounds maintenance for the churchyard and has been working on a suitable replacement with the church and local people. Different options have been considered, including allowing the stump to re-shoot, but it was collectively decided that the best, safest and most practicable option was to completely remove the tree, and plant another in its place.

Sarah Kingsley, Place Director, said: "It was obviously sad to see such a prominent tree fall but we have done all we can to ensure that the new young specimen tree will be quick to establish and grow to a similar prominence.

"Part of the old trunk is already being used as a bench and reminder of such a prominent and attractive tree."
