1 **MEMORANDUM OF POINTS AND AUTHORITIES**

2 **I. INTRODUCTION**

3 Plaintiff moves the Court for an award of attorneys' fees, costs and
 4 incentive payment as part of this preliminarily approved class action settlement
 5 (see Dkt. No. 60 and 62) between plaintiff Lisa Kim ("Plaintiff") and defendants
 6 Tinder, Inc., Match Group, LLC and Match Group, Inc., (hereinafter referred to as
 7 "Defendants" or "Tinder").¹ Defendant does not oppose this Motion. The
 8 Settlement Agreement provides for a substantial financial benefit to the Class
 9 Members, of which there are an estimated 230,000.² The estimated Settlement
 10 benefit to the Class is \$23 million, which is comprised of three components: 1)
 11 \$11.5 million in guaranteed Super Likes under the universal participation
 12 component (not requiring submission of claims), 2) \$5.75 million in potential cash
 13 or cash-equivalent benefits is available to every Member who submits a claim, and
 14 3) an injunction providing for public injunctive relief against Defendants on behalf
 15 of the Class and all members of the California public, which is estimated at a value
 16 to Class Members of at least \$5.75 million. By any means this is a substantial
 17 settlement, insofar as it provides for recovery for a wide scope of consumers, who
 18 will receive meaningful relief, as well as an end to an allegedly unlawful practice.
 19 This robust Settlement on behalf of hundreds of thousands of consumers was
 20 achieved after hard-fought litigation, arm's length negotiations, and the careful and
 21 skilled efforts of Class Counsel.

22 The Settlement benefits that will be provided to Class Members will be
 23 completely and separately recoverably by all Class Members from the attorneys'

 over-inclusive rather than risk being under-inclusive.

1 fees that are requested herein. In deciding this Motion, the Court should give
 2 special consideration to the following: 1) Class Counsel negotiated the fees in this
 3 case completely separate and apart from any Class Member recovery, meaning that
 4 the only part which would benefit from a reduction of the fees would be Defendant,
 5 the one who is alleged to have violated the law and who has already agreed to the
 6 reasonableness of the fees requested herein; 2) As the Court noted in its Order
 7 Granting Preliminary Approval (Dkt. No. 60), the amount of attorney's fees sought
 8 was negotiated only after the Class Members' portion of the settlement had been
 9 negotiated fully, and with the oversight of one of the most respected neutral
 10 mediators in Southern California, meaning there is an absence of evidence of
 11 collusion (Dkt. No. 60 at Pg 12), and 3) the settlement benefits to Class Members
 12 are meaningful and robust, which the Court already found to be fair and adequate
 13 under the requirements of Rule 23(e) (Dkt. No. 60, and 62).

14 On March 1, 2019, the Court granted preliminary approval of the Settlement
 15 and its terms enumerated above, observing, that the Settlement appeared
 16 reasonable and disclosed no grounds to doubt its fairness. Dkt. No. 60. The Court
 17 preliminarily approved the fairness of the anticipated fees, taking particular note
 18 of the fact that fees were not negotiated or discussed at all between the parties until
 19 the class recovery was fully negotiated in principle, and also due to the fact that
 20 the fees requested were only approximately 5% of the Settlement Benefit to the
 21 Class. The Court noted that it would scrutinize the fee request at the final fairness
 22 hearing. Dkt. No. 60, Pg 12.

23 Federal Rules of Civil Procedure provide that “[i]n a certified class action,
 24 the court may award reasonable attorneys' fees and nontaxable costs that are
 25 authorized by law or by the parties agreement.” Fed. R. Civ. P. 23. As noted by
 26 Plaintiff's Motion for Preliminary Approval of Class Action Settlement and
 27 Certification of Settlement Class, which was approved by this Court (Dkt. No. 60
 28 and 62), the Settlement Agreement in this action resulted from extensive arm's

length negotiations, including a full-day mediation session before Hon. Judge Louis M. Meisinger (Ret.). Friedman Decl ¶ 17. The arm's length negotiations, especially those before Judge Meisinger, serve as "independent confirmation" of the reasonableness of the Settlement's terms including the attorneys' fees, costs, and incentive award sought by this Motion. *See Hanlon v. Chrysler Corp.*, 150 F.3d 1011, 1029 (9th Cir. 1998). Under these circumstances, the Court may give deference to the judgment of the parties regarding the reasonableness of the requested fees.

The reasonableness of the requested fees is also supported by the "percentage of-the-fund" and "lodestar" approach. The \$1,200,000 in attorneys' fees sought equates to approximately 5% of the estimated \$23,000,000 in settlement benefit provided to the Class, the majority of which is not subject to the claims process. This is but a small fraction of the Ninth Circuit's benchmark percentage of 25% for attorneys' fee awards. Additionally, Class Counsel have incurred a combined total of 669.95 hours litigating this action for a combined lodestar of \$411,237.75. Notably, Class Counsel estimate that they will spend approximately another 100-150 hours working on the case including overseeing the administration of class settlement benefits, communicating with class members, , responding to any potential objectors, moving for final approval, preparing for and attending the final approval hearing, and ensuring the final distribution of settlement benefits are carried out in full. Without taking into account these additional anticipated hours, the fee request currently represents a reasonable lodestar multiplier of 2.9, which serves as an independent cross check as to the reasonableness of the fee request.³

Through this fee brief, which is unopposed by Defendant, Plaintiff seeks Court approval of the agreed-upon costs and fees as follows: (1) attorneys' fees in

³ The Lodestar multiplier is estimated by counsel to be 2.3 once administration is complete.

1 the amount of \$1,200,000; (2) litigation costs in an amount of \$12,137.51; and (3)
2 an incentive award of \$5,000 to Plaintiff Lisa Kim. As more thoroughly stated
3 herein and as detailed in the supporting declaration filed herewith, these sums are
4 fair and reasonable as they resulted from extensive arm's length negotiations and
5 are further supported by the percentage-of-the-fund and loadstar methodologies.
6 Friedman Decl. ¶¶ 17-61.

7 **II. STATEMENT OF FACTS**

8 **A. Factual Background**

9 Tinder is a smartphone-based dating application that is used by consumers
10 throughout the world, including California. The core functionality of the app
11 enables users to view profiles of other users in the same geographic locale and to
12 either indicate an interest in (i.e., to "like") another user or, alternatively, indicate
13 a lack of interest. If two users indicate an interest in each other's profile, they can
14 then communicate with each other through the app. The app also allows a user to
15 indicate a heightened degree of interest in another user through a feature known as
16 a "Super Like." The app may be downloaded and used for free, but certain
17 additional or premium features can only be accessed by purchasing a subscription
18 to Tinder Plus or Tinder Gold. Such features include, among other things,
19 unlimited likes (whereas the free version has a daily limit), no paid advertisements,
20 the ability to undo dislikes, the ability to view profiles in other locales, and to
21 ability to exert more control over other variables involved in using the app. Also,
22 subscribers receive more free Super Likes than non-subscribers, but any user of the
23 app may purchase additional Super Likes for a typical price of 99 cents each.

24 Plaintiff, a female user over the age of 29, alleges that when she and Class
25 Members purchased Tinder premium services (Plus or Gold), Defendants
26 discriminated against such consumers based on age, by charging more money for
27 the same service for consumers age 29 and older. Plaintiff claims that Defendants'
28 widespread and uniform conduct is in direct violation of the Unruh Civil Rights

1 Act, *Cal. Civ. Code* §§ 51, et seq. (“Unruh Act”), which generally outlaws age
 2 discrimination by businesses operating in California. In addition, Plaintiff alleges
 3 that Defendants’ pricing scheme violates the Unfair Competition Law, *Cal. Bus.*
 4 & *Prof. Code* §§ 17200, et seq. (“UCL”). Plaintiff sought three categories of relief:
 5 1) monetary relief under the Unruh Act in the form of statutory penalties; 2)
 6 restitutionary relief, i.e. a refund of the unlawful premiums charged to users age 29
 7 or older (\$10 per month per user); and 3) public injunctive relief putting a halt to
 8 Defendants’ unlawful age-based price discrimination scheme. Defendants
 9 vigorously dispute Plaintiff’s claims, dispute that Plaintiff will prevail on her
 10 appeal of the Court’s Order granting Defendants’ motion to compel arbitration, and
 11 deny all charges of wrongdoing or liability asserted against them in the Litigation.

12 **B. Proceedings to Date**

13 On April 12, 2018, Plaintiff filed her class action lawsuit against Defendants,
 14 alleging that Defendants violated the Unruh Act. Defendants responded on June
 15 11, 2018 by filing filed a Motion to Compel Arbitration or Stay Under the Colorado
 16 Abstention Doctrine. On June 22, 2018, Plaintiff filed her First Amended
 17 Complaint, adding the UCL cause of action for public injunctive relief. In their
 18 Motion, Defendants claimed that Plaintiff had entered into an arbitration agreement
 19 based on her alleged assent to the arbitration provision in Tinder app’s Term of
 20 Use through the use of “sign-up wrap” consent in order to access the app.
 21 Defendants’ Motion to Compel Arbitration was granted on July 5, 2018, and the
 22 Court compelled Plaintiff’s claims to arbitration.

23 On July 16, 2018, Plaintiff filed her appeal of the Court’s decision on the
 24 Motion, based on her position that the Court did not appropriately consider
 25 California Supreme Court precedent interpreting substantive California law in
 26 *McGill v. Citibank, N.A.*, 2 Cal.5th 945 (2017), which states that claims for public
 27 injunctive relief, such as the one brought in Plaintiff’s case under the UCL, cannot
 28 be compelled to arbitration. In addition, Plaintiff would argue that the Court

1 disregarded recent relevant appellate case law, *Cullinane v. Uber Technology, Inc.*
 2 893 F.3d 53 (1st Cir. 2018), which bore directly on whether there was appropriate
 3 assent by Plaintiff and the Class Members to the Tinder app's Term of Use.⁴

4 A mediation was scheduled for November 29, 2018, and the Parties
 5 stipulated to continue the initial briefing deadlines in the appeal. The Parties
 6 attended a mediation with Judge Meisinger on November 29, 2018. The Parties
 7 did not resolve the case at the mediation, but engaged in subsequent discussions
 8 with Judge Meisinger. With his guidance, this Settlement was reached on
 9 December 1, 2018. On March 1, 2019, the Honorable Court granted Plaintiff's
 10 Motion for Preliminary Approval, finding that the requirements of Rule 23(e) were
 11 preliminarily satisfied. Dkt. No. 60. The Court requested that counsel file a revised
 12 proposed notice, and lodge a revised proposed order granting preliminary approval.
 13 Dkt. No. 60 Pg. 13. Counsel did so. Dkt. No. 61. The Court thereafter granted
 14 preliminary approval. Dkt. No. 62.

15 **C. Class Notice Was Successfully Disseminated**

16 On April 5, 2019, Epiq disseminated the Class Notice to Class Members via
 17 email, as was approved as the best notice practicable by This Honorable Court.
 18 The email campaign was highly successful at delivering targeted notice directly to
 19 the hands of Class Members, who almost certainly all used smartphone devices
 20 hooked to these same email accounts as part of their everyday life. Friedman Decl.
 21 ¶¶ 24-30. Epiq reported that approximately 85% of the Class Members received
 22 direct notice, much higher than the 70% threshold that the Rule 23 guidelines
 23 specify for due process purposes. Epic was able to send 240,592 emails to Class
 24 Members, with 203,741 of those emails delivered. Email addresses for all but 19
 25

26 ⁴ The *Cullinane* opinion was rendered the same day Plaintiff's opposition to
 27 Defendants' Motion was due, leaving Plaintiff no time to incorporate arguments
 28 and facts related to the on-point case into her opposition. The Court did not consider
 Plaintiff's Notice of the new case, and denied Plaintiff's Ex Parte Application.

1 of the Class Members were located in Tinder's records. *Id.* Since that time, neither
2 Plaintiffs' counsel nor Defense counsel have received any objections from absent
3 Class Members, and only one individual has expressed a desire to opt out of the
4 settlement as of the time of the filing of this Motion. *Id.*

5 **III. THE SETTLEMENT**

6 **A. The Settlement Class.**

7 The "Settlement Class" is defined in the Agreement as follows:

8 *"Every California subscriber to Tinder Plus or Tinder Gold
9 during the Class Period who at the time of subscribing was at
10 least 29 years old and was charged a higher rate than
11 younger subscribers, except those who choose to opt out of
12 the Settlement Class."* (Agreement § 2.21.)

13 The Class Period is from March 2, 2015 through the date that the Court grants
14 preliminary approval of the Settlement. (*Id.* § 2.6.) Defendants maintain email
15 addresses for the vast majority of users of the app, and based on data provided by
16 Defendants and their counsel, the Class contains approximately 230,000 Members.

17 **B. Settlement Benefits.**

18 Under the Settlement, Defendants agree to a multifaceted Settlement
19 structure, which includes a universal participation component (automatic benefits
20 to all Class Members); an additional cash or cash-equivalent payout to Class
21 Members who submit timely valid claims; and an agreement to substantially halt
22 Defendants' allegedly discriminatory practices going forward. Attorneys' fees,
23 costs, administration expenses, and the Incentive Payment to Plaintiff will all be
24 separately paid by Defendants. These benefits are significant, tangible and offer
25 fair remuneration for the Class.

26 Pursuant to the Agreement, Class Notice will be sent via email to the
27 approximately 230,000 persons in the Settlement Class. (Agreement § 1.4, 4.3-4.4;
28 Ex A-2). The Class Notice will explain that if the Member has a Tinder account,
or has reactivated a Tinder account associated with the same email address that

1 pertained to his or her previous account, the Member will automatically receive 50
 2 Super Likes (equivalent to \$50 in value). *Id.* This benefit will be issued to each
 3 and every Class Member irrespective of whether the Member submits a claim. In
 4 addition, each Member may submit a claim form to obtain one of the following
 5 benefits: (1) \$25.00 in cash; (2) 25 Super Likes (but only if the Member has a
 6 Tinder account); or (3) a one-month subscription of Tinder Plus or Tinder Gold,
 7 depending on which of those services the Member had previously purchased (but
 8 only if the Member does not already have a subscription). (Agreement § 3.2-3.3).
 9 In addition to foregoing monetary relief, Defendants have agreed to alter their
 10 practices and largely halt their price differentiation practices in California as they
 11 pertain to age. *Id.* at ¶ 3.4. Plaintiff estimates this revision to pricing
 12 discrimination is worth at least \$5.75 million to the Class. Friedman Decl. ¶ 34.

13 Separate and apart from these Class benefits, Defendants have agreed to
 14 retain a Settlement Administrator and to pay for any and all costs associated with
 15 administering the Settlement, including Class and CAFA Notice, handling of
 16 claims and the distribution of monetary payments to Members who choose that
 17 option, and developing and maintaining the Settlement Website. (Agreement §§
 18 4.3-4.5, 5.4). Defendants have also agreed to pay the proposed \$5,000.00 Incentive
 19 Payment to the Plaintiff (Agreement § 7.2) and the proposed Attorneys' Fee Award
 20 in the amount of \$1,200,000.00 plus reasonable Cost Reimbursement to Class
 21 Counsel, pending approval by the Court. (Agreement § 7.1). Class Notice was
 22 provided on April 5, 2019, giving Class Members ample time and notice in advance
 23 of the Final Approval Hearing.⁵ (Agreement § 4.9). Before Class Notice is
 24 provided, the Settlement Administrator will develop the Settlement Website,

25 ⁵ Email is the best notice practicable because Defendants generally maintain email
 26 address data for Class Members but not physical addresses or other information
 27 (such as landline phone numbers) that would permit Class Counsel to efficiently
 28 conduct a reverse lookup and send mail notice. Given the 85% successful
 transmission rate of the email notice, due process has been satisfied.

1 which shall contain relevant documents pertaining to the Settlement including the
 2 Settlement Agreement, the Claim Form, the Class Notice, and the Preliminary
 3 Approval Order. (Agreement §§ 4.5, 5.2). Under the terms of the proposed
 4 Settlement, Members will have the right to opt out of the Settlement or object to
 5 its terms. A Member who wishes to opt out of the Settlement must, no later than
 6 30 days after the Class Notice Date, mail an opt-out request to counsel for the
 7 Parties. (Agreement § 4.8). A Member who does not opt out and who wishes to
 8 object to the Settlement may do so by filing with the Court and mailing to counsel
 9 for the Parties, no later than May 6, 2019. Dkt. No. 60; Agreement § 4.7.

10 The Settlement contemplates that Class Counsel may apply to the Court for
 11 an award of attorneys' fees in the amount of \$1,200,000.00 (plus reimbursement
 12 of costs), representing 5% of the total estimated value of the Settlement (including
 13 the value of the injunctive component), which provides significant value to the
 14 Class. Defendants have agreed not to oppose an application by Class Counsel for
 15 an award of attorneys' fees and costs, as long as it does not exceed this stated
 16 amount. (Agreement § 7.1). The Settlement contemplates that Class Counsel will
 17 request an Incentive Award in the amount of \$5,000.00 to be distributed to the
 18 Class Representative, subject to Court approval. Defendants have agreed not to
 19 oppose this request. (Agreement § 7.2).

20 **IV. ARGUMENT**

21 **A. The Requested Fee Award Is Fair, Reasonable And Justified**

22 Class Counsel respectfully assert that (A) the requested fee award of
 23 \$1,200,000 is fair, reasonable, and justified; and (B) the payment of \$12,137.51 in
 24 costs is fair and reasonable. Friedman Decl., ¶¶ 17-61. The Federal Rules of Civil
 25 Procedure provide that “[i]n a certified class action, the court may award
 26 reasonable attorneys' fees and nontaxable costs that are authorized by law or by
 27 the parties agreement.” Fed. R. Civ. P. 23(h) (emphasis added). As explained by
 28 the Ninth Circuit, “[a]ttorneys' fees provisions included in proposed class action

1 settlement agreements are, like every other aspect of such agreements, subject to
 2 the determination whether the settlement is ‘fundamentally fair, adequate, and
 3 reasonable.’” *Staton v. Boeing Co.*, 327 F.3d 938, 963 (9th Cir. 2003). In common
 4 fund cases, Courts within the Ninth Circuit have discretion to use one of two
 5 methods to determine whether the fee request is reasonable: (1) percentage-of-the-
 6 fund; or, (2) lodestar plus a risk multiplier. *Staton*, 327 F.3d at 967-68. *See also*
 7 *In re Mercury Interactive Corp.*, 618 F.3d 988, 992 (9th Cir. 2010). “Though
 8 courts have discretion to choose which calculation method they use, their
 9 discretion must be exercised so as to achieve a reasonable result.” *In re Bluetooth*
 10 *Headset Prods. Liab. Litig.*, 654 F.3d 935, 942 (9th Cir. 2011).

11 Class Counsel maintain the request for attorneys’ fees is reasonable based
 12 solely upon the arm’s length formal negotiations that serve as independent
 13 confirmation of the fairness of the settlement, including attorneys’ fees. *See*
 14 *Hanlon*, 150 F.3d at 1029. However, the requested fees are also fully supported
 15 under the percentage-of-the-fund and lodestar approach, which Class Counsel offer
 16 as an additional and optional means of cross-checking the requested fees.

17 **1. The Requested Fees Resulted from Arm’s Length
 18 Negotiations**

19 While attorneys’ fee provisions included in class action settlements are
 20 subject to the determination of whether the provision is fundamentally fair,
 21 adequate and reasonable, the Ninth Circuit has opined that “the court’s intrusion
 22 upon what is otherwise a private consensual agreement negotiated between the
 23 parties to a lawsuit must be limited to the extent necessary to reach a reasoned
 24 judgment that the agreement is not the product of fraud or overreaching by, or
 25 collusion between, the negotiating parties, and that the settlement, taken as a
 26 whole, is fair, reasonable and adequate to all concerned.” *Hanlon*, 150 F.3d at
 27 1027 (citing *Officers for Justice v. Civil Serv. Comm’n of City & Cnty. of San*
 28

1 *Francisco*, 688 F.2d 615, 625 (9th Cir. 1982)) (emphasis added). *See also Lundell*
 2 *v. Dell, Inc.*, CIVA C05-3970 JWRS, 2006 WL 3507938 (N.D. Cal. Dec. 5, 2006).

3 In *Hanlon*, the Ninth Circuit went on to state that where settlement terms,
 4 including attorneys' fees, are reached through formal mediation, the Court may
 5 rely upon the mediation proceedings "as independent confirmation that the fee was
 6 not the result of collusion or a sacrifice of the interests of the class." *Hanlon*, 150
 7 F.3d at 1029.⁶ Here and as previously stated in Plaintiff's Motion For Preliminary
 8 Approval of Class Action Settlement and Certification of Settlement Class, which
 9 this Court has approved (Dkt. No. 60 and 62), the Settlement Agreement resulted
 10 from extensive arm's length negotiations. Friedman Decl. ¶¶ 17-19. More
 11 specifically, the Parties attended a full-day mediation session with the Honorable
 12 Louis M. Meisinger (Ret.), where the parties were able to agree on the terms of a
 13 settlement agreement. *Id.* The parties had also conducted extensive informal and
 14 formal discovery surrounding Plaintiff's claims and Defendant's defenses. Agr. §
 15 c; Friedman Decl., ¶¶ 4-19. Additionally, and as noted by The Court in its Order
 16 Granting Preliminary Approval, the attorneys' fees sought were not discussed at
 17 all during settlement negotiations at mediation until after the Class Members'
 18 portion of the recovery had been fully negotiated in principle. Dkt. No. 60 Pg. 12.
 19 Under these circumstances, the Court may give deference to the mediation
 20 proceedings and the judgment of the Parties regarding the reasonableness of fees.

21 ⁶ *See also Milliron v. T-Mobile USA, Inc.*, 2009 WL 3345762, at *5 (D.N.J. Sept.
 22 14, 2009) ("the participation of an independent mediator in settlement negotiation
 23 virtually insures that the negotiations were conducted at arm's length and without
 24 collusion between the parties"); *Sandoval v. Tharaldson Emp. Mgmt., Inc.*, 2010
 25 WL 2486346, at *6 (C.D. Cal. June 15, 2010) ("the assistance of an experienced
 26 mediator in the settlement process confirms that the settlement is non-collusive");
 27 *Dennis v. Kellogg Co.*, 2010 WL 4285011, at *4 (S.D. Cal. Oct. 14, 2010) (the
 28 parties engaged in a "full-day mediation session," which helped to establish that the
 proposed settlement was noncollusive). *See also* 2 McLaughlin on Class Actions,
 § 6:7 (8th ed.) ("A settlement reached after a supervised mediation receives a
 presumption of reasonableness and the absence of collusion").

1 However, the requested fee is also wholly supported by the both the percentage-
 2 of-the-fund and lodestar methods, which the Court may employ as a means of
 3 assessing the reasonableness of the requested fee.

4 **2. The Requested Fees are Reasonable, Fair, and Justified
 5 Under the Percentage-of-the-Fund Method**

6 Courts consider a number of factors to determine the appropriate percentage
 7 of the fund to awarding as attorneys' fees in a common fund case including: (a) the
 8 results achieved; (b) the risk of litigation; (c) the skill required and the quality of
 9 work; (d) the contingent nature of the fee; and, (e) awards made in similar cases.

10 *Vizcaino v. Microsoft Corp.*, 290 F.3d 1043, 1047, 1048-1050 (9th Cir. 2002). The
 11 "benchmark" percentage for attorney's fees in the Ninth Circuit is 25% of the
 12 common fund with costs and expenses awarded in addition to this amount.

13 *Vizcaino*, 290 F.3d at 1047. "However, in most common fund cases, the award
 14 exceeds that [25%] benchmark." *In re Omnivision Techs.*, 559 F. Supp. 2d 1036,
 15 1047 (N.D. Cal. 2007) (citing *In re Activision Sec. Litig.*, 723 F. Supp. 1373, 1378
 16 (N.D. Cal. 1998)). Both the *Omnivision* and *Activision* Courts concluded that
 17 "Absent extraordinary circumstances that suggest reasons to lower or increase the
 18 percentage, the rate should be set at 30%." *Omnivision*, 559 F. Supp. 2d at 1048.

19 Class Counsel's request for attorneys' fees in the amount of \$1,200,000
 20 equates to only approximately 5% of the Settlement Benefits negotiated as part of
 21 the Settlement Agreement. This falls far below the Ninth Circuit's benchmark. In
 22 most cases, the benchmark 25% in attorneys' fees are most often paid from the
 23 fund, thereby reducing class members' recovery, which is not how this agreement
 24 is structured. In fact, Defendant is agreeing to pay fees completely separate from
 25 the Class Members' recoveries, which makes this Settlement Structure even more
 26 favorable for Class Members, and makes the fee request even more reasonable.
 27 The Court does not need to be concerned that the funds paid to Class Counsel will
 28 be coming out of the pockets of Class members. Moreover, the fee request is fully

1 supported by the factors enunciated in *Vizcaino* including: (a) the results achieved;
 2 (b) the risk of litigation; (c) the skill required and the quality of work; (d) the
 3 contingent nature of the fee; and, (e) awards made in similar cases.

4 **a. Class Counsel Obtained Excellent Results for the Class**

5 The results obtained for the class are generally considered to be the most
 6 important factor in determining the appropriate fee award in a common fund case.
 7 *See Hensley v. Eckerhart*, 461 U.S. 424, 435 (1983); *Omnivision*, 559 F. Supp. 2d
 8 at 1046. *See also* Federal Judicial Center, Manual for Complex Litigation, § 27.71,
 9 p. 336 (4th Ed. 2004) (the “fundamental focus is on the result actually achieved for
 10 class members”) (citing Fed. R. Civ. P. 23(h) committee note). Standing alone,
 11 this factor supports Class Counsel’s fee request. The settlement secured by
 12 Plaintiff and Class Counsel provides an excellent recovery for Class Members.
 13 The three-pronged recovery provided to Class Members ensures that Class
 14 Members all will benefit from the agreement, that additional monetary relief will
 15 be available to participating Class Members, and that Defendant will halt its
 16 alleged unlawful price discrimination, which was one of the core goals of the
 17 litigation. As a result, it is anticipated that the vast majority of the Settlement will
 18 provide direct and meaningful benefits to the Settlement Class.⁷

19 This Settlement intentionally avoids providing significant benefits to a *cy*
 20 *pres* recipient at the expense of the class. *See Dennis v. Kellogg Co.*, 697 F.3d 858,
 21 862-63 (9th Cir. 2012) (the amount of a *cy pres* award “must be examined with
 22 great care to eliminate the possibility that it serves only the ‘self-interests’ of the

23 ⁷ *See Shames v. Hertz Corp.*, Case No. 07-CV-2174-MMA WMC, 2012 WL
 24 5392159 at *13 (S.D. Cal. Nov. 5, 2012) (settlement was fair where the parties
 25 “negotiated a settlement that provide[d] direct payment to class members”); *Hopson*
 26 v. *Hanesbrands Inc.*, Case No. CV-08-0844 EDL, 2009 WL 928133, at *11 (N.D.
 27 Cal. Apr. 3, 2009) (“the benefits can be accurately traced because they are monetary
 28 payments directly to Class Members”); *Briggs v. United States*, Case No. C 07-05760 WHA, 2010 WL 1759457 (N.D. Cal. Apr. 30, 2010) (settlement agreement
 was fair where it did not require class members to file claim forms).

1 attorneys and the parties, and not the class”); *Lane v. Facebook, Inc.*, 709 F.3d 791,
 2 793 (9th Cir. 2013) (“We require district judges to be reasonably certain that class
 3 members will benefit before approving a *cy pres* settlement.”); *In re EasySaver
 4 Rewards Litig.*, 921 F. Supp. 2d 1040, 1049 (S.D. Cal. 2013).⁸

5 The settlement award that each Settlement Class Member will receive is fair,
 6 appropriate, and reasonable given the purposes of the Unruh Act and UCL and in
 7 light of the anticipated risk, expense, and uncertainty of continued litigation.
 8 Although the Unruh Act provides for statutory damages of \$4,000.00 per violation,
 9 it is well-settled that a proposed settlement may be acceptable even though it
 10 amounts to a percentage of the potential recovery that might be available to the
 11 class members at trial.⁹ Indeed, California Appellate Courts have upheld the
 12 reasonableness of Unruh Act class action settlements which provided for no
 13 monetary relief, but rather only injunctive relief. *See Carter v. City of Los Angeles*,
 14 224 Cal.App.4th 808 (2014) (injunction only class settlement under Unruh Act
 15 upheld as fair and reasonable, however overturning district court order based solely
 16 on the fact that non-opt out provision violated due process). The case at bar not

17 ⁸ Courts favor payment to class members over *cy pres*. *See Molski v. Gleich*, 318
 18 F.3d 937, 954-55 (9th Cir. 2003) *overruled on other grounds by Dukes v. Wal-*
 19 *Mart Stores, Inc.*, 603 F.3d 571 (9th Cir. 2010) (*cy pres* provision is a disfavored
 20 substitute for distribution of benefits directly to class members); *Nachshin v. AOL,*
LLC, 663 F.3d 1034, 1038 (9th Cir. 2011) (“[T]he *cy pres* doctrine—unbridled by
 21 a driving nexus between the plaintiff class and the *cy pres* beneficiaries—poses
 22 many nascent dangers to the fairness of the distribution process.”).

23 ⁹ *See e.g., National Rural Tele. Coop. v. DIRECTV, Inc.*, 221 F.R.D. 523, 527 (C.D.
 24 Cal. 2004) (“well settled law that a proposed settlement may be acceptable even
 25 though it amounts to only a fraction of the potential recovery”); *In re Global*
Crossing Sec. and ERISA Litig., 225 F.R.D. 436, 460 (E.D. Pa. 2000) (“the fact that
 26 a proposed settlement constitutes a relatively small percentage of the most
 27 optimistic estimate does not, in itself, weigh against the settlement; rather, the
 28 percentage should be considered in light of the strength of the claims”); *In re*
Omnivision Tech., Inc., 559 F. Supp. 2d 1036 (N.D. Cal. Jan. 9, 2008) (court-
 approved settlement amount that was small fraction of the maximum potential
 recovery); *In re Mego Fin'l Corp. Sec. Litig.*, 213 F. 3d 454, 459 (9th Cir. 2000).

1 only provides meaningful injunctive relief, but also provides a universal
 2 participation component via the automatic provision of Super Likes to Class
 3 Members, as well as a monetary relief component to any Class members who
 4 participate in the filing of a claim form. As such, the benefits to Class Members
 5 far exceed the result achieved in other Unruh Act and UCL actions.

6 **b. The Risks of Litigation Support the Requested Fees**

7 “The risk that further litigation might result in Plaintiffs not recovering at
 8 all, particularly a case involving complicated legal issues, is a significant factor in
 9 the award of fees.” *Omnivision*, 559 F. Supp. 2d at 1046-47. *See also Vizcaino*,
 10 290 F.3d at 1048 (risk of dismissal or loss on class certification is relevant to
 11 evaluation of a requested fee). Throughout litigation and mediation, Defendants
 12 have vigorously contested the claims asserted by Plaintiff. While both sides
 13 strongly believe in the merits of their respective cases, there are risks to both sides
 14 in continuing the Litigation. If the Litigation were to continue, the primary initial
 15 challenge for Plaintiff would be overcoming the pending appeal. Defendants
 16 represented that over 95% of the Class Members entered into arbitration
 17 agreements such as the one entered into by Plaintiff. The Ninth Circuit has recently
 18 held that such agreements can be a bar to class certification under the right
 19 circumstances. *See O'Connor v. Uber Technologies, Inc.*, 904 F.3d 1087 (9th Cir.
 20 2018). Even if Plaintiff won her appeal, Defendants would likely challenge any
 21 class certification motion made by Plaintiff, thereby placing in doubt whether
 22 certification of a class could be obtained and/or maintained in the Litigation. Also,
 23 additional substantive challenges to the claims might be raised, including a
 24 challenge on summary judgment. In considering the Settlement, Plaintiff and Class
 25 Counsel carefully balanced the risks of continuing to engage in protracted and
 26 contentious litigation, against the benefits to the Class.

27 Similarly, Defendants believe that they have strong and meritorious defenses
 28

1 not only in the Litigation as a whole, as well as on the appeal, but also as to class
2 certification and the amount of damages sought. However, Defendants recognize
3 that if a class were certified, there is some risk of a damages award substantially
4 higher than the value of the Settlement. The negotiated Settlement reflects a
5 compromise between avoiding that risk and the risk that the Class might not
6 recover. These risks put the strength of the settlement achieved by Class Counsel
7 into context. Because of the costs, risks to both sides, and delays of continued
8 litigation, the Settlement presents a fair and reasonable alternative to continuing to
9 pursue the Litigation.

10 In considering the Settlement, Plaintiff and Class Counsel carefully balanced
11 the risks of continuing to engage in protracted and contentious litigation against
12 the benefits to the Class including the significant benefit and the deterrent effects
13 it would have. As a result, Class Counsel supports the Settlement and seeks its
14 Approval. *Id.* . The negotiated Settlement is a compromise avoiding the risk that
15 the class might not recover and presents a fair and reasonable alternative to
16 continuing to pursue the Action as a class action for alleged violations of the Unruh
17 Act and UCL. Furthermore, Judge Meisiger, who is intimately familiar with the
18 instant litigation as well as the current climate of UCL and Unruh Act litigation as
19 a whole, agrees with the parties. The Honorable Court agreed with this reasoning
20 in preliminarily approving the settlement. Thus, the risks of continued litigation
21 not only depicts the high degree of results obtained for the Class, but also further
22 support the reasonableness of the requested fees.

23 **c. The Skill Required and Quality of Work Performed
24 Support the Requested Fees**

25 The “prosecution and management of a complex [] class action requires
26 unique legal skills and abilities” that are to be considered when evaluating fees.
27 *Omnivision*, 559 F. Supp. 2d at 1047. Class Counsel are experienced class action
28 litigators who have been appointed “class counsel” in numerous UCL and related

1 consumer protection class actions. Class Counsel have successfully prosecuted
 2 numerous complex consumer class actions, and secured noteworthy recoveries for
 3 those classes. Class Counsel's proven track record demonstrates not only the
 4 quality of work performed, but also the skill required to successfully prosecute
 5 large complex class actions. Friedman Decl. ¶¶ 31-37; Kristensen Decl. ¶¶ 16-38.

6 Class Counsel performed significant factual investigation prior to bringing
 7 the action, going back three years to a prior action where the Unruh Act claims at
 8 issue in this litigation were first alleged by Class Counsel. Friedman Decl. ¶¶ 4-8.
 9 Class Counsel conducted extensive discovery into the scope of the violations as
 10 well as the legal and procedural challenges in the case. Nobody could say that this
 11 case was not fully investigated, or thoroughly and vigorously litigated. Class
 12 Counsel requested and was provided with all necessary information necessary to
 13 make a meaningful settlement decision on behalf of the Class, and vigorously
 14 negotiated for and secured this robust and highly favorable result during a full-day
 15 mediations session. Thus, Class Counsels' skill and expertise, reflected in the
 16 prompt and significant Settlement, supports the requested fees.

17 **d. Class Counsels' Undertaking of this Action on a**
 18 **Contingency-Fee Basis Supports the Requested Fees**

19 The Ninth Circuit has long recognized that the public interest is served by
 20 rewarding attorneys who undertake representation on a contingent basis by
 21 compensating them for the risk that they might never be paid for their work. *In re*
 22 *Washington Pub. Power Supply Sys. Sec. Litig.*, 19 F.3d 1291, 1299 (9th Cir. 1994)
 23 (“Contingent fees that may far exceed the market value of the services if rendered
 24 on a non-contingent basis are accepted in the legal profession as a legitimate way
 25 of assuring competent representation for Plaintiffs who could not afford to pay on
 26 an hourly basis regardless of whether they win or lose”); *Vizcaino*, 290 F.3d at
 27 1051 (courts reward successful class counsel in contingency cases “for taking risk
 28 of nonpayment by paying them a premium over their normal hourly rates”).

1 Class Counsel prosecuted this matter on a purely contingent basis while
2 agreeing to advance all necessary expenses knowing that Class Counsel would only
3 receive a fee if there were a recovery. *See* Friedman Decl., ¶¶ 38-60. In pursuit of
4 this litigation, Class Counsel have spent considerable outlays of time and money
5 by, among other things, (1) investigating the actions; (2) conducting discovery on
6 Defendant; (3) opposing motions; (4) filing an appeal; (5) negotiating the
7 Settlement in private mediation; (6) Class counsel will also be required to oversee
8 administration of the Settlement; and, (7) respond to Class Member inquiries.
9 Class Counsel expended these resources despite the risk that Class Counsel may
10 never be compensated especially in light of the fluctuating interpretations of the
11 merits issues, certification issues, and arbitration issues, and the difficulty in
12 securing class certification.

13 Class Counsel here incurred \$12,137.51 in costs (as of April 22, 2019) and
14 spent 669.95 hours litigating this action. Friedman Decl., ¶¶ 33-51 and Ex. A;
15 Kristensen Decl ¶ 16-38; Ex 1. There were no guarantees of victory, and there
16 were numerous risks raised by Defendant. Thus, Class Counsels' "substantial
17 outlay, when there is a risk that none of it will be recovered, further supports the
18 award of the requested fees" in this matter. *Omnivision*, 559 F. Supp. 2d at 1047.
19 As articulated above, the percentage-of-the-fund method is the preferred and most
20 widely used method for determining attorneys' fees. The requested fees are fully
21 supported by the factors enunciated by *Vizcaino* and is commensurate with the
22 excellent results obtained for the Class. While the requested fees are fully
23 supported by the percentage-of-the-fund method, it should again be noted that the
24 application of the percentage-of-the-fund method is optional and may be applied
25 at the Court's discretion. In addition, the Court may also apply the lodestar method
26 as another optional means of cross- checking the requested fees.

27
28

1 **3. The Requested Fee is Reasonable, Fair, and Justified Under**
 2 **the Lodestar Method**

3 A court applying the percentage-of-the-fund method may use the lodestar
 4 method as a “cross-check on the reasonableness of a percentage figure.” *Vizcaino*,
 5 290 F.3d at 1050. However, a cross-check is optional. *See Glass v. UBS Fin.*
 6 *Servs.*, 2007 U.S. Dist. LEXIS 8476, at *48 (N.D. Cal. Jan. 26, 2007) (finding that
 7 “where the early settlement resulted in a significant benefit to the class,” there is
 8 no need “to conduct a lodestar cross-check”). If the Court chooses to perform such
 9 a cross-check in this matter, it will confirm that an approximately 5% fee award of
 10 \$1,200,000 is reasonable. The first step in the lodestar-multiplier approach is to
 11 multiply the number of hours counsel reasonably expended by a reasonable hourly
 12 rate. *Hanlon*, 150 F.3d at 1029. Once this raw lodestar figure is determined, the
 13 Court may then adjust that figure based upon its consideration of many of the same
 14 “enhancement” factors considered in the percentage-of-the-fund analysis, such as:
 15 (1) the results obtained; (2) whether fee is fixed or contingent; (3) the complexity
 16 of the issues involved; (4) the preclusion of the other employment due to
 17 acceptance of the case; and, (5) the experience, reputation, and ability of the
 18 attorneys. *See Kerr v. Screen Extras Guild, Inc.*, 526 F.2d 67, 70 (9th Cir. 1975).¹⁰

19 **a. Class Counsels’ Lodestar is Reasonable**

20 The accompanying declaration of Class Counsel set forth the hours of work
 21 and billing rates used to calculate their lodestar. Plaintiff’s attorneys’ work is
 22 summarized as follows:

23
 24
 25 ¹⁰ The risk inherent in contingency representation is a critical factor. The Ninth
 26 Circuit stresses that “[i]t is an abuse of discretion to fail to apply a risk multiplier
 27 when...there is evidence that the case was risky.” *Fischel v. Equit. Life Assurance*
 28 *Soc’y*, 307 F.3d 997, 1008 (9th Cir. 2002); *see also Glass v. UBS Fin. Servs., Inc.*,
 2007 WL 221862, at *16 (N.D. Cal. 2007).

16 Friedman Decl. ¶¶ 57-60; Ex A; Kristensen Decl. ¶¶ 16-38, Ex 1. As described in
 17 the accompanying declarations, Plaintiff's attorneys have devoted a total of 669.95
 18 hours to this litigation to date, and have a total lodestar to date of \$411,237.75
 19 which represents approximately a 2.9 multiplier. *See* Friedman Decl. ¶¶ 43-60. It
 20 is estimated that the lodestar multiplier will be approximately 2.3 by the time
 21 administration is completed. *Id.*

22 Thus, Class Counsel's lodestar is reasonable. Class Counsel prosecuted the
 23 claims at issue efficiently and effectively, making every effort to prevent the
 24 duplication of work that might have resulted from having multiple firms working
 25 on this case. In this regard, tasks were reasonably divided among attorneys to
 26 ensure avoiding the replication of work. Further, tasks were delegated
 27 appropriately among partners, associate attorneys, paralegals, and other staff
 28 according to their complexity such that the attorneys with higher billing rates billed

1 time only where necessary. The reality is that the complexity of this matter was
 2 high, and required senior attorneys to handle to majority of tasks. In addition,
 3 Class Counsels' contemporaneous time records were carefully reviewed.
 4 Friedman Decl., ¶ 57-60, Ex A; Kristensen Decl. ¶¶ 33-37, Ex. A.

5 **b. A Modest Lodestar Multiplier Is Warranted**

6 A lodestar multiplier in this case is appropriate given the various factors
 7 outlined under prevailing Ninth Circuit jurisprudence. *Kerr v. Screen Extras*
 8 *Guild, Inc.*, 526 F.2d 67, 70 (9th Cir. 1975). There can be no doubt that the result
 9 achieved was robust, widespread in scope, and meaningful. Class Counsel set out
 10 to hold Defendant accountable for its price discrimination, and successfully
 11 achieved a settlement which provides for an estimated \$23 million in class-wide
 12 relief, and put an end to the very practices that were the subject of this litigation.
 13 The first Ninth Circuit factor heavily supports a reasonable enhancement.

14 Second, the fees earned in this matter were entirely contingent. Class
 15 Counsel have been paid nothing to date, and would have been paid nothing had
 16 they not been able to achieve the robust settlement that has been approved
 17 preliminarily by The Court. Indeed, This Court's order granting Defendant's
 18 Motion to Compel Arbitration, which sparked the subsequent Ninth Circuit appeal
 19 by Plaintiff, and eventually resulted in a settlement dialogue between the Parties,
 20 shows the high stakes at issue for Class Members – Class Members could have
 21 received nothing if the Court's Order was upheld on appeal, or if Class Counsel
 22 had not continued to vigorously fight on behalf of Class Members' rights. This is
 23 the very definition of risk that the Ninth Circuit has held would be improper to
 24 ignore when considering whether and to what extent to grant a lodestar multiplier.
Fischel v. Equit. Life Assurance Soc'y, 307 F.3d 997, 1008 (9th Cir. 2002).

25 Third, this matter is a complex class action involving complicated and novel
 26 procedural and legal issues which are actively in flux, including the legality of the
 27
 28

1 alleged conduct by Defendant under applicable law, the arbitrability of public
 2 injunctive relief claims under the UCL, as guided by the recent *McGill v Citibank*
 3 matter, and the enforceability of Defendants' arbitration agreements generally,
 4 among other complex and evolving issues. Navigating these waters required a deft
 5 hand, and experienced Class Counsel who would be able to ensure that the rights
 6 of Class Members were advanced effectively.

7 Fourth, Class Counsel are seasoned litigators with heavy active caseloads,
 8 as can be seen by a brief docket search, as well as by the Accompanying
 9 Declarations of Class Counsel. The Law Offices of Todd M. Friedman for
 10 instance, is currently appointed class counsel on dozens of class actions, and is
 11 actively litigating well over 100 cases. Time spent working on this case was time
 12 that could not be spent on other cases. Accordingly the fourth factor is satisfied.

13 Finally, the experience and reputation of Class Counsel warrants a
 14 multiplier.¹¹ "Multipliers in the 3-4 range are common in lodestar awards for
 15 lengthy and complex class action litigation." *Van Vranken v. Atlantic Richfield*
 16 Co., 901 F. Supp. 294, 298 (N.D. Cal. 1995).¹² For these reasons, the modest
 17 multiplier requested by Class Counsel is appropriate and warranted.

18 c. **Class Counsels' Hourly Rates are Reasonable**

19 Similarly, Class Counsels' hourly rates are also reasonable. In assessing the
 20 reasonableness of an attorney's hourly rate, courts consider whether the claimed
 21 rate is "in line with those prevailing in the community for similar services by
 22 lawyers of reasonably comparable skill, experience and reputation." *Blum v.*
 23

24 ¹¹ Class Counsel are highly skilled and reputable class action attorneys. The Law
 25 Offices of Todd M. Friedman have secured over \$160 million in class-wide relief
 26 over the past four years, been appointed class counsel on over 50 class actions by
 27 stipulated settlement, and been appointed class counsel by contested motion in 10
 28 cases over that same time period.

27 ¹² See *In re Beverly Hills Fire Litigation*, 639 F. Supp. 915 (E.D. Ky. 1986)
 28 (awarding multiplier of 5 for lead counsel); *Di Giacomo v. Plains All Am. Pipeline*,
 2001 U.S. Dist. LEXIS 25532 (S.D. Tex. Dec. 18, 2001) (approving 5.3 multiplier)

1 *Stevenson*, 465 U.S. 886, 895, n.11 (1994). *See also Davis v. City and County of*
 2 *San Francisco*, 976 F.3d 1536, 1546 (9th Cir. 1992); *Serrano v. Unruh*, 32 Cal. 3d
 3 621, 643 (1982). Class Counsel here are experienced, highly regarded members
 4 of the bar with extensive expertise in the area of class actions and complex
 5 litigation involving consumer claims like those at issue here. *See* Friedman Decl.,
 6 ¶¶ 31-37. Mr. Friedman and Mr. Bacon are also very experienced in litigating
 7 UCL and other consumer protection cases, including class actions, and serve as
 8 class counsel in multiple certified UCL class actions. *Id.*

9 According to the well-respected Laffey Matrix, last reviewed on April 22,
 10 2019, reasonable rates for a Partner of a law firm practicing 11-19 years are
 11 calculated at \$742 per hour. Friedman Decl. Ex B. Mr. Friedman has dedicated
 12 his career to consumer protection, including class action litigation. He has secured
 13 eight figure class-wide settlements on behalf of millions of consumers. Thus, the
 14 billing rate for Mr. Friedman of \$725 per hour is well within the normal range of
 15 fees charged by firms in Southern California for partner work.¹³ Additionally,
 16 Adrian R Bacon, who has contributed much to this litigation, has significant
 17 experience in litigating consumer class actions, including UCL class actions, which
 18 justifies his hourly rate of \$625. Friedman Decl. ¶¶ 37-52. Mr. Bacon is a Partner
 19 at The Law Offices of Todd M. Friedman, P.C., and has secured class certification
 20 status in numerous cases by contested motion, as well as worked on dozens of
 21 actions which settled on a class-wide basis. The hourly rates of Mr. Friedman and
 22 Mr. Bacon requested herein have been approved by courts numerously. Friedman
 23 Decl. ¶¶ 46-60, Ex B. The same is true with respect to the rates sought by
 24

25 ¹³ See *Hartless v. Clorox Co.*, 273 F.R.D. 630, 643-44 (S.D. Cal. 2011), aff'd in
 26 part, 473 F. Appx. 716 (9th Cir. 2012) (approving hourly rates of \$675-795 for
 27 partners, up to \$410 for associates, and up to \$345 for paralegals); *see also POM*
 28 *Wonderful, LLC v. Purely Juice, Inc.*, 2008 WL 4351842 at *4 (C.D. Cal 2008)
 (finding partner rates of \$750 and associate rates of \$425 reasonable).

1 Kristensen Weisberg, LLP. Kristensen Decl. ¶ 37. Hence, Class Counsel's
 2 combined lodestar of \$411,237.75 is reasonable and supports the requested fees.

3 **B. The Requested Costs Are Fair And Reasonable**

4 “Reasonable costs and expenses incurred by an attorney who creates or
 5 preserves a common fund are reimbursed proportionately by those class members
 6 who benefit from the settlement.” *In re Media Vision Tech. Sec. Litig.*, 913 F.
 7 Supp. 1362, 1366 (N.D. Cal. 1996) (citing *Mills v. Electric Auto-Lite Co.*, 396 U.S.
 8 375, 391-392 (1970)). The significant litigation expenses Class Counsel incurred
 9 in this case were necessary to secure the resolution of this litigation. *See In re*
 10 *Immune Response Sec. Litig.*, 497 F. Supp. 2d 1166, 1177-78 (S.D. Cal. 2007).
 11 Based upon the discussion herein, Class Counsel believe that the costs incurred in
 12 this matter are fair and reasonable.

13 Throughout the course of this litigation, Class Counsel had to incur costs
 14 totaling \$12,137.51. *See* Friedman Decl., ¶¶ 44-45; Kristensen Decl. ¶ 38, Ex 2.
 15 These costs were necessary to secure the resolution of this litigation and Class
 16 Counsel put forward said costs without assurance that Class Counsel would ever
 17 be repaid. Such costs include the cost of filing the case, service, courier fees,
 18 mediation expenses, and appeal fees. All of these expenses were necessary to
 19 advancing the litigation on behalf of the Class. Moreover, none of this expense
 20 will be borne by Class Members, as Defendants have agreed to separately pay for
 21 these expenses. Class Counsel will likely incur additional costs as this case moves
 22 to the final approval stage, which final approval hearing is set for June 17, 2019.

23 **V. KIM'S APPLICATION FOR INCENTIVE AWARD**

24 The proposed Settlement contemplates that Class Counsel will request an
 25 Incentive Award in the amount of \$5,000 to be distributed to the Class
 26 Representative, subject to Court approval. Medicredit has agreed not to oppose
 27 the request as long as it is not greater than \$5,000. Agreement § 7. District Courts
 28 in California have opined that in many cases, an incentive award of \$5,000 is

1 presumptively reasonable.¹⁴ Plaintiff played an active role in litigation, providing
 2 documents and information to Class Counsel necessary to litigate the case.
 3 Plaintiff participated in mediation and settlement discussions on behalf of the
 4 Class, as well as in informal discovery, and in the drafting of the Complaint. Had
 5 she not done so, the class members would have received nothing, unless another
 6 consumer came forward to bring the case and was successful and achieving a
 7 settlement or judgment on behalf of the other 230,000 Class Members. Plaintiff
 8 acted dutifully in her role as a class representative, and should be awarded this
 9 reasonable sum of \$5,000 for her part in the litigation.

10 **IV. CONCLUSION**

11 For the foregoing reasons, Class Counsel respectfully request that the Court
 12 grant Plaintiff's motion for an award of attorneys' fees in the total amount of
 13 \$1,200,000, litigation costs of \$12,137.51; and a Class Representative Incentive
 14 Award of \$5,000.

DECLARATION OF TODD M. FRIEDMAN

I, TODD M. FRIEDMAN, declare:

- 1 1. I am one of the attorneys for the plaintiff in this action, Lisa Kim (“Kim” or
2 “Plaintiff”). I am an attorney licensed to practice law in the State of California
3 since 2001, the State of Illinois since 2002, and the State of Pennsylvania
4 since 2011. I have been continuously licensed in California since 2001,
5 Illinois since 2002, and Pennsylvania since 2011, and am in good standing
6 with the California State Bar, Illinois State Bar, and Pennsylvania State Bar.
7 I have litigated cases in both state and federal courts in California, Colorado,
8 Florida, Ohio and Illinois. I am also admitted in every Federal district in
9 California and have handled federal litigation in the federal districts of
10 California.
- 11 2. The declaration is based upon my personal knowledge, except where
12 expressly noted otherwise.
- 13 3. I submit this declaration in support of the Plaintiff’s Motion for Attorneys’
14 Fees and Costs, and Plaintiff’s Incentive Award.

CASE HISTORY

- 1 4. This case began long before the instant action was filed. Originally, on
2 March 6, 2015, my office filed a class action against Defendant Tinder, Inc.
3 on behalf of our client Billy Warner, in the matter of *Billy Warner v. Tinder*,
4 Inc. Case No. 2:15-cv-01668-MMM-AJW, Central District Court of
5 California. The case was assigned to Judge Margaret Morrow (ret.). It was
6 in the course of the *Warner* case, that the theory that ultimately was resolved
7 in the instant matter, was first uncovered, developed, and litigated. See Dkt.
8 No. 13 of Case No. 2:15-cv-01668-MMM-AJW (The Second Amended
9 Complaint – filed April 20, 2015). It is important to note that my office was
10 the first to formulate and assert the Unruh Act theories that gave rise to this
11 class action lawsuit.

- 1 5. We filed a follow up action with a California Plaintiff in the case of *Manapol*
 2 *v Tinder, Inc.*, Case No. BC589036, Los Angeles Superior Court. We took
 3 these actions after Defendant challenged Warner's right to bring an Unruh
 4 Act claim due to the fact that he was a Florida resident.
- 5 6. The *Warner* action was subject to a motion to dismiss, based on numerous
 6 challenges, primarily regarding Rule 9 particularity, challenges based on
 7 Warner being a Florida resident not subject to California Law, and challenges
 8 that the alleged conduct was not unlawful. These challenges were met with
 9 varying degrees of success, with the motion being granted, with leave to
 10 amend.
- 11 7. Part of the Order on the Motion to Dismiss held that Warner should be
 12 bringing his claims under Florida law, not California law. We refiled the
 13 *Warner* action in Florida District court in the case of *Warner v. Tinder, Inc.*,
 14 U.S. District Court for the Southern District of Florida, Case No. 15-cv-
 15 23790-JLK (filed October 9, 2015). After filing, Defendant filed a renewed
 16 Motion to Dismiss. The court took the matter under submission and *sua*
 17 *sponte* dismissed the action with prejudice for forum shopping. We appealed
 18 to the Eleventh Circuit for abuse of discretion and prevailed. See *Warner v.*
 19 *Tinder, Inc.*, Case No. 16-10537 675 Fed.Appx. 945 (11th Cir. Jan. 17, 2017).
 20 The case was later resolved during early discovery. Defendant was
 21 represented by the same counsel in the *Warner* and *Manapol* actions as in
 22 this action.
- 23 8. I bring up this backstory to explain the full history of the litigation between
 24 my office and Defendant relating to the theories which gave rise to this
 25 action. This is important because the diligence that went into my office filing
 26 the instant matter goes back over four years. We put a significant amount of
 27 time into this case going back far earlier than the filing of the *Kim* action.
 28 While the costs and fees expended during the *Warner* and *Manopla* actions

1 are not being included in the instant fee petition, the context is important for
 2 This Court to consider in finally approving settlement and the proposed fees.

3 9. Plaintiff filed the initial class action complaint (“Complaint”) on April 12,
 4 2018. In the Complaint, Plaintiff alleged one cause of action for a violation
 5 of the California Unruh Civil Rights Act. Based on those allegations,
 6 Plaintiffs’ restitution, statutory damages, as well as injunctive relief.
 7 Plaintiffs’ claims were brought on behalf of a class of individuals who were
 8 over the age of 30, but did not receive a discount for the Tinder plus service
 9 based on their age. (Dkt. No. 1.)

10 10. The parties filed a joint stipulation on May 3, 2018, extending Defendants’
 11 time to respond to Plaintiff’s Complaint to June 11, 2018.

12 11. Defendants filed a Motion to Compel Arbitration or in the Alternative, stay
 13 the Case on June 11, 2018. (Dkt. No. 24.)

14 12. Plaintiff filed a First Amended Complaint on June 22, 2018, asserting an
 15 additional cause of action under the Unfair Competition Law, Cal. Bus. &
 16 Prof. Code §§ 17200 *et. seq.* (“UCL”). Plaintiffs sought restitution and
 17 injunctive relief under this claim. (Dkt. No. 30.)

18 13. After extensive briefing in Defendant’s Motion, This Honorable Court
 19 granted the Motion to Compel Arbitration on July 12, 2018. (Dkt. No. 44.)

20 14. On July 13, 2018, Plaintiff filed a notice of appeal regarding said order to the
 21 Ninth Circuit Court of Appeals. (Dkt. No. 46.)

22 15. During the appellate process and before full briefing on the appeal, both
 23 parties engaged in informal settlement discussions and eventually agreed to
 24 mediate this matter on a class wide basis.

25 16. Thereafter, the Parties engaged in informal discovery, including the exchange
 26 of documents in order to determine the size and other aspects of a proposed
 27 class-wide settlement, as well as information about the number of class
 28 members who signed arbitration agreements, and the policies and practices

1 of Defendants.
2

3 17.On November 19, 2018 both parties attended a mediation in Los Angeles,
4 CA with the Hon. Louis M. Meisinger (Ret.) at Signature Resolution. My
5 office prepared a mediation brief, extensively reviewing the law and the facts,
6 as yielded by the evidence to date, along with several pages of exhibits.
7 Defendant submitted a similar brief. After a full day of mediation which
8 lasted late into the evening, both parties were able to resolve this matter on a
class wide basis.

9 18.Defendants strongly contested both the legal and factual issues in this matter,
10 as evidenced by it Motion to Compel Arbitration, which was granted by this
11 Honorable Court. (Dkt. No. 44.) Defendant further contested class
12 certification on numerous grounds as well.

13 19.With Judge Meisinger's guidance, a Settlement Agreement and Release
14 ("Settlement Agreement") was ultimately agreed upon in principle by the
15 Parties.

16 20.Plaintiff seeks the Court's approval of the following to be paid by Defendant
17 pursuant to the terms of the Settlement Agreement:

- 18 i. Attorneys' fees in the amount of \$1,200,000, representing a sum
19 of approximately 5% of the Settlement benefits available to Class
20 Members;
21 ii. Costs of litigation incurred by Class Counsel in the amount of
22 \$12,137.51as of April 22, 2019; and
23 iii. An Incentive Award to Plaintiff in the amount of \$5,000.

24 THE PRELIMINARY APPROVAL ORDER

25 21.Plaintiff moved for Preliminary Approval of the settlement. On March 1,
26 2019, The Honorable Court granted Preliminary Approval. Dkt. No. 60. The
27 Court found that

28 22.The Court granted Plaintiff's proposed deadlines and proposed Class Notice

1 on March 12, 2019. Dkt. No. 62. In doing so, the Court conditionally
2 certified the following Settlement Class:

3 Every person in California who subscribed to Tinder Plus or
4 Tinder Gold during the period between March 2, 2015 and March
5 1, 2019 and at the time of the subscription was at least 29 years
6 old and was charged a higher rate than younger subscribers,
7 except those who timely opt out of the Settlement Class

8 23. The Court approved Plaintiff's counsel as Class Counsel and appointed Epiq
9 to administer the Settlement. The Court went to great lengths in a very
10 detailed order to look into all of the fairness factors under Rule 23(4e) and
11 found, among other things: 1) that the proposed settlement was fair and
12 adequate to absent Class Members, and 2) the proposed settlement was free
13 from collusion. The Court came to this conclusion after evaluating the *In RE*
14 *Bluetooth* factors. See Dkt. No. 60. The only factors which have yet to be
15 evaluated are the reaction of the Class Members to the proposed settlement,
16 and, at least in part, the reasonableness of the attorney fee request. The Court
set a deadline of April 22, 2019 for Class Counsel to file a fee petition.

17 **ADMINISTRATION AND CLASS RESPONSE**

18 24. On April 5, 2019, Epiq disseminated the Class Notice to Class Members via
19 email, as was approved as the best notice practicable by This Honorable
20 Court. The email campaign was highly successful at delivering targeted
21 notice directly to the hands of Class Members, who almost certainly all used
22 smartphone devices hooked to these same email accounts as part of their
23 everyday life.

24 25. Epiq reported that approximately 85% of the Class Members received direct
26 notice, a much higher threshold than the Rule 23 guidelines specify for due
27 process purposes. That benchmark is around 70% reach, and Class Counsel
was pleased that we were significantly over target.

28 26. Epic was able to send 240,592 emails to Class Members, with 203,741 of

1 those emails delivered. Email addresses for all but 19 of the Class Members
2 were located in Tinder's records.

3 27. Since that time, neither Plaintiffs' counsel nor Defense counsel have received
4 any objections from absent Class Members.

5 28. My office has received several inquiries from Class Members regarding the
6 settlement, and promptly responded to all inquiries.

7 29. Only one individual to date has expressed any interest in opting out of the
8 settlement and indicated that he would be sending us an opt out notice.

9 30. I consider the foregoing to be both a considerably favorable amount of reach
10 achieved with the Class Notice, as well as a favorable reaction to the
11 Settlement by Class Members thus far.

12 CLASS COUNSEL'S EXPERIENCE

13 31. The Law Offices of Todd M. Friedman, P.C. has been preliminarily
14 appointed as Class Counsel in this Action. I am informed and believe that
15 Class Counsel are qualified and able to conduct this litigation as a class
16 action.

17 32. As one of the main plaintiff litigators of consumer rights cases in Southern
18 of California, I have been requested to and have made regular presentations
19 to community organizations regarding debt collection laws and consumer
20 rights.

21 33. I have extensive experience prosecuting cases related to consumer issues.
22 My firm, The Law Offices of Todd M. Friedman, P.C., in which I am a
23 principal, has litigated over 1000 individual based consumer cases and
24 litigated over 200 consumer class actions. These class actions were litigated
25 in federal courts in California, as well as California State Courts.
26 Approximately 100% percent of my practice concerns consumer litigation in
27 general, with approximately 90% of my class action experience involving
28 consumer protection, and approximately 30% percent of my class action

1 practice involves litigating claims under the UCL.

2 34. My firm has numerously been approved by courts as adequate class counsel,
3 and is highly experienced in litigating UCL class actions. My office recently
4 was granted class action status in the case of *Anne Wolf v Hewlett Packard
5 Company*, Case No. 5:15-cv-01221-TJH-GJS (C.D. Cal.). The case was a
6 UCL/FAL/CLRA class action against HP, which we successfully certified by
7 contested motion, and thereafter resolved favorably on behalf of the Class
8 Members on a claims made basis, with a similar structure to this case. Final
9 approval of the settlement was recently granted by Judge Hatter. My firm is
10 also currently litigating several Unruh Act/UCL class actions, and have
11 successfully brought over a dozen individual cases under the Unruh Act. The
12 certification and merits theory in this case was developed primarily by my
13 office over the course of several years, and with a great deal of experience
14 and effort.

15 35. My experience in litigating class actions and my years in practice allow me
16 to provide outstanding representation to the Settlement Class. I will continue
17 to strive to fairly, responsibly, vigorously and adequately represent the
18 putative class members in this action.

19 36. The Law Offices of Todd M. Friedman has served as plaintiff's counsel in at

24 II. Overview of Law Offices of Todd M. Friedman, P.C.'s
 25 Efforts in this Action

26 A. CONTINGENT NATURE OF ACTION

27 38. Plaintiff filed the initial class action complaint ("Complaint") on April 12,
 28 2018. Dk. No. 1. As described above, that is hardly when the investigation

1 or efforts surrounding the theories which gave rise to this case were first
2 uncovered, investigated, or litigated by my office. This settlement is a result
3 of four years of diligence, and my office was the first to assert the claims that
4 were resolved on behalf of the Class Members.

5 39.In the Complaint, Plaintiff alleged causes of action for violations of the UCL
6 and Unruh Act stemming from allegedly unlawful price discrimination in the
7 Tinder App based on age. Based on these allegations, Plaintiff sought
8 monetary relief as well as injunctive relief on behalf of the Class and
9 members of the California Public.

10 40.The history of the case is described above in my Declaration and is further
11 evident from the docket and from the docket of the Warner actions. However
12 it is important to note that this case was brought on a contingency basis, with
13 my office and my co-counsel's office having advanced all costs of litigation,
14 time and effort to date on behalf of the Class Members, without having been
15 paid anything. The case was brought purely on contingency.

16 41.As evidenced by the record of the case, including the Court's ruling granting
17 the motion to compel arbitration, Defendant strongly contested the legal issues
18 in this matter, and had legitimate procedural defenses which my office was
19 contesting on appeal, but which could have been upheld, either in whole or in
20 part, by the Ninth Circuit. If that had occurred, the Class Members would
21 have received nothing, as such a ruling in Defendant's favor on appeal would
22 have completely dispensed with the class action claims.

23 42.This action, required the Law Offices of Todd M. Friedman, P.C. to spend
24 time and money on this litigation that could have been spent on other matters.
25 At various times during the litigation of this class action, this lawsuit has
26 consumed my time as well as my firm's resources. Over 2,000 emails have
27 been exchanged during that time between members of my firm, co-counsel,
28

1 counsel for Defendant, the claims administrator, class members, Plaintiff, our
2 experts, and others. Plaintiff's Counsel have not been paid anything for our
3 work on this case since it was filed and we have spent over \$12,137.51 in
4 hard costs prosecuting this action on behalf of Plaintiff and the proposed
5 class. I run a relatively small law firm, which carries a high case volume.
6 Currently we are appointed Class Counsel in dozens of cases that are in
7 various stages of either litigation or settlement proceedings, and we are
8 actively litigating well over 100 pending cases, many of which are class
9 actions. Those cases all require oversight and effort. An expenditure of time
10 and costs in a hotly contested case such as this one is a risk that we took for
11 the sake of standing up for the Class. It is my opinion that law firms in such
12 a position expect to receive a multiplier in cases such as these because of the
13 risk taken, the extent to which firms are unable to take on other cases, the
14 delay in getting paid and the costs we have to advance.

15 **B. LAW OFFICES OF TODD M. FRIEDMAN, P.C.'S LODESTAR**

16 Law Offices of Todd M. Friedman, P.C. has maintained contemporaneous
17 time records since the commencement of this action. To date, I have incurred
18 330.60 hours of attorney time for this case,¹ with a total lodestar of
19 \$212,521.50. This figure does not include the estimated hours for preparing
20 the final approval hearing papers, responding to any objectors, appearing at
21 the hearing and overseeing the settlement administration. I anticipate my firm
22 will expend approximately 100-150 hours working on these matters, in
23 addition to the hours described herein. My billing rate is \$725 per hour in this
24 case, the billing rate for Adrian R. Bacon is \$625 per hour, the billing rate for

25 ¹ In calculating these hours, I have excluded time spent by legal clerks and
26 paralegals. While dozens of hours' worth of time were spent by such individuals on
27 this case, we have not included those hours in the lodestar calculation, because the
28 lodestar of just the attorneys comprise enough billable time as to reach a lodestar
cross-check amount roughly equivalent to the amount of attorney's fees requested.

1 Thomas E. Wheeler is \$370 per hour, and the billing rate for various
 2 paralegals from my office is \$175 per hour.

3 **C. LAW OFFICES OF TODD M. FRIEDMAN, P.C.'S COSTS**

4 My firm has incurred litigation costs in this matter in the amount of
 5 \$5,547.55, for which my firm is seeking reimbursement. These costs are
 6 comprised of costs for filing and serving the complaint, transmitting copies
 7 of ECF filings to the Honorable Court, payment of mediation fees to Judge
 8 Meisinger, and appeal costs. The breakdown of costs is as follows:

16 Should my firm incur costs through final approval of this action, Plaintiff will
 17 seek reimbursement of such costs, as set forth in the Settlement Agreement.
 18 If there are any objectors to the Settlement, my office reserves the right to
 19 take their depositions, which would be an additional expense (there have been
 20 no objectors to date). Importantly, regardless of the costs that my firm incurs
 21 or is reimbursed through a Court Order, such costs will be borne solely by
 22 Defendant, and will not detract from Class Members' recoveries.

23 **D. REASONABLENESS OF HOURLY RATES**

24 Law Offices of Todd M. Friedman, P.C.'s hourly rates are reasonable in
 25 respect to the ranges charged by comparable law firms in the State of
 26 California.² My billing rate is \$725 per hour in this case, the billing rate for
 27

28 ² See Laffey Matrix attached hereto as Exhibit B.

1 Adrian R. Bacon is \$625 per hour, the rate of Thomas E. Wheeler is \$370 per
2 hour, and the rate for paralegals is \$175 per hour.

3 Regarding my rate, I have been practicing law since 2001, and am the
4 managing partner of one of the most active consumer protection law firms in
5 California. I have been counsel of record on hundreds of class action
6 lawsuits, over 50 of which have resolved on a class-wide basis, and
7 approximately 10 of which were certified by contested motion after
8 considerable litigation.

9 48. The hourly rates sought herein have been approved by numerous courts.
10 Recently in the case of *Sheena Raffin v Medicredit, Inc. et. al.*, Case No. 2:15-
11 cv-04912-MWF-PJW (C.D. Cal.), Judge Fitzgerald of the Central District of
12 California explicitly found that my rate of \$725 and Mr. Bacon's rate of \$625
13 per hour, Mr. Wheeler's rate of \$370 per hour and a rate of \$175 for our law
14 clerks were all reasonable. The court awarded us fees and granted final
15 approval of a class action settlement, which my office had litigated for over
16 three years. Our fees were also recently approved as reasonable at these same
17 rates in the case of *Jaylinda Girardot et al v. Bail Hotline Bail Bonds, Inc.*,
18 Case No. BC700131 Los Angeles County Superior Court, where Judge Berle
19 found at oral argument that our hourly rates were fair and reasonable and
20 granted approval. Judge Hayes of the Southern District of California recently
21 granted our fee petition in a PAGA settlement that my office oversaw. The
22 court approved our hourly rates at the same rates sought in this matter and
23 found in pertinent part: "The attorneys' fees and costs sought are reasonable
24 and appropriate. The rates that Plaintiff's Counsel have charged are
25 reasonable and within the range of rates customarily charged by attorneys of
26 comparable skill, qualifications, and experience." See *Eubank v. Terminix
27 International, LLC*, Case No. 3:15-cv-00145-WQH-LL (CA. S.D.) Dkt. No.
28 76. Mr. Bacon's hourly rate of \$625 was also recently approved in a motion

1 for sanctions he filed against a defendant in the case of *Fryt v. SRBV Staffing, LLC* Case No. BC682078 Los Angeles Superior Court.
 2

3 49. My partner Adrian R Bacon is the head of litigation at my firm. He has been
 4 practicing law since 2011, and has practiced primarily class action litigation.
 5 He began working on consumer protection class action litigation, including
 6 extensive work on the Toyota Unintended Acceleration Litigation. Mr.
 7 Bacon played a pivotal role in drafting numerous complex class action briefs
 8 in his first year of practice, including drafting significant portions of the
 9 briefs in notable cases such as *Nguyen v. Barnes & Noble, Inc.*, 2012 WL
 10 3711081 (C.D. Cal. August 28, 2012) affirmed at *Nguyen v. Barnes & Noble Inc.*, 763 F.3d 1171 (9th Cir. 2014), and *Corvello v. Wells Fargo Bank, NA*,
 11 728 F.3d 878 (9th Cir. 2013).
 12

13 50. In only his third year of practice he was approved as class counsel, at an
 14 hourly billing rate of \$475 per hour in three class action matters that were
 15 granted final approval:
 16

- 17 a. *Miller v. Ikea California, LLC* , Case No.: 30-2009 00331682,
 18 California Superior Court County of Orange (\$5.75M class settlement
 19 granted final approval and motion for fees and approved at a rate of
 20 \$475 per hour);
 21 b. *David Paiva et al v. Denny Corporation et al.*, Case No. 37-2010-
 22 00103831-CU-OE-CTL, California Superior Court County of San
 23 Diego (granted final approval and motion for fees and approved at a
 24 rate of \$475 per hour); and
 25 c. *Juan Martinez et al v. Valley Pride, Inc. et al.*, Case No. M108688,
 26 California Superior Court County of Monterey

27 51. Mr. Bacon is responsible for drafting and filing the majority of the Complex
 28 Motions filed by my firm in Class Action cases, as well as managing

1 discovery, taking depositions and overseeing and engaging in virtually every
2 aspect of litigation as either lead or co-lead counsel in hundreds of active
3 cases handled by my firm. He also oversees and managers the firm's Orange
4 County office. My office recently successfully achieved class certification
5 by contested motion in six hotly contested class actions, the motions for
6 which Mr. Bacon took point in drafting:

- 7 a. *Sheena Raffin v Medicredit, Inc. et. al.*, Case No. 2:15-cv-04912-
8 MWF-PJW (C.D. Cal.);
- 9 b. *Anne Wolf v Hewlett Packard Company*, Case No. 5:15-cv-01221-
10 BRO-GJS (C.D. Cal.) (CLRA class action certified on behalf of tens of
11 thousands of class members who purchased printer that was falsely
12 advertised to include Smart Install feature);
- 13 c. *Caldera v. American Medical Collection Association*, (C.D. Cal.) Case
14 No. 2:16-cv-00381-CBM-AJW (TCPA class action on behalf of
15 30,000-100,000 class members, certified by contested motion); and
- 16 d. *Alfred Zaklit, et. al. v. Nationstar Mortgage LLC*, Case No. 5:15-cv-
17 02190-CAS-KK (C.D. Cal.) Cal. Penal Code § 632.7 class action
18 certified under Rule 23(b)(2) and (b)(3) on behalf of approximately
19 70,000 class members whose calls were recorded without knowledge
20 or consent);
- 21 e. *Edward Makaron v. Enagic USA, Inc.*, Case No. 2:15-cv-05145-DDP-
22 E (C.D. Cal.) (TCPA class action certified on behalf of approximately
23 1,000,000 class members under Rule 23(b)(2) and 23(b)(3)); and
- 24 f. *McCurley and Deforest v Royal Seas Cruises, Inc.* Case No. 17-cv-
25 00986-BAS-AGS (certified class achieved by motion in TCPA class
26 action on behalf of over 2 million class members).

27 52. Following class certification, five of the six matters above were resolved on
28 a class-wide basis and are in various stages of approval, as described above.

1 Mr. Bacon's efforts were instrumental in achieving this class-wide results, as
2 he was the primary attorney who took the depositions in these matters,
3 handled motion practice, drafted the motions for class certification, and
4 argued the motions for class certification.

5 53.Mr. Bacon also oversees my firm's Appellate briefs, one of which he
6 prevailed we prevailed on in the aforementioned 11th Circuit *Warner* action,
7 and one of which he recently argued before the Ninth Circuit. See *Gallion v*
8 *Charter Communications, Inc.* Case No. 18-55667 (9th Cir.). He has also
9 been principally involved in drafting several petitions to the FCC on new
10 rules and regulations the FCC is considering regarding dozens of different
11 potential standards that are in flux with respect to consumer privacy statutes.

12 54.Mr. Bacon was recently approved at a rate of \$575 at final approval in close
13 to a dozen class actions over the past two years, including the case of *Shelby*
14 *v Two Jinn, Inc.*, Case No. 2:15-cv-03794-AB-GJS (C.D. Cal.). More
15 recently, he has been approved on several instances at a rate of \$625 per hour.

16 55.Mr. Wheeler is a graduate of U. Penn Law and an associate at my firm. He
17 has worked extensively on consumer protection matters, including class
18 actions, during his two years with my firm. His work includes assisting on
19 the *Caldera* and *Makaron* matters cited above, a certified TCPA class action.
20 In light of his experience, an hourly rate of \$370 is warranted, and is further
21 warranted in light of customary rates for associates on the Laffey Matrix.

22 56.I anticipate Law Offices of Todd M. Friedman, P.C. will incur an additional
23 100-150 hours drafting the final approval papers, preparing for the final
24 approval hearing, appearing at the hearing, and overseeing the settlement
25 administration, including addressing any questions by settlement Class
26 Members (there are zero objectors and one opt-out to date), addressing and
27 responding to any objections, as well as filing status reports after final
28 approval.

1 57. With regard to a bare bones loadstar amount, our current billing records
 2 reflect approximately 330.6 hours of time. Based on these rates, and the
 3 accompanying time entries for each corresponding individual, the loadstar
 4 estimate for my office is \$212,521.50. I understand from reviewing the
 5 records of my co-counsel that Kristensen Weisberg's records reflect 339.35
 6 hours of time and a lodestar estimate of 198,716.25. Thus, the total Lodestar
 7 to date for both firms is \$411,237.75.

8 58. Here is a breakdown and summary of the fees incurred by my office in
 9 connection with this Case:

10 59. Attached hereto as Exhibit A is a true a correct list of all time entries in my
 11 firm's records for this matter.

12 60. Based on the foregoing, I submit that our request for an award of 1,200,000,
 13 which is only approximately 5% of the available Settlement benefits for Class
 14 Members, is reasonable. This represents a multiplier of 2.9 based on current
 15 billing records, which will be closer to 2.3 after the case is fully resolved and
 16 after administration efforts are complete. In my experience and based on
 17 prevailing case law, as cited in our contemporaneous papers, I believe this
 18 multiplier is well within the range of reasonableness for a case of this
 19 complexity and risk, based on the considerable results achieved for Class
 20 Members.

21 61. I also would submit that in light of the fact that Plaintiff took an active role
 22 in the investigation and litigation of this case, that Ms. Kim should be

1 awarded an incentive award of \$5,000. Ms. Kim diligently participated
2 throughout the case in investigating the allegations, providing information
3 and documentation necessary to the litigation, participated in motions and
4 settlement discussions, and ensured that the Class Members received the
5 substantial recovery made available to them. I believe the incentive award
6 sought is reasonable and fair under the circumstances.

7

3 1. I am the named plaintiff in this action. I have personal knowledge of
4 the following facts and, if called upon as a witness, could and would competently
5 testify thereto, except as to those matters which are explicitly set forth as based
6 upon my information and belief and, as to such matters, I am informed and
7 believe they are true and correct.

8 2. My attorneys informed me at the beginning of this litigation of the
9 responsibilities of a class representative. I understand these responsibilities and
10 am willing and prepared to put the interest of the class members before my own.
11 Throughout this case, I believe that I served as an adequate class representative. I
12 worked with my attorneys throughout the case, assisting in both formal and
13 informal discovery that was requested of me, and assisting in drafting the
14 complaint. I also regularly discussed the case with my attorneys when they had
15 questions, and was involved and kept apprised of the status of settlement
16 discussions and subsequently approved of the settlement that was obtained.

17 3. I am now seeking an incentive award of \$5,000.

18 4. I have agreed to a class settlement in this case with Defendants. I
19 have reviewed the Complaint, the Settlement Agreement, which I executed, and
20 other related materials, and have discussed their contents with my attorneys. I
21 also provided a Declaration in support of the Motion for Preliminary Approval of
22 the Settlement and Class Certification. I believe that the settlement achieved is an
23 outstanding result for the Class, and is fair and reasonable, considering the
24 potential risks of going forward with litigation, especially in light of some of the
25 defenses that Defendants have raised. In determining that this Settlement is fair
26 and reasonable, my attorneys advised me that about the substantial risks of not
27 having class certification approved. In light of the serious risks of going forward




1 with this case, the chance that we did not win class certification, the likelihood of
2 appeals, the potential for lengthy delay, and the ultimate uncertainty of recovery
3 through litigation of the claims brought under the Unruh Act, I believe the
4 settlement is fair and reasonable and represents an outstanding result for Class
5 Members.

6 5. I understand that by settling this case, both Parties were able to avoid
7 costly and time consuming additional litigation and trial. I understand that there
8 are approximately 230,000 Class Members who will receive benefits from this
9 Settlement.

10 6. To my knowledge, I have no interest that is not in line with the class
11 members. My goal in bringing this case was to ensure that Defendants were made
12 aware of their violations under the Unruh Act of price discrimination based on
13 age, and that I could achieve a fair result for the Class Members who I believed
14 were affected by the policies and practices that affected me. I believe that both of
15 these goals have been achieved by this settlement, which includes obtaining
16 Defendants agreement to stop these acts according to the current California laws,
17 and I am proud to have been a part of it.

18 7. I respectfully request the Court approve the Motion for Final
19 Approval, the Motion for Attorneys' Fees, and Incentive Award.

20 8. I declare under penalty of perjury under the laws of California and
21 the United States that the foregoing is true and correct, and that this declaration
22 was executed on April 21, 2019.

1 **DECLARATION OF JOHN P. KRISTENSEN**

2 I, John P. Kristensen, hereby declare as follows:

3 1. I am an attorney at law, duly licensed to practice in all Courts in the
4 State of California. I am the Managing Partner of the firm of Kristensen
5 Weisberg, LLP, and counsel of record for Lisa Kim (“Plaintiff”), the Class
6 Representative in this action.

7 2. I am licensed to practice law before this court and all California state
8 courts and all federal courts located in the State of California. I have personal
9 knowledge of the following facts, and if called to do so, could and would testify
10 as follows.

11 **SUMMARY OF CASE HISTORY AND SETTLEMENT**

12 3. Plaintiff, a putative class member, retained my firm on or around
13 February 8, 2018, to represent her individually, and the Class in their claims
14 against Defendants Tinder, Inc., Match Group, LLC, and Match Group, Inc.
15 (“Defendants”).

16 4. On April 12, 2018, Plaintiff filed her class action lawsuit
17 against Defendants, alleging that Defendants violated the Unruh Act. Defendants
18 Tinder, Inc., Match Group, LLC, and Match Group, Inc., (“Defendants”)
19 responded on June 11, 2018 by filing filed a Motion to Compel Arbitration or
20 Stay Under the Colorado Abstention Doctrine. On June 22, 2018, Plaintiff filed
21 her First Amended Complaint, adding the UCL cause of action for public
22 injunctive relief. In their Motion, Defendants claimed that Plaintiff had entered
23 into an arbitration agreement based on her alleged assent to the arbitration
24 provision in Tinder app’s Term of Use through the use of “sign-up wrap” consent
25 in order to access the app. Defendants’ Motion to Compel Arbitration was granted
26 on July 5, 2018, and the Court compelled Plaintiff’s claims to arbitration. Since
27 this matter was brought to the attention of Class Counsel, they initiated a thorough





1 investigation, and conducted relevant factual and legal research. The information
2 learned through this investigation was invaluable during settlement negotiations.

3 5. Class Counsel and Defendant engaged in extensive negotiations
4 including an exchange of letters, emails, and telephone conversations that
5 thoroughly analyzed the relevant legal, social, and factual matters at issue, and
6 explored the parties' respective positions on the merits of the action and viability
7 of class certification.

8 6. On July 16, 2018, Plaintiff filed her appeal of the Court's decision on
9 the Motion, based on her position that the Court did not appropriately consider
10 California Supreme Court precedent interpreting substantive California law in
11 *McGill v. Citibank, N.A.*, 2 Cal.5th 945 (2017), which states that claims for public
12 injunctive relief, such as the one brought in Plaintiff's case under the UCL, cannot
13 be compelled to arbitration. In addition, Plaintiff would argue that the Court Case
14 2:18-cv-03093-JFW-AS Document 52 Filed 01/20/19 Page 13 of 33 Page ID
15 #:512 disregarded recent relevant appellate case law, *Cullinane v. Uber*
16 *Technology, Inc.* 893 F.3d 53 (1st Cir. 2018), which bore directly on whether
17 there was appropriate assent by Plaintiff and the Class Members to the Tinder
18 app's Term of Use.

19 7. A mediation was scheduled for November 29, 2018, and the Parties
20 stipulated to continue the initial briefing deadlines in the appeal. The Parties
21 attended a mediation with Judge Meisinger on November 29, 2018. The Parties
22 did not resolve the case at the mediation, but engaged in subsequent discussions
23 with Judge Meisinger. With his guidance, this Settlement, which was considerable
24 and unprecedented for an Unruh Act claim, was reached on December 1, 2018.

25 8. The specific terms of the Settlement are described in further detail in
26 the Motion for Attorneys' Fees and Costs and Representative Incentive Award
27 and accompanying documents. Specifically as it applies to this Motion, after

1 negotiation of the substantive terms were completed, it was agreed that
2 Defendants would not oppose any request by Plaintiff's counsel for attorneys'
3 fees up to \$1.2 million based on Plaintiff's efforts in obtaining substantive and
4 meaningful relief for Plaintiff and the Class.

5 9. Afterwards, the Parties worked together and finalized the Settlement
6 Agreement and it was executed by all parties by early January of 2019.

7 10. Thereafter, on January 20, 2019, Plaintiff filed her Motion for
8 Preliminary Approval of the Class Settlement and Certification of the Settlement
9 Class, with the Defendants filing a Non-opposition to the Motion. On February 4,
10 2019, Allan Candelore, an individual and non-party to this case who has a
11 separate action filed against the Tinder defendant (Los Angeles Superior Court
12 Case No. BC583162), filed an Opposition to the Motion. On February 11, 2019,
13 Plaintiff filed a Reply to the Opposition.

14 11. On March 1, 2019, the Court granted Plaintiff's Motion for Motion
15 for Preliminary Approval of the Class Settlement and Certification of the
16 Settlement Class, requesting that a revised proposed Notice be submitted to the
17 Court, with the Parties submitting a Joint Proposed Order.

18 12. After the parties complied with these further submissions, on March
19 12, 2019, the Court entered the final order on the Motion, preliminarily approving
20 the Settlement and certifying the Class. The Court also designated the Law
21 Offices of Todd M. Friedman, P.C. and Kristensen Weisberg, LLP as Class
22 Counsel, with Plaintiff as the Class Representative; all who would be able to
23 fairly and adequately represent the Class. The Court also approved and
24 designated Epiq to serve as the Settlement Administrator. The Court ordered that
25 Plaintiff and Class Counsel could make a written application to the Court for an
26 award of attorneys' fees, costs and expenses, and Plaintiff's fee award by April
27 22, 2019. The Court also set a Final Approval hearing at 1:30 p.m. on June 17,





1 2019.

2 13. Taking into account the burdens, uncertainty and risks inherent in
 3 this litigation, the Parties have concluded that further prosecution and defense of
 4 this action could be protracted, unduly burdensome, and expensive, and that it is
 5 desirable, fair, and beneficial to the class that the action now be fully and finally
 6 compromised, settled and terminated in the manner and upon the terms and
 7 conditions set forth in the Settlement Agreement.

8 14. I believe as Class Counsel that the claims asserted in the action have
 9 merit. However, I recognize the burdens, uncertainty and risks inherent in
 10 continuing this litigation. Taking into account the burdens, uncertainty and risks
 11 inherent in this litigation, I and my Co-Counsel have concluded that further
 12 prosecution of this action could be protracted, unduly burdensome, and expensive,
 13 and that it is desirable, fair, and beneficial to the class that the action now be fully
 14 and finally compromised, settled and terminated in the manner and upon the terms
 15 and conditions set forth in the Settlement Agreement. These risks include
 16 uncertainties particular to the class action lawsuit process such as class
 17 certification. These risks also include the expense and effort required to pursue
 18 the Litigation and perhaps the difficulties of proof related to prosecuting such
 19 claims. Even if a favorable determination is reached, the possibility of subsequent
 20 appeals further suggests that this action could be protracted, unduly burdensome,
 21 and expensive. Thus, we believe the terms and conditions of this Settlement
 22 Agreement are fair, reasonable and adequate to the proposed class, and that it is in
 23 the best interests of the proposed class to settle the Action. As a result, based
 24 upon my experience in litigating Class Actions, I strongly believe the Settlement
 25 is fair and reasonable and deserves final approval.

26 15. At this time, the Parties are moving forward with our efforts to
 27 implement the terms of Settlement. Plaintiff and her counsel, which includes my



1 office, have filed our Motion for Attorneys' Fees and Costs and Representative
2 Incentive Award for efforts in this litigation and substantive settlement, which has
3 provided a significant benefit to Plaintiff and over 200,000 members in the Class
4 for their Unruh Act claims.

5 **QUALIFICATIONS OF CLASS COUNSEL**

6 16. I am currently the Managing Partner at Kristensen Weisberg, LLP. I
7 am an attorney licensed to practice in the state California. I am admitted to
8 practice before the United States District Courts for the Northern, Eastern,
9 Southern, and Central Districts of California. I have also been admitted pro hac
10 vice for the United States District Court for Idaho, Oregon, Arizona, Minnesota,
11 the Northern District of Texas, the Western District of Virginia as well as two
12 complex helicopter fatality cases in Arizona State Court.

13 17. I graduated from Washington & Lee University School of Law in
14 Lexington, Virginia in 2002 where I received an academic scholarship. Upon
15 graduation, I moved back to Los Angeles and quickly gained admission to the
16 California bar. I began my civil career at Daniels, Fine, Israel, Schonbuch &
17 Lebovits, LLP in Century City. I then spent four years at a multi-disciplinary
18 practice, Avila & Peros, LLP.

19 18. In 2008, I accepted employment at a firm, O'Reilly & Danko, which
20 subsequently changed its name to O'Reilly || Collins. The firm was one of the
21 preeminent plaintiffs' law firms in the country obtaining numerous seven and
22 eight figure verdicts and settlements during my tenure.

23 19. In 2011, I was responsible for a then record and maximum fine
24 against an automotive company after I requested the federal government
25 investigate an auto-manufacturer for its statements regarding why it was
26 conducting a recall overseas, but not for similar vehicles in the United States. The
27 manufacturer paid the maximum fine in excess of \$16,000,000.00 as a result of



1 my investigation.

2 20. In 2011, the Daily Journal selected me as one of five associates to
3 watch in the state of California in its annual 20 under 40 edition. I was the sole
4 plaintiffs' attorney to receive the accolade. I have also been named to Super
5 Lawyers' Rising Stars for Southern California in 2012, 2013 and 2014.

6 21. I have tried employment and wrongful death trials and obtained
7 numerous million dollar settlements for my clients.

8 22. I have litigated against NBC, Enterprise Rent-A-Car, Spearmint
9 Rhino, Ford Motor Company, Toyota Motor Company, General Motors, Taco
10 Bell, Sony and numerous other large corporations. My practice has included in
11 multiple appellate cases where I have argued successfully before the California
12 Courts of Appeal.

13 23. During the course of the Toyota Sudden Acceleration litigation, I
14 was appointed by Hon. Anthony J. Mohr to the Plaintiffs' Steering Committee
15 and was re-appointed in 2012 by Hon. Lee Edmon. Judge Edmon also appointed
16 me as a member of the national fee committee to recommend the allocations and
17 disbursements of the common benefit fund.

18 24. In 2012, I took a position with one of the nation's top Class Action
19 law firms, Strange & Carpenter, where I was instrumental in preparing one of the
20 bellwether sudden acceleration cases that resolved in December 2012. That case
21 was a model for the California class claim that resolved along with the national
22 case. Today, I remain in the role as the youngest attorney appointed to the
23 plaintiffs' steering committees in the California Toyota Sudden Acceleration
24 cases.

25 25. At Strange & Carpenter and since opening Kristensen Weisberg, LLP
26 in 2013, I have litigated numerous class action claims, including privacy cases,
27 illegal phone recording, UCL, and TCPA claims.

28 **DECLARATION OF JOHN P. KRISTENSEN IN SUPPORT OF MOTION FOR

1 26. In 2017, I obtained what was then a record Title IX settlement
2 against UC Regents.

3 27. I was appointed Class Counsel in the matter of *Mankin v. Mountain*
4 *West Research Center, L.C.*, case number 2:13-cv-06447-DSF-AGR in the
5 Central District of California. The class settlement in that matter was approved by
6 Hon. Dale S. Fischer.

7 28. Therefore, my experience is sufficient to act as Class Counsel in this
8 case.

9 29. Other than myself, several members of my firm have knowledge of
10 this case and have worked on this case with me with my oversight.

11 30. Christina M. Le, a Senior Associate at my law firm, has been the
12 primary associate that has been working on this case with me. She has over
13 thirteen (13) years of legal experience working as a litigator in both State and
14 Federal Courts. She has submitted a separate declaration detailing her legal
15 experience.

16 31. David L. Weisberg, who is Partner at my firm, has also provided
17 work on this case on behalf of Plaintiff and the Class. A graduate of McGeorge
18 School of Law, University of Pacific in Sacramento, California, in 2000, David
19 has been practicing law since 2001. Since we started our firm in 2013, David and
20 I have worked together on several of our firm's class action cases, including
21 *Mankin* which I referenced earlier.

22 32. Jesenia A. Martinez, an Associate at my firm, has also worked on
23 this case. Jesenia attended Tufts University for her undergraduate degree and
24 attended Southwestern University School of Law, graduating from its prestigious
25 SCALE accelerated program in May 2017. While in law school, Jesenia
26 completed externships with Judge Kim McLane Wardlaw at the United States
27 Court of Appeals for the Ninth Circuit and Judge Dean D. Pregerson at the United





1 States District Court for the Central District of California. Jesenia was also part of
2 Law Review and was a Dean's Fellow and Teaching Assistant while in law school
3 where she earned several CALI and Witkin awards for excellence. She began
4 working at Kristensen Weisberg, LLP after taking the bar.

5 **CLASS COUNSEL'S ATTORNEYS' FEES AND LITIGATION COSTS AND EXPENSES**

6 33. I have attached as Exhibit "1" hereto a true and correct copy of a
7 detailed itemization of the attorneys' fees. I have attached as Exhibit "2" hereto a
8 true and correct copy of a detailed itemization of the litigation costs and expenses
9 incurred by Kristensen Weisberg, LLP, Class Counsel for Plaintiff. The
10 itemization covers the period from February 1, 2018 to April 19, 2019. My firm's
11 services have been listed chronologically in a single document so that the Court
12 can readily determine what services were rendered by all timekeepers on each
13 day. The time and costs were recorded daily.

14 34. Exhibit "1" states for each entry: (i) the name or initials of the
15 timekeeper, (ii) the hourly rate sought for the timekeeper, (iii) a description of the
16 services performed, (iv) the amount of time billed and (v) the dollar amount
17 charged for that entry. The dollar amounts of these entries were not "rounded up."
18 The entries were also coded consistently with the litigation and expense codes set
19 forth in the Uniform Task-Based Management System ("UTBMS") via EBillity,
20 Westlaw's billing software. Exhibits "1" and "2" show each daily entry of fees or
21 costs, along with one-page summaries showing the total fees and costs incurred
22 under each category of UTBMS coding.

23 35. Exhibit "1" also describes the services rendered in sufficient detail
24 for the Court to determine the nature and reasonableness of the services; (ii)
25 wherever possible, my firm sought to avoid overly general or non-specific entries;
26 (iii) time records were maintained on a contemporaneous and daily basis, in
27 increments of one-tenth of an hour; (iv) my firm avoided block-billing and



1 multiple appearances by my firm at the same event; (v) my firm also sought to
 2 minimize time charged for emails and inter-office communications; and (vi) the
 3 fee requested reflected in Exhibit "1" represent historical hourly rates.

4 36. Litigation costs and expenses are listed in Exhibit "2" in a reasonably
 5 narrow and descriptive manner using the UTBMS expense codes; (ii) only actual
 6 costs and expenses of the type normally billed to a client are included in Exhibit
 7 "2"; (iii) my firm is not seeking reimbursement for items generally regarded as
 8 overhead, such as photocopy costs or Westlaw/Lexis charges; and (iv) my firm
 9 did not incur litigation costs and expenses for first class airfare, expensive hotels
 10 and high-priced meals.

11 37. Exhibit "1" reflects that my firm spent 339.35 hours investigating,
 12 prosecuting and settling this Action. In addition, I estimate that Class Counsel
 13 will incur an additional \$100,000.00 in legal fees and costs in our efforts to
 14 finalize the Settlement, which will include addressing the anticipated objections to
 15 the Settlement. The lodestar value of my firm's fee for these services is
 16 \$198,716.25.¹ My firm's applicable hourly rates during the pendency of the
 17 Action as Class Counsel have been: (i) \$725.00 per hour for John P. Kristensen;
 18 (ii) \$725.00 per hour for David L. Weisberg; (iii) \$625.00 per hour for Christina
 19 M. Le; and \$350.00 per hour for Jesenia A. Martinez. I also had legal assistants
 20 that worked on this case, Justin Farzadkish and Vanessa Brahm – they are billed
 21 at \$175.00 per hour. These are reasonable rates in line with comparable hourly
 22 rates charged by other firms that handle complex litigation in the Southern
 23 California market.

24 38. The cost entries in Exhibit "2" reflect that Class Counsel incurred

4 receive any other funds and the retainer complied with California Rules of
5 Professional Conduct Rule 2-200.

1 Plaintiff Lisa Kim (“Plaintiff”) has moved the Court for attorneys’ fees and
2 costs, and a class representative incentive award as set forth in the Class Action
3 Settlement Agreement filed with the Court on January 20, 2019 (Dkt. No. 52-1 Ex
4 A) (“Agreement”).

5 Having considered all matters submitted to it at the hearing on the motion and
6 otherwise, including the complete record of this action, and good cause appearing
7 therefore, the Court hereby finds and concludes as follows:

- 8 1. In addition to any recovery that Plaintiff may receive under the Settlement, and
9 in recognition of the Plaintiff’s efforts and risks taken on behalf of the
10 Settlement Class, the Court hereby approves the payment of an incentive
11 award to the Plaintiff Lisa Kim, in the amount of \$5,000.
- 12 2. The Court approves the payment of attorneys’ fees to Class Counsel in the sum
13 of \$1,200,000, and the reimbursement of litigation expenses in the sum of
14 \$12,137.51. The Court finds these fees were reasonably incurred, and that the
15 hourly rates sought by counsel are reasonable.
- 16 3. This Court shall retain jurisdiction with respect to all matters related to the
17 administration and consummation of the settlement, and any and all claims,
18 asserted in, arising out of, or related to the subject matter of the lawsuit,
19 including but not limited to all matters related to the Settlement and the
20 determination of all controversies related thereto.
