

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2019 Department of Public Safety Police Department, U.S.
Department of Justice, Community Oriented Policing Services Hiring
Program Homeland Security Grant Budget)

RESOLUTION NO. 18-346

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Public Safety has prepared and submitted for review and
8 approval its FY 2019 Department of Public Safety Police Department, U.S.
9 Department of Justice, Office of Community Oriented Policing Services ("COPS")
10 Hiring Program Homeland Security Grant Budget, which is incorporated by this
11 reference, in the amount of \$125,000.00, and which is cost shared with the FY 2019
12 Department of Public Safety Police Department Law Enforcement Budget; and

13 **WHEREAS,** the Domestic Affairs and Budget and Finance Committees have reviewed the FY
14 2019 Department of Public Safety Police Department, U.S. Department of Justice,
15 Office of Community Oriented Policing Services Hiring Program Homeland
16 Security Grant Budget and recommend its approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
18 FY 2019 Department of Public Safety Police Department, U.S. Department of
19 Justice, Community Oriented Policing Services Hiring Program Homeland
20 Security Grant Budget effective September 1, 2018 in the amount of \$125,000.00,
21 which shall be funded by the Nation's general fund pending reimbursement by
22 the grantor.

23 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
24 Nation chairperson or any designated official is authorized to administer and
25 expend the FY 2019 Department of Public Safety Police Department, U.S.
26 Department of Justice, Community Oriented Policing Services Hiring Program
27 Homeland Security Grant Budget, provided that any amendments or
28 modifications shall be submitted for prior approval by the Tohono O'odham
29 Legislative Council.
