The amendment referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable, provided that you:

- Submit and/or cite all data required for registration/reregistration of your product under FIFRA sec. 3(c)(5) when the Agency requires all registrants of similar products to submit such data
- 2. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:
 - a. The words "ACTIVE INGREDIENTS" and "INERT INGREDIENTS" must be printed in type of the same size and given equal prominence. The words "ACTIVE INGREDIENTS" and "INERT INGREDIENTS" must be aligned on the same margin.
 - b. Either delete "Kills resistant flies and nonresistant flies" or indicate what the flies are resistant to, such as diazinonresistant flies. This should be supported by appropriate data.
 - c. Change "hand-use" in Precautionary Statements to read: "hand. Use etc."
 - d. Delete "Attracts More Flies! Kills More Flies!" or indicate what is less attractive or kills fewer flies. Vague or nonspecific terms implying unstated benefits related to the composition of the product are not acceptable.

- e. Add DIRECTIONS FOR USE before the misuse statement.
- f. Delete "about" in "Use about 4 oz per 1000 sq ft." This allows too much latitude in use.
- g. We have amended our records to reflect the change in product name from Hill Wo. 212 Fly Bait to #212 Fly Bait.

- h. The Confidential Statement of Formula is acceptable and has been made a part of the record for this product. Please note that a slight overformulation of DDVP would be acceptable for this product due to the storage stability of DDVP.
- i. Change "Keep out of any body of water" to "Do not apply directly to any body of water." Also, delete the statement, "Do not apply where runoff is likely to occur."
- 3. Submit five (5) copies of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

A stamped copy of the labeling is enclosed for your records.


Your application of June 17, 1985, to increase DDVP to 1% is not acceptable as an amendment action under this registration. A change from, 0.5% to 1.0% is significant (due to a change in signal word from Caution to Warning and other precautionary statements) and must be submitted as an application for new registration.


