**WHEREAS**, pursuant to Chapter 48 of Title 11 of the Code of Alabama (1975), the City of Birmingham (the "City") is authorized to sell property to foreclose upon liens in favor of the City for unpaid municipal improvement assessments and to acquire such property at the sale; and

WHEREAS, Woodlawn Redevelopment I, LP has requested to purchase the City's interest in the Property and the Director of Finance has investigated the circumstances resulting in the conveyance of the Property to the City and recommends that Woodlawn Redevelopment I, LP be allowed to purchase the Property for the amount of \$5,262.36 (plus accrued daily interest) which represents the total amount of the original assessments plus costs, fees and interest thereon at the rate of six percent (6%) per annum.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of Birmingham that the Mayor be and hereby is authorized to execute, on behalf of the City of Birmingham, a Quit Claim Deed conveying the Property to the designated grantee upon payment of the amount of \$5,262.36 (plus accrued daily interest) to the City within ninety (90) days of City Council approval.

WHEREAS, the City enthusiastically supports and encourages economic development within the City in order to develop a solid and diverse local economy, to increase and or retain employment opportunities in the City, to retain the City's tax base and revenues and to provide necessary and improved services to the citizens of the City, thereby improving the quality of life of its citizens; and

WHEREAS, the 3D Development Partners, LLC ("3D Development Partners") is in the process of assembling eight (8) parcels of land for the purpose of constructing a retail office space for the relocation and expansion of a Family Dollar Store (the "Family Dollar Store") from an approximately 7000 square feet space inside a shopping center on property owned by the City of Birmingham into an approximately 9100 square feet stand-alone space located on a corner of the intersection of Thirty-Second Avenue, North and Twenty-Sixth Street North, Birmingham, Alabama which will be owned by 3D Development Partners (the "Project"); and

**WHEREAS**, the Project involves the acquisition from multiple owners and the clearing of eight (8) parcels of property and the construction, at a total estimated cost to the 3D Development Partners for both acquisition and construction in an approximate amount of One Million One Hundred Thousand and No/100 Dollars (\$1,100,000.00); and

**WHEREAS**, the Project, when completed, is expected to result in the retention of approximately five (5) jobs, the creation of approximately two (2) additional jobs and an estimated 20% increase in sales revenue, due to an increase in product space and inventory and greater street visibility, and an increase in ad valorem tax revenue to the City; and

**WHEREAS**, to induce 3D Development Partners to undertake the Project, the City has agreed to provide financial assistance for the Project through the partial release of a municipal assessment in the amount of One Thousand Twenty-Four and No/100 Dollars (\$1,024.00) (the "City Assistance"); and

**WHEREAS**, as a result of the City's inducement to be provided in the form of the City Assistance, 3D Development Partners has decided to undertake the Project; and

**WHEREAS**, the City accordingly finds that providing financial assistance for the Project in the form of the City Assistance is consistent with and in furtherance of the objectives of Amendment No. 772 and that the expenditure of such public funds for the purposes described herein will serve a valid and sufficient public purpose, notwithstanding any incidental benefit accruing to any private entity or entities; and

**WHEREAS**, the City finds that it is necessary, proper and in the public interest, in accordance with Amendment No. 772, that the City should enter an agreement with 3D Development Partners pursuant to which 3D Development Partners will undertake the Project and the City will provide certain incentives in the form of the City Assistance in connection with the Project, and that providing the City Assistance in accordance with the terms and conditions of the Agreement will promote the economic development of the City and, accordingly, is for a public purpose and is authorized by, consistent with, and in furtherance of the objectives of Amendment No. 772; and

WHEREAS, the City does hereby ascertain, determine, declare and find that development and implementation of the Project with the City Assistance is in the best interest of the City and will serve a public purpose and further enhance the public benefit and welfare by, among other things: promoting local economic development and stimulating the local economy; increasing and employment opportunities in the City; increasing the City's tax base, resulting in additional tax revenues for the City; promoting the retention of business enterprises and retail business in the City; and eliminating blight and blighting factors through the productive re-use of vacant and under-utilized property, all of which inure to the economic health of the City and constitute important public benefits to the City and its citizens; and

**WHEREAS**, as required under Amendment No. 772, the City published notice in the June 15, 2014 edition of The Birmingham News concerning the proposed action of the Birmingham City Council to approve an agreement with 3D Development Partners; and

**WHEREAS**, for purposes of the Amendment No. 772, 3D Development Partners, LLC is the business entity to whom or for whose benefit the City proposes to lend its credit or grant public funds or things of value; and

**WHEREAS**, the City and 3D Development Partners desire to enter into an Agreement to set forth their mutual rights and obligations concerning the funding, development and implementation of the Project.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Birmingham that the Mayor be and hereby is authorized to execute, for and as the act of said City, (1) a Project Funding Agreement with 3D Development Partners, LLC under which 3D Development Partners will assemble and acquire 8 parcels of land and construct an approximately 9100 square foot retail building for the purpose of the relocation and expansion of a Family Dollar store at the corner of Thirty-Second Avenue, North and the alley between Thirty-Second Avenue and Thirty-First Avenue, North, at the intersection with Twenty-Sixth Street, North and the City will support the project by providing a partial release in the amount of up to One Thousand Twenty-Four and No/100 Dollars (\$1024.00) related to a municipal assessment lien on property located at 3125 25th Street, North, Birmingham, Alabama.

That portion of the Alley in Block 775 lying between the Northwesterly Right-of-Way line of 10<sup>th</sup> Avenue South and a line lying 1.00' South of the extended Northerly line of Lot 2A, Part of Medical Center Project U.R. Ala. 2-1, as recorded in Map Book 52, Page 57, in the office of the Judge of Probate of Jefferson County, Alabama located in the NE ¼ of Section 1, Township 18 South, Range 3 West, Jefferson County, Alabama.

The vacation hereinabove declared shall be subject to such conditions and reservations for the benefit of the owners or operators of public utilities or installations in said way or ways as the governing body of the City of Birmingham may see fit to specify in a resolution of assent.

The said owner does further declare that after the vacation hereinabove declared, convenient means of ingress and egress to and from their respective properties will be afforded to all other property owners by the remaining public ways dedicated to the public for public way purposes, and,

WHEREAS, it has been made to appear to this Council that said declarant is the owner of all the land abutting on the portion or portions of public way or ways declared vacated by said Declaration of Vacation and that after the vacation of the said portion or portions of said public way or ways convenient means of ingress and egress to and from their property will be afforded to all other property owners by the remaining public grounds dedicated to the public for public way purposes; and

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Birmingham as follows:

- 1. After hearing all parties and considering all information presented, the assent of this Council be, and hereby is given and granted to the vacation of the portion, or portions, of public way or ways declared vacated in the above quoted Declaration of Vacation, subject to the conditions and reservations hereinafter set out, and further, this Council finds that all other property owners will have convenient means of ingress and egress to and from their property by the remaining public grounds dedicated to the public for public way purposes and that it is in the best interest of the public that the above described public way or ways or portions thereof be vacated.
  - 2. That the foregoing assent be and is hereby given upon condition that any entity,

including the City of Birmingham, which may now own or rightfully maintain any public utility, facility, line or installation, including any open or closed storm or sanitary sewer, in any portion of any public way hereinabove mentioned, shall have a right and easement to continue to maintain same in its present location therein and to repair, cleanse, improve and reconstruct the same and to have convenient storm water drainage and sanitary sewer means thereto and there from for said purposes, and that there be and is hereby reserved and excluded from the said foregoing assent any assent of this Council to the vacation, annulment or impairment of the right, easement or privilege of any such entity to continue to own, maintain, repair, cleanse, improve, reconstruct and have convenient means of ingress and egress to and from such utility, facility, line or installation.

- 3. The foregoing provisions for maintenance and for ingress and egress shall mean, among other things and without limitation, that in case any building or edifice shall be constructed or placed in any portion of any of said vacated ways, it shall be constructed, placed or arranged therein so as to avoid damage to any presently existing concealed or unconcealed or patent or latent public utility, facility, line or installation in any such public way and so as to afford ways and means of ingress and egress to and from such utility, facility, line or installation for purpose of reconstruction, repair, cleansing or improvement of service of same, substantially equal to and as convenient as presently existing ways and means of ingress and egress thereto and therefrom such purposes, or such as shall be approved in writing by the owner or operator of such utility, facility, line or installation.
- 4. This resolution shall be effective only upon the payment of the right-of-way fee within sixty (60) days of the date of this resolution, the recording in the Office of the Judge of Probate of Jefferson County, Alabama, of a map or plat approved by the City Engineer and the Birmingham Planning Commission showing the vacated portion or portions of public way or ways as described above and the boundary lines of the abutting property resulting from the vacation, and notice of the governing body's action being published once in a newspaper in the county no later than 14 days after its adoption.

**BE IT FURTHER RESOLVED** that under the provisions of Act 785 of 1982 the right-of-way vacation fee has been set at \$61,351.78 and is waived.
