Request for Bids Virtual Server and other Associated Systems Wyoming Community College (WCC) Consortium

ARTICLE I - General Conditions and Requirements

NOTICE IS HEREBY GIVEN that the seven Wyoming community colleges:

Casper College, Casper, Wyoming;

Central Wyoming College, Riverton, Wyoming:

Eastern Wyoming College, Torrington, Wyoming;

Laramie County Community College, Cheyenne, Wyoming;

Northwest College, Powell, Wyoming;

Northern Wyoming Community College District; Sheridan, Wyoming; and

Western Wyoming Community College, Rock Springs, Wyoming,

and the Wyoming Community College Commission, Cheyenne, Wyoming, have formed the Wyoming Community College Consortium (WCC Consortium www.wy.edu) for the purpose of jointly issuing this and other Request for Bids (RFBs). By jointly issuing this RFB, it is hoped that the increased quantity of the bid will result in more competitive and thus lower pricing. However, each of the eight members of the consortium are independent fiscal entities and the final purchases of all items will require separate invoicing and payments from each member as outlined in this document. In addition, all bids are FOB to each college address as specified in the Product Lists contained within this RFB

The WCC Consortium is requesting bids from vendors for virtual server systems, associated storage systems, and backup hardware and software, and VMWare licensing. The entire list of products is set forth below, and is divided into lots. Vendors are invited to bid on one or more of these lots in any combination, but cannot divide the lots. Bids for each lot or lot combination will be considered independently. In addition, consortium members seek bids for both 3-year and 5-year support contracts – with payment for all years of support paid at time of initial hardware purchase. Vendors can at their option bid on each lot singly and or in any combination if doing so reduces bids due to larger quantities.

Acting as secretary to the WCC Consortium for this RFB, the Chief Information Officer of Central Wyoming College will receive bids in Room MH210A, 2660 Peck Avenue, Riverton, Wyoming 82501, until 3:00 p.m. Friday, June 22, 2012. Late bids will not be accepted. Bids shall be sealed and clearly marked "WCC Consortium Request for Bids: Virtual Server and Associated Systems". Bids will be opened and read publicly shortly after 3:00 p.m. in Room MH210A. A contract will not be awarded until the bids have been reviewed by consortium members and each college has authorized negotiation of independent contracts.

The consortium reserves the right to reject any and all bids and to waive any irregularities, formalities, or informalities in the bidding process, and to award the bid as may be in the best interest of the Wyoming Community College Consortium.

1. SUBMISSION OF BIDS: It is the responsibility of the proposer to carefully examine the Request for Bids document and be familiar with all of the requirements, stipulations, provisions and conditions. All changes, additions, or clarifications to the RFB documents will be done with a numbered addendum. Vendors wanting to receive notification of any issued addenda must email Kelly Dempster (kdempste@cwc.edu) with that request. No bids will be considered in which any of the conditions or provisions have been modified. No oral or telephone interpretations of the bid documents shall be binding upon the Consortium. Bids received after the time and date specified will not be considered and will be returned unopened to the firm. FAX AND EMAIL BIDS WILL NOT BE ACCEPTED.

2. SURETY:

Bid Bond: None required.

- **3. CONTRACTOR PREFERENCE:** Proposers are advised that the resident contractor preference and State of Wyoming materials preference statutes contained in Wyoming Statutes Sections 16-6-102 and 16-6-106, in the opinion of the WCC Consortium, does NOT apply to purchases by WCC Consortium members as listed in this RFB because all products listed do not qualify for contractor preference. Those bidders claiming otherwise must provide a written explanation of why they believe they do qualify for resident contractor preference in the State of Wyoming and also include a copy of their Wyoming Certificate of Residency. As part of the evaluation of bids, the WCC Consortium will consider any such statement provided.
- **4. ACCEPTANCE PERIOD:** All bids shall be firm until at lease August 31, 2012.
- **5. WYOMING COMMUNITY COLLEGE CONSORTIUM REPRESENTATIVE:** Questions concerning the RFB document and process, acceptance and approval of bids, and contract requirements should be directed to John Wood, CIO at 307-855-2162, jwood@cwc.edu

6. AWARD OF PROPOSAL:

Award of the bid is contingent upon available funding and official approval. This bid <u>cannot</u> be assigned or transferred without the written consent of the WCC Consortium. Where terms conflict, provisions contained within this RFB take precedence.

Minority business enterprises will be afforded full opportunity to submit a bid and to contract with consortium members and will not be subject to discrimination on the grounds of race, creed, national origin, sex or handicap in consideration for an award.

By submitting a bid, the firm certifies under penalty of perjury that it has not acted in collusion with any other firm.

- **7. PROPERTY OF SUBMITTED BID DOCUMENTS:** Bids submitted as a response to this RFB will be distributed to each consortium member, and will then become the property of the member. Such bids, as property of the members, are subject to public disclosure as prescribed by Wyoming statutes. Proprietary information must be identified and will be protected to the extent allowable by Wyoming law.
- **8. CONSIDERATION OF BIDS**: The members of the WCC Consortium seek vendors that will act as partners to the colleges in providing virtual server technology and associated systems that will help us in efficiently fulfilling our missions as public community colleges in the State of Wyoming. The consortium members also reserve the right to purchase products from other vendors at any time should we determine doing so is in the best interest of our members. In awarding the vendor for each lot for which we are seeking bids, cost is only one factor in our evaluation. Total cost of ownership over the expected lifetime of this equipment is important to consortium members, and this includes many factors, some of which are historical repair frequencies of the manufacturer, terms of service contracts, and ability of consortium personnel to efficiently contact manufacturer help desks, and order replacement parts. In all cases we require the ability to contact the customer support representatives of the manufacturer directly without having to work through any third-party vendors.
