Med tech company to break ground on \$40M facility in Spanish Springs

Officials expect to bring around 200 new jobs to the area

International company New Deantronics recently announced that it will be breaking ground on a new 200,000-square-foot facility in Sparks to be used for medical device research, development and manufacturing. New Deantronics expects that it will spend \$40 million on construction of the new campus at the Spanish Springs Business Center that will generate around 200 new jobs in the area.

Since 1985, the company has created medical devices that help healthcare professionals in neurosurgery, orthopedics, cardiology, and more with an overall focus to create medical technology to help improve patients' quality of life.

"The support and assistance received from so many people and organizations here convinced us to select Reno-Sparks to be our new home in the US," says New Deantronics CEO Jane Liu. "We hope to be an integral part of establishing a long-term medical device industry infrastructure, bringing together industry, academia, healthcare providers and others benefiting Reno-Sparks and the global medical device community."

"We are attracted to Nevada because it's very business friendly and we like its proximity to UNR and their strong engineering school," says New Deantronics General Manager Rob Tinker. Convenient transportation, access to a strong labor pool, the booming population growth, and the fact that previous owner Jesse Haw of Hawco Properties already helped develop the facility for the medical company's needs.

New Deantronics made the decision to move to Spanish Springs at the end of 2017 and is still working on designs with a firm in Taiwan where it hosts another facility. Local companies such as Tectonics Design Group and Q&D Construction are also helping with the buildout.



LIFE IN PRISON FOR MURDERER IN 2016 SHOOTING AT RENO PARK

RENO - A 35-year-old northern Nevada man has been sentenced to life in prison for a 2016 fatal shooting at a south Reno park.

Anthony Galbrait was sentenced Friday by a Washoe County District judge after he pleaded guilty in August to first-degree murder in the death of 45-year-old Ralph Lopez.

He'll have to serve a minimum of 20 vears before he can be considered for parole.

Prosecutors say Galbraith sent threatening text messages to Lopez and asked him to meet him at Yori Park in February 2016.

They say Galbraith shot him three times with a 9mm handgun and fled in a previously stolen vehicle.

Police found Lopez lying with gunshot wounds at a Kietzke Lane trailer park.

Officers tracked Galbraith in the stolen vehicle the next day and arrested him.

NEVADA GOP SEN. HELLER BACKS KAVANAUGH, FBI'S INVESTIGATION

LAS VEGAS – Republican U.S. Sen. Dean Heller says he continues to support the nomination of Judge Brett Kavanaugh for a seat on the U.S. Supreme Court.

Heller issued a statement Friday saying he is also in favor of the Trump administration's decision to order the FBI to reopen Kavanaugh's background investigation.

Heller's comments came after more than 60 people gathered outside his

office in Las Vegas to protest against Kavanaugh's nomination.

President Donald Trump on Friday directed the FBI to reopen the background investigation after several women accused Kavanaugh of sexual misconduct.

Protester Susan Jackel says she is "appalled" at what unfolded Thursday during a Senate Judiciary Committee hearing in which Kavanaugh and one accuser, Christine Blasey Ford, testified.

Jackel says she believes Ford "told her truth" and senators "stomped all over her."

AGENCIES: MAN FATALLY SHOT WHILE DRIVING TOWARD **OFFICERS**

RENO – Authorities say Reno police fatally shot a man after he disregarded commands and drove a pickup toward officers as police responded to family disturbance incidents involving him.

The Sparks Police Department and the Washoe County Sheriff's Office are investigating the fatal shooting Sunday evening of Phillip Serrano.

According to a statement released Thursday evening by the investigating agencies, six officers fired at the pickup.

The agencies said their investigation is continuing.

\$500 REWARD IN RASH OF **MIDTOWN RENO COMMERCIAL BURGLARIES**

RENO – Secret Witness is offering a \$500 reward for information leading to the arrest and prosecution of suspects in a series of burglaries at commercial businesses in the Midtown area south of the downtown casino district.

Reno police say there's been a spike the past six months in thefts by Midtown burglars who break through glass doors or windows typically in the late evening or early morning hours.

Investigators say they've been targeting electronics and cash, and usually are in and out within 30 seconds or a minute.

It's not known if it's an organized group of criminals or suspects working independently. Surveillance video has captured different suspects committing the crimes.

HUNDREDS MARCH IN LAS VEGAS TO DEMAND CONTRACTS WITH CASINOS

LAS VEGAS - Hundreds of unionized workers have marched in downtown Las Vegas to demand new contracts with two casino-hotels.

Members of the Culinary Union on Thursday marched down the Fremont Street entertainment district. The group of workers at one point was as long as three city blocks.

This is the latest effort from bartenders, housekeepers and other workers to secure new five-year labor agreements with the D and Golden Gate casino-hotels.

The workers' contracts expired almost four months ago. Negotiations with management have not resulted in new agreements.

The union says it has proposed contract language that includes wage increases and stronger protections against sexual harassment in the workplace.

The workers chanted and held

BIRD ON POWERLINE CAUSED ARC THAT SPARKED RENO WILDFIRE

RENO – Fire investigators say a bird on a powerline apparently caused an arc that sparks a brushfire in south Reno.

The Reno Gazette Journal reports the arcing powerline sparked the blaze that burned about 100 acres on Wednesday.

Truckee Meadows Fire Protection District spokesman Adam Mayberry says the flames burned close to several homes but they're no longer threatened.

Crews are continuing to mop up the fire that burned onto lands under jurisdiction of the Nevada Division of Forestry.

SUSPECT SOUGHT IN ARSON FIRE **AT CARSON CITY PARK**

CARSON CITY – Douglas County sheriff's deputies are investigating a suspected arson fire at a city park in Carson City.

Deputies say they saw smoke coming from inside a restroom near the baseball fields at James Lee Park when they responded to a call at James Lee Park last Sunday.

They found a smoldering pile of paper in the corner of one of the bathroom stalls.

The fire spread to the interior walls causing several thousand dollars in damage.

The sheriff's office asked anyone with information about the incident to report it to authorities.

'Deliberate act of compassion' a reaction to Vegas shooting

LAS VEGAS — As a cloudstreaked orange sunset glowed over Las Vegas, officials, victims' families and survivors of last year's mass shooting at a country music festival marked the first anniversary of the tragedy by placing roses on a tribute wall and dedicating a memorial garden Monday night.

The ceremony at dusk near the city's downtown drew at least 200 people, including Gov. Brian Sandoval and former U.S. Rep. Gabby Giffords of Arizona, herself a survivor of a 2011 mass shooting.

The quarter-acre garden, which features a tree for each of the 58 victims and an oak that represents life, is the only permanent public space that has been created in the memory of 58 people who were killed when a gunman opened fired from a highrise casino-resort suite on a crowd of 22,0000.

The garden, built by volunteers starting days after the Oct. 1, 2017 shooting, was the community's way of reacting to the searing violence, according to the project's creator.

"We've pushed back with a very deliberate act of compassion," Jay Pleggenkuhle said Monday.

The dedication was one of a number of somber events held Monday in the glimmering city, known for its gambling and entertainment, to mark the deadliest mass shooting in modern U.S. history.

As dawn broke over the Las Vegas Monday, a flock of doves were released at a ceremony, with each bird bearing a leg band with the name of one of the 58 people slain.

"Today we remember the unforgettable. Today, we comfort the inconsolable," Nevada Gov. Brian Sandoval gathered told several hundred survivors, families of victims, first-responders and elected officials who gathered at the dawn ceremony at an outdoor amphitheater.

He added: "Today, we are reminded of the pain that never really goes away."

The sunrise ceremony was followed by memorials, prayer services, blood drives and dedications to commemorate the lives lost in the Oct. 1, 2017, shooting. The giant casino marquees were set to go dark in unison Monday night with the names of the victims to be read shortly after.

The festival venue that became a killing ground has not been used in the year since the shooting. MGM Resorts International, the owner of the property and Mandalay Bay hotel, has not said if or when it will reopen.

Company officials redirected curious people on Monday to a nearby Catholic church that offered a spot for quiet reflection.

Clark County Sheriff Joe Lom-

bardo recalled the chaos and confusion of the shooting, and the prayers to "heal broken hearts," blood banks filled with donors and "acts of kindness that comforted the suffering" that followed.

"When the sun rose the next morning, grief turned to anger, anger turned to resolve and resolve turned to action," Lombardo said.

Many who were cheering Jason Aldean's headline set on at the Route 91 Harvest Festival late Oct. 1, 2017 , said later they thought the rapid crack-crack-crack they heard was fireworks — until people fell dead, wounded, bleeding.

From across Las Vegas Boulevard, a gambler-turned-gunman with what police later called a meticulous plan but an unknown reason fired assault-style rifles for 11 minutes from 32nd-floor windows of the Mandalay Bay hotel into the concert crowd below. Police said he then killed himself.

Medical examiners later determined that all 58 deaths were from gunshots. Another 413 people were wounded, and police said at least 456 were injured fleeing the carnage.

Lombardo declared the police investigation finished in August, issuing a report that said hundreds of interviews and thousands of hours of investigative work could not provide answers to what made Stephen Craig Paddock unleash his hail of gunfire. That has left unanswered the question of why a 64-year-old former accountant, real estate investor, small plane pilot and high-limit video poker player assembled his arsenal and attacked the concert crowd.

Paddock was characterized by police as a loner with no religious or political affiliations who became obsessed with guns, spent more than \$1.5 million in the two years before the shooting and distanced himself from his girlfriend and family.

Paddock's gambling habits made him a sought-after casino patron. Over several days, Mandalay Bay employees readily let him use a service elevator to take suitcases to the \$590-per-night suite he had been provided for free. The room had a commanding view of the Strip and the Route 91 Harvest Festival concert grounds across the street.

After breaking out windows, Paddock fired 1,057 shots in 11 minutes, police have said.

Jim Murren, the chief executive and CEO of MGM Resorts International, issued a statement calling the shooting "an unforgettable act of terror."

"Oct. 1 will forever be a day of remembrance, reflection and mourning as we struggle to comprehend the incomprehensible — the senseless act of evil that caused such a tragic loss of life, along with the suffering that we know continues," Murren said.

the judges said of Barbano's columns. "These are some of the most moving columns I've read."

Tribune managing editor Eric Dahlberg won first place for graphic designing for the paper, which judges said made the Tribune stand out among its competitors.

"The strong use of art on tab pages made these entries stand out," judges said. "They weren't cluttered or try too hard, they just presented the content in an easy-to-digest package for readers, a hallmark of good design that's not easy to pull of consistently."

Tribune photographer John Byrne was honored for his photos, taking first place for a picture of horses running near a wildfire.

"A great storytelling image that immediately rose to the top due to its eye-catching qualities," judges said.

The Tribune also won third place for general excellence.

Tribune owner Tim Dahlberg was honored for his work in Nevada journalism and for The Associated Press, where he is the lead national sports columnist.

He started his career at the Sparks Tribune and became a night police reporter at the Review-Journal in 1976. He was among the first on the scene of the 1980 MGM Grand fire that killed 87 people, writing the lead story and covering the aftermath as Nevada legislators were pushed to adopt tough new fire safety standards.

After joining the AP's Las Vegas bureau, Dahlberg covered events like Wayne Newton's libel suit against NBC and a Culinary Union strike that paralyzed the Strip. He later helped cover Muhammad Ali's fight with Larry Holmes at Caesars Palace, launching a career covering the biggest sporting events in the world, including 14 Olympics, more than 100 major golf championships, hundreds of championship fights, 10 Super Bowls and six World Series.

His career came full circle when he teamed up with former RJ publisher Sherman Frederick to form Battle Born Media in 2011, which now owns six weekly newspapers in Nevada, including the Sparks Tribune.

Sparks Troop's Eagle Scout project benefits local fire station

The Truckee Meadows Fire Protection District Station 17 in Spanish Springs located at 500 Rockwell Drive is finally getting the repairs it needs thanks to Sparks Boy Scout Troop 443 and Bryan Green.

Station 17 firefighter and former Eagle Scout Alex Doerr was selling a car and ended up talking about the station's needs to a potential buyer who was involved with Boy Scout Troop 443. The parents/buyer of the car then brought it to the troop with boy scouts who were looking to take on an Eagle Scout project. One member of the troop, Bryan Green, decided to step in and work with the firefighters to make the upgrades.

"Bryan came up with the project proposal, the troop committee approved it, and then Bryan started it Sep. 18-19," says his mother Colleen Green. Station 17 desperately needed a new retaining wall to better conserve water caused by water runoff from the grass along with a more visible sign that was more prominent from major roads.

At the start of the project, Bryan helped remove 16 inches of sod and dug a 12-inch deep trench that was 60-feet long. The firefighters cut the asphalt to replace with brick pavers and Bryan also enlisted the help of other boy scouts and some members of his baseball team.

However, Bryan was the instrumental entity organizing and leading the project, sourcing materials from local businesses and pulling work groups together. Basalite donated the pavers and brickwork for the project and Home Depot contributed concrete, wood beams for the sign, and a wheelbarrow.

On his second day into the project, Bryan started to see the problem of why the retaining wall was needed as water started pooling into the ditch. Enhancements to the station's exterior, along with a more prominent sign,



will greatly improve Station 17's aesthetics and maintenance.

"The sign was far back and kind of hidden amongst the trees, you can't even see it from major roads like La Posada. Now that there's more going on and growth in Spanish Springs, they realized that they needed to bring the sign up," Colleen says. "The sign will help identify the fire station as a safe haven for the community," she adds.

"This has been one of the biggest projects of our troop as far as the amount of work involved," says Colleen. "The focus of the Eagle Scout project is taking on a leadership role which involves planning ahead, helping the community, organization, coordination, asking for donations, and reaching out to experts for help," Colleen says about why Bryan's project is beneficial to the community and his own individual progress.

"The community was with the water loss in front of the fire station and people were complaining about it," Bryan says about why he took this project on. He noted that

Nevada gubernatorial candidate under fire amid arrest report

RENO - Democrats are calling on Nevada Attorney General Adam Laxalt to release his bar association application and full criminal record after the Republican gubernatorial nominee acknowledged he was a "reckless and foolish" teen when he was arrested for assaulting a police officer more than 20 years ago in Virginia.

Records obtained by the Reno Gazette Journal from the city of Alexandria show Laxalt was taken into custody for underage drinking in 1996.

A 17-year-old Laxalt was drinking at a woman's house when officers were called, according to the report. After police entered the residence, Laxalt said he "reacted the wrong way" and tried to keep police from coming into the home. "Today, as a law enforcement officer, I understand they were just doing their jobs," he said.

That and other alcohol-related incidents prompted him to get sober, he said.

Laxalt is facing Democrat Steve Sisolak in one of the most competitive, closely-watched gubernatorial races in the country.

Nevada Democratic Party Chairman William Mc-Curdy II demanded that Laxalt release his full bar application and full criminal record because of the newspaper report.

"These revelations about Adam Laxalt's criminal history are incredibly concerning, and even more concerning is the fact that Laxalt has failed to come clean about his record until just now," McCurdy said.

Nevada is one of 26 Repub-

lican-held governors' offices up for grabs this year and one of eight where Hillary Clinton won the presidential vote over Donald Trump in 2016. The incumbent, moderate GOP Gov. Brian Sandoval is term-limited.

Sandoval has refused to endorse Laxalt in his race against Sisolak, chairman of the local governing body for Clark County, which is home to about two-thirds of the state's population.

Trump has endorsed Laxalt, a former lieutenant in the U.S. Navy, who handily won the GOP primary. Laxalt is the 39-year-old grandson of the late Paul Laxalt, a former U.S. senator and Nevada governor.

Laxalt has been public about his struggle with alcoholism. He was arrested for driving under the influence in Virginia in 1997 and entered a rehabilitation program at age 18.

"As a teenager, I was often reckless and foolish. I've never shied away from telling that story," Laxalt said in a statement emailed to The Associated Press on Monday. "I got my life back, and now I want to help others do the same. It's why I've worked to help others battle addiction and pursue lives of purpose and dignity."

"If I could go back and knock some sense into that drunk teenager I would," Laxalt said.

Other report summaries obtained by authorities in Alexandria, where Laxalt was raised, show that Laxalt was the alleged victim in three reported criminal incidents between 1992 and 1994. He and his family were

Reed storms back to defeat McQueen, 30-22

Reed posted its biggest comeback of the season Friday night after erasing a 13-point halftime deficit to take down unbeaten Mc-Queen. The Raiders blanked the home team in the second half and scored 21 unanswered points to earn a 30-22 win.

Lancers star running back JD Kolb returned the opening kickoff 85 yards for a touchdown, but Reed was able to keep him mostly in check the remainder of the game to the tune of just 54 yards on the ground.

The Raiders ground game went to work and totaled 208 rushing yards in the win, led by Champ Robertson who finished with 85 yards and a touchdown on 16 carries. Baylor Horning and Christian Richer also scored a rushing touchdown while Elijah Tau Tolliver carried the ball 14 times for 78 yards.

Horning was efficient throughout the night for Reed, throwing for 174 yards and a touchdown to Trevor Kibala.

But it was the defense of Reed that shined bright under the Friday night lights as the

Gangi's 4 TD passes carry Nevada past Air Force 28-25

AIR FORCE ACADEMY, Colo. — Ty Gangi's worst moment in the game was fleeting, and no match for the best that was yet to come.

Gangi threw for four touchdowns, three of them after a demoralizing pick-6, and Nevada held off a late Air Force rally to beat the Falcons 28-25 on Saturday.

"Ty is a senior and he's been in a lot of tough games, had ups and downs," Nevada coach Jay Norvell said. "But he just continued to believe in himself and our team and that was really important, to play through that adversity."

Gangi completed 24-of-33 for 259 yards with scoring passes of 40 and 23 yards to Elijah Cooks, 29 yards to Mc-Lane Mannix and 30 yards to Brendan O'Leary-Orange. Nevada (3-2, 1-0 Mountain West) withstood Zane Lewis' school-record 99-yard interception return in the second quarter to win its conference opener and beat Air Force (1-3, 0-2) for the first time in three trips to Falcon Stadium.

"I've been taught and I've learned through this position that you have to have a short memory," Gangi said. "No matter what happens, even after throwing for a touchdown, you have to have a short memory, come back the next play and play every play and just really move on to the next play."

The steely approach helped Nevada snap its eightgame road losing streak and marked Norvell's first win away from home since he became Nevada's coach before the 2017 season.

"Hopefully, this is the first

of many and we keep that rolling," Gangi said.

Nevada's defense also did its part, digging in to turn back the Falcons in the final minutes. Donald Hammond III, who had replaced starting quarterback Arion Worthman midway through the third quarter, drove the Falcons deep into Nevada territory but threw incomplete into the end zone under pressure on a 4th-and-8 play from the 11-yard line with 1:16 remaining.

Nevada ran off most of the clock before deliberately taking a safety and kicking the ball back to the Falcons with 10 seconds left to play. Hammond got off two passes before time expired — both fell incomplete.

Air Force coach Troy Calhoun said he liked the way his team fought back in the second half.

"Obviously, there was a clear difference between the two halves," he said. "You've got to play well for an entire game and no way did that happen."

Passage of Question 5 will do more harm than good

uestion 5 — the Automatic Voter Registration Initiative — on the November ballot is a pointless and costly endeavor likely to do more harm than good.

The proposal would require the **Department of Motor Vehicles** (DMV) to automatically send personal information to the registrar of voters so a person can be registered to vote when receiving a driver's license or making a license change, unless the person affirmatively declines in writing.

It is pointless because the DMV already sends information to the registrar of voters if a person agrees. All Question 5 does is change the system from an "opt in" to an "opt out." It is a distinction without a discernible difference.

The backers of the initiative argue this will make it more convenient to exercise the right to vote and even save money.

"Voting is a fundamental right," the argument for passage reads. "It is our most important way to guarantee our rights and freedoms - and it's a responsibility to be taken seriously by both the people and the government. Yet our outdated voter registration process makes it unnecessarily difficult for eligible Nevada citizens to have their voices heard and leaves our registration system vulnerable to errors. ... It will reduce the risk of fraud and lower costs."

In fact, Gov. Brian Sandoval vetoed the initiative during the 2017 legislative session, saving, "it extinguishes a fundamental, individual choice — the right of eligible voters to decide for themselves whether they desire to apply to register to vote – forfeiting this basic decision to state government. ... the core freedom of deciding whether one wishes to initiate voter registration belongs to the individual, not the government."


Melpomene was the muse of tragedy in the liberal and fine arts, the metaphysical source of inspiration to poets, dramatists and authors. I guess I resemble that remark. I've been quoting her vassal Vanessa in this column for years.

Lilting Vanessa's older brother had been killed in Vietnam not long before I met her. The family, of course, was devastated.

"I saw my father become an old man in one day," she told me. Her parents remain among the finest people I've ever met. I wanted them for in-laws.

If you look back at the milestones of your life, Vanessa was one of mine. Her dad once advised that I look into public relations, something that had never occurred to me. Later, I started knocking on Las Vegas advertising agency doors and was soon writing for three of them. Without that idea, you might not be reading this.

Vanessa's brother bore a close resemblance to actor Steve McQueen. After "The Sand Pebbles" was released in 1966, starring McQueen and Candice Bergin, Vanessa said

Matt Monroe, "We Were Lovers." The past tense provided another dark portent.

One day as we drove to Fresno State in my tricked-out '63 Buick Riviera, out of nowhere she blurted that her brother "tried to rape me when I was a little girl. I had strong legs from being on the swim team and kicked him away. I didn't remember that until now."

She never mentioned it again. She flew to Las Vegas in 1969 to say goodbye. I never got a good reason. It hurt. Still does. I only saw her once more when my brother returned from 'Nam later that year. We never met again.

As old widowers are wont to do, a few years ago I punched her name into a web browser and up came Dr. Vanessa's obituary. She never escaped Fresno and died relatively young of cancer in that polluted valley. I had found the address of her professional office several years earlier and was tempted to write a note. Never did. When the Vietnam Wall website was launched, I almost left a condolence for the family because there were none at her brother's page. Never did.

Her obituary left me cold. Her older brother was totally written out of it. It termed her the second child of her parents and that she had healed a lot of people. Did the psychologist ever heal herself? Apparently not.

The minds of children are like the pristine high desert. There are places not far from here where you can find 19th Century covered wagon tracks. The scars just do not heal. Vanessa had been traumatized at least twice. She discovered the body of drowning victim when she was a child, then came the brother she erased. I hope otherwise, but I'm not sure she ever had a successful relationship. Her mom informed me of a short marriage and divorce back in 1970s.

Did her brother do more than try to rape her? I'll never know. I do know the wagon tracks abided forever.

Which is why I believe the testimony of another psychologist, Dr. Christine Blasey Ford, about Judge Brett Kavanaugh.

Vanessa never recovered from her childhood traumas. Fast forward to another lady of my acquaintance many decades later. She had been sexually abused by her own father during childhood. Unlike Vanessa, who would fall into days of dark depression, this lady lashed out when triggered at random times. She was once estranged from her family for years after falling into a flaming rage at Thanksgiving.

Her family figured that grandma was just getting addle-pated. They never knew what her father did. The scars never healed. I give you Dr. Christine Blasey Ford.

If you don't think you know any rape victims, think again.

Be well. Raise hell. Esté bien. Haga infierno.

Groups try to thwart wild horse experiment

t worked during the Obama administration, but will it work with the Trump administration?

A gaggle of self-styled wild horse advocate groups have filed lawsuits in Washington, D.C., and Portland, Ore., demanding that the Bureau of Land Management abandon plans to spay 100 wild mares in an experiment to help determine a better mechanism for curtailing the ongoing overpopulation on the range. The groups claim the surgical sterilization is dangerous, barbaric and



inhumane. In 2016, a similar project was abandoned by the BLM when some of the same groups filed lawsuits. At that time

the BLM intended to partner with Oregon State University, but the university backed out in the face of protests. This time the BLM planned to link up with Colorado

State University, but that school has already backed out.

In mid-September the BLM announced plans to use helicopters to round up 650 excess wild horses this month from the Warm Springs Herd Management Area near Hines, Ore., and to initiate research on the effects of spaying mares and returning them to the range. The area has a horse population of about 800 but can support less than 200 animals. Horses removed from the range

Tennis in Nevada

he 2018 tennis season is rapidly winding down with the completion of the US open and the Laver Cup. So it might be a good time to recall some of the Nevada highlights on the tennis court.

We have to start off with the most famous career of any Nevadan on the international scene. That would be Andre Agassi. Who had a stellar professional experience after cutting his teeth as the youngest member in the long ago Nevada Governors Cup for youngsters.

While a definitive history of tennis in Northern Nevada would be many volumes in content and would take a long time to write, there are a few names and events which highlight the evolution of the game in this area and are extremely noteworthy.

The University of Nevada has been one of the constants in the ever changing story of tennis in this area. The best remembered tennis coach of the Wolf Pack is the late Bob Fairman, who did a stint at the helm shortly after World War II and then for a long time in the 70's and 80's. Some of the names that will be remembered from the 40's are Judge Ed Reed and all American quarter back Stan Heaths back up, Alva Tabor.

A big contributor to the tennis pack in those days was Pete Pridgen, one of a contingent of Florida athletes who played various sports at Nevada. In those days Pridgen was a playing partner of Jimmy Evert (Chris's dad).

No story about tennis in this area would be complete without mention of Tilly Botti, the garlic groaning godfather of the sport at the Reno Tennis Clubs digs below the Washoe County Golf course. In many time- champion singles and doubles, Tilly was still stoking the ball on a daily basis until his demise. I recall the many occasions I was his doubles partner he would start the game off by saying "do you want to play back hand or do you want to win." Also a clump of garlic from his garden adjacent to the courts was your reward if you happened to win your match.

On the distaff side the most famous local player had to be Barbara Bradley Clark, who graced the courts at Wimbledon.

The aforementioned Nevada Governs Cup was instituted by Supreme Court Justice Dave Zenoff during the tenure of Governor Paul Laxalt (an avid tennis player himself) brought together young and talented tennis players from all parts of the state. Currently one of the tennis pros still operating in this area is personable Glen Grisillo. A star player at Nevada he battled through the qualifying rounds at



Wimbledon, Grisillo knows players at all levels, and once-while a student at the university- with cousin Mel Baleson set the Guiness Book of World Records

tennis in Reno. Another important name on the honor roll of tennis in Northern Nevada is that of Peter Paxton. Coming to nearby Incline Village, Lake Tahoe in 1965 he started the first private club, the Tahoe Racket Club, to achieve major status. The late Dinah Shore was his first charter member. Paxton hosted the largest professional tennis tournament ever seen hereabouts with the likes of Pancho Gonzalez, Rob Laver, Ken Rosewall, Andre Gimeno and many of the top ranked pros. Included on the roster of Paxton professional's in those early days were Gonzalez, Tony Trabert, Dennis Van Der Meer and Billie Jean King.

Best attended-tennis event ever held here was the Clint Eastwood Hyatt tourney held at Incline in 1975. The prestigious tournament was lured from Pebble Beach to the Lake and was attended by more than 150 high-profile entertainers, tennis pros and gifted amatures. More than 3000 spectators witnessed the popular event.

Since I was involved in both Paxton's club as PR man and the individual responsible for security for the Eastwood tournament I have vivid memories of that time in local tennis history.

I first met Paxton at the Chataux, on the golf course at Incline. A mutual friend, realtor Rod Campbell, introduced us and noted that he had sold Paxton a parcel of land on which to build a tennis complex. My first question was "does Paxton know how short the summer season at Lake Tahoe is"? Campbell replied that it didn't seem to phase Paxton. As it turned out the club opened with more than 300 members and then Governor, Grant Sawyer, tossing out the first ball.

As to the Eastwood tournament I remember traveling to San Francisco to meet with Hyatt president, Skip Friend and to sell him on the idea of bringing the Eastwood tournament to Lake Tahoe. After I secured his blessing and financing my next task was to contact Eastwood and ask him to host the tournament. Eastwood turned out to be a most genial host and his name attracted such celebs as Merv Griffin, Gene Hackman, Wayne Rogers, Dan Rowan, Doug McClure, Rick Barry, Lloyd Bridges, Glenn Campbell,R.C.Owens and many others.

Two kinds of shame

he adults who raised and reared me used the word "shame" with some frequency. More specifically, the female adults. As in "Shame on you!" Or the rhetorical reproof "Aren't you ashamed of yourself!" Where I come from, women – grandmothers, mothers, aunties and school teachers – used "shame" this way more often than men.

I don't possess any lucid cultural analysis which explains this. I admit it is anecdotal. But I can't recall my father ever saying "Shame on you!" His disciplinary interventions tended to be less morality-based and more raging incredulity about my mental capacities, often threatening aloud (and I mean really loud) to buy me a bathing cap, given the frequency with which he believed my cranium to be lodged in the far end of my alimentary canal.

These many years later, "shame" is a word containing great paradox for me. The same word is used to describe two very different things. Near polar opposites.

One use of the word "shame" is quite simply a messenger from hell. Dark and destructive. Crippling. Humiliating. A prison of paralyzing self-loathing. In the hands of psychologically immature, dishonest, insecure or just plain mean people with power, shame is manipulative, hostile and deforming, especially to children. In extreme cases of abuse of power, I would be willing to consider this word a kind of evil. I do not exaggerate when I say the core of my life's work as a counselor is identifying and exorcising unhealthy shame.

But another use of "shame" is an angel from heaven. Filled with light and healing. Liberating. Humbling. The only key to the prison door of self-absorption and entitlement. In the hands of a psychological mature, courageous human being, this "shame" is the penultimate teacher. It shapes true character. To be truly human we must be willing to acknowledge and give thanks for healthy shame. One word. Two very different

ideas.

Humiliation is a terrible teacher, extracting a terrible price. Even when the desired lesson is good and true, even when the issue is truly one of justice and right ... well, humiliation leaves scars making even the best lesson hard to celebrate. And humiliation is the desired outcome of unhealthy shame. Shame-based leaders – parents, employers, supervisors, religious leaders, etc. – believe deeply that if people feel badly enough about themselves they



will do better. Any social scientist will tell you the opposite is true, of course. Toxic shame drives bad behavior. In healthy shame, we are

not humili-

ated; rather, we are humbled. To be humbled is to recognize and surrender to limits. I am not God. I am not entitled. While I am not nothing, neither am I everything. I am neither famous nor infamous. Healthy shame is the guardian voice of boundaries. Healthy shame calls out to us when we overstep our ordinary, mortal selfhood in acts of presumption, hubris, self-absorption, blithe narcissism, wanton selfishness, indecency and other such interpersonal indignities. It doesn't say "Shame on you!" Rather, it inquires soberly, "Have you no shame?" I love the way the everpolite English say it: "Sir, you forget yourself."

The boy, age 10, lies to his father. When the father inquires about the discrepancy, the boy lies some more, his face defiant and desperate. The father shows the boy the evidence. The boy confesses, tears looming. The father's heart breaks for the boy. He knows what the boy is feeling: shame. It's awful. It's as if your heart is nauseated, but there's no vomiting the sickness.

How to walk this tightrope? An important lesson must be taught, but how to do it without crushing the boy?

"Well, this changes things," the father says, thoughtfully. "You're old enough now so that you and I should make a decision. If lying is the way you're going to handle yourself, then I guess I should get ready for the next several years of not believing you. On the other hand, maybe lying is not the man you want to be. Not a man you can respect. Maybe you'd like to tell me this is the first and the last time lying will be a part of our relationship. It's your choice, boy."

One tear spills towards a trembling chin. The boy says, "I won't lie to you anymore."

"That's wonderful news," the father exclaims, a warm smile pouring from his eyes.

The boy is humbled. Not humiliated. The father helps him find the courage to embrace a healthy shame. Which opens the way for a healthy self-respect.

Supporting the mental health of Nevada's rural communities

America is facing a public health crisis as health providers in communities across the country report increasing rates of suicide and mental illness diagnoses. A Center for Disease Control report released this June stated that suicide rates are on the rise across the country, particularly in rural communities. Nevada has much more work to do to reduce our suicide rate. In Nevada, the suicide rate is still much higher than the national average, and our veteran suicide rate is one the highest in the nation at 42.5 out of 100,000 residents. Mental illness and depression can affect anyone, but the unique characteristics of geographically remote communities in our state mean that there are many challenges with accessing the support and health treatments necessary to fight this devastating trend.

I am a proud cosponsor of the American Law Enforcement Mental Health and Wellness Act of 2017, which will increase resources and funding for mental health programs supporting local law enforcement, police departments and veterans, and I have demanded more information from this administration about a federal level Joint Action Plan to help reduce veteran suicides. I was proud to support the most recent funding bill, which will provide the Department of Veterans affairs with more than \$206 million to address veteran suicides across the country. Last month, I also introduced legislation aimed at protecting those suffering from addiction from being defrauded by deceptive or fake treatment centers.

I know the challenges facing our communities. Rural areas across the nation are facing a severe shortage of mental health professionals to help people struggling with depression, anxiety, suicidal thoughts, substance abuse and other mental health problems. More than 65% of all rural counties in America do not have a single psychiatrist, and 47% are lacking even a psychologist to listen to and treat patients. In Nevada, there is only one mental health provider for every 580 people living in the state.

I have also seen the incredible determination, strength and compassion that our communities have shown in the face of this crisis. Last summer, I met with members of the Healthy Communities Coalition of Lyon and Storey Counties' Health Services Hub. They're the creators of community hub that coordinates the delivery of mental health care and social services for the most

are to be sent to Oregon's Wild Horse Corral Facility in Hines. Some will be put up for adoption and others selected for participation in the spay and behavior research.

The BLM press release announcing the plans stated, "The public is welcome to view the Warm Springs HMA gather and spay procedures."

But one of the grounds cited in the lawsuits — filed by Front Range Equine Rescue, the American Wild Horse Campaign, the Cloud Foundation, the Animal Welfare Institute and others — is that the project violates the First Amendment, because outside groups are not adequately allowed to observe and record the surgery.

"To date, the BLM has refused to allow a meaningful opportunity for media or the public to observe and record these procedures," said Nick Lawton, a lawyer for one of the groups. "The BLM's refusal to allow meaningful access to observe and record these experiments thwarts the important newsgathering objectives that Plaintiffs aim to achieve by observing and documenting the BLM's treatment of wild horses, and thus violates Plaintiffs' rights under the First Amendment of the U.S. Constitution."

The groups also claim the spaying method — called ovariectomy via colpotomy, in which a veterinarian reaches into a mares' abdomen through an incision and severs and extracts the ovaries — is "unscientific, inhumane and dangerous, and will result in pain, suffering and potentially life-threatening complications for wild mares." They claim this violates the 1971 Wild Free-Roaming Horses and Burros Act and the National Environmental Policy Act.

The BLM spends \$50 million a year, or 60 percent of its annual budget for handling wild horses and burros, warehousing 46,000 of them in corrals and private pastures, while there are 83,000 wild horses and burros on a range that can adequately sustain no more than 27,000.

In a report to Congress earlier this year the BLM explained the problem and offered differ-

ent options, "Wild horses and burros have no natural predators and herds can double in size every 4 years. As herd sizes increase, the forage and water resources from the land become depleted, resulting in starvation, dehydration, and death. In their search for food and water, the animals often move onto private land or along highways resulting in safety issues and habitat destruction for horses and humans alike. Public-land ranchers have cut back on grazing to accommodate increasing numbers of wild horses and burros."

The report noted that overpopulation of these non-native animals is degrading the ecosystem and crowding out native greater sage grouse, pronghorn, deer, elk and bighorn sheep.

According to a CNN account, two of the groups involved — Front Range Equine Rescue and the American Wild Horse Campaign — have called for using an injectable birth control vaccine called Porcine Zona Pellucida (PZP) instead of surgery.

But surgery renders the mare sterile for the rest of its life, which can be as much as 25 years, while PZP must be administered every one to two years and requires more frequent captures of the horses, which can lead to injuries. The BLM is already experimenting with PZP.

The animal advocate groups are really making huge assumptions about what is best for the animals. Until the experiment is performed it is impossible to say what is best for the horses. Let's hope the BLM doesn't back down again in the face of litigation.

23,000 erroneous voter registrations.

The argument against passage of Question 5 points out, "The proposed 'Opt Out' system shifts the responsibility of registering to vote from the individual to the government. Nevada residents who do not want to be registered will have to affirmatively 'Opt Out' or have their names and addresses automatically added to voter rolls and become public information."

It also notes there is not evidence this change would increase voter turnout.

There is no evidence this measure will accomplish anything other than increased opportunities for errors. We shouldn't try to drag motorists kicking and screaming into the voting booth. **— TM**

Sisolak campaign spokesman Grigsby Crawford declined comment on Monday.



vulnerable members of their communities. The Health Services Hub is a partnership that uses federal and state funding to bring together groups like the Lyon County School District, Carson Health and Human Services, and Nevada Rural Counseling to support a wide variety of health initiatives. These vital programs include a series that brings guest speakers to local schools to speak on mental health and drug prevention as well as a support group that has increased the retention rate of mental health providers and non -profit leaders in the area.

Nevada was also one of eight states selected to be part of the Certified Community Behavioral Health Clinics (CCBHCs) demonstration program, which has created two new community behavioral health clinics at New Frontier in Fallon and Vitality Unlimited in Elko. This program has allowed Fallon and Elko to provide a large array of mental health and addiction services to residents with the help of enhanced Medicaid payments from the federal government. I am doing everything I can in the Senate to support these innovative partnerships and health programs to ensure Nevada's communities receive the federal funding and support they need to provide care to all Nevadans.
