Attempted escape from Gilchrist Jail thwarted

to establish control and locked down the facility, with all inmates accounted for. Members of the GCSO Patrol Division, Corrections Division, Gilchrist County Fire Rescue responded to the incident while Dixie and Levy County Sheriffs Office responded and assisted the GCSO staff with relocation of inmates.

At approximately 7:25 p.m. the jail

On Saturday, November 25, during staff on duty responded to an incident in the cell block. While removing one officers and one deputy sheriff were of the inmates the situation escalated and additional units responded to assist. The quick action resulted in the unsuccessful escape attempt. No inmates were injured in the incident and the correctional officers and deputy sheriff were transported to an area hospital and treated and released with minor, non life threatening inju-

All inmates are being temporarily housed at Levy and Dixie County Jails. Details are limited at this time because of the ongoing investigation of the escape attempt.

Trenton finishes 2016-17, \$469K under budget

Trenton City Manager Lyle Wilkerson reported Monday night to the City Commission that the City of Trenton finished the 2016-17 fiscal year \$469,793.63 under budget. Wilkerson explained that the Water and Sewer Fund totaled \$159,255.46 under budget. The General Fund at the end of the September 30, 2017 fiscal year showed that the City of Trenton had \$309,538.17 remaining in the budget for a combined total of \$469,793.63 in revenue. Lyle Wilkerson praised the entire City of Trenton staff for doing a good job and providing good service at a savings to the businesses and the residents of the City of Trenton. 

COOKING AND CARRYIN' ON

Sure hope y'all had a wonderful Thanksgiving. Our family tradition of having Thanksgiving at the family hunting camp continued this year. Although it was a bit messy due to the drizzling rain. Our clan didn't let 1 28-ounce can whole tomatoes, the wet weather stop us from having a good time. The grands had a wonderful time playing and the adults sure enjoyed all the great food. My brother Mike cut and cooked a big pot of swamp cabbage and barbecued some pork. The turkey and dressing was good but those cabbage were to die for.

Rice was a major crop of the Low Country region of South Carolina and Georgia until the end of the Civil War. Today Arkansas ranks first among rice-producing states, accounting for more than 40% of U.S. rice production. Now rice is being grown in South Florida. It is a rotation crop in the same fields where sugarcane is grown.



2018. The Commission discussed the combination of the Trunk or Treat and Halloween Trick or Treating in the downtown area of South Main Street in Trenton was unsafe for kids and those people that came to the courthouse area to take part in the activities planned for the public enjoyment. 

Discount Fluoride as a **Danger for Tea Drinkers**

If you drink tea, you can rest assured about your children's teeth or your adult bones, now that a University of Florida research team has found that most teas contain safe amounts of fluoride.

Drinking tea can benefit human health, but it contains fluoride, and too much fluoride can lead to teeth discoloration and malformation for children and bone problems for adults, said Lena Ma, a UF/IFAS professor of soil and water sciences. If you drink too much of it, scientists from dental fluorosis in children or skeletal fluorosis in adults. The situation can be aggravated if water used for brewing tea contains high amounts of fluoride.

"Few people may be aware of the high fluoride content in some teas," said Ma, who led a new study that researched fluoride levels in traditional and herbal teas.





ECP signup will begin on November 6, 2017, and end on January 6, 2018.

According to VanAernam, approved ECP practices under this authorization include removing debris from farmland; grading, shaping, or releveling severely damaged farmland; restoring permanent fences; and restoring conservation structures

and other similar installations. ECP is administered by FSA to assist producers with the cost of recovery activities required to restore the agricultural land to pre-disaster conditions. Producers who sustained damage from this disaster event are encouraged to submit their request for assistance prior to beginning reconstructive work. Submitting a request after completing qualified was able to pull away in the fourth added six points. reconstructive work may result in forfeiture of program eligibility.

"I realize that there are extenuating circumstances that must be addressed for livestock safety and health reasons, but I strongly recommend at least calling our office before any action is taken," said VanAernam.

FSA county committees will complete an evaluation of submitted requests and obligate available funds based on an on-site inspection of the damaged land, taking into consideration the type and extent of the eligible damage. Completion of the on-site inspection does not guarantee that cost-share funding will be allocated.

The use of obligated funds is limited to return the land to the relative predisaster condition. Conservation concerns that were present on the land prior to the disaster are not eligible for ECP assistance. Approved ECP applicants may receive up to 75 percent of the cost of completing the
