



# **PURCHASING AFFIDAVIT**

MANDATE: Under W. Va. Code §5A-3-10a, no contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and: (1) the debt owed is an amount greater than one thousand dollars in the aggregate; or (2) the debtor is in employer default.

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

# **Engagement Structure**

#### **PROJECT DESCRIPTION**

The services described herein detail the Professional Services to be performed by AdvizeX Technologies for the State of West Virginia (hereafter, "State of West Virginia" or "Customer"). AdvizeX Technologies will deploy one new HP Integrity rx2800i4 HP-UX server, a pair of Brocade 300B Fibre Channel Storage Area Network switches, and one EMC VNX5200 storage array. The equipment will be mounted within the same rack per Customer request. AdvizeX will migrate up to 6 TB of data from existing storage to this new EMC storage solution. AdvizeX will install and configure the HP-UX server, Brocade SAN switches, and EMC VNX storage solution as listed in the Scope section below. The solution will be installed at Customer's Charleston, WV location.

At the conclusion of the project, AdvizeX will deliver "As-Built" documentation for all devices installed and configuration performed as part of this Statement of Work.

#### SCOPE

AdvizeX will perform the project activities defined below:

#### **VNX Implementation Services:**

- Site preparation and installation prerequisites AdvizeX will provide equipment installation prerequisites to Customer. Included are the amount of rack space, power, network interfaces, and environmental requirements to support one VNX5200 storage array.
- Storage array installation, initialization, and configuration The array will be installed into an EMC supported cabinet, labeled, and initialized. The VNX management software will be configured and VNX Operating Environment updated if required by AdvizeX per the EMC support matrix. FAST cache and storage pools will be configured as appropriate on the array for block access based on Customer requirements and EMC best practices. EMC call home support and email notifications will be configured as directed by Customer.
- Host compatibility review AdvizeX will review the EMC support matrix to determine
  the supported levels of drivers and host software for the HP-UX / Integrity rx2800i4 build
  and produce a report with the target levels. Customer will be responsible for any
  application remediation required to correct issues listed in reports provided is the
  responsibility of the Customer.
- **Block storage deployment** Following successful confirmation of host compatibility above, AdvizeX will configure the new VNX array for Fibre Channel block access. One HP Integrity rx2800i4 will be provisioned by AdvizeX. AdvizeX is responsible for installation multi-pathing software as required on Fibre Channel block hosts. Attachment of any additional hosts and affiliated provisioning will be the responsibility of Customer.



#### **Migration Services:**

- General migration planning AdvizeX will discuss pertinent migration methodologies with Customer, including any software or connectivity prerequisites which must be satisfied prior to the start of any migration activities. Cutover procedures, including the number of migration events (if any), and schedules will be built in conjunction with Customer and agreed to by both parties. Customer will be responsible for end user notification and change management processes.
- Block host scoping, analysis, and migration planning Documentation of requirements for block migration targets will be constructed based on existing storage layouts for one HP-UX server. The new storage layout will be documented for these migration targets and agreed upon with Customer. Migration strategies (example. host-based or array-based) will be documented for each host as appropriate. Host based migration will be considered the default method for the one HP-UX server AdvizeX will migrate, unless migration planning determines an alternate method.
- **Host-based data migration** New storage devices will be created on the VNX array based on the scope and documentation created above for block migration. These devices will then be presented to the HP-UX host-based migration target based on the schedule agreed to above. After data migration has completed, removal of old host-side storage volumes will be completed by AdvizeX based on the schedule agreed to with Customer.

#### **SAN Switch Implementation Services:**

- Site preparation and installation AdvizeX will check the SAN switch compatibility with the EMC Support Matrix and provide any recommended changes in a remediation report for Customer to implement prior to implementation of two new Brocade 300B departmental SAN switches with 8 active ports on each switch.
- SAN switch configuration and zoning The departmental SAN switches will be upgraded to the target version of firmware and bios, as required by EMC Support Matrix (ESM). AdvizeX will perform the necessary switch zoning on the two new 300B switches to ensure the connected devices listed in the scope section of this SOW have the proper path connectivity. Zoning will adhere to EMC best practices for the solution involved. In the event these two new SAN switches require merging with existing SAN fabrics to support migration of one HP-UX server, AdvizeX will plan and carry-out the fabric merge. Splitting the fabrics following such a migration will also be the responsibility of AdvizeX. Any additional zoning or switch configuration for connected devices not listed in the scope section of this SOW is the responsibility of Customer.

#### **Documentation and Knowledge Transfer Services:**

• **Documentation delivery and informal knowledge transfer** – Handover of all "As-Built" documentation as well as execution of an informal knowledge transfer session (up to four hours) with Customer's IT group on the new configurations which were constructed and delivered as part of this statement of work. Please note that this knowledge transfer does not replace formal vendor education. AdvizeX recommends formal vendor training.
