**NOTICE IS HEREBY GIVEN** that the Board of Clark County Councilors and the Clark County Planning Commission will conduct a public hearing on **TUESDAY, September 1, 2015, and THURSDAY, September 3, 2015, at 6:00 p.m.**, at the **Clark County Public Service Center, 1300 Franklin, Vancouver, WA**, to consider the following:

**2016 COMPREHENSIVE PLAN UPDATE DRAFT SUPPLEMENTAL ENVIRONMENTAL IMPACT STATEMENT**

Clark County is updating its comprehensive plan to meet the 2016 Growth Management Act deadline. As part of the update process, the county is required to analyze growth alternatives through the SEPA process. The county has re-adopted the environmental impact statement (EIS) prepared on the 2007 update and prepared a supplemental EIS (SEIS) to look at potential growth options for the 2016-2035 time horizon. Four alternatives are reviewed in the draft SEIS.

The purpose of the hearing is to take public testimony on the alternatives. The Board will ultimately recommend a preferred alternative and a final SEIS will be prepared on that alternative.


