# A REVERSE ISOPERIMETRIC INEQUALITY FOR J-HOLOMORPHIC CURVES 

YOEL GROMAN AND JAKE P. SOLOMON


#### Abstract

We prove that the length of the boundary of a $J$ holomorphic curve with Lagrangian boundary conditions is dominated by a constant times its area. The constant depends on the symplectic form, the almost complex structure, the Lagrangian boundary conditions and the genus. A similar result holds for the length of the real part of a real $J$-holomorphic curve. The infimum over $J$ of the constant properly normalized gives an invariant of Lagrangian submanifolds. We calculate this invariant to be $2 \pi$ for the Lagrangian submanifold $\mathbb{R} P^{n} \subset \mathbb{C} P^{n}$. We apply our result to prove compactness of moduli of $J$-holomorphic maps to non-compact target spaces that are asymptotically exact. In a different direction, our result implies the adic convergence of the superpotential.

## 1. Introduction

1.1. A consequence of the Cauchy-Crofton formula. We begin with a bound on the length of a real algebraic curve in terms of its degree, which we learned from 14. Let $\gamma$ be a one dimensional submanifold of $\mathbb{R P}^{n}$. Let $h$ be the round metric on $\mathbb{R} \mathbb{P}^{n}$ normalized so the length of a line is 1 . Let $d V$ be the volume form on $\operatorname{Gr}(n, n+1)$, the Grassmanian of hyperplanes in $\mathbb{R}^{n+1}$, that is invariant under the induced action of the isometry group of $h$ and satisfies

$$
\int_{G r(n, n+1)} d V=1
$$

For $H \in G r(n, n+1)$ denote by $N(H)$ the number of intersection points between $H$ and $\gamma$,

$$
N(H)=N(H, \gamma)=|\{\gamma \cap H\}| .
$$

By transverality, $N(H)$ is finite for generic $H$. Let $\ell(\gamma ; h)$ denote the length of $\gamma$ with respect to $h$. The Cauchy-Crofton formula [26, eq. 12] asserts that

$$
\begin{equation*}
\int_{H \in \operatorname{Gr}(n, n+1)} N(H) d V=\ell(\gamma ; h) . \tag{1}
\end{equation*}
$$

For a quick sanity check, note that when $\gamma$ is a straight line, both sides of equation (1) are equal to 1 .

Assume now that $\gamma$ is an algebraic curve of degree $d$. As observed in [14, p.45], the Cauchy-Crofton formula (1) implies

$$
\begin{equation*}
d \geq \ell(\gamma ; h) \tag{2}
\end{equation*}
$$

We interpret inequality (2) as a reverse isoperimetric inequality. The Fubini-Study metric on $\mathbb{C} P^{n}$ normalized so the area of a complex line is $\frac{1}{\pi}$ induces the metric $h$ on $\mathbb{R} P^{n}$, so we denote it also by $h$. Let
$\alpha \in H_{2}\left(\mathbb{C} P^{n}, \mathbb{R} P^{n}\right) \simeq \mathbb{Z}$ be the generator that pairs positively with the Kähler form of $h$. Let $(\Sigma, \partial \Sigma)$ be a Riemann surface with boundary, and denote by $[\Sigma, \partial \Sigma] \in H_{2}(\Sigma, \partial \Sigma)$ the relative fundamental class. Let

$$
u:(\Sigma, \partial \Sigma) \rightarrow\left(\mathbb{C} P^{n}, \mathbb{R} P^{n}\right)
$$

be a holomorphic map with $[u]:=u_{*}([\Sigma, \partial \Sigma])=d \alpha$. By Wirtinger's theorem,

$$
\operatorname{Area}(u ; h)=\frac{d}{2 \pi}
$$

Schwarz reflection implies that $\left.u\right|_{\partial \Sigma}$ is real algebraic. So equation (2) gives the estimate

$$
\begin{equation*}
2 \pi \operatorname{Area}(u ; h) \geq \ell\left(\left.u\right|_{\partial \Sigma} ; h\right) \tag{3}
\end{equation*}
$$

The present paper extends inequality (3) to general symplectic manifolds $M$, Lagrangian submanifolds $L \subset M$, and $J$-holomorphic maps $(\Sigma, \partial \Sigma) \rightarrow(M, L)$.
1.2. The compact case. In the following let $(M, \omega)$ be a symplectic manifold, let $L \subset M$ be a Lagrangian submanifold and let $J$ be an almost complex structure on $M$ for which the form $\omega(\cdot, J \cdot)$ is positive definite. Denote by $g_{J}$ the symmetrization of the form $\omega(\cdot, J \cdot)$. For $\Sigma$ a Riemann surface with boundary we denote by $\Sigma_{\mathbb{C}}$ the complex double of $\Sigma$.

Theorem 1.1. Suppose $M$ is compact. There are constants $f_{1}=$ $f_{1}(J, \omega, L)$ and $g_{1}=g_{1}(J, \omega, L)$, homogeneous of degrees $-\frac{1}{2}$ and $\frac{1}{2}$ respectively in $\omega$, with the following significance. For any Riemann surface $\Sigma$ with boundary, and for any J-holomorphic curve

$$
u:(\Sigma, \partial \Sigma) \rightarrow(M, L)
$$

we have

$$
\begin{equation*}
\ell\left(\left.u\right|_{\partial \Sigma} ; g_{J}\right) \leq f_{1} \operatorname{Area}\left(u ; g_{J}\right)+g_{1} \operatorname{genus}\left(\Sigma_{\mathbb{C}}\right) \tag{4}
\end{equation*}
$$

Let $(M, L)=\left(\mathbb{C} P^{n}, \mathbb{R} P^{n}\right)$, let $\omega=\omega_{F S}$ be the Fubini-Study form and let $J=J_{s t}$ be the standard complex structure. By the discussion in Section 1.1, we may take

$$
f_{1}\left(J_{s t}, \omega_{F S}, L\right)=2 \pi, \quad g_{1}\left(J_{s t}, \omega_{F S}, L\right)=0
$$

At this point it is not clear whether the genus dependence in (4) can be eliminated in the general case. On the other hand, the monotonicity inequality [27] gives a lower bound on $\operatorname{Area}\left(u ; g_{J}\right)$. So the constant $g_{1}$ can be set to zero at the expense of making $f_{1}$ genus dependent.

Recently, real symplectic geometry has attracted considerable attention. See, for example, [30, 25, 17, 6]. Theorem 1.1 has the following
parallel in the real-symplectic setting. Recall that a real symplectic manifold is a triple $(M, \omega, \phi)$ where $(M, \omega)$ is a symplectic manifold and $\phi: M \rightarrow M$ is an anti-symplectic involution, that is, $\phi^{*} \omega=-\omega$. The natural compatibility condition for almost complex structures is that $\phi^{*} J=-J$. A real Riemann surface is a pair $(\Sigma, \psi)$, where $\Sigma$ is a Riemann surface and $\psi: \Sigma \rightarrow \Sigma$ is an anti-holomorphic involution. We denote by $\Sigma_{\mathbb{R}}$ the fixed point set of $\psi$. A $J$-holomorphic curve $u: \Sigma \rightarrow M$ is called real if $\phi \circ u=u \circ \psi$.

Theorem 1.2. Suppose $(M, \omega, \phi)$ is a compact real symplectic manifold. There are constants $f_{2}=f_{2}(J, \omega)$ and $g_{2}=g_{2}(J, \omega)$, homogeneous of degrees $-\frac{1}{2}$ and $\frac{1}{2}$ respectively in $\omega$, with the following significance. For any real Riemann surface $(\Sigma, \psi)$ and any real J-holomorphic curve $u: \Sigma \rightarrow M$, we have

$$
\begin{equation*}
\ell\left(\left.u\right|_{\Sigma_{\mathbb{R}}} ; g_{J}\right) \leq f_{2} \operatorname{Area}\left(u ; g_{J}\right)+g_{2} \operatorname{genus}(\Sigma) . \tag{5}
\end{equation*}
$$

We remark that a forward isoperimetric inequality does not hold for holomorphic curves. Indeed, consider degree 2 curves in $\left(\mathbb{C P}^{2}, \mathbb{R P}^{2}\right)$. For $t>0$, let $C_{t}$ be the closure of one of the two connected components of the non-real solutions of the equation $X^{2}+Y^{2}-t=0$. Then $C_{t}$ has constant area but arbitrarily small boundary length as $t$ goes to 0 .
1.3. The optimal isoperimetric constant. The preceding theorems, though they involve Riemannian length measurements, lead to a purely symplectic invariant of Lagrangian submanifolds. For a given $J$, denote by $F_{1}(\omega, J, L)$ the optimal value of the constant $f_{1}(\omega, J, L)$ of Theorem 1.1 when $u$ ranges over $J$-holomorphic maps from a surface of genus 0 . Define the constant $h_{1}(M, L, \omega)$ by

$$
h_{1}(M, L, \omega)=\inf _{J} \frac{F_{1}(\omega, J, L)}{2 \operatorname{Diam}\left(L ; g_{J}\right)},
$$

where the infimum is over all $J$ tamed by $\omega$. Similarly, for $(M, \omega, \phi)$ a real symplectic manifold, for given $\phi$ anti-invariant $J$, denote by $F_{2}(\omega, J)$ the optimal value of the constant $f_{2}(\omega, J)$ of Theorem 1.2 when $u$ ranges over maps from the surface of genus 0 . Define the constant $h_{2}(M, \phi, \omega)$ by

$$
h_{2}(M, \phi, \omega)=\inf _{J} \frac{F_{2}(\omega, J)}{2 \operatorname{Diam}\left(\operatorname{Fix}(\phi) ; g_{J}\right)}
$$

where the infimum is over all tame $J$ such that $\phi^{*} J=-J$.
Clearly, $h_{1}$ and $h_{2}$ are symplectic invariants. Theorems 1.1 and 1.2 imply that $h_{i}(M, L, \omega)<\infty$. As seen in the proof of the following proposition, lower bounds follow from open Gromov-Witten theory.

Proposition 1.3. Let $M=\mathbb{C P}^{n}$, let $L=\mathbb{R} \mathbb{P}^{n}$ and let $\omega=\omega_{F S}$ be the Fubini-Study form normalized so the area of a line is $\frac{1}{\pi}$. Then $h_{1}(M, L, \omega)=2 \pi$.

For lower bounds on $h_{2}$, we can use the rapidly developing theory of Welschinger invariants [30, 17, 6, 16]. In the projective real algebraic case, the discussion of Section 1.1 gives upper bounds on $h_{2}$. However, to minimize the discrepancy between upper and lower bounds, it is necessary understand how to maximize diameter within a deformation class of projective real algebraic varieties.

There are various ways to generalize $h_{i}$ to higher genus, and it seems interesting to study the resulting invariants. Also, restricting to $u$ with non-trivial boundary degree, it could be interesting to consider the ratio of the isoperimetric constant $F_{1}$ and a version of the 1 -systole of $L$. As we will see in Section 1.7, such a ratio arises naturally in the context of the Fukaya category. See [18] for background on systolic geometry. We leave these problems for future research.
1.4. The general case. We show how Theorems 1.1 and 1.2 generalize when $M$ and $L$ are not compact. In the process, we characterize more precisely the dependence of the isoperimetric constants $f_{i}$ on the geometry of $(M, \omega, J, L)$.

Denote by $R$ the curvature of $M$, by $B$ the second fundamental form of $L$ and by $i$ the radius of injectivity of $M$, all with respect to the metric $g_{J}$. For a tensor $A$ on $M$ or on $L$, we denote by $\|A\|_{m}$ the $C^{m}$ norm of $A$ with respect to $g_{J}$. We say that $(M, \omega, J, L)$ has $K$-bounded geometry if

$$
\max \left\{\|R\|_{2},\|J\|_{2},\|B\|_{2}, \frac{1}{i}\right\}<K
$$

For any Riemannian manifold $X$ with submanifold $Y$ and $\epsilon>0$, we say that $Y$ is $\epsilon$-Lipschitz if

$$
\frac{d_{X}(x, y)}{\min \left\{1, d_{Y}(x, y)\right\}} \geq \epsilon \quad \forall x \neq y \in Y .
$$

Theorem 1.4. There are functions $f_{1}=f_{1}(K)$ and $g_{1}=g_{1}(K)$, with the following significance. Theorem 1.1 holds upon replacing the assumption that $M$ is compact by the assumption that $(M, \omega, J, L)$ has $K$-bounded geometry as well as one of the following:
(a) $L$ is $\frac{1}{K}$-Lipschitz.
(b) Consider the conformal metric on $\Sigma$ of constant curvature $0, \pm 1$, of unit area in case of zero curvature, such that $\partial \Sigma$ is totally geodesic. Then $\partial \Sigma$ and each connected component of $L$ are $\frac{1}{K}$ Lipschitz.

Theorem 1.2 generalizes to the non-compact case under considerably weaker assumptions.

Theorem 1.5. There are functions $f_{2}(K)$ and $g_{2}(K)$ such that Theorem 1.2 holds upon replacing the requirement that $M$ be compact with the requirement that

$$
\max \left\{\|R\|,\|J\|_{2}, \frac{1}{i}\right\}<K
$$

There is also an a priori estimate on the diameter of $J$-holomorphic curves.

Theorem 1.6. There are functions $f_{3}=f_{3}(K)$ and $g_{3}=g_{3}(K)$ such that under the same assumptions as in Theorem 1.4 and denoting $b:=$ $\left|\pi_{0}(\partial \Sigma)\right|$,
(6) $\operatorname{Diam}\left(u(\Sigma) ; g_{J}\right) \leq(b+1)\left[f_{3} \operatorname{Area}\left(u ; g_{J}\right)+g_{3} \operatorname{genus}\left(\Sigma_{\mathbb{C}}\right)\right]$.

In the case of closed curves, which includes conjugation invariant curves, as well as in case (a) of Theorem 1.4, the diameter estimate (6), without any genus dependence, was proved by Sikorav [27] using the monotonicity inequality. However, Sikorav's technique is image oriented, so we could not see how it would allow one to utilize the bounds on the domain necessary in case (b) of Theorem 1.4. More importantly, we could not see how to generalize Sikorav's technique to obtain results on boundary length.
1.5. An example. The following example, due to [22], illustrates the role of conditions (a) and (b) of Theorem 1.4. Consider the special Lagrangian fibration of $M=\mathbb{C}^{3}$ discussed in [15] and [1]. Namely, let $H: \mathbb{C}^{3} \rightarrow \mathbb{R}^{3}$, be given by

$$
\left(z_{1}, z_{2}, z_{3}\right) \mapsto\left(\left|z_{1}\right|^{2}-\left|z_{3}\right|^{2},\left|z_{2}\right|^{2}-\left|z_{3}\right|^{2}, \operatorname{Im}\left(z_{1} z_{2} z_{3}\right)\right) .
$$

It can be shown that for each $c \in \mathbb{C}^{3}$ the fiber $H^{-1}(c)$ is Lagrangian. Moreover, letting $J_{0}$ and $\omega_{0}$ denote the standard complex and symplectic structures on $\mathbb{C}^{3}$, it can be shown that $\left(M, \omega_{0}, J_{0}, H^{-1}(c)\right)$ has bounded geometry and that $H^{-1}(c)$ is Lipschitz. Thus the reverse isoperimetric inequality applies to curves with boundary in $H^{-1}(c)$.

On the other hand, consider a Lagrangian $L \subset \mathbb{C}^{3}$ which is the union of two or more fibers of $H$. Then the components of $L$ are arbitrarily close to each other at infinity. Thus $L$ as a whole is not Lipschitz, but each component of $L$ is. We construct a counterexample to the reverse isoperimetric inequality as follows. Let $L_{0}=H^{-1}(0,0,0)$ and $L_{1}=H^{-1}(-1,-1,0)$. For any $a \in \mathbb{R}$ we construct a holomorphic
annulus with one boundary component in $L_{0}$ and the other one in $L_{1}$. For any $a \in \mathbb{R}$ let $r_{a}$ be a positive solution of the equation

$$
a^{2} r^{6}+r^{4}-a^{2}=0 .
$$

Let $\Sigma_{a}$ be the annulus in the plane with radii 1 and $r_{a}$. Consider the map

$$
\left(\Sigma_{a}, \partial \Sigma_{a}\right) \rightarrow\left(\mathbb{C}^{3}, L_{0} \cup L_{1}\right)
$$

given by

$$
z \mapsto\left(a z, a z, \frac{a}{z^{2}}\right) .
$$

Allowing $a$ to approach infinity, the boundary length is unbounded while the area, being a homological invariant, remains constant. Thus there is no reverse isoperimetric inequality in this case. Theorem 1.4)(b) implies that the Lipschitz constant of $\partial \Sigma_{a}$ goes to 0 as $a$ approaches infinity. This can indeed be verified directly by noting that

$$
\lim _{a \rightarrow \infty} r_{a}=1,
$$

so $\operatorname{Mod}\left(\Sigma_{a}\right)=\ln r_{a} \rightarrow 0$.
1.6. Application to compactness. We apply Theorem 1.4 to deduce compactness of moduli spaces of $J$-holomorphic maps in the following scenario. Our argument can be seen as a quantitative version of the idea of [19]. We say that the symplectic form $\omega$ is asymptotically exact if for a point $p \in M$ there exists a 1 -form $\lambda$ such that

$$
\lim _{R \rightarrow \infty}\left\|\left.(\omega-d \lambda)\right|_{M \backslash B_{R}(p)}\right\|_{C^{0}}=0 .
$$

Here and below we use the $C^{0}$ norm induced by $g_{J}$. Similarly, we say that $L$ is an asymptotically exact Lagrangian submanifold if $\omega$ is asymptotically exact and there is a function $f: L \rightarrow \mathbb{R}$ so that

$$
\lim _{R \rightarrow \infty}\left\|\left.(\lambda-d f)\right|_{L \backslash B_{R}(p)}\right\|_{C^{0}}=0
$$

Applying Stokes theorem, the following is immediate.
Corollary 1.7. Let $A \in H_{2}(M, L), g \in \mathbb{N} \cup\{0\}$, and $p \in M$. Assume $\omega$ and $L$ are asymptotically exact and $(M, \omega, J, L)$ has $K$-bounded geometry. Then there is an $R=R(M, L, p, K, A)$ such that any $J$ holomorphic

$$
u:(\Sigma, \partial \Sigma) \rightarrow(M, L)
$$

with $[u]=A$ and $\operatorname{genus}\left(\Sigma_{\mathbb{C}}\right) \leq g$ that satisfies the conditions of Theorem 1.4 also satisfies $u(\Sigma) \subset B_{R}(p)$.

Given this corollary, standard Gromov compactness implies compactness of the moduli space of stable maps of degree $A$ and

$$
\operatorname{genus}\left(\Sigma_{\mathbb{C}}\right) \leq g
$$

In a paper to appear subsequently, we prove that toric Calabi Yau manifolds along with the Lagrangian submanifolds of Aganagic Vafa [2] are asymptotically exact and have bounded geometry. Thus, we apply the construction of [23] to define open Gromov-Witten invariants for general toric Calabi Yau 3-folds.
1.7. Application to adic convergence. The linearity in the estimate of Theorem 1.1 is important for proving adic convergence results in the $A_{\infty}$-algebra associated with $L$. As an example of the utility of Theorem 1.1 in this connection, we give an alternative proof of a result of [10, 11]. For simplicity, we restrict attention to cases where the moduli space of $J$-holomorphic disks up to reparametrization is of dimension zero, such as when $M$ is a compact Calabi-Yau manifold of dimension three and $L$ a Lagrangian sub-manifold of Maslov index zero. We limit our discussion to a simplified version of the superpotential. Nevertheless, the ideas we present are not limited to this simplified setting.

Let $T$ be a formal variable and write

$$
\Lambda_{0, \text { nov }}:=\left\{\sum_{i} a_{i} T^{\lambda_{i}} \mid a_{i} \in \mathbb{C}, \lambda_{i} \in \mathbb{R}_{\geq 0}, \lim _{i \rightarrow \infty}\left\{\lambda_{i}\right\}=\infty\right\}
$$

and

$$
\Lambda_{\text {nov }}:=\left\{\sum_{i} a_{i} T^{\lambda_{i}} \mid a_{i} \in \mathbb{C}, \lambda_{i} \in \mathbb{R}, \lim _{i \rightarrow \infty}\left\{\lambda_{i}\right\}=\infty\right\}
$$

Let

$$
\operatorname{val}\left(\sum_{i} a_{i} T^{\lambda_{i}}\right):=\inf \left\{\lambda_{i} \mid a_{i} \neq 0\right\}
$$

The field $\Lambda_{\text {nov }}$ is equipped with a non-Archimedean norm $|\cdot|$ defined by

$$
|x|:=e^{-\operatorname{val}(x)} .
$$

To count $J$-holomorphic disks in $(M, L)$, we use a domain dependent $J$ as follows. Let $J=\left\{J_{z}\right\}_{z \in D^{2}}$ be a family of almost complex structures compatible with $\omega$. Denote by $j$ the standard complex structure on $D^{2}$. Let $u:\left(D^{2}, \partial D^{2}\right) \rightarrow(M, L)$. We say $u$ is $J$-holomorphic if

$$
d u_{z}+J_{u(z), z} \circ d u_{z} \circ j_{z}=0, \quad z \in D^{2}
$$

Our theorem applies to such maps via the following graph construction. Think of $D^{2}$ as the northern hemisphere of $S^{2}$ and denote by $j$ the standard complex structure on $S^{2}$ as well. Extend the family of almost complex structures $J_{z}$ arbitrarily to $z \in S^{2}$. Let $\widetilde{M}=M \times S^{2}$, let $\widetilde{J}$ be the almost complex structure on $\widetilde{M}$ given by $\widetilde{J}_{x, z}=J_{x, z} \oplus j_{z}$, and let $\widetilde{L}=L \times \partial D^{2}$. Define $\tilde{u}:\left(D^{2}, \partial D^{2}\right) \rightarrow(\widetilde{M}, \widetilde{L})$ by $\tilde{u}=u \times$ id. Then $u$ is $J$-holomorphic if and only if $\tilde{u}$ is $\widetilde{J}$ holomorphic, and our theorem applies directly to $\tilde{u}$. For a generic choice of $J$, it is shown in [24] that all $J$-holomorphic maps $u$ are regular. Imposing appropriate divisor constraints on $u$ as in [28], we obtain a discrete space. So, for $\beta \in H_{2}(M, L ; \mathbb{Z})$, we define $N_{\beta}$ to be the number of $J$-holomorphic disks with boundary in $L$ representing $\beta$. In general, the numbers $N_{\beta}$ depend on the choice of $J$.

The superpotential is a map $\psi: H^{1}(L ; \mathbb{C}) \rightarrow \Lambda_{0, \text { nov }}$ defined as follows. Let $\left\{e_{i}\right\}_{i=1}^{m}$ be a basis for the integral lattice in $H^{1}(L ; \mathbb{C})$. For a relative homology class $\beta \in H_{2}(M, L ; \mathbb{Z})$, denote by $E(\beta)$ the symplectic area of $\beta$, and denote by $\left(\partial \beta, e_{i}\right)$ the integral of $e_{i}$ over the boundary of $\beta$. For

$$
b=\sum_{i=1}^{m} b_{i} e_{i} \in H^{1}(L ; \mathbb{C}),
$$

the superpotential is given by

$$
\psi(b):=\sum_{\beta \in H_{2}(M, L ; \mathbb{Z})} N_{\beta} e^{\sum_{i=1}^{m} b_{i}\left(\partial \beta, e_{i}\right)} T^{E(\beta)} .
$$

Let $\tilde{\psi}:\left(\mathbb{C}^{\times}\right)^{m} \rightarrow \Lambda_{0, \text { nov }}$ be the map

$$
\begin{equation*}
\tilde{\psi}\left(t_{1}, \ldots, t_{m}\right)=\sum_{\beta \in H_{2}(M, L ; \mathbb{Z})} N_{\beta} \prod_{i=1}^{m} t_{i}^{\left(\partial \beta, e_{i}\right)} T^{E(\beta)} \tag{7}
\end{equation*}
$$

Thus, $\psi$ factors through the exponential map exp : $H^{1}(L ; \mathbb{C}) \rightarrow\left(\mathbb{C}^{\times}\right)^{m}$ via $\tilde{\psi}$. For the intrinsic construction of the SYZ mirror to $M$ as outlined in [12, 29], it is desirable to extend the domain of $\tilde{\psi}$ and other similar power series to an appropriate annulus in $\left(\Lambda_{\text {nov }}\right)^{m}$. For $\alpha$ a 1-form on $L$, let $\|\alpha\|_{L^{\infty}}$ be the norm given by taking the supremum over the $L^{\infty}$ norms associated with the Riemannian metrics $g_{J_{z}}$ for $z \in D^{2}$. For $a \in H^{1}(L)$, let $\|a\|_{L^{\infty}}$ denote the infimum of $\|\alpha\|_{L^{\infty}}$ over forms $\alpha$ representing $a$. The following theorem is proved in [10, 11] via a different route.

Theorem 1.8. Let $\delta=\frac{1}{f_{1} m \max \left\|e_{i}\right\|_{L^{\infty}}}$. Then the power series (7) converges for $\left(t_{1}, \ldots, t_{m}\right) \in \Lambda_{\text {nov }}^{m}$ with $\operatorname{val}\left(t_{i}\right) \in(-\delta, \delta)$.

Proof. A series $\sum x_{i}$ of elements $x_{i}$ in a non-Archimedean field converges if and only if $\lim \left|x_{i}\right|=0$. See [5] for relevant background. In the case of $\Lambda_{\text {nov }}$, this just means that for any $E \in \mathbb{R}$ there exists a finite set $A_{E}$ such that for any index $i \notin A_{E}$ and any $E^{\prime} \leq E$, the coefficient of $T^{E^{\prime}}$ in $x_{i}$ is 0 . For the question at hand, let $A_{E}$ be the set of classes $\beta \in H_{2}(M, L ; \mathbb{Z})$ such that $N_{\beta} \neq 0$ and

$$
\left(1-m f_{1} \max _{i}\left\{\left|\operatorname{val}\left(t_{i}\right)\right|\left\|e_{i}\right\|_{L^{\infty}}\right\}\right) E(\beta) \leq E .
$$

Suppose $\operatorname{val}\left(t_{i}\right) \in(-\delta, \delta)$. Then by Gromov compactness, $A_{E}$ is a finite set. On the other hand, by Theorem 1.1 we have

$$
\left(\partial \beta, e_{i}\right) \leq f_{1} E(\beta)\left\|e_{i}\right\|_{L^{\infty}}
$$

for any $\beta$ with $N_{\beta} \neq 0$. In particular, for any $\beta \notin A_{E}$ and $E^{\prime} \leq E$ the coefficient of $T^{E^{\prime}}$ in $N_{\beta} \prod_{i=1}^{m} t_{i}^{\left(\partial \beta, e_{i}\right)} T^{E(\beta)}$ vanishes.

The proof given in [10, 11] for the same result avoids the heavy analysis going into the proof of Theorem 1.1. However, it is not clear how to extend that proof to the $A_{\infty}$-algebra of immersed Lagrangians as defined in [3]. On the other hand, the above proof applies to immersed Lagrangians if we extend Theorem 1.1 to $J$-holomorphic maps with strip-like ends asymptotic to a transverse intersection point. Such an extension should not be hard. We thank K. Fukaya for this idea.

In the spirit of Section [1.3, Theorem 1.8 suggests we consider the purely symplectic invariant

$$
h_{3}(M, L, \omega)=\inf _{J} F_{1}(\omega, J, L) \max \left\|e_{i}\right\|_{L^{\infty}}
$$

The norm $\|\cdot\|_{L^{\infty}}$ on cohomology has been studied in the context of systolic geometry [18]. Norms of integral homology bases have been studied in [8] for the case of surfaces. An upper bound on the convergence radius of the superpotential would imply a non-trivial lower bound for $h_{3}$.
1.8. Idea of the proof. We restrict attention to the case of real $J$ holomorphic maps from a real Riemann surface $(\Sigma, \psi)$, which for the time being, we assume to be a sphere. We assume the fixed point set $\Sigma_{\mathbb{R}}$ of $\psi$ is non-empty and abbreviate $\gamma=\Sigma_{\mathbb{R}}$. We equip $\Sigma$ with a round metric invariant under $\psi$ of radius 1 . In particular, $\gamma$ is a great circle.

Let $u: \Sigma \rightarrow M$ be real $J$-holomorphic. Let $f: \gamma \rightarrow[0, \infty)$ be given by $f(x):=\|d u(x)\|$. Then $\ell(u(\gamma))$ is the area of the hypograph of $f$,

$$
H=\{(x, t) \in \gamma \times[0, \infty) \mid t \leq f(x)\}
$$

The bubbling phenomenon implies that there is no a priori bound on the $L_{\infty}$ norm of $f$ in terms of the energy of $u$. Thus our argument relies on a close analysis of the set $H$.

In the following sketch of our proof, we make the simplifying assumption that $f$ has a unique local maximum on $\gamma$. For $t \in[1, \infty)$ write $w_{t}=\{x \in \gamma \mid f(x) \geq t\}$ and let $W_{t} \subset \Sigma$ be the image under the exponential map of the ball of radius $\frac{1}{t}$ in the normal bundle of $w_{t}$. Our simplifying assumption implies that $w_{t}$ is connected. Note also that if $t^{\prime}>t$, then $w_{t^{\prime}} \subset w_{t}$. For any $t$ write

$$
a_{t}:=\left\lfloor\frac{t \ell\left(w_{t}\right)}{2}\right\rfloor .
$$

One of the main ways the fact that $u$ is $J$-holomorphic enters our proof is the following energy quantization property. Let $p \in \Sigma$ with $d=\|d u(p)\| \geq 1$, and let $B \subset \Sigma$ be the disk of radius $\frac{1}{d}$ centered at $p$. Then it is known [24, Lemma 4.3.1] ${ }^{11}$ that

$$
\begin{equation*}
\int_{B}\|d u\|^{2} \geq \delta \tag{8}
\end{equation*}
$$

where $\delta$ is a constant that depends only on the geometry of $(M, \omega, J, L)$. From now on, we call a disk $B \subset \Sigma$ satisfying (8) a dense disk.

Let $R_{i}=w_{3^{i}} \times\left[0,3^{i+1}\right]$ for $0 \leq i \leq \log _{3} \sup _{\partial \Sigma} f$. Clearly, the rectangles $R_{i}$ cover the area under the graph of $f$ wherever $f \geq 1$. Thus to deduce Theorem 1.2, it suffices to bound the sum

$$
S:=\sum_{i} 3^{i+1} \ell\left(w_{3^{i}}\right) .
$$

To get such a bound, note that for any $i \in \mathbb{N}$, by the energy quantization property, the set $W_{3^{i}} \backslash W_{3^{i+1}}$ contains at least $n_{i}$ disjoint dense disks, where

$$
n_{i}:=a_{3^{i}}-\left\lceil\frac{1}{3}\left(a_{3^{i+1}}+1\right)\right\rceil-1 .
$$

See Figure 1. The term in the middle of the formula is an upper bound on the number of disks of radius $3^{-i}$ required to cover $W_{3^{i+1}}$. The -1 in the formula expresses the fact that an arbitrarily small neighborhood of each end point of $W_{3^{i+1}}$ can knock out a whole dense disk of $W_{3^{i}}$. Since area coincides with energy for $J$-holomorphic maps, estimate (8) implies the bound

$$
\sum n_{i} \leq \frac{\operatorname{Area}\left(\Sigma ; g_{J}\right)}{\delta}
$$

Assume momentarily that for each $i$ we have

$$
\begin{equation*}
a_{3^{i}} \geq 4 \tag{9}
\end{equation*}
$$

Then

$$
a_{3^{i+1}}-\left\lceil\frac{1}{3}\left(a_{3^{i+1}}+1\right)\right\rceil-1 \geq \frac{1}{4} a_{3^{i+1}} .
$$

So,

$$
\sum n_{i} \geq \frac{1}{4} \sum a_{3^{i}}=\frac{1}{4} \sum\left\lfloor\frac{1}{2} 3^{i} \ell\left(w_{3^{i}}\right)\right\rfloor .
$$

But, again using assumption (9), we have

$$
\left\lfloor\frac{1}{2} 3^{i} \ell\left(w_{3^{i}}\right)\right\rfloor \geq \frac{4}{5} \cdot \frac{1}{2} 3^{i} \ell\left(w_{3^{i}}\right) .
$$

So,

$$
\frac{\operatorname{Area}\left(\Sigma ; g_{J}\right)}{\delta} \geq \sum n_{i} \geq \frac{1}{4} \cdot \frac{4}{5} \cdot \frac{1}{2} \sum 3^{i} \ell\left(w_{3^{i}}\right) \geq \frac{1}{5 \cdot 6} S
$$

giving the required bound. The argument breaks down, however, if we remove assumption (9) as in Figure 2.

To deal with this problem, we partition $H$ into the sets

$$
K=\left\{\left.(x, t) \in H\right|_{12} \ell\left(w_{t}\right) \geq \frac{8}{t}, t \geq 1\right\}
$$

and $N=H \backslash K$. These are the thick and thin parts of the hypograph respectively. Figure 3 shows a possible alternation between thick and thin. The solid line is the graph of $f$, and the dashed line is the graph of the function

$$
x \mapsto \frac{8}{d\left(x, x_{0}\right)},
$$

where $x_{0}$ is the point where $f$ obtains its maximum. Conceptually, the components of the thick part should be thought of as parts of $\gamma$ which lie on bubbles of $u$, and those of the thin part as the necks separating the bubbles. A slight modification of the above argument shows the same linear lower bound on the area of the thick part. For the thin part we utilize the bound on the width of the graph and well known properties of $J$-holomorphic annuli.

When we consider maps from surfaces with genus greater than 0 , we also have to deal with the fact that the domain has unbounded length. For values of the derivative which are small relative to the radius of injectivity, the above argument again breaks down. Integrating a small number over an unbounded domain gives an unbounded value. This is again dealt with by utilizing the properties of holomorphic annuli. Our
proof thus exhibits a pleasing symmetry between the thin part of the graph and the thin part of the surface.

The main technical difficulties in the proof arise from the a priori arbitrary arrangement of the critical points of $f$. A large part of the proof is devoted to constructing a partition of the hypograph of $f$ into a thick part and a thin part in such away that the above arguments apply.

The paper is organized as follows. Section 2 reviews basic notions of the conformal geometry of surfaces as well as the thick thin decomposition for Riemann surfaces with negative Euler characteristic equipped with a hyperbolic metric. Section 3 presents the concept of thick thin measures. The measure one should have in mind is the energy of a $J$-holomorphic map from the surface. Section 4 formulates Theorem 4.2, which is a generalization of the theorems in this introduction. It addresses arbitrary conjugation invariant geodesics in the complex double $\Sigma_{\mathbb{C}}$. Section 5 discusses a partition for hypographs of continuous functions whose elements form a tree. This partition is the key to the discussion of the thick thin partition of the next section. Section 6 presents the thick thin partition of the hypograph relevant to the proof. It then shows that the number of components of the thin part is linearly bounded by the energy. Moreover, each component lies in a suitable annulus. In Section 7 we define a notion of tame geodesics in holomorphic annuli and discuss their properties. Roughly speaking, tame geodesics are those that do not wrap around the annulus too quickly. In Section 8 we prove Theorem 4.2. In Section 9 we deduce all the theorems of the introduction from Theorem 4.2. Finally, in Section 10 we prove Proposition 1.3 ,

## 2. Preliminaries on conformal geometry.

Let $(I, j)$ be a compact doubly connected surface with complex structure $j$. The modulus of $(I, j)$, denoted by $\operatorname{Mod}(I, j)$ or $\operatorname{Mod}(I)$ when the complex structure is clear from the context, is the unique real number $r>0$ such that $(I, j)$ is conformally equivalent to $[0, r] \times S^{1}$ (see [9]). Here $S^{1}$ is taken to be a standard circle of length $2 \pi$. In the sequel, we denote by $h_{s t}$ the unique flat metric on $I$ with respect to which it has circumference $2 \pi$.

Let $(I, h)$ be doubly connected with Riemannian metric $h$. We call global cylindrical coordinates $(\rho, \theta)$ on $I$,

$$
a \leq \rho \leq b, \quad 0 \leq \theta<2 \pi
$$

axially symmetric if

$$
\begin{equation*}
h=d \rho^{2}+h_{\theta}(\rho)^{2} d \theta^{2} \tag{10}
\end{equation*}
$$

We say $h$ is axially symmetric if $I$ has axially symmetric coordinates. In this case, the conformal length of $(I, h)$ is given by

$$
\operatorname{Mod}(I, h)=\int_{a}^{b} \frac{1}{h_{\theta}(\rho)} d \rho
$$

Definition 2.1. Let $I$ be a doubly connected surface of conformal length $L$. Then there is a holomorphic map $f:[0, L] \times S^{1} \rightarrow I$ unique up to a rotation and a holomorphic reflection. For real numbers $a \leq$ $b \in[0, L]$ with $a \leq L-b$, we write

$$
S(a, b ; I):=f\left([a, b] \times S^{1}\right) \subset I,
$$

and

$$
C(a, b ; I):=S(a, L-b ; I) .
$$

Note that composing $f$ with a holomorphic reflection of $[0, L] \times S^{1}$ replaces $S(a, b)$ with $S(L-b, L-a)$. The expression $C(a, a)$ is independent of the choice of $f$. A subcylinder of $I$ is a set of the form $I^{\prime}=S(a, b ; I)$.

Definition 2.2. Let $U$ be a Riemann surface biholomorphic to the unit disk $D_{1}$. Let $h$ be a conformal metric on $U$ and let $z \in U$. Then there is a biholomorphism $\phi: U \rightarrow D_{1}$ with $\phi(z)=0$, unique up to rotation. The conformal radius of $U$ viewed from $z$ is defined to be

$$
r_{\text {conf }}(U, z ; h):=1 /\|d \phi(z)\|_{h} .
$$

Note that $r_{\text {conf }}(U, z ; h)$ is not conformally invariant, since it depends on the metric at $z$. However, let $\nu_{h}$ denote the volume form of $h$, let $\mu$ be an absolutely continuous measure on $U$ and denote by $\frac{d \mu(z)}{d \nu_{h}}$ the Radon-Nikodym derivative. Then the expression $\frac{d \mu(z)}{d \nu_{h}} r_{\text {conf }}^{2}(z)$ is conformally invariant.

The cases of interest for us will be conformal radii of geodesic disks with metrics of constant curvature $K$, viewed from their center. In these cases, the metric can be written in polar coordinates as

$$
\begin{equation*}
h=d \rho^{2}+h_{\theta}^{2}(\rho) d \theta^{2} \tag{11}
\end{equation*}
$$

where

$$
h_{\theta}(\rho)= \begin{cases}\sinh (\rho), & K=-1  \tag{12}\\ \rho, & K=0 \\ \sin (\rho), & K=1\end{cases}
$$

So, the conformal radius of $B_{r}(p)$ viewed from $p$ is given by

$$
r_{\text {conf }}=\exp (f(r))
$$

where $f$ is the function defined by

$$
f^{\prime}(r)=\frac{1}{h_{\theta}(r)}, \quad f(r)=\log (r)+O(r) \text { as } r \rightarrow 0
$$

More explicitly,

$$
\begin{equation*}
f(r)=\log (r)+\int_{0}^{r}\left(\frac{1}{h_{\theta}(\rho)}-\frac{1}{\rho}\right) d \rho \tag{13}
\end{equation*}
$$

It follows from equation (13) that

$$
\begin{equation*}
r_{\text {conf }} \geq r, \quad K=0,1 \tag{14}
\end{equation*}
$$

and for any $\kappa$ there exists a constant $c>0$ such that

$$
\begin{equation*}
r_{\text {conf }} \geq c r, \quad K=-1, r<\kappa . \tag{15}
\end{equation*}
$$

Definition 2.3. For any Riemann surface $\Sigma=(\Sigma, j)$, write $\bar{\Sigma}:=$ $(\Sigma,-j)$. The complex double is the Riemann surface

$$
\Sigma_{\mathbb{C}}:=\Sigma \cup \bar{\Sigma},
$$

where the surfaces are glued together along the boundary by the identity. The complex structure on $\Sigma_{\mathbb{C}}$ is the unique one which coincides with $j$ and with $-j$ when restricted suitably. $\Sigma_{\mathbb{C}}$ is endowed with a natural antiholomorphic involution and for any $z \in \Sigma_{\mathbb{C}}$ we denote by $\bar{z}$ the image of $z$ under this involution. For more details about these constructions see [4].
Remark 2.4. Note that for any connected Riemann surface $\Sigma, \Sigma_{\mathbb{C}}$ is connected if and only if $\partial \Sigma \neq \emptyset$. Also, for any $\Sigma, \partial \Sigma_{\mathbb{C}}=\emptyset$.

Definition 2.5. Let $I \subset \Sigma_{\mathbb{C}}$ be doubly connected and conjugation invariant. If

$$
S\left(0, \frac{1}{2} \operatorname{Mod} I ; I\right)=\overline{S\left(\frac{1}{2} \operatorname{Mod} I, \operatorname{Mod} I ; I\right)}
$$

we say the conjugation on $I$ is latitudinal. If for each $a, b \in[0, \operatorname{Mod} I]$,

$$
S(a, b ; I)=\overline{S(a, b ; I)},
$$

we say the conjugation on $I$ is longitudinal.

Lemma 2.6. Let $I \subset \Sigma_{\mathbb{C}}$ be doubly connected and conjugation invariant. Then the conjugation on $I$ is either latitudinal or longitudinal.

Proof. The lemma is a consequence of the classification of the holomorphic automorphisms of the annulus and the fact that the composition of two anti-holomorphic automorphisms is holomorphic.

For later reference we conclude with a statement of the thick thin decomposition for surfaces of genus $g>1$. In the following we assume the surfaces are endowed with their unique metric $h$ of constant curvature -1 .

Theorem 2.7. [7, 4.1.1] Let $S$ be a compact Riemann surface of genus $g \geq 2$, and let $\gamma_{1}, \ldots, \gamma_{m}$ be pairwise disjoint simple closed geodesics on $S$. Then the following hold:
(a) $m \leq 3 g-3$.
(b) There exist simple closed geodesics $\gamma_{m+1}, \ldots, \gamma_{3 g-3}$, which, together with $\gamma_{1}, \ldots, \gamma_{m}$, decompose $S$ into pairs of pants.
(c) The collars

$$
\mathcal{C}\left(\gamma_{i}\right)=\left\{p \in S \mid \operatorname{dist}\left(p, \gamma_{i}\right) \leq w\left(\gamma_{i}\right)\right\}
$$

of widths

$$
w\left(\gamma_{i}\right)=\sinh ^{-1}\left(1 / \sinh \left(\frac{1}{2} \ell\left(\gamma_{i}\right)\right)\right)
$$

are pairwise disjoint for $i=1, \ldots, 3 g-3$.
(d) Each $\mathcal{C}\left(\gamma_{i}\right)$ is isometric to the cylinder $\left[-w\left(\gamma_{i}\right), w\left(\gamma_{i}\right)\right] \times S^{1}$ with the Riemannian metric

$$
d \rho^{2}+\frac{\ell^{2}\left(\gamma_{i}\right) \cosh ^{2}(\rho)}{4 \pi^{2}} d \theta^{2} .
$$

Denote by $\operatorname{Inj} \operatorname{Rad}(S ; h, p)$ the radius of injectivity of $S$ at $p \in S$, i.e. the supremum of all $r$ such that $B_{r}(p)$ is an embedded disk. If $h$ or $S$ is clear from the context, we may omit it from the notation.

Theorem 2.8. [7, 4.1.6] Let $\beta_{1}, \ldots, \beta_{k}$ be the set of all simple closed geodesics of length $\leq \sinh ^{-1} 1$ on $S$. Then $k \leq 3 g-3$ and the following hold.
(a) The geodesics $\beta_{1}, \ldots, \beta_{k}$ are pairwise disjoint.
(b) $\operatorname{Inj} \operatorname{Rad}(S ; p)>\sinh ^{-1} 1$ for all $p \in S-\left(\mathcal{C}\left(\beta_{1}\right) \cup \ldots \cup \mathcal{C}\left(\beta_{k}\right)\right)$.
(c) If $p \in \mathcal{C}\left(\beta_{i}\right)$, and $d=\operatorname{dist}\left(p, \partial \mathcal{C}\left(\beta_{i}\right)\right)$, then

$$
\begin{equation*}
\sinh (\operatorname{Inj} \operatorname{Rad}(S ; p))=\cosh \frac{1}{2} \ell\left(\beta_{i}\right) \cosh d-\sinh d \tag{16}
\end{equation*}
$$

## 3. Thick thin measure

For the rest of the discussion, fix constants $c_{1}, c_{2}, c_{3}, \delta_{1}, \delta_{2}>0$. Without loss of generality we will assume that $c_{3} \leq 1$ and that $\delta_{2}<\delta_{1}$. Given a metric $h$ on a measured Riemann surface $(\Sigma, j, \mu)$ we denote by $\frac{d \mu}{d \nu}$ the Radon Nikodym derivative of $\mu$ with respect to $\nu_{h}$, the volume form induced by $h$.

Definition 3.1. Let $\Sigma$ be a Riemann surface. A subset $S \subset \Sigma_{\mathbb{C}}$ is said to be clean if either $S=\bar{S}$ or $S \cap \bar{S}=\emptyset$.

Definition 3.2. Let $(\Sigma, j)$ be a Riemann surface, possibly bordered. Let $\mu$ be a finite measure on $\Sigma$ and extend $\mu$ to a measure on $\Sigma_{\mathbb{C}}$ by reflection i.e.

$$
\mu(U):=\mu(\bar{U}),
$$

for $U \subset \bar{\Sigma}$ a measurable set. $\mu$ will be called thick thin if it satisfies the following conditions:
(a) $\mu$ is absolutely continuous and has a continuous density $\frac{d \mu}{d \nu_{h}}$, where $h$ is any Riemannian metric on $\Sigma_{\mathbb{C}}$.
(b) Gradient inequality. Let $U \subset \Sigma_{\mathbb{C}}$ be a simply connected domain and let $z \in U$. Then for any conformal metric $h$ on $\left(\Sigma_{\mathbb{C}}, j\right)$,

$$
\mu(U)<\delta_{1} \quad \Rightarrow \quad \frac{d \mu}{d \nu_{h}}(z) \leq c_{1} \frac{\mu(U)}{r_{\text {conf }}^{2}}
$$

where $r_{\text {conf }}=r_{\text {conf }}(U, z ; h)$.
(c) Cylinder inequality. Let $I \subset \Sigma_{\mathbb{C}}$ be a doubly connected domain so that $\operatorname{Mod}(I)>2 c_{2}$ and satisfying either $I \subset \Sigma$ or $I=\bar{I}$. Then

$$
\begin{array}{r}
\mu\{I\}<\delta_{2} \Rightarrow \quad \mu\{C(t, t ; I)\} \leq e^{-c_{3} t} \mu\{I\}, \\
\forall t \in\left(c_{2}, \frac{1}{2} \operatorname{Mod}(I)\right) .
\end{array}
$$

Remark 3.3. Let $\mu$ be a thick thin measure on $\Sigma$, and let $h$ be a conformal metric of constant curvature $K=0, \pm 1$ on $\Sigma_{\mathbb{C}}$. By inequalities (14) and (15), there is a constant $c_{1}^{\prime}$ depending linearly on $c_{1}$ such that for any $z \in \Sigma$ and $r \in\left(0, \min \left(\sinh ^{-1}(1), \operatorname{Inj} \operatorname{Rad}(\Sigma ; h, z)\right)\right)$,

$$
\begin{equation*}
\mu\left(B_{r}(z ; h)\right)<\delta_{1} \Rightarrow \frac{d \mu}{d \nu_{h}}(z) \leq c_{1}^{\prime} \frac{\mu\left(B_{r}(z ; h)\right)}{r^{2}} . \tag{17}
\end{equation*}
$$

Remark 3.4. Let $\Sigma, \mu$ and $h$ be as in Remark 3.3. We will apply the gradient inequality in the following way. For any point $z \in \Sigma_{\mathbb{C}}$, let
$d=\frac{d \mu}{d \nu_{h}}(z)$ and let

$$
\begin{equation*}
r_{d}:=\sqrt{\frac{c_{1}^{\prime} \delta_{1}}{d}} \tag{18}
\end{equation*}
$$

Suppose

$$
r_{d} \in\left(0, \min \left(\sinh ^{-1}(1), \operatorname{Inj} \operatorname{Rad}(\Sigma ; h, z)\right)\right) .
$$

Then

$$
\mu\left(B_{r_{d}}(z ; h)\right) \geq \delta_{1}
$$

Moreover, we have

$$
\frac{d \mu}{d \nu_{h}}(z) \leq c_{1}^{\prime} \frac{\mu\left(B_{r}(z ; h)\right)}{r^{2}}, \quad r \leq r_{d}
$$

To simplify our formulas, we always scale $\mu$ so that $c_{1}^{\prime} \delta_{1}=1$.
We denote by $\mathcal{M}=\mathcal{M}\left(c_{1}, c_{2}, c_{3}, \delta_{1}, \delta_{2}\right)$ the family of measured Riemann surfaces $(\Sigma, j, \mu)$ such that $\mu$ is thick-thin.

Lemma 3.5. There is a constant a with the following significance. Let $(\Sigma, j, \mu) \in \mathcal{M}$. Let $I \subset \Sigma_{\mathbb{C}}$ be clean and doubly connected, and let $h=h_{\text {st }}$. Suppose $\mu(I)<\delta_{2}$. Let $z \in C\left(c_{2}+\pi, c_{2}+\pi ; I\right)$ be a point with cylindrical coordinates

$$
(s, t) \in\left[-\frac{1}{2} \operatorname{Mod}(I)+c_{2}+\pi, \frac{1}{2} \operatorname{Mod}(I)-c_{2}-\pi\right] \times S^{1}
$$

Then,

$$
\begin{equation*}
\frac{d \mu}{d \nu_{h}}(z)<a e^{-c_{3}\left(\frac{1}{2} \operatorname{Mod}(I)-|s|\right)} \mu(I) \tag{19}
\end{equation*}
$$

Proof. Combining the gradient inequality and the cylinder inequality,

$$
\begin{align*}
\frac{d \mu}{d \nu_{h}}(z) & \leq \frac{c_{1}}{\pi^{2}} \mu\left([s-\pi, s+\pi] \times S^{1}\right)  \tag{20}\\
& \leq \frac{c_{1}}{\pi^{2}} \mu\left([-|s|-\pi,|s|+\pi] \times S^{1}\right) \\
& \leq \frac{c_{1}}{\pi^{2}} e^{-c_{3}\left(\frac{1}{2} \operatorname{Mod}(I)-\pi-|s|\right)} \mu(I) .
\end{align*}
$$

## 4. A PRIORI BOUND

Definition 4.1. Let $(M, h)$ be a Riemannian manifold, let $N$ be a totally geodesic submanifold possibly with boundary, and let $h_{N}$ be the induced metric on $N$. Let $p \in N$. Define the segment width by

$$
\begin{aligned}
& \operatorname{SegWidth}(N, p ; h)= \\
& =\sup \left\{s>0 \mid B_{r}(p ;(M, h)) \cap N=B_{r}\left(p ;\left(N, h_{N}\right)\right) \text { for all } r<s\right\} \text {. }
\end{aligned}
$$

In the following, an embedded geodesic is a one-dimensional totally geodesic submanifold possibly with boundary. Let $(M, h)$ be a Riemannian manifold. For $\gamma$ an embedded geodesic, we denote by $d \ell_{h}$ the line element, or volume form, of the induced metric on $\gamma$. Now, consider the special case when $M$ is a Riemann surface $\Sigma$. Let $\mu$ be a measure and $h$ a conformal metric on $\Sigma$. Define

$$
d \ell_{\mu}=\left.\sqrt{\frac{d \mu}{d \nu_{h}}}\right|_{\gamma} d \ell_{h} .
$$

It easy to see that $d \ell_{\mu}$ is independent of $h$. If $\gamma$ is compact, define

$$
\ell_{\mu}(\gamma)=\int_{\gamma} d \ell_{\mu}
$$

Let $\Sigma$ be a Riemann surface possibly with boundary. For the rest of the paper, denote by $h_{\text {can }}$ the unique conformal metric on $\Sigma_{\mathbb{C}}$ satisfying the following conditions. If $\chi\left(\Sigma_{\mathbb{C}}\right) \neq 0$, then $h_{\text {can }}$ has constant curvature $\pm 1$. If $\chi\left(\Sigma_{\mathbb{C}}\right)=0$, then $h_{\text {can }}$ has constant curvature 0 and $\nu_{h_{c a n}}(\Sigma)=1$.

Theorem 4.2. There are constants $b_{1}$ and $b_{2}$ with the following significance. Let $(\Sigma, \mu) \in \mathcal{M}$, let $\gamma \subset \Sigma_{\mathbb{C}}$ be a compact embedded conjugation invariant geodesic, and let $k \geq 1$ be a constant such that for any $x \in \gamma$,

$$
\begin{equation*}
\operatorname{Seg} \operatorname{Width}\left(\gamma, x ; h_{c a n}\right)>\frac{1}{k} \operatorname{Inj} \operatorname{Rad}\left(\Sigma_{\mathbb{C}} ; h_{c a n}, x\right) \tag{21}
\end{equation*}
$$

Then

$$
\begin{equation*}
\ell_{\mu}(\gamma) \leq k^{2}\left\{b_{1} \mu\left(\Sigma_{\mathbb{C}}\right)+b_{2} \operatorname{genus}\left(\Sigma_{\mathbb{C}}\right)\right\} \tag{22}
\end{equation*}
$$

For the rest of this discussion up to and including the proof of Theorem 4.2, we fix $\gamma$ and $k$.

Remark 4.3. Recall the definition of $c_{1}^{\prime}$ from Remark 3.3. In the proof of Theorem 4.2, without loss of generality, we may assume the constants $c_{1}^{\prime}, \delta_{1}$, pertaining to the definition of thick-thin satisfy $c_{1}^{\prime} \delta_{1}=1$. This is true for two reasons. First, for $\tilde{c}_{1} \geq c_{1}$ and $\tilde{\delta}_{1} \leq \delta_{1}$, we have

$$
\mathcal{M}\left(c_{1}, c_{2}, c_{3}, \delta_{1}, \delta_{2}\right) \subset \underset{20}{\subset} \mathcal{M}\left(\tilde{c}_{1}, c_{2}, c_{3}, \tilde{\delta}_{1}, \delta_{2}\right)
$$

Such $\tilde{c}_{1}, \tilde{\delta}_{1}$, can always be chosen so that $\tilde{c}_{1}^{\prime} \tilde{\delta}_{1}=1$. However, this will not yield the optimal constant $c$ for a given $c_{1}, \delta_{1}$. To obtain the optimal value of $c$, it is useful to note that for $\lambda>0$, the map

$$
\mathcal{M}\left(c_{1}, c_{2}, c_{3}, \delta_{1}, \delta_{2}\right) \rightarrow \mathcal{M}\left(c_{1}, c_{2}, c_{3}, \lambda \delta_{1}, \lambda \delta_{2}\right)
$$

given by $(\Sigma, j, \mu) \mapsto(\Sigma, j, \lambda \mu)$ scales the constants $b_{i}$ for $i=1,2$, by $b_{1} \mapsto b_{1} / \sqrt{\lambda}$ and $b_{2} \mapsto \sqrt{\lambda} b_{2}$.

For any metric $n$ on $\gamma$, denote by $d \ell_{n}$ the line element. By definition,

$$
\ell_{\mu}(\gamma)=\int_{x \in \gamma} \frac{d \ell_{\mu}}{d \ell_{n}} d \ell_{n}(x)
$$

We derive Theorem 4.2 by studying the graph of the function

$$
g:=\ln \frac{d \ell_{\mu}}{d \ell_{n}}: \gamma \rightarrow(-\infty, \infty)
$$

for a convenient choice of the metric $n$. We define $n$ as follows. For any $x \in \gamma$, let

$$
r(x):=\min \left(\sinh ^{-1}(1), \operatorname{Inj} \operatorname{Rad}\left(\Sigma ; h_{c a n}, x\right)\right)
$$

It turns out that for dealing with higher genus, where there is no a priori bound on the radius of injectivity of $\Sigma$, it is convenient to use the metric $n=\left.\frac{1}{r(x)} h_{\text {can }}\right|_{\gamma}$.

We use the normalized metric $n$ only on $\gamma$. On $\Sigma_{\mathbb{C}}$ we continue to use the standard metric $h_{\text {can }}$. To translate from estimates in terms of the one to estimates in terms of the other metric, we will use the following lemma.

Lemma 4.4. Let $x_{1}, x_{2} \in \gamma$ such that $d_{\gamma}\left(x_{1}, x_{2} ; h_{\text {can }}\right) \leq r\left(x_{1}\right) / 2$. Then

$$
\begin{equation*}
\frac{2 d_{\gamma}\left(x_{1}, x_{2} ; h_{c a n}\right)}{3 r\left(x_{1}\right)} \leq d_{\gamma}\left(x_{1}, x_{2} ; h_{n}\right) \leq \frac{2 d_{\gamma}\left(x_{1}, x_{2} ; h_{c a n}\right)}{r\left(x_{1}\right)} \tag{23}
\end{equation*}
$$

Lemma 4.5. For all $t$ such that $r(\gamma(t))$ is differentiable,

$$
\begin{equation*}
\frac{d r(\gamma(t))}{d t} \leq 1 \tag{24}
\end{equation*}
$$

Proof. If $h_{\text {can }}$ has curvature -1 , inequality (4.5) follows from Theorem 2.8(b) and (c). If $h_{\text {can }}$ has non-negative curvature, then $\frac{d r(\gamma(t))}{d t}=$ 0 .

Proof of Lemma 4.4. Write $\Delta x=d_{\gamma}\left(x_{1}, x_{2} ; h_{\text {can }}\right)$. Parameterize $\gamma$ by $h_{\text {can }}$-length so that $\gamma(0)=x_{1}$ and $\gamma(\Delta x)=x_{2}$. It is easy to see that
$r(\gamma(t))$ is piecewise smooth and thus differentiable almost everywhere with respect to $t$. Applying Lemma 4.5 we calculate

$$
\begin{align*}
d_{\gamma}\left(x_{1}, x_{2} ; h_{n}\right) & =\left|\int_{0}^{\Delta x} \frac{1}{r(\gamma(t))} d t\right|  \tag{25}\\
& \leq \frac{\Delta x}{\inf _{t \in[0, \Delta x]} r(\gamma(t))} \\
& \leq \frac{\Delta x}{r\left(x_{1}\right)-\Delta x \operatorname{ess} \sup _{t \in[0, \Delta x]}\left|\frac{d r(\gamma(t))}{d t}\right|} \\
& \leq \frac{2 \Delta x}{r\left(x_{1}\right)}
\end{align*}
$$

For the last inequality we have used (4.5). The upper bound of estimate (23) follows. A similar argument gives the lower bound.

Definition 4.6. Denote

$$
D:=\{(x, t) \in \gamma \times[\ln 2 k, \infty) \mid \ln 2 k \leq t \leq g(x)\} .
$$

For any $(x, t) \in D$, denote $B(x, t):=B_{e^{-t_{r}(x)}}\left(x ; \Sigma, h_{\text {can }}\right)$.
Lemma 4.7. For $(x, t) \in D$, we have $\mu(B(x, t)) \geq \delta_{1}$.
Proof. Since $k \geq 1$, we have $t>0$. Therefore, $B(x, t)$ is an embedded disk. By Remark [3.4, $\mu(B(x, t)) \geq \delta_{1}$.

Lemma 4.8. Let $\left(x_{i}, t_{i}\right) \in D$ for $i=1,2$. Suppose

$$
d_{\gamma}\left(x_{1}, x_{2} ; h_{n}\right)>2\left(e^{-t_{1}}+e^{-t_{2}}\right) .
$$

Then $B\left(x_{1}, t_{1}\right) \cap B\left(x_{t}, t_{2}\right)=\emptyset$.
Proof. By Lemma 4.4 we have

$$
d_{\gamma}\left(x_{1}, x_{2} ; h_{\text {can }}\right) \geq e^{-t_{1}} r\left(x_{1}\right)+e^{-t_{2}} r\left(x_{2}\right) .
$$

Since $t_{i} \geq \ln 2 k$, the assumption of Theorem 4.2 implies that

$$
\operatorname{SegWidth}\left(\gamma, x_{i} ; h_{\text {can }}\right) \geq 2 e^{-t_{i}} r\left(x_{i}\right) .
$$

The claim now follows.

## 5. Partitions of hypographs

Let $\gamma$ be a 1 -dimensional manifold, let $f: \gamma \rightarrow[0, \infty)$ be a continuous function, and let $E$ be the hypograph of $f$. That is, $E$ is the set of points under the graph of $f$ in $\gamma \times[0, \infty)$. In this section we introduce a binary relation on subsets of $E$, which should be thought of intuitively as the relation of lying above. We prove two basic theorems about this order relation. Theorem 5.7 states that for any partition $P$ of $E$
into connected subsets by intersecting $E$ with horizontal segments, the binary relation on the elements of $P$ is a tree-like partial order. See Figure 4. Theorem 5.21 states that there is a particular such partition, denoted $\mathcal{T}_{E}$, such that the branchings in the tree associated with $\mathcal{T}_{E}$ correspond to local minima in the graph of $f$. See Figure 5. After proving these theorems, we show that continuity of $f$ allows us two control the number of elements of $\mathcal{T}_{E}$ by the number of its maximal elements. Note that in general $\mathcal{T}_{E}$ might be infinite, and if $f$ is not continuous, there might not be any maximal elements.

5.1. A binary relation. Let $\gamma$ be a compact 1-dimensional manifold with or without boundary. Let $\xi \in \mathbb{R}$, write $X=\gamma \times[\xi, \infty)$, and denote by $p_{1}: X \rightarrow \gamma$ and $p_{2}: X \rightarrow[\xi, \infty)$ the canonical projections. Denote $X_{t}:=\gamma \times\{t\}$. For any subset $S \subset X$ denote $S_{t}:=X_{t} \cap S$. If $p_{2}(S) \subset[\xi, \infty)$ is bounded, denote

$$
\begin{aligned}
T_{f}(S) & :=\sup \left\{p_{2}(S)\right\}, \\
T_{i}(S) & :=\inf \left\{p_{2}(S)\right\},
\end{aligned}
$$

and $T(S):=T_{f}(S)-T_{i}(S)$.
Let $f: \gamma \rightarrow[\xi, \infty)$ be a continuous function. Denote the region under the graph of $f$ by

$$
E:=\left\{y \in X \mid p_{2}(y) \leq f\left(p_{1}(y)\right)\right\} .
$$

For a topological space $Y$, denote by $\pi_{0}(Y)$ the set of path-connected components. An $E$-segment is an element of $\cup_{t \in[\xi, \infty)} \pi_{0}\left(E_{t}\right)$. For any

$t \geq \xi$, and for any $x \in p_{1}\left(E_{t}\right)$ we denote by $e(x, t)$ the $E$-segment containing $(x, t)$.

Remark 5.1. It follows from the continuity of $f$ that $E$ is a closed set. So, all $E$-segments are closed. It also follows from the continuity of $f$ that if $e$ is an $E$-segment, $x$ is not a boundary point of $\gamma$, and $(x, t)$ is a boundary point of $e$, then $f(x)=t$.

We define a relation on the power set $P(E)$ as follows. Let $S_{1}, S_{2} \subset$ $E$. We say that $S_{1} \leq_{1} S_{2}$ if $p_{1}\left(S_{2}\right) \subseteq p_{1}\left(S_{1}\right)$. We say that $S_{1} \leq_{2} S_{2}$ if for any $t \in p_{2}\left(S_{2}\right)$ there is a $t^{\prime} \in p_{2}\left(S_{1}\right)$ such that $t^{\prime} \leq t$. Finally we say that $S_{1} \leq S_{2}$ is $S_{1} \leq_{1} S_{2}$ and $S_{1} \leq_{2} S_{2}$.

The following properties of $\leq$ are obvious and are stated without proof.

Lemma 5.2. (a) The relation $\leq i s$ reflexive and transitive.
(b) Let $\Pi \subset P(E)$ be the collection of subsets of the form

$$
s_{1} \times\{t\}
$$

where $s_{1} \subset \gamma, t \in[\xi, \infty)$. The restriction of $\leq t o \Pi$ is antisymmetric. $\Pi$ contains the singletons of $E$ and the $E$-segments.
(c) For any two sets $S_{1}, S_{2} \in P(E), S_{1} \leq S_{2}$ if and only if for any $(x, t) \in S_{2}, S_{1} \leq\{(x, t)\}$
Lemma 5.3. Let $\xi \leq t \leq t_{1}, t_{2}$, let $x \in p_{1}\left(E_{t}\right), x_{i} \in p_{1}\left(E_{t_{i}}\right)$ for $i=1,2$ and denote $e_{i}=e\left(x_{i}, t_{i}\right)$.
(a) For any $t^{\prime} \in[\xi, t], e\left(x, t^{\prime}\right)$ is well defined.
(b) If $e\left(x_{1}, t\right)=e\left(x_{2}, t\right)$ then for any $t^{\prime} \in[\xi, t], e\left(x_{1}, t^{\prime}\right)=e\left(x_{2}, t^{\prime}\right)$.
(c) For any $t^{\prime} \in[\xi, t], e\left(x, t^{\prime}\right) \leq e(x, t)$.
(d) $e_{1} \leq e_{2}$ if and only if $t_{1} \leq t_{2}$ and $e\left(x_{2}, t_{1}\right)=e_{1}$.
(e) If $e_{1}$ and $e_{2}$ are incomparable with respect to $\leq$, then

$$
d\left(p_{1}\left(e_{1}\right), p_{1}\left(e_{2}\right)\right)>0
$$

(f) If $e\left(x_{1}, t_{1}\right) \leq e\left(x_{2}, t_{2}\right)$, then for any $t \in\left[t_{1}, t_{2}\right]$, $e\left(x_{1}, t_{1}\right) \leq$ $e\left(x_{2}, t\right)$.
Proof. (a) We have $t^{\prime} \leq t \leq f(x)$, so $\left(x, t^{\prime}\right) \in E$.
(b) Let $S=p_{1}\left(e\left(x_{1}, t\right)\right)$ then $S$ is a segment which by assumption contains $x_{1}$ and $x_{2}$. Since $S \times\{t\} \subset E_{t}$, for all $t^{\prime} \in[\xi, t]$, and all $x \in S, t^{\prime} \leq f(x)$. Therefore, $S \times\left\{t^{\prime}\right\} \subset E_{t^{\prime}} . S \times\left\{t^{\prime}\right\}$ is connected and contains $\left(x_{i}, t^{\prime}\right)$ for $i=1,2$. In particular $e\left(x_{1}, t^{\prime}\right)=e\left(x_{2}, t^{\prime}\right)$.
(c) It is clear that $e\left(x, t^{\prime}\right) \leq_{2} e(x, t)$. If $x^{\prime} \in p_{1}(e(x, t))$, then $e\left(x^{\prime}, t\right)=e(x, t)$. By (b), $e\left(x^{\prime}, t^{\prime}\right)=e\left(x, t^{\prime}\right)$. In particular, $x^{\prime} \in p_{1}\left(e\left(x, t^{\prime}\right)\right)$. Thus $e\left(x, t^{\prime}\right) \leq_{1} e(x, t)$.
(d) Assume first that $e_{1} \leq e_{2}$. Then $t_{1} \leq t_{2}$ by definition. Further, $x_{2} \in p_{1}\left(e_{1}\right)$, so $e\left(x_{2}, t_{1}\right) \subset e_{1}$. But $e_{1}$ is an $E$-segment, so $e\left(x_{1}, t_{2}\right)=e_{1}$ as required. Assume now that $e\left(x_{2}, t_{1}\right)=e_{1}$, and $t_{1} \leq t_{2}$. Then by (c), $e_{1} \leq e\left(x_{2}, t_{2}\right)$.
(e) Assume without loss of generality that $t_{1} \leq t_{2}$ and denote $e_{2}^{\prime}=$ $e\left(x_{2}, t_{1}\right)$. By Remark 5.1, $E_{t_{1}}$ is closed. So, since $e_{2}^{\prime}$ and $e_{1}$ are both connected components of $E_{t_{1}}$, we have that either $e_{2}^{\prime}=e_{1}$ or $d\left(p_{1}\left(e_{2}^{\prime}\right), p_{1}\left(e_{1}\right)\right)>0$. Thus, by (d), $d\left(p_{1}\left(e_{2}^{\prime}\right), p_{1}\left(e_{1}\right)\right)>0$. By (c), $e_{2}^{\prime} \leq e_{2}$. In particular, $p_{1}\left(e_{2}\right) \subset p_{1}\left(e_{2}^{\prime}\right)$, so

$$
d\left(p_{1}\left(e_{1}\right), p_{1}\left(e_{2}\right)\right)>d\left(p_{1}\left(e_{2}^{\prime}\right), p_{1}\left(e_{1}\right)\right)>0 .
$$

(f) Using (d) twice, $e\left(x_{1}, t_{1}\right) \leq e\left(x_{2}, t_{2}\right)$ implies $e\left(x_{2}, t_{1}\right)=e\left(x_{1}, t_{1}\right)$, which implies $e\left(x_{1}, t_{1}\right) \leq e\left(x_{2}, t\right)$.

### 5.2. Tree-like partial order.

Definition 5.4. Let $S \subset E . S$ is said to be $E$-saturated if $S$ is a union of $E$-segments.
Remark 5.5. Clearly, any union or intersection of $E$-saturated sets is $E$-saturated. Moreover, a connected component of an $E$-saturated set and the complement in $E$ of an $E$-saturated set are $E$-saturated.
Definition 5.6. Let $S$ be a set. A tree-like order relation on $S$ is a partial order relation $\leq$ which satisfies for any $v, v_{1}, v_{2} \in S$,

$$
v_{1} \leq v \text { and } v_{2} \leq v \quad \Rightarrow \quad v_{1} \leq v_{2} \text { or } v_{2} \leq v_{1} .
$$

Theorem 5.7. Let $P$ be a collection of pairwise disjoint E-saturated connected sets. Then the restriction of $\leq$ to $P$ is a tree-like order relation.

For the proof of Theorem 5.7, we first prove a few lemmas.
Lemma 5.8. Let $S \subset E$ be connected. For any compact set $K \subset S$ there exists a point $(x, t) \in S$ such that $e(x, t) \leq K$.

Proof. Using the compactness of $K$, choose $\left(x_{1}, t_{1}\right) \in K$ such that $t_{1}=$ $T_{i}(K)$. Let $L \subset p_{1}(S)$ be a connected compact subset containing $p_{1}(K)$. Using the continuity of $f$, choose $x_{2} \in L$ such that

$$
f\left(x_{2}\right)=\inf _{y \in L} f(y)
$$

Since $x_{2} \in p_{1}(S)$, and $S \subset E$, there exists $t_{2} \leq f\left(x_{2}\right)$ such that $\left(x_{2}, t_{2}\right) \in S$. Choose $i$ such that $t_{i}=\min \left(t_{1}, t_{2}\right)$ and set $(x, t)=\left(x_{i}, t_{i}\right)$. Clearly, $(x, t) \in S$. Since $t \leq t_{2}$, we have

$$
L \times\{t\} \subset E
$$

So, since $L \times\{t\}$ is connected and contains $(x, t)$, we have

$$
L \times\{t\} \subset e(x, t)
$$

Therefore, since $p_{1}(K) \subset L$ and $t \leq t_{1}$, we have $e(x, t) \leq K$.

Lemma 5.9. Let $S_{1} \subset E$ be E-saturated and let $S_{2} \subset E$ be connected such that $S_{1} \cap S_{2}=\emptyset$. Suppose there exist $x \in \gamma$ and $t_{1}<t_{2} \in[\xi, \infty)$ such that $\left(x, t_{i}\right) \in S_{i}$ for $i=1,2$. Then $S_{1} \leq S_{2}$.

Proof. Let $e=e\left(x, t_{1}\right)$. Since $S_{1}$ is $E$-saturated, we have $e \subset S_{1}$. So,

$$
\begin{equation*}
e \cap S_{2}=\emptyset \tag{26}
\end{equation*}
$$

Let $x_{1}, x_{2} \in \gamma$ be the boundary points of $p_{1}(e)$. By Remark 5.1,

$$
\begin{equation*}
f\left(x_{i}\right)=t_{1}, \quad \text { for } i \in\{1,2\} \text { such that } x_{i} \notin \partial \gamma . \tag{27}
\end{equation*}
$$

Define

$$
r_{i}= \begin{cases}\left\{x_{i}\right\} \times\left(t_{1}, \infty\right), & x_{i} \notin \partial \gamma \\ \emptyset & x_{i} \in \partial \gamma\end{cases}
$$

By equation (27), the rays $r_{i}$ are disjoint from $E$. In particular,

$$
\begin{equation*}
S_{2} \cap r_{i}=\emptyset, \quad i=1,2 \tag{28}
\end{equation*}
$$

Define disjoint open sets $U_{1}$ and $U_{2}$ by

$$
\begin{aligned}
& U_{2}=\left\{(x, s) \in X \mid x \in\left(x_{1}, x_{2}\right) \cup\left(\partial \gamma \cap\left\{x_{1}, x_{2}\right\}\right) \text { and } s>t_{1}\right\}, \\
& U_{1}=X \backslash \bar{U}_{2}
\end{aligned}
$$

Clearly,

$$
U_{1} \cup U_{2}=X \backslash\left(e \cup r_{1} \cup r_{2}\right) .
$$

So, by equations (26) and (28), $S_{2} \subset U_{1} \cup U_{2}$. Since $\left(x, t_{2}\right) \in S_{2} \subset E$, we have $f(x) \geq t_{2}>t_{1}$. Thus by equation (27), we have $x \notin\left\{x_{1}, x_{2}\right\} \backslash \partial \gamma$. So, by definition of $U_{2}$, we have $\left(x, t_{2}\right) \in U_{2}$. Therefore, $S_{2} \cap U_{2} \neq$ $\emptyset$. Since $S_{2}$ is connected, it follows that $S_{2} \subset U_{2}$. So, $U_{2} \leq S_{2}$. By definition of $U_{2}$, we have $e \leq U_{2}$. Since $e \subset S_{1}$, we have $S_{1} \leq e$. Combining the foregoing inequalities, we have

$$
S_{1} \leq e \leq U_{2} \leq S_{2}
$$

which proves the lemma.

Lemma 5.10. Let $S \subset E$ be $E$-saturated and connected.
(a) Let $e_{1}, e_{2} \subset S$ be $E$-segments. If $e_{3}$ is an $E$-segment such that $e_{1} \leq e_{3} \leq e_{2}$, then $e_{3} \subset S$.
(b) For any $t_{1} \leq t_{2} \in p_{2}(S), S_{t_{1}} \leq S_{t_{2}}$.

Proof. (a) Suppose that $e_{3} \not \subset S$. Since $S$ is $E$-saturated it follows that

$$
\begin{equation*}
\underset{27}{e_{3} \cap S}=\emptyset \tag{29}
\end{equation*}
$$

Take $S_{1}=e_{3}$ and $S_{2}=S$. Set $t_{0}=p_{2}\left(e_{1}\right), t_{1}=p_{2}\left(e_{3}\right)$ and $t_{2}=$ $p_{2}\left(e_{2}\right)$. Since $e_{1}, e_{2} \subset S$, by equation (29) we have $t_{0}<t_{1}<t_{2}$. Choose $x \in p_{2}\left(e_{2}\right)$. Then $S_{1}, S_{2}, x, t_{1}, t_{2}$ satisfy the hypotheses of Lemma 5.9. We conclude that $e_{3} \leq S$. So,

$$
p_{2}\left(e_{1}\right)=t_{0}<t_{1}=p_{2}\left(e_{3}\right) \leq T_{i}(S)
$$

contradicting the assumption that $e_{1} \subset S$.
(b) By Lemma 5.8 with $K=S_{t_{1}} \cup S_{t_{2}}$, there exists $(x, t) \in S$ such that $e(x, t) \leq S_{t_{i}}$ for $i=1,2$. Since $S$ is $E$-saturated, $e(x, t) \subset S$. Let $y \in p_{1}\left(S_{t_{2}}\right)$. Since $S$ is $E$-saturated, $e\left(y, t_{2}\right) \subset S$. In particular, $e(x, t) \leq e\left(y, t_{2}\right)$. So, by Lemma 5.3)(f), $e(x, t) \leq$ $e\left(y, t_{1}\right)$. By Lemma 5.3)(c), $e\left(y, t_{1}\right) \leq e\left(y, t_{2}\right)$. Therefore, by (a) we have $e\left(y, t_{1}\right) \subset S$. Since $y \in p_{1}\left(S_{t_{2}}\right)$ was arbitrary, it follows that $S_{t_{1}} \leq S_{t_{2}}$.

Corollary 5.11. Let $F$ be a collection of pairwise disjoint connected $E$-saturated sets. Then the restriction of the relation $\leq$ to $F$ is antisymmetric.

Proof. Let $S_{1}, S_{2} \in F$ and let $x \in p_{1}\left(S_{1}\right)$. Assume $S_{1} \leq S_{2}$ and $S_{2} \leq S_{1}$. Then in particular, $p_{1}\left(S_{1}\right)=p_{1}\left(S_{2}\right)$ so that $x \in p_{1}\left(S_{2}\right)$. Therefore, there are $t_{1}, t_{2} \in p_{2}\left(S_{1}\right)$ such that $\left(x, t_{1}\right) \in S_{1}$ and $\left(x, t_{2}\right) \in S_{2}$. Assume without loss of generality that $t_{1} \leq t_{2}$. Since $S_{2} \leq_{2} S_{1}$ there is a $t \in p_{2}\left(S_{2}\right)$ with $t \leq t_{1}$. Since $S_{2}$ is connected, $p_{2}\left(S_{2}\right)$ is connected and so $\left[t, t_{2}\right] \subset p_{2}\left(S_{2}\right)$. In particular $t_{1} \in p_{2}\left(S_{2}\right)$. By Lemma 5.1q](b), $S_{2, t_{1}} \leq S_{2, t_{2}}$, so $\left(x, t_{1}\right) \in S_{2}$. Thus $S_{1} \cap S_{2}$ is nonempty, and by the assumption on $F, S_{1}=S_{2}$.

Lemma 5.12. Let $S_{1}, S_{2} \subset E$. Suppose that $S_{1}$ is $E$-saturated and connected, that $S_{2}$ is connected and that $S_{1} \leq_{2} S_{2}$. Then either $S_{1} \leq S_{2}$ or

$$
p_{1}\left(S_{1}\right) \cap p_{1}\left(S_{2}\right)=\emptyset .
$$

Proof. Suppose that there is a point $x_{1} \in p_{1}\left(S_{1}\right) \cap p_{1}\left(S_{2}\right)$. Then there is a $t_{1} \in p_{2}\left(S_{2}\right)$ such that $\left(x_{1}, t_{1}\right) \in S_{2}$. Let $\left(x_{2}, t_{2}\right) \in S_{2}$. By Lemma 5.8 with $K=\left(x_{1}, t_{1}\right) \cup\left(x_{2}, t_{2}\right)$, there is an $\left(x_{3}, t_{3}\right) \in S_{2}$ such that $e\left(x_{3}, t_{3}\right) \leq\left(x_{i}, t_{i}\right)$ for $i=1,2$. In particular,

$$
p_{1}\left(e\left(x_{3}, t_{3}\right)\right) \cap p_{1}\left(S_{1}\right) \neq \emptyset .
$$

Let $t \in p_{2}\left(S_{1}\right)$ such that $t \leq \min \left(t_{1}, t_{3}\right)$. Such a $t$ exists by the assumption $S_{1} \leq_{2} S_{2}$. By Lemma 5.3)(e) and the fact that $t \leq t_{3}$, $e\left(x_{1}, t\right) \leq e\left(x_{3}, t_{3}\right)$. By Lemma $\frac{5.1 q](\mathrm{b})}{28}$ and the fact that $t \leq t_{1}$, we
have $S_{t} \leq S_{t_{1}}$. In particular, $\left(x_{1}, t\right) \in S_{1}$. Since $S_{1}$ is $E$-saturated, $e\left(x_{1}, t\right) \subset S_{1}$. Therefore,

$$
S_{1} \leq e\left(x_{1}, t\right) \leq e\left(x_{3}, t_{3}\right) \leq\left\{\left(x_{2}, t_{2}\right)\right\} .
$$

But ( $x_{2}, t_{2}$ ) was an arbitrary point of $S_{2}$, so the claim follows.
Lemma 5.13. Let $S_{1}, S_{2} \subset E$ be connected and let $S_{1}$ be $E$-saturated. Suppose $S_{1} \leq_{2} S_{2}$. If there is a nonempty set $S \subset E$ such that $S_{i} \leq S$ for $i=1,2$, then $S_{1} \leq S_{2}$.

Proof. By assumption, $p_{1}\left(S_{1}\right) \cap p_{1}\left(S_{2}\right) \neq \emptyset$. Therefore, by Lemma 5.12 $S_{1} \leq S_{2}$.

Proof of Theorem 5.7. By Cor. 5.11, $\leq$ is an order relation when restricted to $P$. By Lemma 5.13, this order is tree-like.

### 5.3. Equivalence relation.

Definition 5.14. A branching point is a point $(x, t) \in \partial E$ that is contained in an open segment $s \subset e(x, t)$ such that $\partial s \subset E^{o}$. Here, $E^{o}$ denotes the interior of $E$.

Definition 5.15. Let $\left(x_{i}, t_{i}\right) \in E$ for $i=1,2$. If $t_{1} \leq t_{2}$, we say that $\left(x_{1}, t_{1}\right) \sim\left(x_{2}, t_{2}\right)$ if the following two conditions hold:
(a) $e\left(x_{1}, t_{1}\right) \leq e\left(x_{2}, t_{2}\right)$.
(b) The rectangle $R=p_{1}\left(e\left(x_{1}, t_{1}\right)\right) \times\left[t_{1}, t_{2}\right)$ contains no branching points.
If $t_{2}<t_{1}$, we reverse the roles of $t_{1}$ and $t_{2}$.
Lemma 5.16. $\sim$ is an equivalence relation.
Before proving Lemma 5.16, we prove the following preparatory lemma.

Lemma 5.17. Let $t_{1}>\xi$ and $t_{2} \geq t_{1}$. Let $x \in p_{1}\left(E_{t_{2}}\right)$. Let $R=$ $p_{1}\left(e\left(x, t_{1}\right)\right) \times\left[t_{1}, t_{2}\right)$ and $\bar{R}=p_{1}\left(e\left(x, t_{1}\right)\right) \times\left[t_{1}, t_{2}\right]$. Assume that $R$ contains no branching points.
(a) $(\bar{R} \cap E)_{t_{2}}$ is connected.
(b) The order $\leq$ on the set of $E$-segments contained in $\bar{R}$ is linear.
(c)
$\left(p_{1}\left(e\left(x, t_{2}\right)\right) \times\left[t_{2}, \infty\right)\right) \cap E=\left(p_{1}\left(e\left(x, t_{1}\right)\right) \times\left[t_{2}, \infty\right)\right) \cap E$
Proof. (a) We prove this by contradiction. Choose an orientation on $\gamma$ so that intervals between points on $\gamma$ are well defined. Let $e_{1}$ and $e_{2}$ be distinct connected components of $(\bar{R} \cap E)_{t_{2}}$. Let
$\left(x_{1}, t_{2}\right)$ and $\left(x_{2}, t_{2}\right)$ be boundary points of $e_{1}$ and $e_{2}$ respectively such that the segment $\left(x_{1}, x_{2}\right) \times\left\{t_{2}\right\}$ is contained in $\bar{R}$ and is disjoint from both $e_{1}$ and $e_{2}$. By continuity of $f$, choose $x_{3} \in$ $\left[x_{1}, x_{2}\right]$ where $\left.f\right|_{\left[x_{1}, x_{2}\right]}$ obtains its minimum and let $t_{3}=f\left(x_{3}\right)$. Since

$$
x_{3} \in\left[x_{1}, x_{2}\right] \subset p_{1}(\bar{R})=p_{1}\left(e\left(x, t_{1}\right)\right),
$$

it follows that $t_{3}=f\left(x_{3}\right) \geq t_{1}$. Since

$$
\left[x_{1}, x_{2}\right] \times t_{2} \cap(X \backslash E)_{t_{2}} \neq \emptyset,
$$

there is an $x^{\prime} \in\left(x_{1}, x_{2}\right)$ such that $f\left(x^{\prime}\right)<t_{2}$, which implies that $t_{3}<t_{2}$. For each $x^{\prime} \in\left[x_{1}, x_{2}\right], f\left(x^{\prime}\right) \geq t_{3}$. Therefore,

$$
\left[x_{1}, x_{2}\right] \times\left\{t_{3}\right\} \subset e\left(x, t_{3}\right) \subset E .
$$

On the other hand, since $f\left(x_{i}\right)=t_{2}>t_{3}$ for $i=1,2$, we have that $x_{3} \in\left(x_{1}, x_{2}\right)$. Furthermore, by continuity of $f$ and the fact that $t_{3} \geq t_{1}>\xi$, we have $\left(x_{1}, t_{3}\right),\left(x_{2}, t_{3}\right) \in E^{o}$. Thus $\left(x_{3}, t_{3}\right)$ is a branching point. Since $t_{2}>t_{3} \geq t_{1},\left(x_{3}, t_{3}\right)$ is contained in $R$ contradicting the assumption.
(b) Let $e_{1}=e\left(x_{1}, t_{1}^{\prime}\right)$ and $e_{2}=e\left(x_{2}, t_{2}^{\prime}\right)$ for $\left(x_{1}, t_{1}^{\prime}\right),\left(x_{2}, t_{2}^{\prime}\right) \in \bar{R}$. Suppose without loss of generality that $t_{1}^{\prime} \leq t_{2}^{\prime}$, then by Lemma 5.3)(d) it suffices to show that $e\left(x_{1}, t_{1}^{\prime}\right)=e\left(x_{2}, t_{1}^{\prime}\right)$. Since $e_{i} \in \bar{R}$, it follows that $e\left(x, t_{1}\right) \leq e\left(x_{i}, t_{1}^{\prime}\right)$ for $i=1,2$. So, $e\left(x_{i}, t_{1}^{\prime}\right)$ are connected components of $(R \cap E)_{t_{1}^{\prime}}$. The claim now follows immediately from (a).
(c) We show the less obvious inclusion. Let

$$
\left(x^{\prime}, t^{\prime}\right) \in\left(p_{1}\left(e\left(x, t_{1}\right)\right) \times\left[t_{2}, \infty\right)\right) \cap E .
$$

By (a),

$$
e\left(x^{\prime}, t_{2}\right)=e\left(x, t_{2}\right) .
$$

In particular,

$$
x^{\prime} \in p_{1}\left(e\left(x, t_{2}\right)\right)
$$

Remark 5.18. It is immediate from the definition of a branching point that the converse to 5.17 (a) is also true. Namely, if there is a $t \in\left(t_{1}, t_{2}\right)$ for which $R_{t}$ contains a branching point, then there is a $t^{\prime}>t$ with $t^{\prime} \in p_{2}(R \cap E)$ such that $R_{t^{\prime}}$ has at least two components. It is clear that $t^{\prime}$ can be taken arbitrarily close to t .

Proof of Lemma 5.16. Suppose $\left(x_{1}, t_{1}\right) \sim\left(x_{2}, t_{2}\right)$ and $\left(x_{2}, t_{2}\right) \sim$ $\left(x_{3}, t_{3}\right)$. We wish to prove that $\left(x_{1}, t_{1}\right) \sim\left(x_{3}, t_{3}\right)$. Without loss of generality we assume $t_{1} \leq t_{3}$. For $i=1,2,3$, denote $e_{i}=e\left(x_{i}, t_{i}\right)$,
$c_{i}=p_{1}\left(e_{i}\right)$ and let $R=c_{1} \times\left[t_{1}, t_{3}\right)$. We need to prove that $e_{1} \leq e_{3}$ and that $R$ contains no branching points.

We distinguish between the three possibilities for the order of $t_{1}, t_{2}$ and $t_{3}$. We start with the case $t_{2} \leq t_{1} \leq t_{3}$. Then $R \subset c_{2} \times\left[t_{2}, t_{3}\right)$ and thus $R$ contains no branching points. By Lemma 5.17(b), $e_{1}$ and $e_{3}$ are comparable, and since $t_{1} \leq t_{3}$, we have $e_{1} \leq e_{3}$.

If $t_{1} \leq t_{2} \leq t_{3}$, then by Lemma 5.17(c),

$$
R \cap E \subset p_{1}\left(e_{1}\right) \times\left[t_{1}, t_{2}\right) \cup p_{1}\left(e_{2}\right) \times\left[t_{2}, t_{3}\right),
$$

and thus $R$ contains no branching points. Furthermore,

$$
e_{1} \leq e_{2} \leq e_{3}
$$

by assumption.
If $t_{1} \leq t_{3} \leq t_{2}$, then $R \subset c_{1} \times\left[t_{1}, t_{2}\right)$. So, there are no branching points in $R$. By Lemma 5.17](b), $e_{1}$ and $e_{3}$ are comparable. Since $t_{1} \leq t_{3}$, it follows that $e_{1} \leq e_{3}$.

### 5.4. Tree-like partition.

Definition 5.19. A subset $S \subset X$ is closed from above if for any $x \in \gamma$ the intersection $\{x\} \times[\xi, \infty) \cap S$ is closed from the right.
Remark 5.20. Any finite union, intersection and relatively closed subset of sets that are closed from above is closed from above.

Let $\mathcal{T}_{E}$ denote the partition of $E$ into $\sim$ equivalence classes.
Theorem 5.21. Each $c \in \mathcal{T}_{E}$ satisfies the following properties.
(a) c is E-saturated and connected.
(b) For any $c_{1} \neq c \in \mathcal{T}_{E}$ such that $c \leq c_{1}$, there exists a $c_{2} \in \mathcal{T}_{E}$ that is incomparable to $c_{1}$ and such that $c \leq c_{2}$.
(c) Let $c^{\prime} \subset c$ be E-saturated, connected and closed from above. Let $S \subset E$ be disjoint from $c^{\prime}$. Then

$$
c^{\prime} \leq S \Rightarrow c_{T_{f}\left(c^{\prime}\right)}^{\prime} \leq S
$$

In Figure 7 the shaded and white parts correspond to different elements in a partition of $E$. The right side of the figure shows what part (b) of Theorem 5.21 rules out. The left side shows what is ruled out by part (c).
Corollary 5.22. The restriction of $\leq$ to $\mathcal{T}_{E}$ is a tree-like order relation.
Proof. The corollary follows from Theorem 5.21(a) and Theorem 5.7.

Lemma 5.23. Let $c \subset E$ be an equivalence class under $\sim$. Then $c$ is closed from above.

Proof. Let $x \in p_{1}(c)$. Choose $t \geq \xi$ such that $(x, t) \in c$. Let

$$
t_{1}=\sup \{s \in[\xi, \infty) \mid(x, s) \in c\}
$$

Since $E$ is closed and $c \subset E$, we have $\left(x, t_{1}\right) \in E$. It suffices to show that $\left(x, t_{1}\right) \in c$. Suppose it is not. By Lemma 5.3)(c), $e(x, t) \leq e\left(x, t_{1}\right)$. So, the rectangle $R=p_{1}(e(x, t)) \times\left[t, t_{1}\right)$ must contain a branching point $\left(x_{1}, t_{2}\right)$. But then for any $t_{3} \in\left(t_{2}, t_{1}\right),\left(x, t_{3}\right)$ is not contained in $c$. This contradicts the definition of $t_{1}$.

Lemma 5.24. Let $S \subset E$ be E-saturated and contained in a single $\sim$ equivalence class. Then $S_{t}$ is a single $E$-segment for all $t \in p_{2}(S)$.

Proof. Since $S$ is $E$-saturated, $S_{t}$ is union of $E$-segments. Suppose $e\left(x_{1}, t\right), e\left(x_{2}, t\right) \subset S_{t}$. By assumption, $\left(x_{1}, t\right) \sim\left(x_{2}, t\right)$, so by definition of $\sim$, we have $e\left(x_{1}, t\right) \leq e\left(x_{2}, t\right)$ and $e\left(x_{2}, t\right) \leq e\left(x_{1}, t\right)$. Thus $e\left(x_{1}, t\right)=$ $e\left(x_{2}, t\right)$ by Lemma 5.2 (b). Therefore, $S_{t}$ is a single $E$-segment.

Lemma 5.25. Let $S \subset E$ be E-saturated, connected, closed from above and contained in a single $\sim$ equivalence class. Then $T_{f}(S) \in p_{2}(S)$.

Proof. By Lemma 5.24, $S_{t}$ is a single $E$-segment for each $t \in p_{2}(S)$. So, by Remark $5.1 p_{1}\left(S_{t}\right)$ is closed. Since $\gamma$ is compact, so is $p_{1}\left(S_{t}\right)$. By Lemma 5.1q(b), $p_{1}\left(S_{t^{\prime}}\right) \subset p_{1}\left(S_{t}\right)$ for all $t^{\prime} \geq t$. So $p_{1}\left(S_{t}\right)$ for $t \in p_{2}(S)$ is a nested family of compact non-empty sets. Therefore, we may choose

$$
x \in \bigcap_{t \in p_{2}(S)} p_{1}\left(S_{t}\right) .
$$

So,

$$
\left.\{x\} \times p_{2}(S)=\underset{32}{(\{x\}} \times[\xi, \infty)\right) \cap S .
$$

Therefore, since $S$ is closed from above, $\left(x, T_{f}(S)\right) \in S$, and $T_{f}(S) \in$ $p_{2}(S)$.

Lemma 5.26. Let $S \subset E$ be E-saturated, connected, closed from above and contained in a single $\sim$ equivalence class. Then for any $T \subset E \backslash S$,

$$
S \leq T \Rightarrow S_{T_{f}(S)} \leq T
$$

Proof. Let $(x, t) \in T$. We show first that $t>T_{f}(S)$. By assumption there is a $t_{1} \in p_{2}(S)$ such that $\left(x, t_{1}\right) \in S$ and a $t_{2} \in p_{2}(S)$ such that $t_{2} \leq \min \left\{t, t_{1}\right\}$. By 5.1q(b), $\left(x, t_{2}\right) \in S$. Assume now that $t \leq T_{f}(S)$. Then we have that

$$
R=p_{1}\left(e\left(x, t_{2}\right)\right) \times\left[t_{2}, t\right) \subset p_{1}(S) \times\left(T_{i}(S), T_{f}(S)\right)
$$

and thus $R$ contains no branching point. By Lemma 5.25, there is an $x^{\prime} \in \gamma$ such that $\left(x^{\prime}, T_{f}(S)\right) \in S$. By Lemma 5.10)(b), $e\left(x^{\prime}, t\right) \subset S$. Thus by Lemma 5.24, $e\left(x^{\prime}, t\right)=e(x, t)$. In particular, $(x, t) \in S$ contradicting the assumption that $T \subset E \backslash S$. Thus $t>T_{f}(S)$, so $e\left(x, T_{f}(S)\right)$ is well defined. By Lemma 5.24, $e\left(x, T_{f}(S)\right)=S_{T_{f}(S)}$, so by Lemma 5.3)(d), $S_{T_{f}(S)} \leq e(x, t) \leq(x, t)$. Since $(x, t) \in T$ was arbitrary, the lemma follows.

Lemma 5.27. Let $c \in \mathcal{T}_{E}$, and let $t_{1}, t_{2} \in p_{2}(c)$ satisfy $t_{1} \leq t_{2}$. Let $x_{2} \in p_{1}\left(c_{t_{2}}\right)$. Then $\left\{x_{2}\right\} \times\left[t_{1}, t_{2}\right] \subset c$.
Proof. Let $x_{1} \in p_{1}\left(c_{t_{1}}\right)$. Then $\left(x_{1}, t_{1}\right) \sim\left(x_{2}, t_{2}\right)$. By definition of $\sim$, $e\left(x_{1}, t_{1}\right) \leq e\left(x_{2}, t_{2}\right)$. Let $t \in\left[t_{1}, t_{2}\right]$. Then by Lemmas 5.3)(c) and 5.3)(f),

$$
e\left(x_{1}, t_{1}\right) \leq e\left(x_{2}, t\right) \leq e\left(x_{2}, t_{2}\right) .
$$

Let $R=p_{1}\left(e\left(x_{2}, t\right)\right) \times\left[t, t_{2}\right)$. Then $R \subset p_{1}\left(e\left(x_{1}, t_{1}\right)\right) \times\left[t_{1}, t_{2}\right)$. Therefore $R$ contains no branching points. Thus $\left(x_{2}, t\right) \sim\left(x_{2}, t_{2}\right)$. The lemma follows.

Lemma 5.28. Let $c \in \mathcal{T}_{E}$, and $\left(x_{i}, t_{i}\right) \in c$ for $i=1,2$. Suppose $t_{1} \leq t_{2}$. There exists a path $\rho \subset c$ connecting $\left(x_{1}, t_{1}\right)$ and $\left(x_{2}, t_{2}\right)$ such that $p_{2}(\rho) \subset\left[t_{1}, t_{2}\right]$.
Proof. Let $\rho^{\prime}=\left\{x_{2}\right\} \times\left[t_{1}, t_{2}\right]$. By Lemma [5.27, $\rho^{\prime} \subset c$. By definition of $\sim e\left(x_{1}, t_{1}\right) \leq e\left(x_{2}, t_{2}\right)$. Thus $\rho^{\prime}$ connects the path connected sets $e\left(x_{1}, t_{1}\right)$ and $e\left(x_{2}, t_{2}\right)$. So, choose

$$
\rho \subset e\left(x_{1}, t_{1}\right) \cup \rho^{\prime} \cup e\left(x_{2}, t_{2}\right)
$$

connecting $\left(x_{1}, t_{1}\right)$ to $\left(x_{2}, t_{2}\right)$. By definition of $\sim, c$ is $E$-saturated, so $e\left(x_{i}, t_{i}\right) \subset c$. Thus $\rho \subset c$. Since

$$
p_{2}\left(e\left(x_{1}, t_{1}\right) \cup \rho^{\prime} \cup e\left(x_{2}, t_{2}\right)\right) \subset\left[t_{1}, t_{2}\right],
$$

we have $p_{2}(\rho) \subset\left[t_{1}, t_{2}\right]$.

Proof of Theorem 5.21. Any $c \in \mathcal{T}_{E}$ is $E$-saturated by definition. Such $c$ is connected (in fact, path connected) by Lemma 5.28. Thus $\mathcal{T}_{E}$ satisfies (a). That it satisfies (b) follows from the definition of $\sim$ and Remark 5.18. Condition (c) follows from Lemma 5.26 ,
Corollary 5.29. Let $s \in \mathcal{T}_{E}$.
(a) $s$ is closed from above.
(b) For any $t \in p_{2}(s), s_{t}$ is connected.

Proof. By definition, $s$ is a $\sim$-equivalence class. We rely on this in the following.
(a) The claim is Lemma 5.23.
(b) The claim is Lemma 5.24.

Corollary 5.30. Let $s \in \mathcal{T}_{E}$ and let $s^{\prime} \subset s$ be E-saturated. Then for any $a \subset p_{2}\left(s^{\prime}\right)$, we have

$$
p_{2}^{-1}(a) \cap s=p_{2}^{-1}(a) \cap s^{\prime} .
$$

Proof. Let $t \in a$. Since $s^{\prime}$ is $E$-saturated, $s_{t}^{\prime}$ is an $E$-segment. So, Corollary 5.29(b) implies $s_{t}^{\prime}=s_{t}$.
Corollary 5.31. Let $s \in \mathcal{T}_{E}$ and let $s^{\prime} \subset s$ be E-saturated. Suppose $p_{2}\left(s^{\prime}\right)$ is connected. Then $s^{\prime}$ is connected.

Proof. Let $\left(x_{i}, t_{i}\right) \in s^{\prime}$ for $i=1,2$. Suppose $t_{1} \leq t_{2}$. Since $p_{2}\left(s^{\prime}\right)$ is connected, for any $t \in\left[t_{1}, t_{2}\right], s_{t}^{\prime} \neq \emptyset$. By Corollary 5.30 with $a=\left[t_{1}, t_{2}\right]$, we have

$$
p_{2}^{-1}\left(\left[t_{1}, t_{2}\right]\right) \cap s=p_{2}^{-1}\left(\left[t_{1}, t_{2}\right]\right) \cap s^{\prime} .
$$

So, by Lemma 5.28 we can connect $\left(x_{1}, t_{1}\right)$ to $\left(x_{2}, t_{2}\right)$ by a path in $s^{\prime}$. Since $\left(x_{i}, t_{i}\right) \in s^{\prime}$ were arbitrary, $s^{\prime}$ is (path) connected.
Lemma 5.32. Let $c \in \mathcal{T}_{E}$. Let $\mathcal{P}$ be a collection of disjoint connected $E$-saturated subsets of $c$. The relation $\leq$ induces a linear order on $\mathcal{P}$.

Proof. First, we prove that for $P \subset \mathcal{P}$ we have

$$
\begin{equation*}
P \leq c_{T_{f}(c)} . \tag{30}
\end{equation*}
$$

Indeed, for $t \in p_{2}(P)$ since $P$ is $E$-saturated, Lemma 5.2.(b) implies that $P_{t}=c_{t}$. By Lemma 5.1q(b), we have $c_{t} \leq c_{T_{f}(c)}$. So,

$$
P \leq P_{t}=c_{t} \leq c_{T_{f}(c)}
$$

as desired.
Suppose $P_{1}, P_{2} \in \mathcal{P}$. Without loss of generality, we may assume $P_{1} \leq_{2} P_{2}$. So, by relation (30) and Lemma 5.13, we have $P_{1} \leq P_{2}$, which implies the lemma.

Lemma 5.33. For each $s \in \mathcal{T}_{E}$ there exists a maximal element $m \in \mathcal{T}_{E}$ such that $s \leq m$.
Proof. Let $x \in \overline{p_{1}(s)}$ be the point where $f$ obtains its maximum. Then $f(x) \geq T_{f}(s)$. If $f(x)=T_{f}(s)$ then $s$ itself is maximal. If $f(x)>T_{f}(s)$ we claim that $s \leq\{(x, f(x))\}$. Assume by contradiction otherwise. Then $x \notin p_{1}\left(s_{T_{f}(s)}\right)$. By Lemma 5.2g(b) $s_{T_{f}(s)}$ is a single $E$-segment. Therefore $p_{1}\left(s_{T_{f}}(s)\right)$ is closed. It follows that $x$ has an open neighborhood $v \subset \gamma \backslash p_{1}\left(s_{T_{f}(s)}\right)$. Since $x \in \overline{p_{1}(s)}$ and $f$ is continuous, there is a point $x^{\prime} \in p_{1}(s) \cap v$ close enough to $x$ so that $f\left(x^{\prime}\right)>T_{f}(s)$. Therefore $s \leq\left\{\left(x^{\prime}, f\left(x^{\prime}\right)\right)\right\}$. On the other hand, since $f\left(x^{\prime}\right)>T_{f}(s)$, $\left(x^{\prime}, f\left(x^{\prime}\right)\right) \notin s$. But since $x^{\prime} \notin p_{1}\left(s_{T_{f}(s)}\right), s_{T_{f}(s)} \not \leq\left\{\left(x^{\prime}, f\left(x^{\prime}\right)\right)\right\}$ in contradiction to 5.21)(c),

Let $m \in \mathcal{T}_{E}$ be the element containing $(x, f(x))$. Then we have that $s \leq\{(x, f(x))\}$ and $m \leq\{(x, f(x))\}$. Therefore, by Lemma 5.13 $s \leq m$.

Given a finite collection $V$ of connected $E$-saturated sets, we define a graph $F_{V}$ as follow. $V$ is the set of vertices of $F$. We connect the vertex $v_{1}$ to $v_{2}$ if $v_{1} \leq v_{2}$ and there is no $v_{3} \in V$ such that $v_{1} \leq v_{3} \leq v_{2}$. By virtue of Corollary 5.22, $F_{V}$ has no cycles and so is a forest. Again by Corollary 5.22, each tree $T$ in $F_{V}$ has a unique minimal vertex $r_{T}$, which we designate as the root of $T$. Thus the leaves of $F_{V}$ are the maximal vertices. Denote by $R(V) \subset V$ the roots of $F_{V}$, by $L(V) \subset V$ the leaves, and by $I(V) \subset V$ the vertices which are neither roots nor leaves. Denote by $E(V)$ the edges of $F_{V}$.

A finite forest $F$ is called stable if any $v \in F$ which is not a leaf has at least two direct descendants. The proof of the following lemma is standard and we omit it.
Lemma 5.34. Let $F$ be a finite stable forest and let $L$ be the number of its leaves. Then $|F| \leq 2 L$.

Lemma 5.35. Let $M \subset \mathcal{T}_{E}$ be the set of maximal elements under $\leq . \mathcal{T}_{E}$ is finite if and only if $M$ is finite. Moreover, in that case $\left|\mathcal{T}_{E}\right| \leq 2|M|$.
Proof. First, we let $S$ be an anti-chain in $\mathcal{T}_{E}$ and show that $|S| \leq|M|$. By Lemma 5.33, for each $s \in S$ there is at least one $m \in M$ such that $s \leq m$. Since the elements of $S$ are pairwise incomparable, and since by Corollary 5.22 the order on $\mathcal{T}_{E}$ is tree-like, for any element $m \in M$ there is at most one $s \in S$ such that $s \leq m$. Thus $|S| \leq|M|$.

It suffices to prove the bound for any finite subset $V \subset \mathcal{T}_{E}$. Given such $V$, by Theorem 5.21](c) we may choose $V^{\prime} \subset \mathcal{T}_{E}$, such that $V \subset V^{\prime}$ and $F_{V^{\prime}}$ is stable. The claim now follows from Lemma 5.34.

## 6. Thick thin partition

6.1. Thickened hypograph. We now specialize the discussion of the previous section to the case where $\gamma$ is a geodesic in $\Sigma$ as in Theorem 4.2. Denote the connected components of $\gamma$ by $\gamma_{i}$. We will assume throughout this section that for all $i$ we have

$$
\begin{equation*}
4 e^{-\max _{x \in \gamma_{i}} g(x)} \leq \ell_{n}\left(\gamma_{i}\right), \tag{31}
\end{equation*}
$$

and

$$
\begin{equation*}
2 k \leq \max _{x \in \gamma_{i}} e^{g(x)} \tag{32}
\end{equation*}
$$

Recall Definition4.6. Here and below, we abbreviate $\ell_{n}(c)=\ell_{n}\left(p_{1}(c)\right)$. Let $s_{t}:=\left\{c \in \pi_{0}\left(X_{t} \backslash D\right) \mid \ell_{n}(c)>4 e^{-t}\right\}$, and let $S_{t}$ be the union of elements of $s_{t}$. Let $E_{t}:=X_{t} \backslash S_{t}$, and $E:=\cup_{t} E_{t} \cup \gamma \times\{\ln 2 k\}$. We will show that $E$ is the hypograph of a continuous function. Figure 8 gives a picture of a typical $E$ compared with $D$.


Figure 8.
Remark 6.1. By definition $D_{t}$ is $2 e^{-t}$-dense in $E_{t}$. Let $t_{1}, t_{2} \geq \ln (2 k)$. Let $S_{1} \subset E_{t_{1}}, S_{2} \subset E_{t_{2}}$, be segments such that $p_{1}\left(S_{1}\right) \cap p_{1}\left(S_{2}\right)=\emptyset$ and such that $\ell_{n}\left(S_{i}\right) \geq 8 e^{-t_{i}}$ for $i=1,2$. Then $S_{i}$ contains a point $x_{i} \in D_{t}$ such that $d\left(x_{i}, \partial S_{i} ; h_{n}\right) \geq 2 e^{-t_{i}}$. Let $B_{i}=B\left(x_{i}, t_{i}\right)$. By Lemma 4.7, $\mu\left(B_{i}\right) \geq \delta_{1}$. Furthermore, by Lemma 4.8

$$
B_{1} \cap B_{2}=\emptyset .
$$

This observation will play a key role in the following.

Lemma 6.2. E is closed.
Proof. Let $(x, t) \in \partial E$. We show that $(x, t) \in E$. If $(x, t) \in D$, we are done since $D \subset E$. Otherwise, let $s$ be the connected component of $X_{t} \backslash D$ containing $(x, t)$. We show that $\ell_{n}(s) \leq 4 e^{-t}$, which implies that $s \subset E$. Assume by contradiction otherwise. Then there is a compact segment $s^{\prime} \subset s$ such that $\ell_{n}\left(s^{\prime}\right)>4 e^{-t}$ and such that $(x, t) \in$ $s^{\prime 0}$. By the closedness of $D$, compactness of $s^{\prime}$, and continuity of the exponent, there is an $\epsilon>0$ such that $\pi_{1}\left(s^{\prime}\right) \times(t-\epsilon, t+\epsilon) \subset X \backslash D$ and such that for any $t^{\prime} \in(t-\epsilon, t+\epsilon), \ell_{n}\left(s^{\prime}\right)>4 e^{-t^{\prime}}$. This implies that $\pi_{1}\left(s^{\prime}\right) \times(t-\epsilon, t+\epsilon) \subset X \backslash E$. But $\pi_{1}\left(s^{\prime}\right) \times(t-\epsilon, t+\epsilon)$ contains an open neighborhood of $(x, t)$ in contradiction to the fact that $(x, t) \in \partial E$.

Lemma 6.3. Let $t \in[\ln 2 k, \infty)$. For all $x \in p_{1}\left(E_{t}\right),\{x\} \times[\ln 2 k, t) \subset$ $E^{o}$.

Proof. First, we prove that for all $y \in p_{1}\left(E_{t}\right)$,

$$
\begin{equation*}
\{y\} \times[\ln 2 k, t) \subset E . \tag{33}
\end{equation*}
$$

Let $t^{\prime} \in[\ln 2 k, t)$. We show that $\left(y, t^{\prime}\right) \in E$. Indeed, if $\left(y, t^{\prime}\right) \in D$, we are done since $D \subset E$. If $\left(y, t^{\prime}\right) \notin D$, then $(y, t) \notin D$. Let $S$ and $S^{\prime}$ be the components of $X_{t} \backslash D$ and $X_{t^{\prime}} \backslash D$ containing $(y, t)$ and $\left(y, t^{\prime}\right)$ respectively. Clearly $p_{1}\left(S^{\prime}\right) \subset p_{1}(S)$. Since $(y, t) \in E$, we have by definition of $E$ that

$$
\ell_{n}\left(S^{\prime}\right) \leq \ell_{n}(S) \leq 4 e^{-t}<4 e^{-t^{\prime}}
$$

By the same definition, we conclude that $\left(y, t^{\prime}\right) \in E$.
To prove the claim, it suffices to show for any $t^{\prime} \in[\ln 2 k, t)$ that $\left(x, t^{\prime}\right) \in E^{o}$. If $t^{\prime}<g(x)$, then $\left(x, t^{\prime}\right) \in D^{o} \subset E^{o}$ by continuity of $g$. If $t^{\prime} \geq g(x)$, then $t>g(x)$. Let $S$ be the component of $X_{t} \backslash D$ containing $(x, t)$. By definition of $E$, we have $S \subset E_{t}$. So, invoking inclusion (33) for each $y \in \pi_{1}(S)$, we conclude that the open neighborhood $\pi_{1}(S) \times$ [ $\ln 2 k, t)$ of $\left(x, t^{\prime}\right)$ is contained in $E$.

It is clear from the definition that for any $x \in \gamma$, the set

$$
\{t \in[\ln 2 k, \infty) \mid(x, t) \in E\}
$$

is bounded from above. It follows from Lemma 6.3 that $E$ is the hypograph of the function $f_{\partial E}$ defined by

$$
f_{\partial E}(x)=\sup \{t \in[\ln 2 k, \infty) \mid(x, t) \in E\}
$$

Lemma 6.4. $\partial E$ is the graph of $f_{\partial E}$.

Proof. Clearly, the graph of $f$ is contained in $\partial E$. So, it suffices to prove the opposite inclusion. Let $(x, t) \in \partial E$. Then by Lemma $6.2(x, t) \in E$, so by Lemma $6.3\{x\} \times[\ln 2 k, t) \subset E^{o}$. On the other hand, we show that $\{x\} \times(t, \infty) \subset X \backslash E$. Indeed, if $t^{\prime} \in(t, \infty)$ and $\left(x, t^{\prime}\right) \in E$, then by Lemma 6.3

$$
(x, t) \in\{x\} \times\left[\ln 2 k, t^{\prime}\right) \subset E^{o}
$$

contradicting the choice of $(x, t)$. Thus, by definition $f_{\partial E}(x)=t$.
Corollary 6.5. $f_{\partial E}$ is continuous.
Proof. The graph of $f_{\partial E}$ is closed being the boundary of $E . f_{\partial E}$ is bounded, so its graph is compact. Thus, the projection $p_{1}$ restricted to the graph of $f_{\partial E}$ is closed. It follows that $f_{\partial E}$ is continuous.

Remark 6.6. It follows from equations (31) and (32) that

$$
\max _{x \in \gamma} f_{\partial E}(x)=\max _{x \in \gamma} g(x) .
$$

Lemma 6.7. Let $e_{1}$ and $e_{2}$ be E-segments that are incomparable with respect to $\leq$. Let $t_{i}=p_{2}\left(e_{i}\right)$. Then,

$$
d\left(p_{1}\left(e_{1}\right), p_{1}\left(e_{2}\right) ; h_{n}\right) \geq 4 e^{-\min \left(t_{1}, t_{2}\right)}
$$

Proof. Assume without loss of generality that $t_{1} \leq t_{2}$. Let $x \in p_{1}\left(e_{2}\right)$ and denote $e_{2}^{\prime}=e\left(x, t_{1}\right)$. Since $e_{2}^{\prime}$ and $e_{1}$ are both connected components of $E_{t_{1}}$, we have by the definition of $E_{t_{1}}$ that either $e_{2}^{\prime}=e_{1}$ or $d\left(p_{1}\left(e_{2}^{\prime}\right), p_{1}\left(e_{1}\right)\right) \geq 4 e^{-t_{1}}$. By Lemma 5.3)(c), $e_{2}^{\prime} \leq e_{2}$. Thus $p_{1}\left(e_{2}\right) \subset$ $p_{1}\left(e_{2}^{\prime}\right)$ giving the claim.

Lemma 6.8. Let $S_{1}, S_{2} \subset E$. Suppose $S_{1}$ is $E$-saturated and connected, $S_{2}$ is connected and $S_{1} \leq_{2} S_{2}$. Then either $S_{1} \leq S_{2}$ or

$$
d\left(p_{1}\left(S_{1}\right), p_{1}\left(S_{2}\right) ; h_{n}\right) \geq 4 e^{-T_{i}\left(S_{1}\right)} .
$$

Proof. Suppose $S_{1} \not \leq S_{2}$. Let $\left(x_{1}, t_{1}\right) \in S_{1}$ and $\left(x_{2}, t_{2}\right) \in S_{2}$. Let $e_{i}=e\left(x_{i}, t_{i}\right)$ for $i=1,2$. We show that $d\left(x_{1}, x_{2}\right) \geq 4 e^{-T_{i}\left(S_{1}\right)}$. Suppose $t \in p_{2}\left(S_{1}\right)$ is such that $t \leq t_{1}$. Since $S_{1}$ is $E$-saturated and connected, Lemma 5.1d(b) implies that $\left(x_{1}, t\right) \in S_{1}$. Since $S_{1} \leq_{2} S_{2}$, there is a a $t \in p_{2}\left(S_{1}\right)$ such that $t \leq t_{2}$. We may thus assume without loss of generality that $t_{1} \leq t_{2}$. Furthermore, $t_{1}$ may be assumed to be arbitrarily close to $T_{i}\left(S_{1}\right)$. Since $S_{1}$ is $E$-saturated, $e_{1} \subset S_{1}$. By Lemma 5.12 we have $p_{1}\left(S_{1}\right) \cap p_{1}\left(S_{2}\right)=\emptyset$. In particular $x_{2} \notin p_{1}\left(e_{1}\right)$, so $e_{1} \not \leq e_{2}$. Since $t_{1} \leq t_{2}, e_{1}$ and $e_{2}$ are incomparable. Therefore, by Lemma 6.7 we have

$$
d\left(x_{1}, x_{2}\right) \geq d\left(p_{1}\left(e_{1}\right), p_{1}\left(e_{2}\right)\right) \geq 4 e^{-t_{1}} .
$$

Since $t_{1}$ is arbitrarily close to $T_{i}\left(S_{1}\right)$, we have

$$
d\left(x_{1}, x_{2}\right) \geq 4 e^{-T_{i}\left(S_{1}\right)} .
$$

Since $x_{i}$ were arbitrary points in $p_{1}\left(S_{i}\right)$, the claim follows.
Corollary 6.9. Let $S_{1}, S_{2} \subset E$ be incomparable connected $E$-saturated sets. Then

$$
d\left(p_{1}\left(S_{1}\right), p_{1}\left(S_{2}\right) ; h_{n}\right) \geq 4 e^{-\min \left\{T_{i}\left(S_{1}\right), T_{i}\left(S_{2}\right)\right\}} .
$$

Proof. Without loss of generality $S_{1} \leq_{2} S_{2}$. The claim thus follows from Lemma 6.8.

Corollary 6.10. $\mathcal{T}_{E}$ is finite.
Proof. Let $M$ be the set of maximal elements of $\mathcal{T}_{E}$. Then the elements of $M$ are pairwise incomparable under $\leq$. Let $T=\sup _{x \in \gamma} g(x)$. By Remark 6.6 we have $T_{i}(c) \leq T$ for any $c \in M$. It follows from Corollary 6.9 that

$$
|M| \leq \frac{1}{4} e^{T} \ell_{n}(\gamma)
$$

In particular, $M$ is finite. The claim therefore follows from Lemma 5.35
6.2. Thick thin partition. We now wish to partition $E$ into a thin part and a thick part. To this end, let

$$
N:=\left\{(x, t) \in E \mid \ell_{n}(e(x, t)) \leq 24 e^{-t}\right\},
$$

and let

$$
K:=E \backslash N .
$$

Lemma 6.11. $N$ is E-saturated and closed from above.
Proof. It is obvious that $N$ is $E$-saturated. We show that $N$ is closed from above. Let $(x, t)$ be a right boundary point of $\{x\} \times[\ln 2 k, \infty) \cap N$. Since $E$ is closed, we have $(x, t) \in E$. Thus we need to show that $\ell_{n}(e(x, t)) \leq 24 e^{-t}$. Assume by contradiction otherwise. Let $\epsilon>0$ be so small that $\ell_{n}(e(x, t))>24 e^{\epsilon-t}$. By Lemma 6.3, we have

$$
\{x\} \times[t-\epsilon, t) \subset E .
$$

On the other hand, for any $t^{\prime} \in[t-\epsilon, t)$, by Lemma 5.10(c)

$$
p_{1}(e(x, t)) \subset p_{1}\left(e\left(x, t^{\prime}\right)\right) .
$$

So,

$$
\ell_{n}\left(e\left(x, t^{\prime}\right)\right) \geq \ell_{n}(e(x, t))>24 e^{-t+\epsilon} \geq 24 e^{-t^{\prime}}
$$

Therefore, $\{x\} \times[t-\epsilon, t) \subset E \backslash N$ giving a contradiction.

Definition 6.12. A thin neck is a connected component of $c \cap N$ where $c \in \mathcal{T}_{E}$. Given a thin neck $L$, we denote by $c_{L}$ the unique $c \in \mathcal{T}_{E}$ such that $L \subset c$.

Lemma 6.13. Let $L$ be a thin neck.
(a) $L$ is $E$-saturated and closed from above.
(b) Let $S \subset E$ be disjoint from $L$, then

$$
L \leq S \Rightarrow L_{T_{f}(L)} \leq S
$$

(c) For any $x \in p_{1}(L) \backslash p_{1}\left(L_{T_{f}(L)}\right)$,

$$
\left(x, f_{\partial E}(x)\right) \in L
$$

(d) For any $x \in p_{1}(L) \backslash p_{1}\left(L_{T_{f}(L)}\right)$,

$$
g(x) \leq \ln 24-\ln d\left(x, p_{1}\left(L_{T_{f}(L)}\right) ; h_{n}\right)
$$

Proof. (a) Let $c \in \mathcal{T}_{E}$ such that $L$ is a connected component of $c \cap N . c$ is $E$ saturated by definition and closed from above by Corollary 5.29)(a), $N$ is $E$-saturated and closed from above by Lemma 6.11. It follows from Remark 5.5 that $L$ is $E$-saturated. By Remark 5.20, $L$ is closed from above.
(b) $L$ is connected and contained in an equivalence class $c \in \mathcal{T}_{E}$ by definition. $L$ is $E$-saturated and closed from above by (a). The claim thus follows from Theorem 5.21)(c).
(c) Let $t \geq \ln 2 k$ be such that $(x, t) \in L$. Since $L \subset E$, we have $t \leq f_{\partial E}(x)$. This means that $L \leq\left\{\left(x, f_{\partial E}(x)\right)\right\}$. Suppose

$$
\left(x, f_{\partial E}(x)\right) \notin L
$$

Then by (b), $L_{T_{f}(L)} \leq\left\{\left(x, f_{\partial E}(x)\right)\right\}$. This produces the contradiction $x \in p_{1}\left(L_{T_{f}(L)}\right)$.
(d) Let $x^{\prime} \in p_{1}\left(L_{T_{f}(L)}\right)$. By (c), $\left(x, f_{\partial E}(x)\right) \in L$, so $f_{\partial E}(x) \in p_{2}(L)$. Thus by 5.1q(b) we have $x^{\prime} \in p_{1}\left(L_{f_{\partial E}(x)}\right)$. Let $c \in \mathcal{T}_{E}$ be such that $L \subset c$. By (a), $L$ is $E$-saturated, so by Corollary 5.29 we have $L_{f_{\partial E}(x)}=c_{f_{\partial E}(x)}$ and $L_{f_{\partial E}(x)}$ is connected. Thus $e\left(x, f_{\partial E}(x)\right)=e\left(x^{\prime}, f_{\partial E}(x)\right)$. But

$$
\ell_{n}\left(e\left(x^{\prime}, f_{\partial E}(x)\right)\right) \leq 24 e^{-f_{\partial E}(x)}
$$

so

$$
\begin{aligned}
d\left(x, p_{1}\left(L_{T_{f}(L)}\right) ; h_{n}\right) & \leq d\left(x, x^{\prime} ; h_{n}\right) \\
& \leq \ell_{n}\left(e\left(x^{\prime}, f_{\partial E}(x)\right)\right) \\
& \leq 24 e^{-f_{\partial E}(x)} \\
& \leq 24 e^{-g(x)} .
\end{aligned}
$$

The claim follows by taking logarithms in (34).

Lemma 6.14. For $i=1,2$, let $L_{i}$ be disjoint thin necks such that $p_{2}\left(L_{1}\right) \cup p_{2}\left(L_{2}\right)$ is connected.
(a) $c_{L_{1}} \neq c_{L_{2}}$.
(b) If $L_{1} \leq L_{2}$, then $L_{1, T_{f}\left(L_{1}\right)}$ contains a branching point.

Proof. (a) Suppose the contrary. Then Corollary 5.31 implies that $L_{1} \cup L_{2}$ is connected. The definition of thin necks implies the contradiction $L_{1}=L_{2}$.
(b) Let $(x, t) \in L_{2}$. For any $t^{\prime} \in\left[T_{f}\left(L_{1}\right), t\right)$, denote

$$
R\left(t^{\prime}\right)=p_{1}\left(e\left(x, t^{\prime}\right)\right) \times\left[t^{\prime}, t\right) .
$$

Since $L_{1} \leq L_{2}$, by Lemma 6.13(b), $\left(x, T_{f}\left(L_{1}\right)\right) \in L_{1}$. By (a), $c_{L_{1}} \neq c_{L_{2}}$. Therefore, $(x, t) \nsim\left(x, T_{f}\left(L_{1}\right)\right)$. Thus $R\left(T_{f}\left(\overline{\left.\left.L_{1}\right)\right)}\right.\right.$ contains a branching point $p$. But for any $t^{\prime} \in\left(T_{f}\left(L_{1}\right), t\right)$, by Lemma 5.27, $\{x\} \times\left[t^{\prime}, t\right] \subset c_{L_{2}}$. In particular, $(x, t) \sim\left(x, t^{\prime}\right)$. So, $R\left(t^{\prime}\right)$ contains no branching point. Thus $p \in e\left(x, T_{f}\left(L_{1}\right)\right)$. Since $\left(x, T_{f}\left(L_{1}\right)\right) \in L_{1}$, by Lemma 6.13(a), $e\left(x, T_{f}\left(L_{1}\right)\right) \subset L_{1, T_{f}\left(L_{1}\right)}$. Therefore, $p \in L_{1, T_{f}\left(L_{1}\right)}$.

Definition 6.15. Let $L$ be a thin neck. $L$ is exceptional if it satisfies the following two conditions.
(a)

$$
T(L)<\ln 3
$$

(b) For any $\epsilon>0$ there are $\left(x_{i}, t_{i}\right) \in K$ for $i=1,2$, such that $t_{1} \in\left(T_{i}(L)-\epsilon, T_{i}(L)\right], t_{2} \in\left(T_{f}(L), T_{f}(L)+\epsilon\right)$, and

$$
e\left(x_{1}, t_{1}\right) \leq L \leq e\left(x_{2}, t_{2}\right)
$$

Definition 6.16. Let $L$ be a thin neck. We write

$$
\mathcal{N}^{+}(L, \epsilon):=\left(p_{1}(L) \times\left[T_{i}(L), T_{f}(L)+\epsilon\right)\right) \cap E
$$

and

$$
\mathcal{N}^{-}(L, \epsilon):=\left(p_{1}(L) \times\left[T_{i}(L)-\epsilon, T_{f}(L)\right)\right) \cap E .
$$

We say that $L$ is upper interior if there is an $\epsilon>0$ such that $\mathcal{N}^{+}(L, \epsilon) \subset N$. Similarly, we say that $L$ is lower interior if there is an $\epsilon>0$ such that $\mathcal{N}^{-}(L, \epsilon) \subset N$.
Remark 6.17. By Definition 6.15)(b), every non-exceptional thin neck $L$ such that $T(L)<\ln 3$ is either upper interior or lower interior.

Remark 6.18. It is clear that for any $\epsilon>0, \mathcal{N}^{+}(L, \epsilon)$ and $\mathcal{N}^{-}(L, \epsilon)$ are connected.

Definition 6.19. The thin part $A \subset E$ is the union of non-exceptional thin necks. The thick part of $E$ is

$$
C:=E \backslash A
$$

Lemma 6.20. $C$ is $E$-saturated.
Proof. This follows from Lemma 6.13) and Remark 5.5.
6.3. Energy bound on the number of thin necks. Let $H$ denote the set of non-exceptional thin necks $L$ such that $T(L)<\ln 3$. Let $G$ denote the set of all non-exceptional thin necks.

## Lemma 6.21.

$$
|H| \leq 2\left|\mathcal{T}_{E}\right|
$$

Proof. We will show that the map $H \rightarrow \mathcal{T}_{E}$ defined by $L \mapsto c_{L}$ is at most two to one. Let $c \in \mathcal{T}_{E}$. By Remark 6.17 every $L \in H$ is either upper interior or lower interior. We claim that that there is at most one lower interior $L \in H \cap \pi_{0}(N \cap c)$. Similarly we claim that there is at most one upper interior $L \in H \cap \pi_{0}(N \cap c)$.

Indeed, suppose $L \subset c$ is a lower interior element of $H$. First, we show that

$$
\begin{equation*}
T_{i}(L)=T_{i}(c) \tag{35}
\end{equation*}
$$

Since $L \subset c$, we have $T_{i}(c) \leq T_{i}(L)$. Suppose by contradiction the inequality is strict. Let $\epsilon>0$ be such that $\mathcal{N}^{-}(L, \epsilon) \subset N$. By Theorem 5.21](a), $c$ is connected, so $p_{2}(c)$ is an interval. Thus we may choose $t_{1} \in p_{2}(c) \cap\left[T_{i}(L)-\epsilon, T_{i}(L)\right)$. Choose $\left(x_{2}, t_{2}\right) \in L$. By Lemma 5.27, $\left\{x_{2}\right\} \times\left[t_{1}, t_{2}\right] \subset c$. By definition of $\mathcal{N}^{-}(L, \epsilon)$, we have $\left\{x_{2}\right\} \times\left[t_{1}, t_{2}\right] \subset \mathcal{N}^{-}(L, \epsilon) \subset N$. It follows that ( $x_{2}, t_{1}$ ) belongs to the same connected component of $c \cap N$ as $\left(x_{2}, t_{2}\right)$. However $t_{1}<T_{i}(L)$, so $\left(x_{1}, t_{1}\right) \notin L$ contradicting the definition of $L$. Equation (35) follows.

Let $L^{\prime} \in H \cap \pi_{0}(N \cap c)$ also be lower interior. Then $T_{i}\left(L^{\prime}\right)=T_{i}(c)=$ $T_{i}(L)$. In particular, $p_{2}(L) \cup p_{2}\left(L^{\prime}\right)$ is connected. Therefore, by Lemma 6.14)(a), $L=L^{\prime}$.

The upper interior case follows similarly. Thus the map $L \mapsto c_{L}$ is at most two to one.

Corollary 6.22. $|G|<\infty$.
Proof. In light of Lemmas 6.21 and 6.10 we need only bound $G \backslash H$. Again relying on Lemma 6.10, it suffices to bound the set $S_{c}$ defined for any $c \in \mathcal{T}_{E}$ by

$$
S_{c}=(G \backslash H) \cap \pi_{0}(N \cap c) .
$$

By Remark 6.6 we have

$$
T(c) \leq \sup _{x \in \gamma} g(x)-\ln 2 k=: M .
$$

Lemma 6.14(a) implies that $p_{2}\left(L_{1}\right) \cap p_{2}\left(L_{2}\right)=\emptyset$ for any two elements $L_{1}, L_{2} \in S_{c}$. Therefore $\left|S_{c}\right| \leq \frac{T(c)}{\ln 3} \leq \frac{M}{\ln 3}$.
Lemma 6.23. Let $c \in \mathcal{T}_{E}$ and let $L_{1}, L_{2} \subset c$ be non-exceptional thin necks. Let $k$ be a connected component of $c \cap C$ satisfying $L_{1} \leq k \leq L_{2}$. Then $k$ is a connected component of $C$.

Proof. By Remark 5.5 and Lemma 6.20, $k$ is $E$-saturated. Choose $\left(x, t_{2}\right) \in L_{2}$. Since $L_{1} \leq k \leq L_{2}$, there exist $t_{1} \in p_{2}\left(L_{1}\right)$ and $t \in p_{2}(k)$ such that $\left(x, t_{1}\right) \in L_{1}$ and $(x, t) \in k$. Since $L_{1}, L_{2} \subset A$ and $k \subset C$, we have

$$
L_{i} \cap k=\emptyset, \quad i=1,2 .
$$

So, by Lemma 5.9 and Corollary 5.11, we deduce that $t_{1}<t<t_{2}$.
Let $k^{\prime}$ be the connected component of $C$ containing $k$. We prove that $k^{\prime} \subset c$, which immediately implies the lemma. Indeed, let

$$
R=p_{1}\left(e\left(x, t_{1}\right)\right) \times\left[t_{1}, t_{2}\right) .
$$

Since $L_{1}, L_{2} \subset c$, we have $\left(x, t_{1}\right) \sim\left(x, t_{2}\right)$. So, $e\left(x, t_{1}\right) \leq e\left(x, t_{2}\right)$ and $R$ contains no branch points. Since $e\left(x, t_{1}\right) \leq e\left(x, t_{2}\right)$, we have

$$
e\left(x, t_{2}\right) \subset(\bar{R} \cap E)_{t_{2}} .
$$

Since $R$ contains no branched points, by Lemma 5.17 we deduce that $(\bar{R} \cap E)_{t_{2}}$ is connected. So,

$$
e\left(x, t_{2}\right)=(\bar{R} \cap E)_{t_{2}} .
$$

Since $L_{i} \subset A$ does not intersect $C$,

$$
e\left(x, t_{i}\right) \subset L_{i}
$$

does not intersect $C$ for $i=1,2$. Let $x_{1}$ and $x_{2}$ be the endpoints of the interval $p_{1}\left(e\left(x, t_{1}\right)\right)$. By Remark 5.1.

$$
\left(\left\{x_{i}\right\} \times\left(t_{1}, \infty\right)\right) \cap C \subset\left(\left\{x_{i}\right\} \times\left(t_{1}, \infty\right)\right) \cap E=\emptyset .
$$

It follows that $\partial R \cap C=\emptyset$. So, $C_{1}=C \backslash \bar{R}$ and $C_{2}=C \cap R^{o}$ constitute a partition of $C$ into relatively open subsets. Since $(x, t) \in R^{o}$ and $(x, t) \in k \subset k^{\prime}$, the connectedness of $k^{\prime}$ implies that $k^{\prime} \subset C_{1}$. Therefore, by the definition of $\sim$, we conclude that $k^{\prime} \subset c$ as desired. The lemma follows.

Lemma 6.24. Let $L$ be an exceptional thin neck. Then $L_{T_{f}(L)}$ does not contain a branching point.

Proof. Let $R=p_{1}\left(L_{T_{f}(L)}\right) \times\left(T_{f}(L), \infty\right) \cap E$, and let $\epsilon>0$. By Definition 6.15) there exists $t \in\left(T_{f}(L), T_{f}(L)+\epsilon\right)$ and a component $k$ of $R_{t}$ satisfying $k \subset K$. Suppose now that $L_{T_{f}(L)}$ contains a branching point. Then by Remark 5.18 there exists $t^{\prime} \in\left(T_{f}(L), t\right]$ such that $R_{t^{\prime}}$ has at least two components. Therefore, there is at least one component $e$ of $R_{t^{\prime}}$ such that $e \not \leq k$. By Lemma 6.8, $d\left(p_{1}(e), p_{1}(k)\right) \geq 4 e^{-t^{\prime}}$. Furthermore, $L_{T_{f}(L)} \leq e \cup k$. So, since $k \subset K$,

$$
\begin{align*}
\ell_{n}\left(p_{1}\left(L_{T_{f}(L)}\right)\right) & >\ell_{n}\left(p_{1}(e)\right)+\ell_{n}\left(p_{1}(k)\right)+4 e^{-t^{\prime}}  \tag{36}\\
& >24 e^{-t}+4 e^{-t^{\prime}} \\
& >28 e^{-\left(T_{f}(L)+\epsilon\right)} .
\end{align*}
$$

On the other hand, since $L \subset N, \ell_{n}\left(L_{T_{f}(L)}\right) \leq 24 e^{-T_{f}(L)}$. This together with Equation (36) implies that

$$
28 e^{-\left(T_{f}(L)+\epsilon\right)}<24 e^{-T_{f}(L)}
$$

Since $\epsilon$ is arbitrary, we obtain a contradiction.
Corollary 6.25. Let $L$ be an exceptional thin neck. Let $L^{\prime}$ be any thin neck such that $L \lesseqgtr L^{\prime}$. Then $T_{i}\left(L^{\prime}\right)>T_{f}(L)$.
Proof. Suppose the contrary. Then by Lemma 6.14](b), $L_{T_{f}(L)}$ contains a branching point. This contradicts Lemma 6.24,
Corollary 6.26. Let $L$ be an exceptional thin neck. There is an $\epsilon>0$ such that $\mathcal{N}^{+}(L, \epsilon) \subset C$.
Proof. Let $S$ be the set of non-exceptional thin necks $L^{\prime}$ such that $L \leq$ $L^{\prime}$. It follows from Corollary 6.22 that $S$ is finite. Let $t=\min _{s \in S} T_{i}(s)$. By Corollary 6.25, $t>T_{f}(L)$. Let $\epsilon=t-T_{f}(L)$. Then $\epsilon$ satisfies the requirement.
Lemma 6.27. Let $t \in p_{2}(C)$ and let $c$ be a connected component of $C_{t}$. There is a $t^{\prime} \in[t, t+\ln 3)$ and a component $c^{\prime}$ of $K_{t^{\prime}}$ such that $c \leq c^{\prime}$. Furthermore, $c^{\prime}$ can be taken to belong to the same connected component of $C$ as $c$.

Proof. If $c \subset K$, take $t^{\prime}=t$. Otherwise, since by Lemma 6.20, $c$ is an $E$-segment, and by Remark $5.5 K$ is $E$-saturated, we have $c \cap K=\emptyset$. So, $c \subset N \cap C$. Therefore, $c$ is contained in an exceptional thin neck $L$. Using Corollary 6.26, choose $\epsilon_{1}$ small enough that $\mathcal{N}^{+}\left(L, \epsilon_{1}\right) \subset C$. Let

$$
0<\epsilon<\min \left(\ln 3-\left(T_{f}(L)-t\right), \epsilon_{1}\right) .
$$

By Definition 6.15)(b) and Lemma 6.13), there is a

$$
t^{\prime} \in\left(T_{f}(L), T_{f}(L)+\epsilon\right)
$$

and an

$$
x \in p_{1}\left(K_{t^{\prime}}\right)
$$

such that $L_{T_{f}(L)} \leq e\left(x, t^{\prime}\right)$. By Lemma 6.13(a), again using the fact that $c$ is an $E$-segment, $c=L_{t}$. So, by Lemma 5.1q(b)

$$
c \leq L_{T_{f}(L)} \leq e\left(x, t^{\prime}\right)
$$

By the choice of $\epsilon$,

$$
t<t^{\prime}<T_{f}(L)+\epsilon<\ln 3+t
$$

So, we take $c^{\prime}=e\left(x, t^{\prime}\right)$. By Remark 6.18, $\mathcal{N}^{+}\left(L, \epsilon_{1}\right)$ is a connected subset of $C$ that contains both $c$ and $c^{\prime}$.

Definition 6.28. A subset $Z \subset \Sigma$ is dense if $\mu(Z) \geq \delta_{1}$.
Definition 6.29. Let $S$ be a set. An energy partition for $S$ is a map which assigns to each element $e \in S$ a dense subset $Z(e) \subset \Sigma$ in such a way that if $e_{1} \neq e_{2} \in S, Z\left(e_{1}\right) \cap Z\left(e_{2}\right)=\emptyset$.

Remark 6.30. Any set $S$ that carries an energy partition satisfies $|S| \leq$ $\frac{E}{\delta_{1}}$. Let $F$ be a finite forest, and denote by $Y_{F}$ the set of vertices of $F$ with at most one child. It is easy to see that $|F| \leq 2\left|Y_{F}\right|$. So, if $Y_{F}$ admits an energy partition, then

$$
|F| \leq 2 \frac{\mu\{\Sigma\}}{\delta_{1}}
$$

Lemma 6.31. $\left|\mathcal{T}_{E}\right| \leq 2 \frac{\mu\{\Sigma\}}{\delta_{1}}$.
Proof. Let $c \in \mathcal{T}_{E}$ and let $t_{c} \in p_{2}(c)$. By definition of $E$ and Remark 6.6, we have $c_{t_{c}} \cap D_{t_{c}} \neq \emptyset$. Let $x_{c} \in c_{t_{c}} \cap D_{t_{c}}$ and let $B_{c}=B\left(x_{c}, t_{c}\right)$. By Lemma 4.7, $\mu\left\{B_{c}\right\} \geq \delta_{1}$. Let $c_{1} \neq c_{2} \in \mathcal{T}_{E}$ be maximal elements. By Corollary 6.9

$$
d\left(x_{c_{1}}, x_{c_{2}}\right)>2\left(e^{-t_{c_{1}}}+e^{-t_{c_{2}}}\right) .
$$

Thus, by Lemma 4.8, $B_{c_{1}} \cap B_{c_{2}}=\emptyset$. The claim follows from Remark 6.30 and Lemma 5.35 .

Lemma 6.32. $\left|\pi_{0}(C)\right| \leq 10 \frac{\mu\{\Sigma\}}{\delta_{1}}$.
Proof. Let $P \subset \pi_{0}(C)$ be finite. Let $Q$ be the set of vertices of $F_{P}$ with at most one child. We partition $Q$ into two sets, $Q_{1}$ and $Q_{2}$, such that $Q_{1}$ carries an energy partition, and $Q_{2}$ is mapped two to one into $\mathcal{T}_{E}$. Let $Q^{\prime} \subset Q$ be the set of vertices with exactly one child. Let $q \in Q^{\prime}$, let $q^{\prime}$ be the unique child of $q$, and let $\left(x, t^{\prime}\right) \in q^{\prime}$. Since $q \leq q^{\prime}$, there exists $t \in p_{2}(q)$ such that $(x, t) \in q$. By Lemma 5.9, we have $t<t^{\prime}$. Let

$$
L_{q}=\underset{45}{\{x\}} \times\left[t, t^{\prime}\right] .
$$

Since $q$ and $q^{\prime}$ are different components of $C$, and $L_{q}$ is a path connecting them, it follows that $L_{q}$ intersects at least one non-exceptional thin neck. So, for each $q \in Q^{\prime}$, choose a non-exceptional thin neck $g_{q}$ such that $g_{q} \cap L_{q} \neq \emptyset$. Denote by $Q_{2}$ the subset of elements $q \in Q^{\prime}$ for which $g_{q} \in H$. By Lemmas 6.21 and 6.31, $\left|Q_{2}\right| \leq 4 \frac{\mu\{\Sigma\}}{\delta_{1}}$.

Denote $Q_{1}=Q \backslash Q_{2}$. We define an energy partition for $Q_{1}$ as follows. To each $q \in Q_{1}$ we associate a $t_{q} \in p_{2}(q)$ and a connected segment $s_{q} \subset q_{t_{q}}$ in such a way that the following conditions hold:
(a)

$$
\ell_{n}\left(s_{q}\right) \geq 8 e^{-t_{q}} .
$$

(b)

$$
p_{1}\left(s_{q}\right) \times\left[t_{q}, \infty\right) \cap\left(\cup_{\left\{q^{\prime \prime} \in Q_{1} \mid q \leq q^{\prime \prime}\right\}} q^{\prime \prime}\right)=\emptyset .
$$

Indeed, suppose $q \in Q_{1}$ has no children. By Lemma 6.27 there is a $t_{q} \in p_{2}(q)$ such that $q_{t_{q}}$ contains a component of $K_{t_{q}}$. Let $s_{q}$ be a connected component of $K_{t_{q}} \cap q_{t_{q}}$. Such $s_{q}$ satisfies condition (a) by definition of $K$ and condition (b) because $q$ has no descendants.

Otherwise $q \in Q^{\prime}$. Let $q^{\prime}, x, t, t^{\prime}$ and $g_{q}$ be as above. By Lemma 6.27 we may choose $t_{q} \in p_{2}(q)$ and a connected component $k_{q} \subset q_{t_{q}} \cap K$ such that $e(x, t) \leq k_{q}$. In particular, $\left(x, t_{q}\right) \in k_{q}$. By choice of $g_{q}$, there exists $t_{g_{q}} \in p_{2}\left(q_{q}\right)$ such that $\left(x, t_{g_{q}}\right) \in L_{q}$. Since $q, q^{\prime} \subset C$, we have

$$
\begin{equation*}
q \cap g_{q}=\emptyset=q^{\prime} \cap g_{q} . \tag{37}
\end{equation*}
$$

In particular, $t^{\prime}>t_{g_{q}}>t$. It follows from Lemma 5.9 that

$$
\begin{equation*}
q \leq g_{q} \leq q^{\prime} \tag{38}
\end{equation*}
$$

By Lemma 6.13)(b), we have

$$
\begin{equation*}
\left(g_{q}\right)_{T_{f}\left(g_{q}\right)} \leq q^{\prime} . \tag{39}
\end{equation*}
$$

We show that

$$
\begin{equation*}
t_{g_{q}}>t_{q} . \tag{40}
\end{equation*}
$$

Indeed, if $t_{g_{q}}<t_{q}$, then Lemma 5.9 would imply that $g_{q} \leq q$, which in light of equation (37) and relation (38), contradicts Corollary 5.11. Also, $t_{g_{q}} \neq t_{q}$ by equation (37). Inequality (40) follows. Lemma 5.9 and inequality (40) imply that $k_{q} \leq g_{q}$. So,

$$
\begin{equation*}
t_{q} \leq T_{i}\left(g_{q}\right) \tag{41}
\end{equation*}
$$

Since $q \in Q_{1}$, we have $g_{q} \in G \backslash H$, that is $T\left(g_{q}\right) \geq \ln 3$. So, by inequality (41), we have

$$
\begin{equation*}
T_{f}\left(g_{q}\right) \geq T_{i}\left(g_{q}\right)+\ln 3 \geq t_{q}+\ln 3 \tag{42}
\end{equation*}
$$

By definition of $K$ and $N$ respectively, we have

$$
\ell_{n}\left(p_{1}\left(k_{q}\right)\right)>24 e^{-t_{q}}, \quad \ell_{n}\left(p_{1}\left(\left(g_{q}\right)_{T_{f}\left(g_{q}\right)}\right)\right) \leq 24 e^{-T_{f}\left(g_{q}\right)}
$$

So, by relation (39) and inequality (42), we conclude that

$$
\ell_{n}\left(p_{1}\left(q^{\prime}\right)\right) \leq \ell_{n}\left(p_{1}\left(\left(g_{q}\right)_{T_{f}\left(g_{q}\right)}\right)\right) \leq 24 e^{-\left(\ln 3+t_{q}\right)}<\frac{1}{3} \ell_{n}\left(p_{1}\left(k_{q}\right)\right) .
$$

Therefore, there exists an $s_{q} \subset k_{q} \subset q_{t_{q}}$ such that $\ell_{n}\left(s_{q}\right) \geq 8 e^{-t_{q}}$ and such that $p_{1}\left(q^{\prime}\right) \cap p_{1}\left(s_{q}\right)=\emptyset$. By construction $s_{q}$ satisfies condition (a). We show it satisfies condition (b) as follows. Since $q^{\prime}$ is the unique child of $q$, any $q^{\prime \prime} \in Q_{1} \backslash\{q\}$ such that $q \leq q^{\prime \prime}$ must satisfy $q^{\prime} \leq$ $q^{\prime \prime}$. In particular, $p_{1}\left(q^{\prime \prime}\right) \subset p_{1}\left(q^{\prime}\right)$. Thus $p_{1}\left(q^{\prime \prime}\right) \cap p_{1}\left(s_{q}\right)=\emptyset$ implying condition (b).

We claim that if $q \neq q^{\prime} \in Q_{1}$, then

$$
\begin{equation*}
p_{1}\left(s_{q}\right) \cap p_{1}\left(s_{q^{\prime}}\right)=\emptyset . \tag{43}
\end{equation*}
$$

Indeed, if $q \neq q^{\prime} \in Q_{1}$ are comparable, condition (b) implies equation (43). So, suppose they are incomparable. We may assume without loss of generality that $q \leq_{2} q^{\prime}$. Thus since $s_{q} \subset q$, equation (43) follows from Lemma 5.12, By condition (a), equation (43) and Remark 6.1, we can associate with each $q$ a dense disk $B_{q}$ such that if $q \neq q^{\prime}$, then $B_{q} \cap B_{q^{\prime}}=\emptyset$. The assignment $q \mapsto B_{q}$ is an energy partition.

Therefore, we have

$$
|P| \leq 2\left(\left|Q_{1}\right|+\left|Q_{2}\right|\right) \leq 10 \frac{\mu(\Sigma)}{\delta_{1}}
$$

Since $P$ was an arbitrary finite subset, it follows that $\pi_{0}(C)$ itself is finite and thus satisfies the same inequality.

For $c \in \mathcal{T}_{E}$, let $\mathcal{P}_{c}$ denote the partition of $c$ into the connected components of $c \cap C$ together with the connected components of $c \cap A$. That is, $\mathcal{P}_{c}$ is the partition of $c$ into non-exceptional thin necks and the connected components of their complement.

Lemma 6.33. Let $c \in \mathcal{T}_{E}$.
(a) The set $\mathcal{P}_{c}$ is well-ordered under the relation $\leq$ and finite.
(b) If $L \in \mathcal{P}_{c}$ is a non-exceptional thin neck that has a successor, its successor is a component of $c \cap C$.

Proof. (a) By Corollary 6.22, the set of non-exceptional thin necks in $\mathcal{P}_{c}$ is finite. We denote them by $L_{1}, \ldots, L_{n}$. Let $a_{i}=p_{2}\left(L_{i}\right)$ for $i=1, \ldots, n$. Since $L_{i}$ is connected, $a_{i}$ is an interval. Since $c$
is connected, $p_{2}(c)$ is an interval. So, $p_{2}(c) \backslash\left(L_{1} \cup \cdots \cup L_{n}\right)$ is a finite collection of intervals $b_{1}, \ldots, b_{k}$, with $k \leq n+1$. Let

$$
M_{j}=p_{2}^{-1}\left(b_{j}\right) \cap c
$$

for $j=1, \ldots, k$. By definition, $M_{j}$ is $E$-saturated. By Corollary 5.31, $M_{j}$ is connected. By Corollary 5.30,

$$
c=\bigcup_{i=1}^{n} L_{i} \cup \bigcup_{j=1}^{k} M_{j} .
$$

By the construction of the $M_{j}$, the union is disjoint. Therefore,

$$
\mathcal{P}_{c}=\left\{L_{1}, \ldots, L_{n}, M_{1}, \ldots, M_{k}\right\} .
$$

In particular, $P_{c}$ is finite. By Lemma 5.32, it is well-ordered.
(b) We continue using the notation of part (a). Without loss of generality, we may assume $L_{i} \leq L_{i+1}$ for $i=1, \ldots, n-1$. Let $i$ be such that $L=L_{i}$. If the successor of $L_{i}$ were not a component of $c \cap C$, it would have to be $L_{i+1}$. Assume so by way of contradiction. But the union $a_{i} \cup a_{i+1}$ cannot be connected by Lemma 6.14)(a). So, there is a $j$ such that $a_{i} \leq$ $b_{j} \leq a_{i+1}$, where $\leq$ denotes the usual order on $\mathbb{R}$. It follows that $L_{i} \leq_{2} M_{j} \leq_{2} L_{i+1}$. By Lemma 5.32, we conclude that $L_{i} \leq M_{j} \leq L_{i+1}$, contradicting the assumption that $L_{i+1}$ is the successor of $L_{i}$.

Lemma 6.34. $|G| \leq 12 \frac{\mu\{\Sigma\}}{\delta_{1}}$.
Proof. It suffices to define an injective map $i: G \rightarrow \pi_{0}(C) \coprod \mathcal{T}_{E}$. Let $L \in G$. If $L$ is maximal in the set of thin necks which are components of $c_{L}$, map $L$ to $c_{L}$. Otherwise, $L$ is not a maximal element of $\mathcal{P}_{c_{L}}$. By Lemma 6.33)(a), $\mathcal{P}_{c_{L}}$ is well-ordered. So, we let $j_{L} \in P_{c_{L}}$ be the successor of $L$. By Lemma 6.33)(b), we have $j_{L} \subset c_{L} \cap C$. Since $L$ is not a maximal thin-neck in $c_{L}$, Lemma 6.23 implies that $j_{L}$ is a connected component of $C$. So, we map $L$ to $j_{L}$.

We prove that $i$ is injective. Indeed, suppose $i(L)=c_{L} \in \mathcal{T}_{E}$. By Lemma 5.32 maximal thin necks in $c_{L}$ are unique. So, there can be no other thin neck mapped to $c_{L}$. On the other hand, suppose $i(L)=$ $j_{L} \in \pi_{0}(C)$. By construction $j_{L}$ is a subset of a unique $c \in \mathcal{T}_{E}$. It has a unique predecessor in $\mathcal{P}_{c}$, which is $L$. So, no other thin neck can be mapped to $j_{L}$.
Remark 6.35. It is straightforward to verify that all constructions of this section, namely $E, N, K, C, A$ and $G$, are conjugation invariant.

## 7. TAME GEODESICS

Definition 7.1. Let $k>0$ and let $I$ be a cylinder. A compact embedded geodesic $\gamma \subset I$ is said to be $k$-tame if for any sub-cylinder $I^{\prime} \subset I$, we have

$$
\ell_{h_{s t}}\left(\gamma \cap I^{\prime}\right) \leq 2 \pi k \max \left(M o d I^{\prime}, 1\right)
$$

Lemma 7.2. There are constants $a_{1}, a_{2}$ such that the following holds. Let $k_{1}, k_{2}>0$ and let $(\Sigma, j, \mu) \in \mathcal{M}$. Let $I \subset \Sigma_{\mathbb{C}}$ be clean and doubly connected. Let $\gamma:[0,1] \rightarrow I$ be $k_{1}$-tame. Let $\mu$ be a thick thin measure on I and let

$$
f(x):=\min \left(\frac{d \ell_{\mu}}{d \ell_{h_{s t}}}, k_{2}\right) .
$$

Then

$$
\int_{0}^{1} f(\gamma(t))\|\dot{\gamma}(t)\|_{s t} d t \leq k_{1}\left(k_{2}+1\right)\left(a_{1} \mu(I)+a_{2}\right)
$$

Proof. First assume that either $I \cap \bar{I}=\emptyset$ or the conjugation on $I$ is longitudinal as in Definition [2.5, Let $e:[0, \operatorname{Mod} I] \rightarrow \mathbb{R}$ be given by

$$
e(t)=\mu(S(0, t ; I)) .
$$

Let $M=\left\lfloor\frac{2 \mu(I)}{\delta_{2}}\right\rfloor$, let $0=\alpha_{0}<\alpha_{1}<\ldots<\alpha_{M}$ be the sequence defined by $e\left(\alpha_{i}\right)=i \frac{\delta_{2}}{2}$ and let $\alpha_{M+1}=L$. By our current assumption, $S\left(\alpha_{i}, \alpha_{i+1}\right)$ is clean. Therefore, by Lemma 3.5 there is a constant $K \geq 1$ such that for any $1 \leq j \in \mathbb{N}$, any $0 \leq i \leq M$ such that $\alpha_{i+1}-\alpha_{i}>2 j K$ and any $x \in S\left(\alpha_{i}+j K, \alpha_{i+1}-j K ; I\right)$, we have

$$
f(x) \leq 2^{-j}
$$

Therefore, we calculate

$$
\begin{align*}
\int_{0}^{1} f(\gamma(t))\|\dot{\gamma}(t)\|_{s t} d t & =\sum_{i=0}^{M} \int_{\gamma^{-1}\left(\left(\alpha_{i}, \alpha_{i+1}\right) \times S^{1}\right)} f(\gamma(t))\|\dot{\gamma}(t)\|_{s t} d t  \tag{44}\\
& \leq \sum_{i=0}^{M}\left(4 \pi k_{2} k_{1} K+\sum_{j=1}^{\left\lfloor\frac{\alpha_{i+1}-\alpha_{i}}{L}\right\rfloor} 4 \pi k_{1} K \times 2^{-i}\right) \\
& \leq \sum_{i=0}^{M} 4 \pi k_{1}\left(k_{2}+1\right) K
\end{align*}
$$

By Lemma 2.6 it remains only to treat the case where the conjugation on $I$ is latitudinal. Denote $I_{1}=S\left(0, \frac{1}{2} \operatorname{Mod} I ; I\right)$ and $I_{2}=$ $S\left(\frac{1}{2} \operatorname{Mod} I, \operatorname{Mod} I ; I\right)$. Then $I_{i} \cap \overline{I_{i}}=\emptyset$ for $i=1,2$. So, by what has
already been proved, the claim of the lemma holds for $I_{1}$ and $I_{2}$ separately. But up to addition of a constant the claim is additive. Thus the claim holds for $I=I_{1} \cup I_{2}$.

For the following few lemmas let $\Sigma_{\mathbb{C}}$ be a surface with $\operatorname{genus}\left(\Sigma_{\mathbb{C}}\right)>1$ equipped with the metric $h_{\text {can }}$ of constant curvature -1 , and let $\beta \subset \Sigma_{\mathbb{C}}$ be a simple closed geodesic. Recall the notation of Theorem [2.7. Let $I=\mathcal{C}(\beta)$. Denote by $(\rho, \theta)$ the coordinates on $I$ given by Theorem 2.7) (d). Note that $\rho$ gives the distance from $\beta$. The coordinates $(\rho, \theta)$ are axially symmetric in the sense of equation (10) with

$$
\begin{equation*}
h_{\theta}(\rho)=\frac{\ell(\beta) \cosh \rho}{2 \pi} . \tag{45}
\end{equation*}
$$

Lemma 7.3. There is a constant c with the following significance. For any $x \in I$,

$$
\frac{1}{\pi} \leq \frac{h_{\theta}(x)}{\operatorname{Inj} \operatorname{Rad}\left(\Sigma_{\mathbb{C}} ; h_{c a n}, x\right)} \leq c
$$

Proof. First we prove the lower bound. Indeed, the non-contractible loop $\rho=\rho(x)$ has $h_{\text {can }}$-length $2 \pi h_{\theta}(x)$. So, there is a non-constant geodesic beginning and ending at $x$ with length less than $2 \pi h_{\theta}(x)$. Therefore, $\operatorname{Injrad}\left(\Sigma_{\mathbb{C}} ; h_{\text {can }}, x\right) \leq \pi h_{\theta}(x)$ as desired.

We turn now to the proof of the upper bound. Denote $b=\frac{1}{2} \ell(\beta)$. Let $d_{0}(b)=w(\beta)$ and for any $x \in I$, let $d(x)=w(\beta)-\rho(x)$. By Theorems 2.7 and 2.8, we need only bound the expression

$$
E(d, b)=\frac{b \cosh \rho}{\pi \sinh ^{-1}(\cosh b \cosh d-\sinh d)}
$$

in the region $0 \leq \rho \leq d_{0}(b)$. We have

$$
\begin{align*}
& E(d, b) \leq \frac{b \cosh \rho}{\pi \sinh ^{-1}\left(e^{-d}\right)} \\
& \leq \frac{b e^{\rho}}{2 \pi \sinh ^{-1}\left(e^{-d}\right)}  \tag{46}\\
&=\frac{b e^{\rho}}{2 \pi\left(e^{-d}+o\left(e^{-d}\right)\right)} \\
&=\frac{b e^{\rho+d}}{2 \pi(1+o(1))} \\
&=\frac{b e^{d_{0}(b)}}{2 \pi(1+o(1))} .  \tag{47}\\
& 50
\end{align*}
$$

Pick a $d^{\prime}$ large enough that

$$
\left|\sinh ^{-1}\left(e^{-d^{\prime}}\right)-e^{-d^{\prime}}\right| \leq \frac{1}{2}
$$

A bound

$$
\begin{equation*}
\frac{b e^{d_{0}(b)}}{2 \pi} \leq c^{\prime} \tag{48}
\end{equation*}
$$

combined with bound (47) suffices to give the desired bound on $E(d, b)$ in the region $d>d^{\prime}$. On the other hand, for $d \leq d^{\prime}$ the desired bound on $E(d, b)$ follows from inequalities (46) and (48) since $\rho \leq d_{0}(b)$. To prove inequality (48), we use Theorem 2.7(c) to calculate

$$
\frac{b e^{d_{0}(b)}}{2 \pi}=\frac{b}{2 \pi}\left(\frac{1}{\sinh b}+\sqrt{\frac{1}{\sinh ^{2} b}+1}\right),
$$

which is clearly bounded for $b \in[0, \infty)$.
Lemma 7.4. Let $\epsilon \leq \pi$.
(a) $B_{\epsilon / 2}\left(x ; h_{s t}\right) \subset B_{\epsilon h_{\theta}(x)}\left(x ; h_{\text {can }}\right)$.
(b) Let $\gamma \subset I$ be a embedded 1-manifold possibly with boundary. If $x_{1}, x_{2} \in \gamma$ satisfy $d_{\gamma}\left(x_{1}, x_{2} ; h_{s t}\right) \geq \epsilon / 2$, then

$$
d_{\gamma}\left(x_{1}, x_{2} ; h_{\text {can }}\right) \geq \epsilon h_{\theta}\left(x_{1}\right)
$$

Proof. (a) Let $\tau$ be the function on $I$ defined by

$$
\tau(y)=\tau(\rho(y))=\int_{\rho(x)}^{\rho(y)} \frac{d \rho}{h_{\theta}(\rho)}
$$

So, $\tau \times \theta$ is a conformal diffeomorphism of $I$ to the flat cylinder. In particular,

$$
h_{s t}=d \theta^{2}+d \tau^{2}
$$

Suppose $y \in B_{\epsilon / 2}\left(x ; h_{s t}\right)$. First, we show that

$$
|\rho(y)-\rho(x)| \leq \epsilon h_{\theta}(x) .
$$

Indeed, assume the contrary. By the formula (45) for $h_{\theta}$, and the fact from Theorem 2.7(c) that

$$
|\rho| \leq w(\beta)=\sinh ^{-1}(1 / \sinh (\ell(\beta) / 2))
$$

we have

$$
\begin{equation*}
\left|\frac{d h_{\theta}}{d \rho}(\rho)\right|=\left|\frac{\ell(\beta) \sinh \rho}{2 \pi}\right| \leq \frac{1}{\pi} . \tag{50}
\end{equation*}
$$

So,

$$
\begin{aligned}
|\tau(y)| & =\left|\int_{\rho(x)}^{\rho(y)} \frac{d \rho}{h_{\theta}(\rho)}\right| \\
& \geq\left|\int_{\rho(x)}^{\rho(y)} \frac{d \rho}{h_{\theta}(x)+\frac{1}{\pi}|\rho-\rho(x)|}\right| \\
& >\int_{|\rho(x)|}^{|\rho(x)|+\epsilon h_{\theta}(x)} \frac{d \rho}{h_{\theta}(x)+\frac{\epsilon h_{\theta}(x)}{\pi}} \\
& \geq \frac{\epsilon}{2},
\end{aligned}
$$

which is a contradiction. Inequality (49) follows. Combining inequalities (49) and (50), we obtain

$$
h_{\theta}(y) \leq 2 h_{\theta}(x), \quad \forall y \in B_{\epsilon / 2}\left(x ; h_{s t}\right) .
$$

So, since $h_{\text {can }}=h_{\theta}^{2} h_{s t}$, on $B_{\epsilon / 2}\left(x ; h_{s t}\right)$ we have the inequality of bilinear forms $h_{\text {can }} \leq\left(2 h_{\theta}(x)\right)^{2} h_{s t}$. Therefore, for $y \in$ $B_{\epsilon / 2}\left(x ; h_{s t}\right)$, and $\alpha$ an $h_{s t}$ geodesic from $x$ to $y$, we have

$$
\ell_{h_{c a n}}(\alpha) \leq 2 h_{\theta}(x) \ell_{h_{s t}}(\alpha) \leq h_{\theta}(x) \epsilon .
$$

That is, $y \in B_{\epsilon h_{\theta}(x)}\left(x ; h_{c a n}\right)$.
(b) By way of contradiction, suppose $d_{\gamma}\left(x_{1}, x_{2} ; h_{\text {can }}\right)<\epsilon h_{\theta}\left(x_{1}\right)$. Then the segment $a$ in $\gamma$ between $x_{1}$ and $x_{2}$ must be contained in $B_{\epsilon h_{\theta}\left(x_{1}\right)}\left(x_{1} ; h_{\text {can }}\right)$. Moreover, by inequality (50) we have

$$
h_{\theta}(y) \leq 2 h_{\theta}\left(x_{1}\right), \quad \forall y \in B_{\epsilon h_{\theta}\left(x_{1}\right)}\left(x_{1} ; h_{\text {can }}\right) .
$$

So $h_{s t} \leq\left(2 h_{\theta}\left(x_{1}\right)\right)^{-2} h_{\text {can }}$ on $B_{\epsilon h_{\theta}\left(x_{1}\right)}\left(x_{1} ; h_{c a n}\right)$. It follows that

$$
\ell_{h_{s t}}(a) \leq\left(2 h_{\theta}\left(x_{1}\right)\right)^{-1} \ell_{h_{c a n}}(a)<\frac{\epsilon}{2},
$$

which is a contradiction.

Lemma 7.5. There is a constant $C$ with the following significance. Let $k \geq 1$ and let $\gamma$ be a compact embedded geodesic in I such that

$$
\operatorname{SegWidth}\left(\gamma, x ; h_{c a n}\right) \geq \frac{1}{k} \operatorname{InjRad}\left(\Sigma_{\mathbb{C}} ; h_{c a n}, x\right)
$$

for all $x \in \gamma$. Then $\gamma$ is Ck-tame.
Proof. Let $I^{\prime} \subset I$ with $\operatorname{Mod}\left(I^{\prime}\right) \geq 1$. Choose a collection of points $x_{1}, \ldots, x_{n} \in \gamma \cap I^{\prime}$ maximal with respect to the condition that

$$
d_{\gamma}\left(x_{i}, x_{j} ; h_{s t}\right) \geq \frac{\pi}{2 k}, \quad i \neq j .
$$

In particular,

$$
\begin{equation*}
\ell_{h_{s t}}\left(\gamma \cap I^{\prime}\right)<\frac{n \pi}{k} . \tag{51}
\end{equation*}
$$

By Lemmas 7.4(b) and 7.3, we have

$$
\begin{aligned}
d_{\gamma}\left(x_{i}, x_{j} ; h_{c a n}\right) & \geq \frac{\pi}{k} \max \left(h_{\theta}\left(x_{i}\right), h_{\theta}\left(x_{j}\right)\right) \\
& \geq \frac{1}{k} \max \left(\operatorname{Inj} \operatorname{Rad}\left(x_{i}\right), \operatorname{Inj} \operatorname{Rad}\left(x_{j}\right)\right)
\end{aligned}
$$

So, by the assumption on SegWidth,

$$
B_{\frac{I n j \operatorname{Rad}\left(x_{i}\right)}{2 k}}\left(x_{i} ; h_{\text {can }}\right) \cap B_{\frac{I n j \operatorname{Rad}\left(x_{j}\right)}{2 k}}\left(x_{j} ; h_{\text {can }}\right)=\emptyset, \quad i \neq j .
$$

Thus by Lemma 7.3 we have

$$
B_{\frac{h_{\theta}\left(x_{i}\right)}{2 c k}}\left(x_{i} ; h_{c a n}\right) \cap B_{\frac{h_{\theta}\left(x_{j}\right)}{2 c k}}\left(x_{j} ; h_{c a n}\right)=\emptyset, \quad i \neq j .
$$

It follows by Lemma 7.4) (a) that

$$
\begin{equation*}
B_{\frac{1}{4 c k}}\left(x_{i} ; h_{s t}\right) \cap B_{\frac{1}{4 c k}}\left(x_{j} ; h_{s t}\right)=\emptyset, \quad i \neq j . \tag{52}
\end{equation*}
$$

Consider the case $\operatorname{Mod}\left(I^{\prime}\right) \geq 1$. Even if $x_{i} \in \partial I^{\prime}$, at least half of $B_{\frac{1}{4 c k}}\left(x_{i} ; h_{s t}\right)$ is contained in $I^{\prime}$. So,

$$
\operatorname{Area}\left(B_{\frac{1}{4 c k}}\left(x_{i} ; h_{s t}\right) \cap I^{\prime}\right) \geq \frac{\pi}{32 c^{2} k^{2}}, \quad \operatorname{Area}\left(I^{\prime}\right)=2 \pi \operatorname{Mod}\left(I^{\prime}\right)
$$

Therefore, by equation (52) we have

$$
\begin{equation*}
n \leq 64 c^{2} k^{2} \operatorname{Mod}\left(I^{\prime}\right) \tag{53}
\end{equation*}
$$

Combining inequalities (51) and (53), we deduce the lemma with

$$
C=32 c^{2}
$$

On the other hand, suppose $\operatorname{Mod}\left(I^{\prime}\right)<1$. Then

$$
\operatorname{Area}\left(B_{\frac{1}{4 c k}}\left(x_{i} ; h_{s t}\right) \cap I^{\prime}\right) \geq \frac{\pi}{32 c^{2} k^{2}} M o d I^{\prime}
$$

So, by equation (52) we have

$$
\begin{equation*}
n \leq 64 c^{2} k^{2} \tag{54}
\end{equation*}
$$

Combining inequalities (51) and (54), the lemma follows with the same value of $C$.

## 8. Proof of the theorem

The goal of this section is to prove Theorem 4.2, We use the notation and terminology of Theorem 4.2 as well as Sections 5, 6, and 7. To begin, observe that

$$
\begin{align*}
\ell_{\mu}(\gamma) & =\int_{x \in \gamma} e^{g(x)} d \ell_{n}(x)  \tag{55}\\
& =\int_{x \in \gamma} \min \left\{e^{g(x)}, 2 k\right\} d \ell_{n}(x)+\int_{x \in \gamma} \max \left\{e^{g(x)}-2 k, 0\right\}
\end{align*}
$$

We denote the first term by $I_{0}$ and the second by $I_{1}$ and deal with each term separately.

We first dispense with $I_{0}$.
Lemma 8.1. There are constants $d_{1}$ and $d_{2}$ such that

$$
I_{0} \leq k^{2}\left\{d_{1} \mu\left(\Sigma_{\mathbb{C}}\right)+d_{2} \operatorname{genus}\left(\Sigma_{\mathbb{C}}\right)\right\}
$$

Proof. Let

$$
\operatorname{Thick}\left(\Sigma_{\mathbb{C}}\right):=\left\{x \in \Sigma_{\mathbb{C}} \mid \operatorname{Inj} \operatorname{Rad}\left(x ; h_{c a n}\right) \geq \sinh ^{-1}(1)\right\}
$$

and

$$
\operatorname{Thin}\left(\Sigma_{\mathbb{C}}\right)=\Sigma_{\mathbb{C}} \backslash \operatorname{Thick}\left(\Sigma_{\mathbb{C}}\right)
$$

In the following write $\Gamma=\operatorname{genus}\left(\Sigma_{\mathbb{C}}\right)$. Note that when $\Gamma>1$, Theorem 2.8 implies $\operatorname{Thin}\left(\Sigma_{\mathbb{C}}\right)$ is contained in the union of at most $3 \Gamma-3$ clean geodesic cylinders. Cleanness follows from the conjugation invariance of $h_{\text {can }}$. When $\Gamma=1, \operatorname{Thin}\left(\Sigma_{\mathbb{C}}\right)$ is either empty or all of $\Sigma_{\mathbb{C}}$. $\operatorname{So}, \operatorname{Thin}\left(\Sigma_{\mathbb{C}}\right)$ is contained in the union of at most 2 clean geodesic cylinders. When $\Gamma=0, \operatorname{Thin}\left(\Sigma_{\mathbb{C}}\right)$ is always empty. So, we define

N_{\Gamma}= \begin{cases}3 \Gamma-3, & \Gamma \geq 2 \\ 2, & \Gamma=1 \\ 0, & \Gamma=0\end{cases}
$$

We calculate

\begin{align*}
I_{0} & =\int_{x \in \gamma} \min \left\{e^{g(x)}, 2 k\right\} d \ell_{n}(x)  \tag{56}\\
& \leq \int_{\text {Thick }\left(\Sigma_{\mathbb{C}}\right) \cap \gamma} \frac{2 k}{\sinh ^{-1}(1)} d \ell_{h_{\text {can }}}+\int_{\operatorname{Thin}\left(\Sigma_{\mathbb{C}}\right) \cap \gamma} \min \left\{e^{g(x)}, 2 k\right\} d \ell_{n}(x)
\end{align*}
$$

Let $\chi\left(\Sigma_{\mathbb{C}}\right)$ denote the Euler characteristic and let

$$
M_{\Gamma}=\max _{54}\left(\left|\chi\left(\Sigma_{\mathbb{C}}\right)\right|, 1\right)
$$

We claim that

$$
\begin{equation*}
\int_{T h i c k\left(\Sigma_{\mathrm{C}}\right) \cap \gamma} \frac{2 k}{\sinh ^{-1}(1)} d \ell_{h_{c a n}} \leq \frac{2 k^{2} M_{\Gamma}}{\pi\left(\sinh ^{-1}(1)\right)^{2}} \tag{57}
\end{equation*}
$$

Indeed, let $x_{1}, \ldots, x_{n} \in \gamma \cap \operatorname{Thick}\left(\Sigma_{\mathbb{C}}\right)$ be a collection of points maximal with respect to the condition that

d_{\gamma}\left(x_{i}, x_{j} ; h_{\text {can }}\right) \geq \frac{\sinh ^{-1}(1)}{k}, \quad i \neq j
$$

In particular,

\ell_{h_{\text {can }}}\left(\gamma \cap \operatorname{Thick}\left(\Sigma_{\mathbb{C}}\right)\right)<2 n \frac{\sinh ^{-1}(1)}{k} \tag{58}
\end{equation*}
$$

By assumption (21), we have

B_{\frac{\sinh ^{-1}(1)}{k}}^{k}\left(x_{i} ; h_{\text {can }}\right) \cap B_{\frac{\sinh ^{-1}(1)}{k}}^{k}\left(x_{j} ; h_{\text {can }}\right)=\emptyset, \quad i \neq j .
$$

Moreover,

\operatorname{Area}\left(B_{\frac{\sinh ^{-1}(1)}{k}}\left(x_{i} ; h_{c a n}\right)\right) \geq \pi\left(\frac{\sinh ^{-1}(1)}{k}\right)^{2}, \quad \operatorname{Area}\left(\Sigma_{\mathbb{C}}\right)=M_{\Gamma}
$$

So,

\begin{equation*}
n \leq \frac{k^{2} M_{\Gamma}}{\pi\left(\sinh ^{-1}(1)\right)^{2}} \tag{59}
\end{equation*}
$$

Combining inequalities (58) and (59) we obtain

\ell_{h_{c a n}}\left(\gamma \cap \operatorname{Thick}\left(\Sigma_{\mathbb{C}}\right)\right)<\frac{k M_{\Gamma}}{\pi \sinh ^{-1}(1)},
$$

which implies inequality (57) as claimed.
Furthermore, we calculate

\leq & \int_{\operatorname{Thin}\left(\Sigma_{\mathbb{C}}\right) \cap \gamma} \min \left\{e^{g(x)}, 2 k\right\} \frac{d \ell_{h_{\text {can }}}(x)}{\operatorname{InjRad}(x)} \\
= & \int_{\operatorname{Thin}\left(\Sigma_{\mathbb{C}}\right) \cap \gamma} \min \left\{e^{g(x)}, 2 k\right\} \frac{h_{\theta}(x)}{\operatorname{InjRad}(x)} d \ell_{h_{s t}}(x) \\
\leq & C k(2 k+1)\left(a_{2} N_{\Gamma} a_{1} \mu\left(\Sigma_{\mathbb{C}}\right)\right)
\end{align*}
$$

using Lemmas 7.2, 7.5 and 7.3 in the last inequality. Combining inequalities (56), (57), and (60), we obtain

$$
\begin{equation*}
I_{0} \leq \frac{2 k^{2} M_{\Gamma}}{\pi\left(\sinh ^{-1}(1)\right)^{2}}+C k(2 k+1)\left(a_{2} N_{\Gamma}+a_{1} \mu\left(\Sigma_{\mathbb{C}}\right)\right) . \tag{61}
\end{equation*}
$$

Note that when $\Gamma=0$, the first term in the right hand side of (61) can be absorbed in the coefficient $d_{1}$. This is so because the gradient inequality implies that for any $(\Sigma, \mu) \in \mathcal{M}$ with $\operatorname{genus}\left(\Sigma_{\mathbb{C}}\right)=0$, we have $\mu(\Sigma) \geq \delta_{1}$.

Assumption 8.2. From here until Lemma 8.10, we assume that conditions (31) and (32) are satisfied. Thus we may use the constructions and results of Section 6 .

The following arguments deal with $I_{1}$ given the preceding assumption.

I_{1} & =\int_{x \in \gamma} \max \left\{e^{g(x)}-2 k, 0\right\} d \ell_{n}(x) \\
& =\int_{x \in \gamma} \int_{2 k}^{\max \left\{e^{g(x)}, 2 k\right\}} d y d \ell_{n}(x) .
\end{aligned}
$$

Change variables to $y=e^{t}$. Then, using Fubini's theorem,

& =\int_{\ln 2 k}^{\infty} \int_{x \in D_{t} \cap C} d \ell_{n}(x) e^{t} d t+\int_{\ln 2 k}^{\infty} \int_{x \in D_{t} \cap A} d \ell_{n}(x) e^{t} d t \\
& \leq \int_{\ln 2 k}^{\infty} \int_{x \in C_{t}} d \ell_{n}(x) e^{t} d t+\int_{\ln 2 k}^{\infty} \int_{x \in D_{t} \cap A} d \ell_{n}(x) e^{t} d t .
\end{align*}
$$

In the last line, denote the first term, giving the contribution of the thick part, by $I_{2}$, and the second, giving the contribution of the thin part, by $I_{3}$.

Lemma 8.3. There is a constant $d_{3}$ such that $I_{2} \leq d_{3} \mu\left(\Sigma_{\mathbb{C}}\right)$.
Proof. Discretizing, we have the bound

Write $c_{i}:=C_{2 i \ln 3+\ln 2 k}$ and denote by $c_{i j}$ the components of $c_{i}$. By Lemma 6.27, for each $j$ choose

and a component $k_{i j} \subset K_{t_{i j}}$ such that $c_{i j} \leq k_{i j}$. In the case that $c_{i j} \subset K$, we insist upon taking $t_{i j}=2 i \ln 3+\ln 2 k$ and $k_{i j}=c_{i j}$. For each $j$ let $T_{i j} \subset k_{i j}$ be a segment of length

Since $k_{i j} \subset K_{t_{i j}}$, we have

\end{equation*}

\ell_{n}\left(T_{i j}\right) \geq \frac{3}{4} \ell_{n}\left(k_{i j}\right) \tag{66}
\end{equation*}
$$

Partition $T_{i j}$ into segments $T_{i j k}$ such that

\ell_{n}\left(T_{i j k}\right)=8 e^{-t_{i j}} \tag{67}
\end{equation*}
$$

Let $n_{i j}$ be the number of segments $T_{i j k}$. We claim that

\begin{equation*}
\frac{8 n_{i j}}{3^{2 i} 2 k} \geq \frac{3}{4} \ell_{n}\left(c_{i j}\right) \tag{68}
\end{equation*}
$$

Indeed, suppose first that $c_{i j}=k_{i j}$. Then $t_{i j}=3^{2 i} 2 k$. So, using inequality (66), we have

\frac{8 n_{i j}}{3^{2 i} 2 k}=8 e^{-t_{i j}} n_{i j}=\ell_{n}\left(T_{i j}\right) \geq \frac{3}{4} \ell_{n}\left(k_{i j}\right)=\frac{3}{4} \ell_{n}\left(c_{i j}\right) .
$$

On the other hand, suppose $c_{i j} \neq k_{i j}$. Then $c_{i j} \subset N$, so $\ell\left(c_{i j}\right) \leq \frac{24}{3^{2 i} 2 k}$. But

Since $n_{i j}$ is an integer, we have $n_{i j} \geq 3$. Thus

Inequality (68) follows. Setting

inequality (68) implies

\begin{equation*}
\frac{8 n_{i}}{3^{2 i} 2 k} \geq \frac{3}{4} \ell_{n}\left(C_{2 i \ln 3+\ln 2 k}\right) \tag{70}
\end{equation*}
$$

To each segment $T_{i j k}$, assign a disk $B_{i j k} \subset \Sigma_{\mathbb{C}}$ as in Remark 6.1. So, if $k_{1} \neq k_{2}$, then $B_{i j k_{1}} \cap B_{i j k_{2}}=\emptyset$. Let $m_{i}$ denote the number of disks $B_{i^{\prime} j^{\prime} k^{\prime}}$ with $i^{\prime}<i$ that intersect one of the disks $B_{i j k}$ but do not intersect any disk $B_{i^{\prime \prime} j^{\prime \prime} k^{\prime \prime}}$ for $i^{\prime}<i^{\prime \prime}<i$. We claim that

$$
\begin{equation*}
m_{i} \leq \frac{3}{4} n_{i} . \tag{71}
\end{equation*}
$$

Indeed, let $m_{i}^{\prime}$ denote the number of intervals $T_{i^{\prime} j^{\prime} k^{\prime}}$ with $i^{\prime}<i$ such that $p_{1}\left(T_{i^{\prime} j^{\prime} k^{\prime}}\right) \cap p_{1}\left(T_{i j k}\right) \neq \emptyset$ for some $j, k$, and $p_{1}\left(T_{i^{\prime} j^{\prime} k^{\prime}}\right) \cap p_{1}\left(T_{i^{\prime \prime} j^{\prime \prime} k^{\prime \prime}}\right)=\emptyset$
for $i^{\prime}<i^{\prime \prime}<i$. By Remark 6.1 we have $m_{i} \leq m_{i}^{\prime}$. So inequality (71) will follow if we show

$$
\begin{equation*}
m_{i}^{\prime} \leq \frac{3}{4} n_{i} . \tag{72}
\end{equation*}
$$

Let $m_{i j}^{\prime}$ denote the number of intervals $T_{i^{\prime} j^{\prime} k^{\prime}}$ with $i^{\prime}<i$ such that $p_{1}\left(T_{i^{\prime} j^{\prime} k^{\prime}}\right) \cap p_{1}\left(T_{i j k}\right) \neq \emptyset$ for some $k$ and

$$
\begin{equation*}
p_{1}\left(T_{i^{\prime} j^{\prime} k^{\prime}}\right) \cap p_{1}\left(T_{i^{\prime \prime} j^{\prime \prime} k^{\prime \prime}}\right)=\emptyset \tag{73}
\end{equation*}
$$

for $i^{\prime}<i^{\prime \prime}<i$. Then

m_{i}^{\prime} \leq \sum_{j} m_{i j}^{\prime}
$$

So, by equation (69) inequalities (72) and (71) will follow if we prove

m_{i j}^{\prime} \leq \frac{3}{4} n_{i j} \tag{74}

for all $j$. To see this, choose integers $a_{1}$ and $0 \leq a_{2}<3$ such that $n_{i j}=3 a_{1}+a_{2}$. By equations (64), (65) and (67), we have $a_{1} \geq 1$. Enumerate the intervals $T_{i^{\prime} j^{\prime} k^{\prime}}$ by $T_{i l j k_{l}}$ for $l=1, \ldots, m_{i j}^{\prime}$. By (731) we conclude the intervals $p_{1}\left(T_{i_{l} j_{l} k_{l}}\right)$ are pairwise disjoint. Since $i_{l}<i$ for all $l$, by equation (67) we have $\ell_{n}\left(T_{i_{l} j_{l} k_{l}}\right) \geq 3 \ell_{n}\left(T_{i j k}\right)$. Therefore it is easy to verify that $m_{i j}^{\prime}$ is at most $a_{1}+2$ when $a_{2} \neq 0$, and at most $a_{1}+1$ when $a_{2}=0$. But in the first case,

and in the second case,

Inequalities (74), (72) and (71) follow.
Combining inequalities (71), (70) and (63), we obtain

& \geq \sum_{i=0}^{\infty} \frac{1}{4} n_{i} \\
& \geq \frac{2 k}{4 \cdot 8 \cdot 4} \sum_{i=0}^{\infty} 3^{2 i+1} \ell_{n}\left(C_{2 i \ln 3+\ln 2 k}\right) \\
& \geq \frac{1}{256 \ln 3} I_{2} .
\end{align*}
$$

We now deal with the thin part.
Lemma 8.4. There is a constant $d_{4}$ such that $I_{3} \leq d_{4} \mu\left(\Sigma_{\mathbb{C}}\right)$.
Proof. Recall that $G$ denotes the collection of all non-exceptional thin necks. Let $G_{1}=\{v \in G \mid T(v) \leq \ln 48\}$. The contribution of the thin part is

& \leq \sum_{v \in G_{1}} \int_{T_{i}(v)}^{T_{f}(v)} 24 d t+\sum_{v \in G \backslash G_{1}} \int_{T_{i}(v)}^{T_{f}(v)} \int_{x \in v_{t} \cap D} d \ell_{n}(x) e^{t} d t \\
& \leq 24 \ln 48 \frac{12 \mu\left(\Sigma_{\mathbb{C}}\right)}{\delta_{1}}+\sum_{v \in G \backslash G_{1}} \int_{T_{i}(v)}^{T_{f}(v)} \int_{x \in v_{t} \cap D} d \ell_{n}(x) e^{t} d t .
\end{aligned}
$$

The last transition relies on Lemma 6.34,
To each $v \in G \backslash G_{1}$ we associate an annulus as follows. Let $x_{v}$ denote the midpoint of $v_{T_{f}(v)}$ with respect to the metric $h_{c a n}$ and let

r_{v}=\frac{1}{2} \ell_{h_{c a n}\left(v_{T_{f}(v)}\right)} .
$$

Let

$$
\begin{gathered}
r_{v}^{1}=r_{v}+2 r\left(x_{v}\right) e^{-T_{f}(v)} \\
r_{v}^{2}=r\left(x_{v}\right) e^{-T_{i}(v)} \\
B_{v}^{1}:=B_{r_{v}^{1}}\left(x_{v} ; h_{c a n}\right) \subset \Sigma_{\mathbb{C}}, \quad B_{v}^{2}=B_{r_{v}^{2}}\left(x_{v} ; h_{c a n}\right) \subset \Sigma_{\mathbb{C}},
\end{gathered}
$$

and $A_{v}:=B_{v}^{2} \backslash B_{v}^{1}$.
The following claims justify the definitions of the preceding paragraph.
Claim 8.5. $r_{v}^{1}<r_{v}^{2} \leq \frac{1}{2 k} r\left(x_{v}\right)<\frac{1}{2} \operatorname{SegWidth}\left(\gamma, x_{v} ; h_{\text {can }}\right)$.
Proof. The inequality $r_{v}^{2} \leq \frac{1}{2 k} r\left(x_{v}\right)$ follows from the fact that $T_{i}(v) \geq$ $\ln 2 k$. The inequality $\frac{1}{2 k} r\left(x_{v}\right)<\frac{1}{2} \operatorname{Seg} \operatorname{Width}\left(\gamma, x_{v} ; h_{\text {can }}\right)$ is a special case of assumption (21). By inequality (23) and the definition of $N$,

$$
r_{v} \leq \frac{3}{4} \ell_{n}\left(v_{T_{f}(v)}\right) r\left(x_{v}\right) \leq \frac{3}{4} \cdot 24 e^{-T_{f}(v)} r\left(x_{v}\right)
$$

Therefore, $r_{v}^{1} \leq 20 r\left(x_{v}\right) e^{-T_{f}(v)}$. Since

$$
T_{f}(v)-T_{i}(v)=T(v)>\ln 20
$$

the inequality $r_{v}^{1}<r_{v}^{2}$ follows.
Claim 8.6. Let $t \geq T_{i}(v)+\ln 48$. Then $p_{1}\left(v_{t}\right) \subset B_{v}^{2}$.
Proof. This is immediate from inequality (23) and the definition of $N$.

Claim 8.7. For any $v_{1}, v_{2} \in G \backslash G_{1}$, we have

v_{1} \neq v_{2} \Rightarrow A_{v_{1}} \cap A_{v_{2}}=\emptyset
$$

Proof. Consider first the case that $p_{1}\left(v_{1}\right) \cap p_{1}\left(v_{2}\right) \neq \emptyset$. By Lemmas 5.12 and 6.13), we may assume without loss of generality that

\left(v_{1}\right)_{T_{f}\left(v_{1}\right)} \leq v_{2} .
$$

So, we have

Thus by Claim 8.5 we obtain

$$

So, it follows from Lemma 4.5 that

Thus we have

The preceding inequality and inequality (76) together imply

It follows that $B_{v_{2}}^{2} \subset B_{v_{1}}^{1}$ giving the claim.
On the other hand, if $p_{1}\left(v_{1}\right) \cap p_{2}\left(v_{2}\right)=\emptyset$, Corollary 6.9 implies

d\left(x_{v_{1}}, x_{v_{2}} ; h_{n}\right) \geq 4 e^{-\min \left\{T_{i}\left(v_{1}\right), T_{i}\left(v_{2}\right)\right\}}
$$

But by inequality (23) and the definition of $B_{v_{j}}^{2}$ for $j=1,2$, we have the inequality

d\left(x_{v_{j}}, \partial B_{v_{j}}^{2} \cap \gamma ; h_{n}\right) \leq 2 e^{-T_{i}\left(v_{j}\right)}
$$

Therefore, $B_{v_{1}}^{2} \cap B_{v_{2}}^{2} \cap \gamma=\emptyset$. By definition of SegWidth and by Claim 8.5, we conclude $B_{v_{1}}^{2} \cap B_{v_{2}}^{2}=\emptyset$.

Claim 8.8. $A_{v}$ is clean.
Proof. Keeping in mind Remark 6.35, by construction $A_{\bar{v}}=\overline{A_{v}}$. In particular if $v=\bar{v}$, then $A_{v}$ is conjugation invariant. If $v \neq \bar{v}$, then by Claim 8.7 we have $A_{v} \cap \overline{A_{v}}=\emptyset$.

## Claim 8.9.

$$
\begin{equation*}
\ell_{n}\left(B_{v}^{1} \cap \gamma\right) \leq 32 e^{-T_{f}(v)} \tag{77}
\end{equation*}
$$

Proof. We have

$$
\ell_{n}\left(B_{v}^{1} \cap \gamma\right)=\ell_{n}\left(v_{T_{f}(v)}\right)+\ell_{n}\left(B_{v}^{1} \cap \gamma \backslash p_{1}\left(v_{T_{f}(v)}\right)\right) .
$$

Denote the first term by $a$ and the second term by $b$. The definition of $N$ implies that $a \leq 24 e^{-T_{f}(v)}$. Since $T(v) \geq \ln 48$, we have $2 r\left(x_{v}\right) e^{-T_{f}\left(x_{v}\right)} \leq \frac{1}{2} r\left(x_{v}\right)$. So, we use inequality (23) to verify that $b \leq 8 e^{-T_{f}(v)}$.

We return to estimating $I_{3}$. By the inclusion of Claim 8.6, for $v \in$ $G \backslash G_{1}$ we obtain

& \int_{T_{i}(v)}^{T_{f}(v)} \int_{x \in p_{1}\left(v_{t} \cap D\right)} d \ell_{n}(x) e^{t} d t \leq \\
& \leq 24 \ln 48+\int_{T_{i}(v)+\ln 48}^{T_{f}(v)} \int_{x \in p_{1}\left(v_{t} \cap D\right)} d \ell_{n}(x) e^{t} d t \\
& \leq 24 \ln 48+\int_{0}^{T_{f}(v)} \int_{x \in B_{v}^{2} \cap p_{1}\left(v_{t} \cap D\right)} d \ell_{n}(x) e^{t} d t .
\end{aligned}
$$

By equation (77) we have

\begin{gathered}
\int_{0}^{T_{f}(v)} \int_{x \in B_{v}^{2} \cap p_{1}\left(v_{t} \cap D\right)} d \ell_{n}(x) e^{t} d t \leq \\
\quad \leq \int_{x \in A_{v} \cap \gamma} e^{g(x)} d \ell_{n}(x)+\int_{x \in B_{v}^{1}} e^{T_{f}(v)} d \ell_{n}(x) \\
\quad \leq \int_{x \in A_{v} \cap \gamma} e^{g(x)} d \ell_{n}(x)+32 .
\end{gathered}
$$

We bound the integral on the domain $A_{v} \cap \gamma$ as follows. By Lemma 6.13(d), we have

$$
\frac{d \ell_{\mu}}{d \ell_{n}}(x)=e^{g(x)} \leq \frac{24}{d\left(x, x_{v} ; h_{n}\right)},
$$

for any $x \in A_{v} \cap \gamma$. So, by inequality (23) we deduce that

$$
\begin{equation*}
r\left(x_{v}\right) \frac{d \ell_{\mu}}{d \ell_{h_{c a n}}}(x) \leq \frac{36 r\left(x_{v}\right)}{d\left(x, x_{v} ; h_{c a n}\right)} . \tag{78}
\end{equation*}
$$

In polar coordinates on $B_{v}^{2}$, the metric $h_{\text {can }}$ is given by formulas (11) and (12), and $\left.h_{c a n}\right|_{A_{v}}=h_{\theta}^{2} h_{s t}$. So, since by Claim 8.5 we have $r_{v}^{2} \leq 1$,
it follows that

$$
\begin{equation*}
\frac{d \ell_{h_{c a n}}}{d \ell_{h_{s t}}}(x)=h_{\theta}(x) \leq 3 d\left(x, x_{v} ; h_{c a n}\right), \quad x \in A_{v} \tag{79}
\end{equation*}
$$

Using the chain rule to combine inequalities (78) and (79), we obtain

$$
\frac{d \ell_{\mu}}{d \ell_{h_{s t}}}(x) \leq 108
$$

for $x \in A_{v} \cap \gamma$. On the other hand, we have

$$
\int_{x \in A_{v}} e^{g(x)} d \ell_{n}(x)=\int_{x \in A_{v}} \frac{d \ell_{\mu}}{d \ell_{h_{s t}}} d \ell_{h_{s t}} .
$$

It follows from Claim 8.5 that $\gamma \cap B_{v}^{2}$ is a radial geodesic, so $\gamma \cap A_{v}$ is 1 -tame. Thus by Claim 8.8 we may apply Lemma 7.2 with $k_{1}=1$ and $k_{2}=108$ to deduce the bound

$$
\int_{x \in A_{v}} e^{g(x)} d \ell_{n}(x) \leq 108\left(a_{1} \mu\left(A_{v}\right)+a_{2}\right) .
$$

Collecting the terms, using Claim 8.7, and invoking Lemma 6.34 for the constant terms, we obtain

$$
\begin{align*}
\sum_{v \in G \backslash G_{1}} \int_{t_{0}(v)}^{t_{1}(v)} & \int_{x \in v_{t} \cap D} d \ell_{n}(x) e^{t} d t \leq  \tag{80}\\
& \leq\left(\frac{12}{\delta_{1}}\left(24 \ln 48+108 a_{2}+32\right)+108 a_{1}\right) \mu\left(\Sigma_{\mathbb{C}}\right)
\end{align*}
$$

which completes the proof.
Lemma 8.10. Let $\beta \subset \gamma$ be the union of the connected components $\beta_{i}$ of $\gamma$ such that

$$
\begin{equation*}
\ell_{n}\left(\beta_{i}\right)<4 e^{-\max _{x \in \beta_{i}} g(x)}, \tag{81}
\end{equation*}
$$

and

$$
\begin{equation*}
\ln 2 k \leq \max _{x \in \beta_{i}} g(x) . \tag{82}
\end{equation*}
$$

We have

$$
\ell_{\mu}(\beta) \leq 4 \frac{\mu\left(\Sigma_{\mathbb{C}}\right)}{\delta_{1}}
$$

Proof. Using inequality (81) we estimate

$$
\ell_{\mu}\left(\beta_{i}\right) \leq \ell_{n}\left(\beta_{i}\right) \max _{x \in \beta_{i}} \frac{d \ell_{\mu}}{d \ell_{n}}(x) \leq 4
$$

Choose $x_{i} \in \beta_{i}$ such that

$$
\frac{d \ell_{\mu}}{d \ell_{n}}\left(x_{i}\right)=\max _{x \in \beta_{i}} \frac{d \ell_{\mu}}{d \ell_{n}}(x) .
$$

Set $t_{i}=\frac{d \ell_{\mu}}{d \ell_{n}}\left(x_{i}\right)$. By inequality (82), we have $\left(x_{i}, t_{i}\right) \in D$. So, Lemma4.7 implies that $\mu\left(B\left(x_{i}, t_{i}\right)\right) \geq \delta_{1}$, and Lemma 4.8 implies the disks $B\left(x_{i}, t_{i}\right)$ are pairwise disjoint implying the claim.

Proof of Theorem 4.2. By equation (55), it suffices to bound $I_{0}$ and $I_{1}$. Lemma 8.1 takes care of $I_{0}$ unconditionally. The components $\gamma_{i} \subset \gamma$ that violate condition (32) contribute trivially to $I_{1}$, so we assume without loss of generality that condition (32) does hold. Then Lemma 8.10 allows us to disregard the contribution to $I_{1}$ of components $\gamma_{i} \subset \gamma$ that violate condition (31). So, without loss of generality, we impose Assumption 8.2. Then equation (62), Lemma 8.3 and Lemma 8.4 bound $I_{1}$ implying Theorem 4.2.

## 9. Applications

We now apply Theorem 4.2 to prove the theorems stated in the introduction.

Lemma 9.1. Let $\Sigma$ be a closed Riemann surface with an isometric involution $\psi$. Suppose $p \in \Sigma$ is fixed under $\psi$. Then for any $r>0$, $B_{r}\left(p ; h_{\text {can }}\right)$ is $\psi$ invariant.

Proof. For any $q \in \Sigma$ we have

$$
d\left(p, q ; h_{c a n}\right)=d\left(\psi(p), \psi(q) ; h_{c a n}\right)=d\left(p, \psi(q) ; h_{c a n}\right)
$$

In particular, $q \in B_{r}\left(p ; h_{\text {can }}\right)$ if and only if $\psi(q) \in B_{r}\left(p ; h_{\text {can }}\right)$.
Lemma 9.2. Let $\Sigma$ be a closed Riemann surface with an isometric involution $\psi$. Let $\gamma$ be either a minimal geodesic connecting two points or an embedded geodesic fixed under an isometric involution $\psi$. Then for any $p \in \gamma$,

$$
\operatorname{Seg} \operatorname{Width}\left(\gamma, p ; h_{c a n}\right) \geq \operatorname{Inj} \operatorname{Rad}\left(\Sigma ; h_{c a n}, p\right)
$$

Proof. If $\gamma$ is a minimal geodesic the claim is obvious. Suppose $\gamma$ is fixed under $\psi$. For any $p \in \gamma$ and $r \in\left(0, \operatorname{Inj} \operatorname{Rad}\left(\Sigma ; h_{\text {can }}, p\right)\right)$, write $B=B_{r}\left(p ; h_{\text {can }}\right)$. Let $\Sigma_{\psi}$ denote the fixed points of $\psi . B$ is conjugation invariant by Lemma 9.1. Denote by $B_{\psi}$ the fixed points of $\left.\psi\right|_{B}$. It is clear that $B_{\psi}$ is a radial geodesic and that $B_{\psi}=\Sigma_{\psi} \cap B$. It follows that $B_{r}\left(p ; h_{\text {can }}\right) \cap \gamma$ is contained in a radial geodesic and so, that $\operatorname{Seg} \operatorname{Width}\left(\gamma, p ; h_{\text {can }}\right) \geq r$.

Let $(M, \omega)$ be a symplectic manifold, $L \subset M$ a Lagrangian submanifold, and $J$ an $\omega$-tame almost complex structure.

Definition 9.3. Let $S$ be a family of compact Riemann surfaces, possibly with boundary. We say that the data of $S$ together with $(M, \omega, L, J)$ comprise a K-bounded setting if one of the following holds.
(a) $M$ and $L$ are compact.
(b) $L=\emptyset$ and

$$
\max \left\{\|R\|,\|J\|_{2}, \frac{1}{i}\right\}<K
$$

(c) $L$ is $\frac{1}{K}$-Lipschitz and

$$
\max \left\{\|R\|_{2},\|J\|_{2},\|B\|_{2}, \frac{1}{i}\right\}<K
$$

(d) Each connected component $L^{\prime}$ of $L$ is $\frac{1}{K}$-Lipschitz and

$$
\max \left\{\|R\|_{2},\|J\|_{2},\|B\|_{2}, \frac{1}{i}\right\}<K
$$

Furthermore, for each $\Sigma \in S$, there is a conformal metric $h$ of constant curvature $0, \pm 1$, and of unit area in case of zero curvature, such that $\partial \Sigma$ is totally geodesic and $\frac{1}{K}$-Lipschitz.
Let $\mathcal{M}$ be a family of $J$-holomorphic curves in $M$ with boundary in $L$, and let $S$ be the family of Riemann surfaces that are domains of members of $\mathcal{M}$. For each $(u, \Sigma) \in \mathcal{M}$ let $\mu_{u}$ be the corresponding energy measure

$$
\mu_{u}(U):=\int_{U}\|d u\|^{2} d v o l_{\Sigma}
$$

for $U \subset \Sigma$ an open subset. The following is Theorem 2.8 of [13]. In cases (a) and (b) of Definition 9.3, it follows straightforwardly from the discussion in Chapter 4 of [24].

Theorem 9.4. Suppose $S$ and $(M, \omega, J, L)$ comprise a $K$-bounded setting. Then the collection of measured Riemann surfaces

$$
\left\{\left(\Sigma, \mu_{u}\right) \mid(u, \Sigma) \in \mathcal{M}\right\}
$$

is uniformly thick thin with constants depending only on $K$.
Proof of Theorems 1.1, 1.2, 1.4 and 1.5. Theorems 1.1, 1.2, 1.4 and 1.5 are immediate from Theorem 4.2, Lemma 9.2, Remark 4.3 and Theorem 9.4. Note that Theorem 1.5 is covered by Theorem 9.4 applied to case (b) in Definition 9.3 ,

To prove Theorem 1.6, we need the following additional definitions and lemmas.

Definition 9.5. Let $\Sigma$ be a Riemann surface with boundary. A bridge in $\Sigma$ is a length minimizing geodesic connecting two components $\gamma_{1} \neq$ $\gamma_{2}$ of $\partial \Sigma$. An admissible bridge is a bridge $\gamma$ such that for any $p \in \gamma$ and any $r \in \frac{1}{3} \operatorname{Inj} \operatorname{Rad}\left(\Sigma_{\mathbb{C}} ; h_{\text {can }}, p\right)$, we have $B_{r}\left(p ; h_{\text {can }}\right) \cap \partial \Sigma \subset \gamma_{1} \cup \gamma_{2}$.

In the following Lemmas 9.6 to 9.9 , we shall consider a Riemann surface $\Sigma$ with boundary and its complex double $\Sigma_{\mathbb{C}}$. All metric quantities and sets are with respect to the metric $h_{c a n}$ on $\Sigma_{\mathbb{C}}$, so we omit them from the notation.
Lemma 9.6. Let $\gamma$ be an admissible bridge in $\Sigma$ connecting the components $\gamma_{1}$ and $\gamma_{2}$ of $\partial \Sigma$. Then for any $p \in \gamma \cup \bar{\gamma} \subset \Sigma_{\mathbb{C}}$,

$$
\operatorname{SegWidth}(\gamma \cup \bar{\gamma}, p) \geq \frac{1}{3} \operatorname{Inj} \operatorname{Rad}(p)
$$

Proof. Let $p \in \gamma$ and $r \in\left(0, \frac{1}{3} \operatorname{Inj} \operatorname{Rad}(p)\right)$. Write

$$
B=B_{r}(p)
$$

and

$$
B^{\prime}:=B_{3 r}(p) .
$$

We need to show that $B \cap(\gamma \cup \bar{\gamma})$ is a radial geodesic. If $B \cap \partial \Sigma=\emptyset$ then $(\gamma \cup \bar{\gamma}) \cap B=\gamma \cap B$ is a minimizing geodesic, so the claim follows from Lemma 9.2. Otherwise, let $q$ be the point of $\gamma \cap \partial \Sigma$ closest to $p$, and let

$$
B^{\prime \prime}:=B_{2 r}(q)
$$

Since $\gamma$ is admissible, $B \cap \partial \Sigma \subset \gamma_{1} \cup \gamma_{2}$. Thus since $\gamma$ minimizes length between $\gamma_{1}$ and $\gamma_{2}$, we have $q \in B$. The triangle inequality implies that $B \subset B^{\prime \prime} \subset B^{\prime}$. Since $h_{\text {can }}$ has constant curvature and $B^{\prime}$ is a normal disk, it follows that $B^{\prime \prime}$ is a normal disk. By Lemma 9.2 and the fact that $B^{\prime \prime}$ is a normal disk, we have that each of $\gamma \cap B^{\prime \prime}$ and $\bar{\gamma} \cap B^{\prime \prime}$ lies on a radial geodesic of $B^{\prime \prime}$. Furthermore $\gamma$ and $\bar{\gamma}$ intersect $\partial \Sigma$ at $q$ in a right angle. So, $B^{\prime \prime} \cap(\gamma \cup \bar{\gamma})$ is a radial geodesic which we denote by $C$. Since $p \in C$, again using the fact $h_{\text {can }}$ has constant curvature, $B \cap C=B \cap(\gamma \cup \bar{\gamma})$ is a radial geodesic in $B$.
Definition 9.7. Let $\Sigma$ be a Riemann surface with boundary and let $\gamma_{i}$, for $i=1,2$, be components of $\partial \Sigma$. An admissible chain connecting $\gamma_{1}$ and $\gamma_{2}$ is a pairwise disjoint sequence

$$
\alpha_{1}=\gamma_{1}, \alpha_{2}, \ldots, \alpha_{n}=\gamma_{2},
$$

of components of $\partial \Sigma$ with admissible bridges $\beta_{i}$ connecting $\alpha_{i}$ and $\alpha_{i+1}$ for each $1 \leq i \leq n-1$.

Lemma 9.8. Let $\Sigma$ be a Riemann surface with boundary and let $\chi_{i}$, for $i=1,2$, be components of $\partial \Sigma$. There exists an admissible chain connecting $\chi_{1}$ and $\chi_{2}$.

Lemma 9.9. Let $\beta$ be a bridge connecting boundary components $\gamma_{1}$ and $\gamma_{2}$. Suppose there is a boundary component $\gamma_{3}$ and a point $p \in \beta$ such that

$$
d\left(p, \gamma_{3}\right)<\frac{1}{3} \operatorname{Inj} \operatorname{Rad}(p) .
$$

Let $\beta_{i}$ for $i=1,2$, be a bridge connecting $\gamma_{3}$ with $\gamma_{i}$. Then

$$
\ell\left(\beta_{i}\right)<\ell(\beta) .
$$

Proof. Let $\delta$ be the length minimizing geodesic from $p$ to $\gamma_{3}$ and let $q=\delta \cap \gamma_{3}$. Write $r=\operatorname{Inj} \operatorname{Rad}(p)$. Let $B_{1}=B_{r}(p)$ and $B_{2}=B_{\frac{2}{3} r}(q)$. By the triangle inequality, $B_{2} \subset B_{1}$. Since $h_{\text {can }}$ has constant curvature and $B_{1}$ is a normal disk, so is $B_{2}$. In particular $\operatorname{Inj} \operatorname{Rad}(q) \geq \frac{2}{3} \operatorname{Inj} \operatorname{Rad}(p)$. It follows that

$$
\begin{equation*}
d(p, q)<\frac{1}{3} \operatorname{Inj} \operatorname{Rad}(p) \leq \frac{1}{2} \operatorname{Inj} \operatorname{Rad}(q) . \tag{83}
\end{equation*}
$$

On the other hand, by Lemma 9.2 applied to the Riemann surface $\Sigma_{\mathbb{C}}$ with conjugation as the isometric involution we have, for $i=1,2$,

$$
\begin{equation*}
d\left(q, \gamma_{i}\right) \geq \operatorname{Inj} \operatorname{Rad}(q) \tag{84}
\end{equation*}
$$

Denote by $p_{i}$ for $i=1,2$, the point where $\beta$ meets $\gamma_{i}$. Combining inequalities (83), (84) and the triangle inequality,

$$
\begin{equation*}
d\left(p, p_{i}\right) \geq d\left(q, p_{i}\right)-d(p, q) \geq d\left(q, \gamma_{i}\right)-d(p, q)>\frac{1}{2} \operatorname{Inj} \operatorname{Rad}(q) . \tag{85}
\end{equation*}
$$

Therefore, since $d\left(p, p_{1}\right)+d\left(p, p_{2}\right)=\ell(\beta)$, we have

$$
\begin{equation*}
d\left(p, p_{i}\right)<\ell(\beta)-\frac{1}{2} \operatorname{Inj} \operatorname{Rad}(q) . \tag{86}
\end{equation*}
$$

Combining inequalities (83) and (86), we conclude

$$
\begin{equation*}
\ell\left(\beta_{i}\right) \leq d\left(p_{i}, q\right) \leq d\left(p_{i}, p\right)+d(p, q)<\ell(\beta) \tag{87}
\end{equation*}
$$

Proof of Lemma 9.8. For any graph $\Gamma$, we denote by $\mathcal{E}(\Gamma)$ the set of edges of $\Gamma$. Let $G$ be the complete graph with vertices the boundary components of $\Sigma$. For any $e \in \mathcal{E}(G)$, denote by $\ell(e)$ the length of a corresponding bridge. Let $\mathcal{S}$ be the set of spanning trees of $G$. For $T \in \mathcal{S}$, we write

$$
\ell(T)=\sum_{e \in \mathcal{E}(T)} \ell(e) .
$$

Let $T \in \mathcal{S}$ be a tree that minimizes $\ell(\cdot)$. We claim that all bridges corresponding to an edge of $T$ are admissible. Indeed, suppose the contrary and let $e \in \mathcal{E}(T)$ correspond to a non-admissible bridge $\beta$ connecting $\gamma_{1}$ and $\gamma_{2}$. By definition, there is a $\gamma_{3}$ such that, using the notation of Lemma 9.9, the condition of Lemma 9.9 is satisfied. For $i=1,2$, let $e_{i}$ be the edge of $G$ connecting $\gamma_{3}$ and $\gamma_{i}$. Removing $e$ disconnects $T$ into two connected components $T_{1}$ and $T_{2}$ containing the vertices $\gamma_{1}$ and $\gamma_{2}$ respectively. Without loss of generality, suppose the vertex corresponding to $\gamma_{3}$ is in $T_{2}$. Then, connecting $T_{1}$ and $T_{2}$ with the edge $e_{1}$ produces a spanning tree $T^{\prime}$. By Lemma 9.9 we have

$$
\ell\left(T^{\prime}\right)=\ell(T)-\ell(e)+\ell\left(e_{1}\right)<\ell(T)
$$

contrary to the choice of $T$. The claim follows. So, the sequence of boundary components corresponding to the unique path in $T$ connecting $\chi_{1}$ with $\chi_{2}$ is an admissible chain.

Proof of Theorem 1.6. To deduce the diameter estimate of Theorem 1.6, let $p_{1}, p_{2} \in \Sigma$. If $\partial \Sigma=\emptyset$, Theorem 4.2 and Lemma 9.2 immediately imply the claim. Otherwise, let $\delta_{i}$, for $i=1,2$, be the minimal geodesic connecting $p_{i}$ to $\overline{p_{i}}$. Clearly, $\delta_{i}$ is conjugation invariant and intersects a component $\gamma_{i}$ of $\partial \Sigma$. Let $\left(\alpha_{i}\right)_{i \leq n}$ be an admissible chain connecting $\gamma_{1}$ and $\gamma_{2}$ with bridges $\beta_{i}$ connecting $\alpha_{i}$ and $\alpha_{i+1}$ for $1 \leq i \leq n-1$. It follows from the definition of an admissible chain that $n \leq\left|\pi_{0}(\partial \Sigma)\right|$. We have the estimate

$$
d\left(u\left(p_{1}\right), u\left(p_{2}\right)\right) \leq \ell\left(\left.u\right|_{\delta_{1}}\right)+\ell\left(\left.u\right|_{\delta_{2}}\right)+\ell\left(\left.u\right|_{\partial \Sigma}\right)+\sum_{i=1}^{n-1} \ell\left(\left.u\right|_{\beta_{i}}\right)
$$

where all the lengths and distances are measured with respect to $g_{J}$. So, the claim again follows from Theorem 4.2, Lemmas 9.2 and 9.6 , and Theorem 9.4.

Remark 9.10. The reader may have noted the unequal treatment of the elements $\alpha_{i}$ and $\beta_{i}$ in the admissible chain connecting two boundary components. For the $\alpha_{i}$ we have an estimate which is independent of the number of components since Lemma 9.2 bounds the segment widths of the boundary as a whole. For the $\beta_{i}$, on the other hand, Lemma 9.6 only provides estimates for each component separately. For now we leave open the question whether or not this may be improved to eliminate the dependence on the number of boundary components in Theorem 1.6 altogether.

## 10. Calculation of optimal isoperimetric constant

Proof of Proposition 1.3. Let $M=\mathbb{C P}^{n}$, let $L=\mathbb{R} \mathbb{P}^{n}$ and let $\omega=$ $\omega_{F S}$ be the Fubini Study form, normalized so the area of line is $\frac{1}{\pi}$. Let $J$ be an $\omega$-tame almost complex structure. Let $\mathcal{M}_{0,2}(M, L, J)$ denote the moduli space of degree $1 J$-holomorphic disk maps with two marked points on the boundary modulo reparametrization. Since the energy of a degree 1 map is minimal, there is no bubbling, and $\mathcal{M}_{0,2}(M, L, J)$ is compact. The structure theorem for the image of $J$-holomorphic disks [20, 21] implies that minimal energy disks are somewhere injective. It follows that there is a dense set of regular $J$. Recall that for $J$ regular, $\mathcal{M}_{0,2}(M, L, J)$ is a manifold. Let

$$
e v_{J}: \mathcal{M}_{0,2}(M, L, J) \rightarrow L^{2}
$$

be the evaluation map. We claim that $e v_{J}$ is surjective for all $J$. To see this, note that for $J$ regular $e v_{J}$ is relatively orientable by [28, Theorem 1]. In particular, it is not hard to check that the standard complex structure $J_{s t}$ is regular. For $J=J_{s t}$, degree 1 disk maps are equivalent to oriented real lines. So $e v_{J_{s t}}$ is 2 to 1 away from the diagonal. Using [28, Prop. 5.1], one can check that conjugate disks contribute with equal sign, so $e_{J_{s t}}$ has degree 2 . A routine cobordism argument then shows $e v_{J}$ has degree 2 for $J$ regular. Finally, Gromov compactness implies surjectivity for any $J$.

We deduce that for any smooth almost complex structure $J$ on $M$, there is a $u:\left(D^{2}, \partial D^{2}\right) \rightarrow\left(\mathbb{C} P^{n}, \mathbb{R} P^{n}\right)$ such that

$$
\ell\left(\left.u\right|_{\partial D^{2}} ; g_{J}\right) \geq 2 \operatorname{Diam}\left(L ; g_{J}\right)=4 \pi \operatorname{Diam}\left(L ; g_{J}\right) \operatorname{Area}\left(u ; g_{J}\right) .
$$

So, for any $\omega$-tame $J$, we have $F_{1}(M, L, J) \geq 4 \pi \operatorname{Diam}\left(L ; g_{J}\right)$, which implies

$$
h_{1}(\omega) \geq 2 \pi .
$$

On the other hand, it follows from the discussion of Section 1.1 that $F_{1}\left(J_{s t}, \omega\right) \leq 2 \pi$ and $\operatorname{Diam}\left(L ; g_{J_{s t}}\right)=\frac{1}{2}$, which implies that $h_{1} \leq 2 \pi$. Combining the two inequalities, we conclude $h_{1}(\omega)=2 \pi$.
