Dear Greenville,

Fall can be the most amazing time of year. The leaves of the trees are a palette of colors we only get to witness for a short few weeks. The temperatures are cool and parents are thankful for the first days of school. There are so many great things to experience around the Fox Valley during the fall including Oktoberfest, apple picking, corn mazes, haunted hayrides, and carving pumpkins. I hope you and yours take the time to experience them all.

As we are all busy with our lives, so is the Town of Greenville. The approval of the referendum for the new Fire Safety building brings additional planning needs for the Greenville Facility Committee. Town staff continues to work with governmental agencies who will lead us through the incorporation process. Local officials are joining together to support changes to local roadways. Lastly, Town staff and the Planning Commission are collaborating with East Central Wisconsin Regional Planning Commission to update the communities Comprehensive Plan

### Fire/Safety Building Referendum

The approval of the facility referendum brings an incredibly exciting time for the community. The current fire and safety building is over 50 years old and lacks many features that impact the quality of service the that staff can provide. Which also contributes to an unsafe environment for staff with a lack of decontamination areas, showers, and adequate space to don and doff turnout gear. The new facility will provide significant enhancements to all capabilities of the volunteer staff thru dedicated space for turnout gear, drive-thru bays that have adequate space to re-supply and

service vehicles as well as provide space for decontamination areas. The current fire and safety building is planned to be utilized by the Town's public works staff housing offices and small vehicle storage.

The Greenville Facility Committee (GFC) has already been meeting to discuss next steps for the new facility. Starting with formal design documents, which will take about four months to draft, and on to a probable 12-month construction of the new building. Design and civil engineering will be completed between October 2018 and January 2019 leading to competitive bidding during the first few months of 2019. Construction is expected to be completed in early 2020 with immediate occupancy to follow.

## Incorporation as a Village



The incorporation process for Greenville has been continuing forward. Outagamie County Circuit Courts recently heard initial considerations for incorporating with a second hearing scheduled for early October. Once approved by the county circuit courts the process moves to the State level with the Wisconsin Department of Administration and the Incorporation Review Board. The Department will determine if the incorporation meets certain standards including:

- Characteristics of the Territory
- Territory Beyond the Core
- Tax Revenue
- Level of Services
- Impact on the Remainder of the Town
- Impact on the Metropolitan Community

Once the Department of Administration approves the incorporation petition, there will be a referendum to determine whether the voters within the area of the proposed to be in-

corporated approve. Finally, once all requirements are met, the Department of Administration will provide the certificate of incorporation to the community.

The most often asked question I get from citizens is what are the benefits of incorporating? The answer to this question and many more can be found on the Town website, but I wish to provide you an initial list. Why incorporate:  
Preserve the Town of Greenville's identity and character;  
Make local planning & zoning decisions;

1. Preserve Greenville's borders and protect the future of our community;
2. Attract and retain businesses to the region and promote infrastructure improvement;
3. Have the ability to be more fiscally sound and finance projects more efficiently and effectively;
4. Ability to receive a better bond rating;
5. Villages and cities have more access to State and Federal aids, grants and shared revenues than Towns.

## State Highway Corridor Call to Action

Work continues by local officials, Town staff, and myself to improve the safety of our state highway corridors. Over the last two months, Kevin Sturn (Outagamie County Supervisor) and I met with State Representative Dave Murphy and State Senator Roger Roth to discuss our thoughts and concerns for the safety and attention needed for projects in the area to be completed. Projects of concern include the STH 15 Expansion in Outagamie County, the STH 76 Urbanization project, and the STH 76 & School Rd intersection in the Town of Greenville.

Together, Kevin and I continue to bring attention for the need to properly prioritize the STH 15 Expansion project. Not only is this roadway a heavily used commuter route into Greenville and the Fox Valley, but it is also used by the majority percentage of young drivers on their way to Hortonville High School. According to the Wisconsin Department of Transportation (DOT) website, this project will increase safety, enhance economic development and lower transportation costs in the region. Even though the majority of land acquisitions for this project have completed, state officials continue to pluck monies from this initiative for efforts in other regions of the state. Traffic forecasts along the corridor show without an expansion STH 15 has a failing level of service by 2040. We need our taxpayer's money to stay home benefiting local development.

A second project the state had planned within Greenville is the WIS 76 Urbanization project. Due to statewide budget

cuts, in particular to transportation funded projects, the Wisconsin DOT is no longer planning to fully reconstruct and urbanize STH 76 from STH 15 to CTH JJ. Rather, the State is planning to simply mill and pave (resurface) the roadway. Traffic volume has grown on this roadway over the last 10 years due to significant residential growth and the addition of a new public elementary school to the area. This narrow roadway was assuredly engineered for traffic volumes of yesteryear and definitely not to support the current recreational use it now is asked to support. Comprehensive planning for Greenville has this area earmarked for additional substantial residential growth, which will only add to a worsening problem. Urbanizing this roadway by expanding the width of vehicle traffic lanes, adding safe pedestrian walkways, and adding recreational use lanes must not be overlooked by nearsighted officials. With continued growth and development in this area, I would hate for the State to spend monies on insufficient projects that do not achieve the full immediate need and value for the community.



STH 76 in Greenville, WI

As Greenville Town Chairperson, I most often hear from citizens in regards to their concerns about the safety of one particular intersection in the community, STH 76 and the

Town's School Road. This intersection is a consistent stop for the community's volunteer fire department and first responders, as accidents occur at the intersection on a regular basis. Recently our meetings have begun to garner the attention we have been hoping to achieve. During the fall of this year, State DOT officials will be applying for grant money to use on changes to this unsafe intersection. In addition to changes to this intersection, the Town is petitioning the State DOT to reduce speed limits on this roadway from STH 15 to STH 96. Residential growth and use by families headed to local schools and Fox West YMCA will continue to influence the volume of traffic on the roadway. These changes are long overdue.

As a special note, Town Staff have recently seen a change to their office hours. In order to accommodate the needs of the community Town Hall office hours are now 7:00 AM – 4:30 PM Monday thru Thursday and 8:00 AM – 12:00 PM on Fridays.

With the many great things happening in the community, do not forget to enjoy the changes of the seasons. Get out to the Greenville Lioness Art & Craft Show October 7, enjoy the Greenville Civic Club Fright Night, and always stay safe.

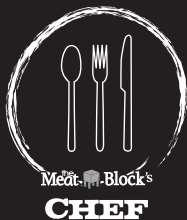

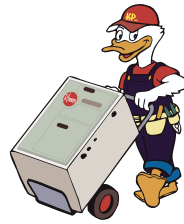

## COMMERCIAL PROJECTS UNDERWAY FOR THE SUMMER OF 2018:

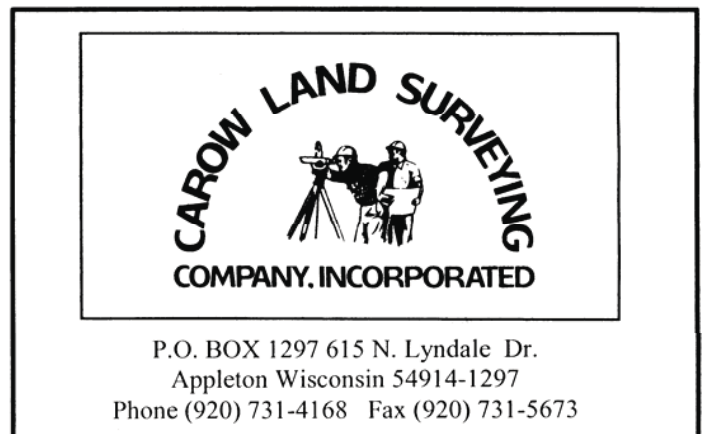
1. United Cooperative - Construction has started on a new gas station and hardware store on Municipal Dr. in the Heritage District. This building will be replacing the old Greenville Coop next to the railroad tracks.
2. All World Ford - Site work is completed and building has begun on the New All World Ford site on Hwy 15, on the Northwest side of Greenville.
3. Thrivent Financial - Site work is underway and the office building will be going up shortly on Parkview Dr.
4. Savannah Heights 1 - The first phase of Savannah Heights, East of Hwy 76 and North of the Towering Pines subdivision has been final platted and home construction will begin soon.
5. Aircraft Rescue and Fire Fighting - Appleton International Airport began construction of an aircraft rescue and firefighting facility that will train fire fighters & rescue teams from all over the nation.
6. Well #5 - Greenville Well #5 on Hwy 96 at the Greenville Sports Complex is almost complete.
7. TID Design Dr. - The Town of Greenville has approved the Design Dr. roadway and Stormwater concept for the Tax Incremental District in order to be ready for future development.
8. Gulfstream - Gulfstream off of Hwy CB is underway in their expansion plans at the Appleton International Airport.
9. ATW Hanger - The Appleton International Airport is currently constructing a new hanger that will be housing Air Wisconsin.
10. Wolf River Machine - New machining facility is almost complete next to the Town business park.

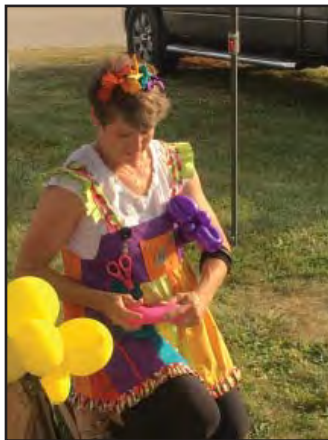

We are so proud of the fact that we kept all that metal out of our landfills. Some of the lights were quite dangerous and it was good to prevent a potential house fire! We will start to have light/wire boxes out in October, look for them in familiar locations and some new ones! This is not just for Christmas lights, we will take any string wires and any electronic cords (extension cords, computer cords, Halloween, Hanukkah, etc).

## RAIN BARRELS

We still are having great sales with rain barrels. During those hot, dry summer months that we had this year they were a wonderful relief for plants to not only get water but rain water which is so much better for your plants! They also help prevent all that water that would have soaked into the ground from running off and causing ecological damages. If you are interested in purchasing one, they are assembled and ready to be connected to your downspouts. They are just \$40 and are available at the Public Works Building across from the Town Hall. Anyone may purchase, you do not have to live in Greenville so tell your friends and family!

## FARM TO SCHOOL PROGRAM

The Farm to School program which we help support. They have added over 15 gardens, some at each of our 6 school buildings K-12 and added 6X8 greenhouses at each of our middle/elementary sites. We received an eagle scout project from Christopher Lamers that resulted in a large hoop house at our high school which impacted: Botany outdoor classroom, family & consumer science herb production, summer classes utilizing the gardens. We also collaborated with Taher food service to serve produce from gardens in our lunchrooms and the Fuel Up 2 Play 60 team with members K-12 and strong connections to this organization. The Little Chefs Cook Off Competition partnering with Trim Hunger, a non-profit to end hunger, local restaurants, other schools, boys and girls organizations and the technical college. Students ages 8-13 submit recipes, 4 are chosen to cook at local restaurants at a fundraising event. Each of the 3 Little Chef's in 2017-18 received a \$500 scholarship. Two of the three donated ½ of their scholarship back to Trim Hunger.

The HASD received \$5,000 for their work. 2018-19 event is well underway! We also received 2 acres on which to plant pumpkins for 17-18. Partnered with a master gardener and local farmers to plant, weed, harvest over 500 pumpkins to raise over \$1,300. They also became a member of the Land Stewardship Committee in Greenville.

# Visit Your Historic Yellowstone Trail in Greenville's Greenbelt

Some travel thousands of miles to spend time in a beautiful natural setting. Some expend lots of money to explore a historic site. As a Greenville resident, you can do both in minutes and at no cost. Where? Just visit Greenville's segment of the Historic Yellowstone Trail.

## A Short Lesson in Yellowstone Trail History

Before there were county and state highway departments—even before there were highways or highway signs—there was the Yellowstone Trail. And a segment of it crossed Greenville on what are now Julius and Winnegamie Drives. Digging a little deeper into history reveals that when roads were made of dirt and gravel and there were only few cars, some enterprising businessmen built a road of sorts to connect the Twin Cities of Minnesota with the newly popular Yellowstone National Park. Naturally, they named it The Yellowstone Trail. Farmers would roll a rock to the roadside and paint it yellow to mark the Trail. Sometimes they painted signs on the sides of sheds and barns to mark the Trail for travelers.

Later extensions east and west connected this first segment with the East Coast at Plymouth Rock and the West Coast at Puget Sound. For the first time you could chug along in your Model T on a cross-country trip that eventually took you through some of the most scenic vistas in our own beautiful Greenville.

## Greenville History Enthusiasts Made the Difference

It started about fifteen years ago, when the history of the Yellowstone Trail in Greenville was discovered by local history enthusiasts. Soon after, members of Greenville's Urban Forestry volunteers planted 120 shade trees and landscaped the power substation on the corner of WI Hwy 96 and Julius Drive. Go check it out! We likely have the most beautiful power substation in the Country! Who would believe it?

## A Lot of History in Just 3 Miles

Here are some landmarks you will want to see when you visit Greenville's Yellowstone Trail. Start at the power substation on the above-mentioned corner, and take note of the Julius Drive addresses as currently marked.

1. **Power Substation**—Owned by WE Energies, the landscaping project was sponsored by the Wisconsin Department of Natural Resources, the Wisconsin Energy Corporation Foundation and the Town of Greenville, and built with rocks donated by Michaels Materials. Annual maintenance is provided by local volunteers.
2. **N853—Dennis and Jean (Julius) Goffard's Home**—This classic farmhouse was built around 1875, and was once an overnight stop on the Yellowstone Trail. It has two front doors. The door on the left was for overnight visitors, which entered into a gathering room with two small guest rooms on the south end of the house. The door on the right was for family guests who would enter the parlor. The house is actually built of bricks, with the aluminum siding added much later. Note the windmill, the first of three area windmills now restored on our Yellowstone Trail segment.

3. **N679—Julius Family Farm**—Homesteaded in 1864 by German immigrants, the Julius Farm has been in continuous operation since that time. The main house is actually two houses joined together. The back half stood across the driveway. The front half stood where it is but turned 90 degrees when the two halves were joined together. Talk about ingenuity! The farm is operated by James Julius with the help of brother John.

4. **W7560 Spencer Rd.—Homestead Meadows Farm**—A short detour west on West Spencer Road will take you to one of Wisconsin’s first agriculture-themed event venues. Purchased by Steve Nagy at a farm auction in 1970, the Farm has hosted close to 1,500 weddings and a total of over 6,000 group events



since it opened in 1982. People love to celebrate on a farm! See more at [www.homesteadmeadows.com](http://www.homesteadmeadows.com).

5. **N451—Roger and Kay Seifert Farm**—Established in the late 1800s by Roger Seifert’s grandfather, after moving ‘out of the swamp’ from the farm that is now Homestead Meadows. Grandpa’s family included 13 children, including ten girls.



6. **N435—Steve Nagy residence** since 1976, this is the historic William Schaefer House, designed by noted area architect W.W. DeLong and built in 1911. It was purchased by Steve in 1976, and restored to its classic beauty for his family of Arlene and three sons, Tom, Jon and Steve.



7. **N349—Larry and Terrie Bentle Farm**—The farm’s history is chronicled on a memorial plaque placed on the foundation to honor the family story. A recent large addition has brought the home to modern standards and provides room for many family visitors.



8. **Shade Trees Along East Side of Road**—120 shade trees were planted by the Greenville Urban Forestry Board, under the leadership of its founding Chairman, Steve Nagy.
9. **N208—Menning Century Farm**—Homesteaded in 1864 by Tim Menning’s great great grandfather, the farmhouse is now the home of Tim’s son Tony, wife Becca and their young family.
10. **N137—Tim & Brenda Menning Residence**—This grand farmhouse was homesteaded by Tim’s great great grandfather’s brother in 1864.



11. **South Julius Drive Monument**—Built in 2008 by Urban Forestry volunteers, the monument celebrates the history of the Yellowstone Trail and its role in the development of cross-country travel in the US. See above, being painted by Dennis.
12. **South Greenville Grange**—Built in 1928 after the original hall was destroyed by fire, this grand brick-over-tile building is one of the finest Grange halls in the United States. Grange was a dominant social and political group in the days when agriculture was the dominant lifestyle in the US. The building was added to the Wisconsin Register of Historic Places in 2017 and to the National Register of Historic Places in 2018.

Many materials frequently flushed or poured down the drain can damage the pipes that connect to city sewers as well as the city sewer system. When you use your toilet, shower, washing machine or dishwasher, the wastewater then leaves your home through pipes that connect

to the city sewer. Every property owner connected to the city sewer system can be a potential contributor to sewer problems or even a potential victim of those problems.

Any resident who uses the city sewer system should be responsible for what they flush or pour down drains. Putting the wrong things down the drain can damage the sewer system, causing sewer backups in your home, and releases sewer gas into the environment. It is very expensive to have to repair and remove rags and diapers from the submerged waste water pumps.

Basically, the only thing you should ever flush down a toilet is human waste (urine and feces) and toilet paper. Even though some products such as wipes and baby diapers claim to be flushable, they are not. Here is a list of some things to keep out of the toilet and drains:

- Disposable Diapers
- Cloth Diapers
- Tampons and Tampon Applicators
- Sanitary Napkins
- Cotton Balls and Swabs
- Condoms
- Cleaning wipes of any kind
- Facial Tissue
- Bandages and Bandage Wrappings
- Paint, Solvents, Sealants and Thinners
- Automotive Fluids
- Poisons and Hazardous Waste
- Cat Litter
- Kitchen Grease

## Oil Filter and Absorbent Recycling

Per state law the following are not allowed in Wisconsin landfills: used oil, oil filters from cars, trucks, buses, motorcycles, snowmobiles, forklifts, tractors, ATV's and UTV's as well as the absorbents used to clean up waste oil spills. This rule applies to homeowners, farmers and businesses. If you have more than one gallon of oil saturated absorbents, such as oil dry, rags, wipes, toweling, or pads, you must take it to a designated site for proper disposal.

The Town of Greenville Yard Waste Site accepts used oil, oil filters, oil absorbents and antifreeze from residents and farmer's only. Business may check Outagamie County Recycling & Solid Waste's website for disposal options at [www.RecycleMoreOutagamie.org](http://www.RecycleMoreOutagamie.org).

## Brush Pick-Up

Brush will be picked up from Town of Greenville Residential homes is the 2nd Monday of every month. Greenville residents need to be on the Brush Pick-Up List for the Public Works employees to come by with the chipper. To be added to this list, call the Greenville Municipal Building at (920)757-7276 by noon the Friday prior to the 2nd Monday. If there are an exceedingly high number of people on the list, your brush may not be picked up on Monday, but early in the week.

For brush to be picked up it needs to be placed in a **NEAT PILE WITH THE CUT ENDS FACING THE ROAD**, lying in front of your house in the Town right of way. Piles not stacked neatly with the cut ends facing the road will be left for the homeowner to bring down to the yard waste site. It will also not be picked up if it is in your neighbor's yard or on a private road. All branches need to be at least 36 inches in length, no larger than 8 inches in diameter or exceed 50 lbs. in weight. No root balls, stumps or construction material will be accepted. Please do not put waste, grass clippings, shrub trimmings or leaves at the curb, they will not be collected and may cause your brush to be left.

If the Town Public Works Crew spends more than 20 minutes at a stop, the property owner will be charged at a rate of \$200 per hour, with a minimum charge of \$100. The purpose in doing this is to be equitable to all the Town taxpayers. The crew will not stop after 20 minutes but will continue until all of the brush is chipped.

## Street Light Outages or Problems

All streetlights in the Town of Greenville are owned and maintained by We-Energies. We-Energies has website that makes it very easy to report these problems: [www.we-energies.com](http://www.we-energies.com). Click on "Outages and Safety" at the top of the homepage and then click "Street Light or Area Light Not Working." Follow the prompts to enter the address, pole number or general location, as you will be able to choose the pole with the problem once zoomed in on a map. These reports go directly to We-Energies and are usually corrected within 5 to 8 business days.

## Snow Plowing

Well it is that time again when we need to start thinking about the cold weather and snow of our Wisconsin winters. When the snow does start, we want to let everyone know that the Town of Greenville will not start plowing the roads until after the storm or when three (3) inches of snow accumulates on the roads. We will start with main roads and work our way around town to the less traveled roads such

as residential roads. This also means that sometimes residential roads will not get plowed, meaning that the road temperature is high enough to melt on its own. Just a reminder that we use a de-icing agent on large ice patches, but that does not mean that all roads will be free of ice, so **DRIVE SLOWLY AND SAFELY**. For snow plowing routes and our Winter Maintenance Policy, see the new Town of Greenville website under the Public Works section at [www.townofgreenville.com](http://www.townofgreenville.com).

When snowplows are on the road, please be considerate and leave plenty of room for them. Snowplows do back up frequently and it is hard to see vehicles that are directly behind the plow. If you cannot see the mirrors, the driver cannot see you!

If a storm is predicted, please do not park your vehicle on the road. This will help the Town of Greenville employees to clear the roads to the best of our ability.

Also, just a reminder that **NO** vehicles can be parked on Town roads between the hours of 12:00am and 6:00am from midnight on November 15th through midnight of March 31st of the subsequent year. During times when snowplows are clearing snow off roads, please do not park on the roads. This way, we will be able to effectively clear all the snow. Town employees are unable to pull anyone out of ditches, but we will stop to make sure you are ok and have a phone to call someone for help.

As of February 15, 2008, the Town of Greenville has adopted an ordinance that bans depositing of snow in public right-of-ways. This means that any snow that is plowed may not be deposited on any street right-of-ways, including ditches, paths and walkways. Snow may also not be pushed across or into Town roads. All snow that is cleared from your driveway must be deposited onto your own property. The Town of Greenville may issue citations from \$25-\$250 for repeat violations.

Residents are responsible for clearing their mailboxes of snow that may hinder mail delivery.

Parents, do not let children play in the right-of-ways, when a plow comes through they may not see a child in the roadway or ditch. To keep from harming anyone, please do not play in the ditches.

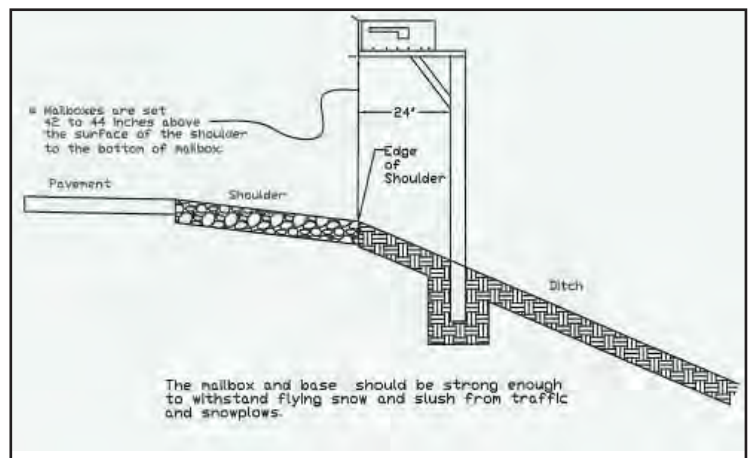
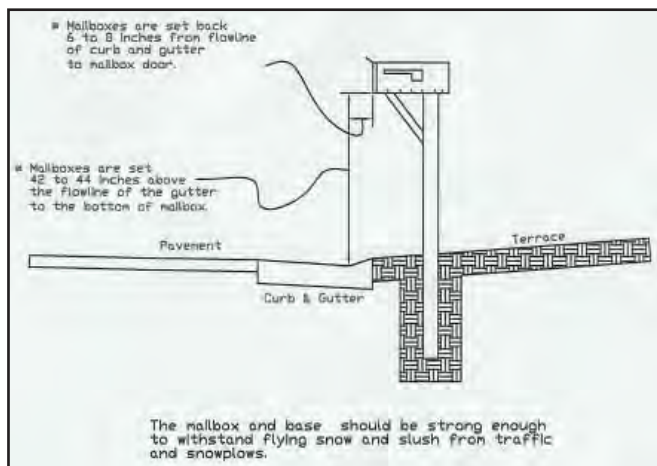

## Mailbox Damage Policy

The Town of Greenville has adopted the following policy for mailboxes damaged directly by Town crews during snow plowing:

- The Town will provide reimbursement up to \$50.00 per correctly installed mailbox damaged by a Town plow truck. This does not cover any mailboxes that are damaged by flying snow from plow trucks or cars. Reimbursement is limited to material cost only.
- Town crews will install the replacement mailbox or repair the mailbox upon request.
- Claims must be submitted to the Public Works department by May 1st and the Mailbox Damage Report (found on the Town's website) must be completely filled out and returned to the address at the bottom of the form with pictures, receipts and the damaged mailbox. We can also be reached at (920)757-7276.
- Claims will be reviewed and forwarded to the Director of Public Works for approval.
- Mailboxes will be reimbursed after Town receives pictures, receipts AND damaged mailbox.
- New mailboxes must be installed in accordance to Town and Postal Service standards.
- **ALL MAILBOXES THAT ARE INSTALLED NEED TO BE CRASHWORTHY**

# Renew Our Waters

*Every choice counts.*

## Leave your Leaves on Land

Fall leaves provide beautiful color on trees, but in local waters they contribute to green algae blooms - not so pretty.

Cleaning up your yard in the fall properly will help keep our local waters clean too! Read these tips. Post this sheet in your garage near your rakes. Working together to keep leaves out of the storm drain and out of local waters will help keep green on the land and out of the water.

### KEEP YOUR LEAVES ON YOUR PROPERTY

A great way to make sure leaves do not end up in local waters is to keep them on your property!

Mulch leaves in place by making several passes over the leaves with a mulching mower. This will keep leaves on your lawn and provide it with nutrients it needs for healthy grass next spring.

### Composting is recycling your lawn trimmings and turning them into a valuable resource for your garden or houseplants!

Collect leaves and spread them in garden beds or under shrubs. Here leaves provide valuable protection for plants through the winter.

#### COMPOSTING

Composting is recycling your lawn trimmings and turning them into a rich soil, known as compost - a valuable resource for your garden or houseplants.

Cold composting requires little maintenance but can take up to 2 years to complete. To create a cold compost pile, mix non-woody yard wastes and let them sit.

Hot composting requires regular maintenance such as turning and watering. Typically, compost can be reached in 1-3 months. To create a hot compost pile, layer or mix roughly equal amount of high nitrogen "Greens" (wet and soft materials, like grass clippings) and high-carbon "Browns" (dry and woody, like dead leaves) with 10% bulky materials (wood chips) to keep the pile loose.

All materials in the pile must stay moist, but not soaking wet. Add water to maintain conditions conducive to the composting process. Turn the pile often.

#### RAKING & COLLECTION

If you decide to collect your leaves for removal from your yard, follow your community leaf collection policies and schedules. Put a tarp over leaf piles between pick-up times to prevent them from blowing away. Remove leaves and debris from the gutters and storm sewer outlets.

Stormwater is rain or snowmelt and water from things people do, like overwatering the lawn or letting fertilizer fall into the street drain. We can choose products carefully and shape our lawns and pavement so water sinks in. When we do, runoff is reduced, pollutants filter out and streams and groundwater are protected.

Untreated runoff is the biggest threat to our nation's water quality, according to the U.S. Environmental Protection Agency. Let's make the small, important changes that will reduce that threat and improve water quality and our lives!

# BUILDING INSPECTION DEPARTMENT

## BUILDING PERMIT CLARIFICATION

We feel a need to inform homeowners that the building permit taken out for the principal structure is only for what was submitted with the plans. Most likely this did not include finishing the basement, deck, or any other item not on the approved permit. Failure to obtain a building permit can result in double fees and / or citations. If you have questions, you may call the Building Inspector, Dale Waala, at 757-5151, ext. 2200.

## BUILDING PERMITS

As the construction season continues to boom, residents are reminded that building permits are required for the following projects:

- Construction or installation of any building (house, garage, shed, or any structure)
- Additions to any house or structure
- Re-roofing
- Fences
- Decks, Porches, or Pergolas
- Remodeling of any sort (including finishing any basement area, windows, or doors)
- Heating or air conditioning (new or replacement) including garage heaters
- Electric work
- Plumbing
- Any moving or demolition of buildings

Please plan ahead. The amount of time to issue any permit may take up to five (5) days.

Again, failure to obtain a building permit can result in double fees and/or citations. We'd also like to make you aware that there have been issues arising at the time of home sales that have been caused by building permits not being pulled for work that has been done on the home. This has resulted in some sellers losing their buyers.

  - Distances to other structures
  - Location of septic system – if applicable
  - Location of well – if applicable
  - Drainage easements
  - Utility easements
4. Shed detail
  - Type of material
  - Floor plan & front elevation – blueprints or hand drawn sketch to include location of braced wall panels
  - Material sizes
  - Footings / foundation

1. Drainage easements
2. Utility easements – structures cannot go over power lines or into utility easements
3. Shoreland Zoning
4. Airport Zoning
5. Wetlands
6. Hydric Soils
7. Property lines

10. Electrical needs

## PARK RESTROOMS CLOSING

The restrooms in the parks will be closing on or near October 1st for the season. While the restrooms may be closed, the parks remain open all through the winter. Be sure to get out and enjoy them through the fall and winter months as there are many activities that can be enjoyed during this period.

## STREET TREES

Street trees are planted during the spring on lots that have an established lawn. If you received trees in front of your home, please help us care for them by keeping them watered during the summer through fall. You should have received a letter along with a care sheet earlier this spring. If you didn't or need another copy please contact us and we will get another copy to you. Keeping the tree properly watered is very important for the establishment of these young trees but remember that over watering can kill a tree just as easily as under watering. If you received a tree last year, please continue to water it as well. All we ask is that you water and keep the tree mulched. All other maintenance such as pruning, staking or fertilizing will be done by Town staff. If you have any questions or concerns about your tree please feel free to give us a call.

## LANDSCAPING IN THE RIGHT OF WAY

The Town of Greenville has an ordinance that regulates landscaping within the Town right of way. This ordinance requires that a permit be obtained if one desires to perform any landscaping activities within the Town right of way. The Town right of way typically extends 33' out from the centerline of the road which usually amounts to 15' from the curb. If you are unsure of the location of the right of way, please contact Town Hall. This ordinance only applies to subdivisions with curb and gutter. Landscaping is still prohibited in any Town ditch. In order to receive a permit, one must fill out an application and submit a landscape plan that adheres to the regulations set forth by the ordinance. If you are planning to do any landscaping in the right of way, please stop by the Municipal Services Building and pick up a permit application and a copy of the ordinance. This may also be viewed on the Town Website. Violators of this ordinance will be subject to a fine and removal of any landscaping that violates the regulations set forth by this ordinance.

## NEIGHBORHOOD TREE PROGRAM

The Greenville Parks, Recreation and Forestry Department has a program that allows homeowners to help fill in tree locations in the new subdivisions. The funding for the street

trees in many of the current subdivisions was provided by fees that were collected on a per lot basis at the time a building permit was issued. Depending on the subdivision, this fee may or may not provide enough funding to completely line the streets with trees, leaving some vacant planting sites. The neighborhood tree program provides homeowners the opportunity to fill in these vacant locations. The homeowner pays for the cost of the tree while the Town will pick up the cost of the planting. The trees will be planted during the spring along with the normal street tree planting. For more information please call us at 757-7276.

## **FALL SAFETY TIPS:**

### **Smoke Detectors**

- Smoke alarms should be replaced every 10 years.
- Make sure you know how old all the smoke alarms are in your home.
- To find out how old a smoke alarm is, look at the date of manufacture on the back of the alarm; the alarm should be replaced 10 years from that date.
- If you are physically or financially unable to install new smoke detectors, we have a limited number of smoke detectors that can be installed free of charge. This program is available through a partnership with the American Red Cross. Please call the Greenville fire department for details (757-7262).

### **Carbon Monoxide (CO) alarms**

- Install one on every level of your home
- Test CO alarms monthly by using the test button.
- Replace all CO alarms every 6 years or sooner if they don't respond properly when tested.
- Change your CO and Smoke alarm batteries twice a year (at daylight saving time).
- Take an alarming CO detector seriously. We've had several calls lately, where a CO alarm was going off, the homeowner didn't think much of it and we actually found a dangerous amount of CO and/or Natural Gas. CO is a tasteless, colorless, and odorless gas that is poisonous to humans and can lead to death. **PLEASE TAKE CO AND SMOKE ALARMS SERIOUSLY. WHEN YOUR ALARM GOES OFF, EVACUATE TO FRESH AIR AND CALL 911.**

### **Wood/Pellet Stoves and Fireplaces**

- Be sure the fireplace or stove is installed properly. Wood stoves should have adequate clearance from combustible surfaces and proper floor support and protection.
- Have the chimney inspected annually and cleaned if necessary, especially if it has not been used for some time.
- Do not use flammable liquids to start or accelerate any fire.
- Keep a glass or metal screen in front of the fireplace opening, to prevent embers or sparks from jumping out, unwanted material from going in, and help prevent the possibility of burns to occupants.
- Don't use excessive amounts of paper to build fires in fireplaces. It is possible to ignite creosote in the chimney by overbuilding the fire.

# FIRE DEPARTMENT

- Never burn charcoal indoors. Burning charcoal can give off lethal amounts of carbon monoxide.
- Keep flammable materials away from your fireplace mantel. A spark from the fireplace could easily ignite these materials.
- Before you go to sleep, be sure your fireplace fire is out. NEVER close your damper with hot ashes in the fireplace. A closed damper will help the fire to heat up again and will force toxic carbon monoxide into the house.
- If synthetic logs are used, follow the directions on the package. NEVER break a synthetic log apart to quicken the fire or use more than one log at a time. They often burn unevenly, releasing higher levels of carbon monoxide.

## Furnaces

- Be sure all furnace controls and emergency shutoffs are in proper working condition.
- Do not attempt repairs yourself: leave furnace repairs to qualified specialists.
- Check the flue pipe and pipe seams. Are they well supported and free of holes and cracks? Soot along or around seams may be an indicator of a leak.
- Is the chimney solid, with cracks or loose bricks? All unused flue openings should be sealed with solid masonry.
- Keep trash and other combustibles away from the heating system.
- It is important that you have your furnace inspected to ensure that it is in good working condition.

## Prevent Clothes Dryer Fires by Doing the Following:

- Clean the lint screen/filter before or after drying each load of clothes.
- Clean the dryer vent and exhaust duct periodically.
- Clean behind the dryer, where lint can build up.
- Replace plastic or foil, accordion-type ducting material with rigid metal ducts.

If you have a dehumidifier in your home or business, check this link to see if yours is on the recall list. Please take this recall seriously. We have had several fires in Greenville and the Fox Valley where dehumidifiers were involved. The recall claim process is very easy. # FIRST RESPONDERS

The Greenville First Responder have been busy this summer from the beginning of 2018 though the end of August we have responded to 229 calls compared to 218 the same time period in 2017. So far this summer it has been pretty hot and with good fortune we haven't been called for a lot of heat related calls.

The Automated External Defibrillators (AEDs) have been around for quite a while now and in Greenville all of the first responders carry an AED which has been possible because of all the groups, businesses and resident's that have generously donated money in the past years. I only bring this up because this year we have been very successful with our AEDs. So anyone that has had anything to do with supporting the first responders should be proud that your donation has been put to good use, there are several families in the Greenville area that would share that sentiment.

We know school has already started, but here are some tips for parents to go over with their children and also a good reminder for us parents to:

## **Here is the driving procedure for stopping for a school bus.**

- Always use extreme caution when approaching a school bus, children do not always pay attention to their surroundings and it's our responsibility as drivers to always use caution. All vehicles must stop on the street or highway 20 feet or more from any school bus with flashing red warning lights and stop arm extended, this applies to vehicles approaching from the rear and opposing lanes. All lanes of traffic must stop for the school bus, except in opposing lanes if the highway is divided with a center median. No vehicle may proceed until the bus resumes motion and has turned off the red warning lights. The stop arm on the bus is an added communication to other drivers, but the lack of an extended arm **is not reason to pass a bus whose red lights are flashing.** A vehicle owner can be cited when the driver of a vehicle passes a school bus illegally. A law enforcement officer need not witness this violation if the school bus driver reports it to the law enforcement agency within 24 hours. Fines can be quite high; up to \$300.00 for illegally passing a school bus, but the risk of hitting a child is even higher.

## **SAFETY TIP:**

Most school bus-related deaths and injuries occur while children are crossing the street after leaving the bus, not in collisions involving school buses. So after you stop for a school bus, watch for children along the side of the road. Drive slowly until you have passed them.

## **Here are some safety guidelines for walkers, joggers and students going to school using roadways without side-walks.**

- Stay on the shoulder off the roadway.
- Walk against the flow of traffic. (You must face oncoming traffic)
- Wear bright colored clothing.
- Walk during daytime hours/at night wear light colored clothing and reflective clothing.
- Riding bikes or skate boards always wear a helmet.
- Cross the roadway at an intersection, look both ways before you cross the street. Make eye contact with any driver who may be turning. Give them a wave. Make sure they see you. In a car-walker interaction, you can only lose.
- Walk single file, unless you are on a sidewalk separated from the road, you should walk single file. This is especially important on a road with curves, where traffic has only a split second of seeing you. Just remember it may be enjoyable to walk down the road two or three abreast chatting merrily, but drivers don't expect it and you may lose in the end.
- Keep the volume down; don't drown out your environment with your iPod. Keep the volume at a level where you can still hear warnings from drivers, walkers, runners and bikers.
- Hang up; talking on a cell phone while you walk or bike is a dangerous as talking while driving. You are less likely to recognize traffic dangers and other hazards. Potential criminals see you as a distracted easy target.
- Be aware of stranger danger; choose your walking route for paths frequented by other walkers, joggers and bikers. If you see someone suspicious, be prepared to alter your course or go in to a public building to avoid them. Acting alert and aware can convince bad guys that you're not an easy target.
- Know when to stop walking, heat sickness, dehydration, heart attack or stroke can strike walkers and any age. Learn the symptoms of medical emergencies and carry a cell phone to dial 911.

## Driving in Fog

- This time of the year we may have to drive in more foggy conditions than any other time of the year. Here are some things to think about for driving in fog.
- The best advice for driving in fog is to delay the trip until conditions improve. However, this is not always possible so remember fog can limit visibility to less than 50 feet at 60 miles per hour, that's just over half a second in front of you. It is imperative to do everything possible to increase your vision as well as alert other drivers of your intentions as early as possible.

## Visibility

- It is difficult to notice fog becoming thicker, so visibility can decrease without you being aware of it. To increase your vision, use windshield wipers and the defroster to minimize any condensation on your windows. Also be sure to use your low beam lights because high beam lights reflect back to your eyes. For guidance in following the road, follow the solid lines on the outer lanes.

## Following Distance

- With decreased visibility comes a decreased amount of time to react to other cars, road changes, pedestrians and even animals in the road. At high speeds, the car can reach unseen objects in the distance before you have a chance to react to it. While it can be very reassuring to have a car in front of you to follow, you still need to keep a proper following distance. You can judge how close based on the skip marks-the white dashes between lanes on the highway. Each skip mark is about 40 feet apart so if you can't see any skip marks you are too close. Try to stay as far back as possible while keeping the vehicle ahead of you in sight. Fog also makes roads damp so braking will require a greater distance to stop or slow down. Not using cruise control will give you better control of your vehicle.

## Alerting Other Drivers

- Not only does fog increase the chance of having problems with keeping your vehicle on the road, but it also increases the chances of being surprised by the actions of other drivers. Giving other cars the maximum amount of time to react will help to avoid accidents. Though you should not change lanes unless you really have to, when you do, turn on your blinkers well in advance of the change so other cars can react. Also, try to apply the brakes gradually so other drivers will have a chance to react and avoid a pile up.

## Transportation Riding Safety

- Did you know that the air bag that saves your life could also kill you or your child? Air bags are not soft, billowy pillows. They are bags that can come out of the dashboard at up to 200 miles per hour, faster than a blink of an eye. I have seen children riding in the front seat of vehicles without seat belts and children who have their feet up on the dashboard that have no clue what could happen to them if the air bag deployed at that instant. It's better to be safe than sorry, always stay in a sitting position with your feet on the floor. All drivers should use common sense when traveling with children. Drivers can prevent air bag-related injuries to adults and children by following these critical safety points:
  - **Make sure everyone is buckled up**
  - **All children ride safer in the back seat (12 and under, or under 90 lbs.)**
  - **Anyone in the front seat must wear BOTH the shoulder and lap portions of the seat belt**
  - **Always put a baby under age 1 in a rear-facing car seat in the back seat and make sure the car seat is properly installed**

It's been a great summer visiting with all of you at the various Greenville events; we thank you all for supporting the town of Greenville. It seems like with the weather we've had (with no rain like last year) the various groups I'm sure did pretty well, even when the weather isn't very good the residents still come out and support all of the groups. These groups do a lot of good things for the community with the money you spend we are able to purchase much needed equipment.

We would also like to thank all of the supporting votes for the new Fire Station; it will improve our efficiency and make training a lot easier and safer for the Firemen and First Responders. So thank you again and have a safe start of the school year.

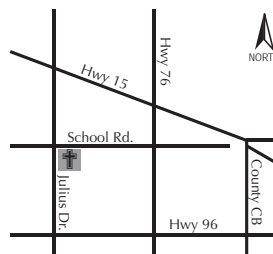

# TOWN CONSTABLE

As we close the books on another summer, and a busy summer it was, I took the time to reflect on why this summer was so much busier in the animal control world.

One reason is the rapid growth of Greenville. Back in 2005, when I first took over the animal control duties Greenville had a population of about 5,000 residents with about 850 licensed dogs. Today we are closing in on 13,000 residents and over 2,000 licensed and unlicensed dogs. I also need to consider cats, domestic rabbits, snakes and other exotic pets along with the once in a while wildlife call to that increase in calls for service. Residents also have higher expectations with regard to results when responding to these calls.

This department saw a sharp increase in calls for service related to unexpected fireworks in the area. The loud, out of the norm noise associated with these fireworks would send dogs running in fear and confusion. Some dogs were injured as a result of running off and several dogs did not survive after running off and being hit by a vehicle.

With the long stretch of hot and humid days the calls for animal welfare checks increased. Some calls were for animals tied outside for extended periods of time with no means of shelter from the sun. Other calls were for dogs that are outside dogs with inadequate shelter and no visible source of water.

We also saw an increase in calls for “dogs running at large”. In talking with many new residents who are also dog owners, the thought was that since this is the “country” it is acceptable for dogs to not be leashed or supervised.

I would encourage all pet owners in Greenville to familiarize themselves with our ordinances related to animal control and welfare. They can be found at [www.townofgreenville.com](http://www.townofgreenville.com) under Municipal Code then Part 1, Chapter 76.

## COLD-WEATHER PET TIPS

People who live in areas experiencing cold weather and winter storms need to take extra precautions to keep their animals safe. Pets left to fend for themselves in cold weather are susceptible to injury and death.

### Be Prepared

- Plan ahead and pay attention to cold-weather warnings.
- Unless significant power outages are experienced, most cold-weather episodes and winter storms are “shelter in place” events, so pet care needs should be planned for in the home. Keep your pet preparedness kit well-stocked and ready — in a winter storm, you may not be able to leave your home for several days.

- Leave your pets’ coats a little longer in the winter to provide more warmth. That summer “short cut” from your groomer should be avoided during cold weather. If you have short-haired breeds, consider getting them a coat or sweater that covers them from neck to tail and around the abdomen.

### Winter Pet Care

- When you bathe your dogs in cold weather, make sure they are completely dry before taking them outside for a romp or walk.
- When walking your dogs during bad weather, keep them on leash. It’s easier for a dog to become lost in winter storm conditions — more dogs are lost during the winter than during any other season. (And don’t forget to microchip and put ID tags on your dogs and cats!)
- Leash your pets if you have frozen ponds, lakes or rivers nearby, as loose pets can break through ice and quickly succumb to hypothermia before trained ice-rescue personnel can arrive. Never try an ice rescue of a pet yourself — leave that to trained professionals.
- When you are working on housebreaking your new puppy, remember that puppies are more susceptible to cold than are adult dogs. In cold conditions or bad weather, you may need to opt for paper training your new pet rather than taking the pup outside.
- Keep your pets inside, both during the day and night. Just because they have fur doesn’t mean they can withstand cold temperatures.
- If dogs are left outside, they should have a draft-free shelter large enough to stand and turn around in, yet small enough to retain body heat. Use a layer of straw or other bedding material to help insulate them against the cold. Make sure the entrance to the shelter faces away from the direction of incoming wind and snow.
- Keep your cats indoors. Cats can freeze in cold weather without shelter. Sometimes cats left outdoors in cold weather seek shelter and heat under the hoods of automobiles and are injured or killed when the ignition is turned on. Banging loudly on the hood of your car a few times before starting the engine will help avoid a tragic situation. (This is true for wild animals in cold weather as well).
- When taking your pets out for a bathroom break, stay with them. If it’s too cold for you to stand outside, it is probably also too cold for your pets.

### Precautions for Outdoor Pets

- If your pet is outside during cold weather:
- Remember that staying warm requires extra calories. Outdoor animals typically need more calories in the

winter, so feed them accordingly when the temperature drops. Talk to your veterinarian for advice on proper diet.

- Watch your pet's outside fresh-water bowl. If it is not heated, you may need to refresh it more often as it freezes in cold weather.
- Salt and de-icers: Many pets like to go outside to romp and stomp in the snow, but many people use powerful salt and chemicals on their sidewalks to combat ice buildup. Thoroughly clean your pets' paws, legs and abdomen after they have been outside, to prevent ingestion of toxic substances and to prevent their pads from becoming dry and irritated. Signs of toxic ingestion include excessive drooling, vomiting and depression.
- Ice and snow: When you let your pets in from a walk or a romp outside, make sure to wipe their paws and undersides — get those ice balls off as soon as possible, as they can cause frostbite. After being outside, check your pets' paws, ears and tail for frostbite. Frostbitten skin usually appears pale or gray and can be treated by wrapping the area in a dry towel to gradually warm the area. Check with your veterinarian if you suspect frostbite.
- Use nontoxic antifreeze. Antifreeze is great-tasting to pets, but even a very small amount ingested can be deadly. Look for "safe" nontoxic antifreeze, consider using products that contain propylene glycol rather than ethylene glycol, and make sure all spills are cleaned up immediately and thoroughly. Contact your veterinarian immediately if you suspect your pets have ingested any antifreeze!

## And now.....the Story.....

This sad but true story is of Bo (not his real name), a large breed dog that had a zest for life and only wanted to be loved.

I became familiar with Bo several years ago when I picked him up as a stray at the ripe age of 13 months. Bo weighed in at about 110 pounds. He was all muscle and loved life. His worried and anxious owner was quickly found and he was returned. I was also told that Bo had been running away quite frequently and that his owner was at a loss as to what to do. We had a discussion about getting Bo neutered and microchipped. An ID tag on his collar would help too. We also discussed tie out methods for this powerful boy and better supervision by his humans. I was told that this would be discussed with the other half of the human ownership. I sensed some frustration and dismay.

Fast forward to 8 months later when I was called out to a deceased dog found behind a vacant building. What I found was an emaciated, large breed, unaltered male between 2-3

years of age. His once beautiful body was covered in scars that later were determined to be cigarette burns. Some of his teeth were broken.

He was scanned and a microchip was found. When the name of the registered owner was revealed my heart sank. It was the person to whom I had returned Bo to 8 months ago. Thankfully, at least he had gotten microchipped.

In this profession you deal with many different human personalities and you hear so many interesting stories. Although you may at times be filled with anger and frustration you must remain unbiased and listen very closely.

I was able to make contact with Bo's owner and she told a story of how she got involved with the wrong guy. This guy used Bo as a means to control her. At one point she was told that Bo had been sold because money was needed. But she didn't believe it. When she was finally able to escape the abuse she reported that she felt Bo may or may not still be alive and that she had been lied to about him being sold. Based on reports from the neighbors, after dark on the day that the police visited the home inquiring about Bo, friends of the male party removed something large wrapped in a blanket or a carpet from a shed at the rear of the property, loaded it in a pickup truck and drove away.

I believe this was Bo. He was found behind the vacant building about a week after that night. The person most likely responsible for Bo's death left the home and hasn't yet been located.

What we believe happened is that Bo was put in that shed and left to starve to death as a means of punishment for his owner trying to leave the relationship.

Many will want to blame the female for not doing something to save Bo, but the sad truth is that she could barely save herself. She thought Bo was lost to her after being told he'd been sold.

What I hope you gain from this story is if you are or you know someone in an abusive situation, the abuser will use the pets to maintain control. Many women and men in abusive situations will not leave unless they are sure that their pets can leave with them or are temporarily placed somewhere safe.

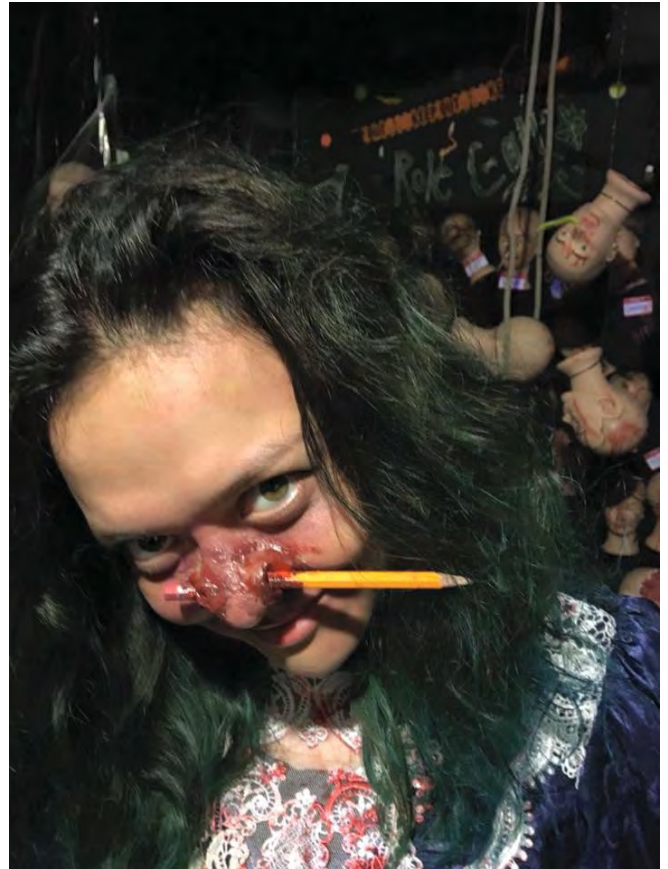

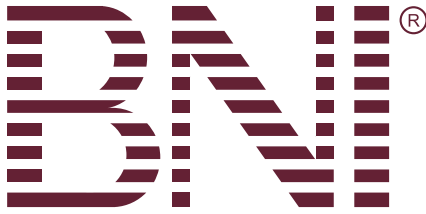
