- 1. The special meeting was called to order at 7:00 a.m. by President, Monty Breneman.

Kathy Robertson reported that she will be meeting with David Dohe, Emergency Preparedness Director for Lincoln County, and Ladonna Reinert, Lincoln County Health Administrator, regarding the USD #298 Lincoln Crisis Management Plan next Monday. The information will be presented at the meeting next Monday evening.
- 9. Lincoln Elementary School Staff Handbook and Lincoln Jr./Sr. High School Staff Handbooks were distributed for board review. Mrs. Robertson stated they both follow the negotiated agreement but this would provide a document for principals to go over at the beginning of the year and reference throughout the school year. Both will be brought back for discussion at the July 2, 2018, meeting.
- 10. Mrs. Robertston stated that as budget year draws to a close, consideration might be given to the HVAC Units that have been proposed for the Lincoln Jr./Sr. High School industrial shops and the gym at an approximate cost of \$70,870. There would be \$3,375 for engineering fees that would include obtaining bids for the units. The \$52,500 from the WindFarm money remains available and the remaining \$20,000 could come from Capital Outlay after the first of the new fiscal year. Monty Breneman requested that consideration be given to bringing this item back as an action at the July meeting.
