## PROCLAMATION

**WHEREAS**, Civil Air Patrol was founded on December 1, 1941 to supplement the U.S. military during World War II; and

**WHEREAS**, the Oak Ridge Composite Civil Air Patrol Squadron was organized on November 9, 1943 and is celebrating its 80<sup>th</sup> birthday this year; and

WHEREAS, since its beginning, the Civil Air Patrol has set itself apart during the country's most tumultuous times – locating enemy submarines during World War II, assisting rescuers and state agencies immediately following the September 11, 2001 terrorist attacks, heavily supporting hurricane relief efforts in 2005, 2008, 2012, and 2016 and responding to the 2010 Gulf Coast oil spill, as well as aiding communities during other natural disasters, such as floods, wildfires, ice storms, and tornadoes; and

**WHEREAS**, the Civil Air Patrol further provides vital homeland security missions that help ensure the protection of the nation's capital and the nation as a whole by assisting Air Force pilots with target-intercept training as well as the military with acquiring distant targets; and

**WHEREAS**, the Civil Air Patrol provides exceptional educational and growth opportunities for youth through its nearly 24,000-member strong cadet program, which annually provides access to top national summer flight academies to learn to fly powered or glider aircraft, as well as to more than 30 national programs emphasizing leadership and careers in aviation; and

WHEREAS, the Oak Ridge Composite Civil Air Patrol Squadron continues the tradition of service to our country and community by performing search and rescue, disaster relief and homeland security missions, as well as operating a cadet program that is active in leadership development, aerospace education, and drill and ceremony and honor guard presentations for community organizations; and

**WHEREAS**, the Oak Ridge Composite Civil Air Patrol Squadron has received many awards through its history, including awards for drill team and color guard competitions, cadet competitions, ground team competitions and the Air Force of Tennessee's Squadron of the Year Award.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF OAK RIDGE, TENNESSEE, that November, 2023 be proclaimed

## OAK RIDGE CIVIL AIR PATROL MONTH

in the City of Oak Ridge, Tennessee, and that all citizens be encouraged to show appreciation to the Civil Air Patrol for 80 years of outstanding programs which have touched the lives and ensured the safety of our citizens.

## PROCLAMATION

**WHEREAS**, seven genres of music call Tennessee home, with more songs being written, recorded and played live here than anywhere else in the world; and

**WHEREAS**, the Tennessee Department of Tourist Development established a statewide program, Tennessee Music Pathways, which identifies, explains and preserves the legacy of music in Tennessee; and

**WHEREAS**, on Monday, November 20, 2023, a commemorative marker will be placed in front of the historic Grove Theater to honor the legacy of the Oak Ridge Boys and their contribution to music as part of the Tennessee Music Pathways program; and

**WHEREAS**, although they scored seventeen number one country hits in the 1970's and 1980's, the Oak Ridge Boys actually began in the mid-1940's as a Southern Gospel group, the Oak Ridge Quartet; and

**WHEREAS**, founding member Wally Fowler and his original band, the Georgia Clodhoppers, played regularly for U.S. government personnel at the nuclear development site later known as the Oak Ridge National Laboratory, and they drove to Oak Ridge on Saturday mornings to perform for the facility's schoolchildren, who were not allowed to leave the compound; and

**WHEREAS**, around 1945, the Oak Ridge Quartet became a breakout unit within the Clodhoppers and made their first recordings in 1946, shortly after moving to Nashville; and

**WHEREAS**, the group's name changed to the Oak Ridge Boys in 1963 after signing with Warner Brothers Records, with William Lee Golden joining the group in 1964, Duane Allen in 1966, Richard Sterban in 1972, and Joe Bonsall in 1973; and

**WHEREAS**, the Oak Ridge Boys performed in Las Vegas with Johnny Cash in 1974, later headlining their own shows there, and made their first country recordings in 1976; and

**WHEREAS**, in 2000, the Oak Ridge Boys were inducted into the Gospel Music Hall of Fame, and in 2015, they were inducted into the Country Music Hall of Fame.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF OAK RIDGE, TENNESSEE, that the City of Oak Ridge pays tribute to

and encourage all citizens to show their appreciation to this blockbuster group for their many accomplishments and commitments to our city's historical legacy.

SUBJECT: 2023 Board and Commission Elections

### Introduction

During the November 13, 2023 regular meeting, City Council will elect city representatives to the Convention and Visitors' Bureau/Explore Oak Ridge Board, the Environmental Quality Advisory Board, and the Senior Advisory Board. A student representative will also be elected to the Environmental Quality Advisory Board. The student representative vacancy was left over after the 2023 Mid-Year elections, and the other three vacancies have occurred through resignations, members moving away, and one death.

### Funding

No funding is associated with this item.

### **Background**

The seats referenced above, with the exception of the student representative, became vacant after the 2023 mid-year elections. City Council directed the City Clerk to begin advertising for these vacancies and not wait until the end-of-year election process began. A vacancy on the Land Bank Corporation Board of Directors was filled last month, but applications for these vacancies were held open due to not receiving an adequate number of applicants. Including the Land Bank, there were fourteen applicants for six vacancies. Ads were run weekly in The Oak Ridger during the recruitment period, and information was posted on social media and on the City's website. The recruitment period was extended once. The agenda packet includes applications and resumes submitted by applicants for Council's review. In cases where there is only one applicant for a vacancy, Council may decide to elect the applicant by acclamation.

Elect one (1) representative to the Environmental Quality Advisory Board for the balance of an unexpired term ending on December 31, 2025

Elect one (1) student representative to the Environmental Quality Advisory Board for a twoyear term ending on June 30, 2025 Elect one (1) representative to the Senior Advisory Board for the balance of an unexpired term ending on December 31, 2025

The Oak Ridge – Heritage Railroad Authority is pleased to submit it's 2022/2023 Annual Report to City Council in accordance with Council's resolution and State Law. The Oak Ridge – Heritage Railroad Authority was established by the Oak Ridge City Council on August 20, 2001. By State Law Railroad Authorities are chartered to assist cities and counties to maintain adequate and safe railroad service. The Oak Ridge Railroad Authority has only two Board Members. Both Board members are appointed by City Council. Gordon Fee serves as Chairman and Mike Magill serves as Secretary/Treasurer.

The Heritage Railroad, which the Authority supports, provides the only railroad service to the City of Oak Ridge. It runs from the Heritage Center Industrial Park (i.e. K-25) to the Blair Interchange on the Norfolk Southern main line, a distance of a little over 11.5 miles. Within the site the Heritage Railroad main line serves the intermodal transfer area operated by EnergySolutions, Inc. and a rail car repair area operated by East Tennessee Rail Car Services Company. There is also a spur (See Exhibit A) which serves the old K-25 Powerhouse area S50, 10 acres of which is currently leased by Carbon Rivers, a startup company engaged in recycling windmill blades. The railroad is owned by Heritage Railroad Corporation, a wholly owned subsidiary of EnergySolutions, Inc.

**CAR MOVEMENTS**. For the first nine months of this calendar year, the rail traffic on the line has been 108 cars. On site as of the date of this report are (a) rail cars being used by Energy*Solutions* to transfer waste to and from their processing plant on Bear Creek Road, (b) cars and engines being repaired or awaiting repair by East Tennessee Rail Car Services Company, and (c) historic rail cars and engines belonging to Southern Appalachian Railroad Museum (SARM). A small number of the Energy*Solutions* cars are slightly radioactive and must be stored on a permitted site located on the K 25 S50 Powerhouse spur.

SARM continues to maintain approximately 37 vintage pieces of railroad equipment at Heritage Center. They are still not allowed to operate any excursion trains as a result of an edict by Energy*Solutions* in May of 2016 which directed SARM to stop all excursion trains and to vacate the property. Unfortunately, to date SARM has not been able to find a location capable of supporting their museum operations. SARM continues to seek other locations and the funding needed to move the vintage rail cars.

A summary of the traffic on the line for the last several years is shown in Table 1. The car numbers for the last several years have been relatively low due to the limited number of customers. At this time, the primary customers are Energy*Solutions* and Permafix with outbound shipments to Energy*Solutions* Clive Utah landfill. The third customer is East Tennessee Rail Car Services whose primary business is the repair of railroad cars.

Heritage Railroad and Energy*Solutions* continue to work hard to develop rail opportunities originating from or destined to the Heritage Industrial Park. Over the last year there have been two potential customers that may have a need for significant rail car service. One of these is Carbon Sweep.

Carbon Sweep is hoping to build a biodiesel recycling plant and should that be built Energy *Solutions* is estimating they will generate 5 to 7 Carloads per Week (260-364 carloads annually).

The other new customer is Carbon Rivers. Carbon Rivers is engaged in bringing online a process to recycle used Windmill blades and has leased 10 acres of the Powerhouse area and are engaged in discussions with DOE to purchase a much larger parcel. At the time that Carbon Rivers first began discussions with CROET in the spring of 2022, they were advised that rail service to the area was being terminated in order to eliminate an interference with the City's plans to build an airport at the K-25 site. According to CROET, Carbon Rivers indicated that this was acceptable. However after a review of their business plans, they indicated that they would in fact need rail service and provided Energy*Solutions* with a forecast that they would move 50 cars in 2022, 500 to 800 in 2023 and 1000 in 2024.

In December of 2022 Carbon Rivers, working with Energy*Solutions*, brought in 10 loads of windmill blades using low side gondolas. These first loads demonstrated that using these type of rail cars was not economically competitive with using over the road trucks. To be competitive mid and /or high cube gondolas must be used.

Because of delays in procuring the land, building the processing plant, and finding the right size rail cars, Although the Authority has no official information, it now appears that Carbon Rivers will not have any need for rail service in 2023 or 2024. It is unknown at this time whether there will be any rail traffic in 2025.

## Airport Interference

A major complication with providing Carbon Rivers with rail service is the fact that their proposed site is located at the end of the Railroad's S50 Powerhouse spur. This spur crosses the proposed site for the city airport which is under design at this time. In order to allow the airport to be built the spur must be abandoned and removed or a tunnel built under the runway. In addition to Carbon Rivers, Energy*Solutions* uses this spur to store slightly radioactive cars and Southern Appalachian Railway Museum owns a site that has access to this site.

Energy *Solutions* has reaffirmed its commitment to file for the abandonment of the spur to accommodate the airport. At this time Energy *Solutions* is preparing a cost estimate to make the requisite filings and close the Radioactive Materials License assigned to their storage use of the spur. Energy *Solutions* will require a financial commitment from the city to fund the abandonment. The city in the meantime continues to evaluate building a tunnel or some other alternative to deal with the Interference.

## Consolidated Rail Infrastructure and Safety Improvements (CRISI) Grant Program

The Federal Government in 2020 established a new grant program to further aid the short line railroads in the US. This grant program is primarily open to States. Tennessee submitted grant requests in the last three years but only received \$2,500,000 in 2020 and no funds in 2021. However it was announced in September of 2023 that Tennessee was being awarded \$23.7 million dollars which will be used to pay for upgrading or replacing 42 rail bridges that are past their intended lifespan and in need of immediate repair or replacement across State.

Under the terms of the grant, the Federal CRISI grant will pay 50% of the project costs, TDOT will pay 45%, and the railroad owner must pay 5%.

The Oak Ridge-Heritage Railroad Authority in conjunction with Energy*Solutions* was included in the State's request for projects totaling \$5,402,000. These funds will be used to replace in their entirety three of the five bridges on the main line of the Heritage Railroad and to replace the center span of bridge 4. Energy*Solutions* will provide \$270,100 over a five-year period in matching funds. (See Exhibit B for a Proposed Cost Breakdown.)

As of the date of this report, the Authority has not yet received any information from TDOT as to when funds will be available and whether the Authority will receive 100% of their request.

**TDOT Short line Preservation Grant Program** One of the primary goals of the Railroad Authority is to participate in the State's Short line Preservation program to help fund the maintenance and upgrades needed by the 18 short line railroads which operate in the State. The Authority has participated in this program since 2001 and during that period the State of Tennessee has granted the City \$3,416,651. In order to participate in the program the owner of the railroad, (not the city) must provide a 10% match to the State funds. The \$406,962 granted in 2023 is under contract with JCD Bridge and will be used to upgrade and improve four of the bridges on the mainline. TDOT has already advised the Authority that we should plan on receiving additional grant of \$397,442 in fiscal year 2024. The Authority has been assured by EnergySolutions that they will provide the matching 10% funds and are developing the work scope for this additional grant. A summary of the funds received and planned at this time is shown below.

It is also noted that Energy*Solutions* has had to invest significant dollars to maintain and upgrade the line above what the State provided. However as a result of the States' grant program it has been possible to upgrade the majority of the rail line to the 286 standard which allows the carrying of 286,000-pound cars and loads up to 110 tons.

## **Bridge Inspection Report**

Each year an annual bridge inspection is made by Crouch Engineering to assess the condition of the five bridges on the Heritage Railroad line. This year's inspection was completed in early October and their summary statement was:

"In general, all the bridges on the Heritage Railroad were found to be in fair condition. At the time of this report, there were no repairs noted that would warrant the bridge to be put out" of service and only one problem was recommended to be repaired in next two years.

The majority of the bridges go back to World War days and one of them, is over 90 years old in that the Corps of Engineers moved it from Kingston Tennessee in order to save construction time.

## Financial Audit

A financial audit of the 2022/2023 books was conducted by Brown, Jake, McDaniel, PC. They had no findings.

SUBJECT: Permanent Access to Oak Ridge Turnpike (TN SR-95)

SUPPORTING DEPARTMENT: -None-

## Introduction

An Item for City Council's consideration is the recommendation of a resolution approving a permanent access to Oak Ridge Turnpike (ORTP). The purpose of the access is to provide ingress and egress to a new proposed residential development called Poplar Creek Townhomes.

## Funding

There is no cost to the City associated with this request.

## Background

The development which will have a total of forty (40) townhome type residences will be located in the 2300 block of ORTP. The development is on the south side of ORTP opposite Bradley Avenue.

ORTP at this location is a four (4) lane divided roadway section. There is a median cut available so vehicles traveling to and from Poplar Creek Townhomes will be able to enter or exit from both directions. Based on trip projections three hundred and sixty (360) trip per day can be expected. Site distance is adequate.

Oak Ridge Turnpike is a Tennessee is a state route (TN SR-95) so in addition to local approval the Tennessee Department of Transportation (TDOT) will need to review and issue a state route driveway permit. Urban Engineering Inc., engineering firm of record has submitted a site plan for approval to TDOT.

Section 11.01 (a) (11) of the Oak Ridge zoning ordinance classifies Oak Ridge Turnpike as an arterial street. The Oak Ridge Zoning Ordinance section 11.01 (b) (1) requires approval from City Council for access to streets classified as arterial. Oak Ridge ordinance does not specify or require Traffic Safety Advisory Board (TSAB) approval however City Council typically

requests it. The subject access was presented to TSAB at its October 16, 2023, meeting. TSAB approved the access. The proposed access meets the requirements of the City of Oak Ridge zoning ordinance section 11.01 entitled Vehicle Access Control.

<u>Recommendation</u> Staff recommends approval of the accompanying resolution.



I am drafting this letter to request that the plans be presented to the City's Traffic Safety Advisory Board.





#### Introduction

An item for the agenda is a Resolution authorizing the Police Department to accept a passthrough allocation of Fiscal Year 2023 Violent Crime Intervention Fund grant funding of \$25,000 from the City of Knoxville Police Department.

#### Funding

No local match is required, and no other funding is associated with this project.

#### **Background**

The State of Tennessee has made grant funding available to local law enforcement agencies through the Fiscal Year 2023 Violent Crime Intervention Fund (VCIF). The purpose of the VCIF grant program is to provide support to local law enforcement in developing and implementing proven public safety strategies to combat violent crime. The Police Department is a direct recipient of VCIF funding, which Council approved in December 2022.

The Knoxville Police Department is also a direct recipient of VCIF funding and has allocated \$25,000 of its VCIF funding to the Oak Ridge Police Department to support our inter-agency partnership to investigate and prosecute violent crime. The Police Department proposes to use these funds to send two Police Officers assigned as criminal investigators to the National Forensic Academy (NFA) and purchase three digital cameras and accessories for \$23,881.70. No local match is required for this funding.

• The NFA is operated by the University of Tennessee's Law Enforcement Innovation Center in Oak Ridge. The NFA "is an intensive 10-week training program designed to meet the needs of law enforcement agencies in evidence identification, collection, and preservation. The NFA is offered in-residence, utilizing curriculum developed by leading forensic practitioners from across the United States. Participants will be challenged in the various disciplines through classroom instruction, lab activities, and field practicums in the specialized courses. Academy participants will complete written and in-class competency exams to demonstrate mastery of the subject areas. The goal of the Academy is to prepare the crime scene investigator to recognize key elements and to improve the process of evidence recovery and submission" (University of Tennessee, 2023). The cost for two criminal investigators to attend the NFA is \$14,000.00.

 The Nikon Z7 II digital camera with a 24-200mm lens is a professional-grade, ultra-high performance camera. The Police Department intends to purchase three cameras, which will be issued to three criminal investigators assigned to the Investigations Division to document crime scenes. The cost to purchase the three cameras and accessories from B&H Photo is \$9,881.70.

The described training and equipment will improve investigation capabilities, enhance the identification of suspects and repeat offenders of violent crime, and improve the Police Department's ability to prosecute violent offenders.

- I suggest having the Law Department contact Mrs. Rackard regarding who the City of Oak Ridge requires to sign contracts. It will likely require hers and our new City Manager's signature.

#### Funding

#### Background

#### **Introduction**

#### Funding

Funding for the project as proposed is not to exceed \$380,000.00. The originally approved funding of \$300,000.00 is available through the Community Development Block Grant (CDBG) fund. Capital Improvement Program (CIP) funds designated for Recreation Facility ADA improvements will provide an additional \$60,000.00 and undesignated CIP funds of \$20,000.00, as authorized by the City Manager, will provide the balance of the requested funding.

#### **Background**

City Council approved a resolution to award a contract for design and construction of an inclusive playground at Highland View Park at the April 10, 2023, City Council meeting. The contract, in an amount not to exceed \$300,000.00, was awarded to Recreational Concepts, LLC of Cookeville, TN. Staff provided a project update to City Council at the October 17, 2023, work session. As reported at the work session, costs for inclusive playgrounds are typically higher due to the use of improved surfacing materials, ramps and specialized play equipment designed to make the playground accessible to children of all abilities. Staff are requesting additional funds for the project in order to include these accessibility improvements while still providing a substantial amount of play activity for all children.

An item for City Council's consideration is the accompanying resolution authorizing the City to apply for, and accept if awarded, a U.S. Department of Homeland Security Cybersecurity grant in the amount of \$100,000.00 for the Information Services Department.

#### Funding

This grant requires a 10 percent (10%) match, which is available in the Information Services FY24 budget.

#### Background

The U.S. Department of Homeland Security (DHS) has established the State and Local Cybersecurity Grant Program (SLCGP) as an assistance program that provides funds to build capabilities at the state and local levels through planning, infrastructure investment, and training activities. The program seeks to implement the goals and objectives of state and federal cybersecurity strategies.

The DHS provides a baseline allocation to each state, and the State of Tennessee's FY22 allocation is \$4,244,182.00. The Tennessee Cybersecurity Grant Planning Committee (Committee) approved the State of Tennessee's Cybersecurity Plan on June 29, 2023, thus meeting a key DHS requirement to access the federal grant funding. The Committee has opened an application period for local governments that ends on November 17, 2023.

Staff has been working on the grant application to request funding to support projects/activities that would strengthen the City's capabilities, and which align with the State's cybersecurity plan. These include conducting penetration testing, end of life equipment replacement, cybersecurity gap analysis and training in cybersecurity best practices.

Staff recommends approval of the attached resolution.

SUBJECT: An Amendment to Article 11, Section 11.6 of the Personnel Plan

SUPPORTING DEPARTMENT: Legal

#### Introduction

An item for City Council's consideration is an amendment to Article 11, Section 11.6 of the Personnel Plan of the City of Oak Ridge, titled Military Leave for Reserve Training or Emergency State Service, to increase compliance with Tennessee Code Annotated § 8-33-109.

#### Funding

There are no funding impacts to this change.

#### Background

In order to make Article 11, Section 11.6, Military Leave for Reserve Training or Emergency State Service more compliant with Tennessee Code Annotated (T.C.A.) § 8-33-109, several changes are proposed to the ordinance. A strike-through version showing the current version of the ordinance and the proposed changes is attached. In this memo, the proposed new language is *italicized* with an explanation for the change under the passage.

• Clarification of language to more closely match T.C.A. § 8-33-109

"In accordance with Tennessee Code Annotated §8-33-109, all employees who are members of any reserve component of the United States Armed Forces, including members of the Tennessee Army and Air National Guard, are entitled to a leave of absence without loss of time, pay, General or Emergency leave, or any other rights or benefits to which otherwise entitled for all periods of military service during which they are engaged in the performance of duty or training in the service of this state or of the United States, under competent orders."

This language has been added to the ordinance to more closely resemble T.C.A. § 8-33-109 and to clarify that employees taking military leave are entitled to protections beyond just paid time off such as continuation of benefits.

Removal of amounts of hours equal to 20 working days and clarification of "working days"

"While on such leave the employee will be paid full compensation for a period not exceeding twenty (20) working days during a calendar year, plus any additional days as may result from any call to active state duty pursuant to Tennessee Code Annotated §58-1-106. For employees who work shifts that carry over from one calendar day into the next calendar day, a "working day" is defined as one shift. For example, Fire Department station-based shift employees work a 24-hour shift that crosses over two calendar days which shall be considered one working day for the purposes of this section."

T.C.A. § 8-33-109 states that workers are entitled to 20 working days off during 1 calendar year, but it does not define "working days." Currently, Article 11, Section 11.6 states that 20 working days is equivalent to "a maximum of 160 hours for employees working forty hours per week and 224 hours for Fire Department station-based shift employees." While 160 hours is equivalent to 20 working days for those who work an 8-hour day, this creates issues for shift-based employees. For example, a Police Officer who works 12-hour shifts would only be able to take off 13.33 shifts due to the ordinance specifically stating 160 hours. Even though Fire Department station-based shift employees are allotted 224 hours, because they work a 24-hour shift, that only equals 9.33 shifts.

• Clarification that military leave is unaffected by date of hire or years of service

## "The military leave herein shall be unaffected by date of employment or length of service."

This passage has been added to clarify that employees are entitled to the full 20 working days, regardless of hire date. For example, an employee hired in July would not have their 20 working days prorated to 10 working days just because they started working for the City halfway through the year.

• Adding a provision that employees who exhaust their 20 working days of military leave may use up to 5 days of emergency leave in lieu of general leave or leave without pay

"After twenty (20) working days of paid leave at full compensation, the employee may take up to five (5) days of Emergency Leave in lieu of General Leave for the purposes of not having to take Leave Without Pay."

T.C.A. § 8-33-109 states that employees who use up 20 working days are entitled to use up to 5 days of sick leave in lieu of annual leave or leave without pay. Because the City combines sick leave and vacation leave into one General Leave bank, employees will be entitled to use 5 days of Emergency Leave prior to needing to use General Leave.

This item was taken to the Personnel Advisory Board (PAB) for their consideration and recommendation. The PAB discussed the item at it's October 26 Regular Meeting and November 2 Special Meeting. During the October 26 meeting, members indicated their support for the changes but had questions regarding the use of specific phrases such as "competent orders" and "active state duty." The board voted to table their decision for one week to get clarity. City Attorney Tammy Rackard explained to the board that those phrases were taken directly from T.C.A. § 8-33-109 and that their use was to ensure compliance with state law. The board was pleased with this explanation, and at their November 2 meeting,

unanimously voted in favor of recommending the change be adopted.

<u>Recommendation</u> Staff recommends the proposed ordinance change.

In accordance with TCA-Tennessee Code Annotated §-8-33-109, all employees who are members of any reserve component of the United States Armed Forces, including members of the Tennessee Army and Air National Guard, are entitled to a leave of absence without loss of time, pay, General or Emergency leave, or any other rights or benefits to which otherwise entitled for all periods of military service during which they are engaged in the performance of duty or training in the service of this state or of the United States, under competent orders. upon presentation of official ordersWhile on such leave, the employee will be allowed-paid full compensation leave of absence for required training or duty for a period not exceeding twenty (20) working days during a calendar year, plus any additional days as may result from any call to active state duty pursuant to Tennessee Code Annotated §58-1-106. This would be a maximum of 160 hours for employees working forty hours per week and 224 hours for Fire Department station based shift employees For employees who work shifts that carry over from one calendar day into the next calendar day, a "working day" is defined as one shift. For example, Fire Department station-based shift employees work a 24-hour shift that crosses over two calendar days which shall be considered one working day for the purposes of this section. In the event that the time of such training is optional, the time shall be designated at the discretion of the City. The military leave herein shall be unaffected by date of employment or length of service. After twenty (20) working days of paid leave at full compensation, the employee may take up to five (5) days of Emergency Leave in lieu of General Leave for the purposes of not having to take Leave Without Pay.

All employees who are members of the Tennessee National Guard, upon presentation of official orders, shall be entitled to the same amounts of paid leave during a calendar year from their respective duties on all days during which they shall be engaged in field training ordered or authorized under military code. TCA § 58-1-106 provides that additional military leave will be granted on all days when they are called into the actual service of the State by the commander-in chief.

Every request for military leave is to be submitted as far in advance as practical and must be accompanied by <u>official\_competent\_orders</u>. Until the City has received the <u>officialWithout</u> <u>competent</u> orders, any absence for military training or duty will be charged as <u>leave\_Leave without</u> Without pay Pay or as General Leave until and unless competent orders are received by the City.

#### Introduction

An item for City Council's consideration is a resolution to approve the purchase of server storage equipment, software, and associated services from Insight Public Sector in an amount not to exceed \$98,722.95.

The purchase is being made through OMNIA Partners, a cooperative of which the city is a participating member as authorized by City Council Resolution 9-89-2014. The proposed purchase was discussed and was received favorably at the October 18th meeting of the City Council's Budget and Finance Committee.

#### Funding

Funding for this item is available in the FY2024 Budget in the Equipment Replacement Fund.

#### **Background**

The goal of this project is to continue the process of advancing and renewing the City's storage array infrastructure. This initiative aligns with industry best practices and is expected to significantly enhance the reliability, security, functionality, and performance of the City's virtual infrastructure.

The quote consists of \$64,133.99 for equipment and \$34,588.96 for licensing and software. The system will be included in a regular maintenance schedule, with system refreshes and updates occurring in the third and sixth years. There will also be the option to continue this update schedule as needed.

Importantly, the project is carefully planned to ensure it does not disrupt the City's daily

operations. Any necessary data migrations will be scheduled for after business hours or during non-working days. The implementation is expected to occur over a one-week period with no downtime to services.

#### **Introduction**

An item for the City Council's consideration is a resolution to approve the purchase of new Core network switching equipment from Insight Public Sector not to exceed \$175,185.36. The purchase is being made through OMNIA Partners, a cooperative of which the City is a participating member as authorized by City Council Resolution 6-59-2019. The proposed purchase was discussed and was received favorably at the October 18th meeting of the City Council's Budget and Finance Committee.

#### Funding

Funding for this item is available in the FY2024 Budget in the Equipment Replacement Fund

#### Background

The core switch project will enhance the City's core network by replacing the current core switches, which are at end of lifecycle. This upgrade is essential for bolstering network security and expanding the backbone to support higher throughput speeds of up to 25G.

The quote consists of \$140,274.84 for equipment and \$34,910.52 for licensing and software. To minimize disruption to City employees, the project will be executed in stages and during non-business hours. Information Services staff will communicate with all departments well in advance to notify them of any potential service interruptions caused by the project.

Upon its completion, the City's infrastructure will benefit from improved network capabilities and the capacity to back up data to the "cloud." With this upgrade, the City will gain the ability to store a complete backup of the City's data systems in an offsite, secure, and accessible location, thereby significantly strengthening the City's security and recovery capabilities. <u>Recommendation</u> Approval of the attached resolution is recommended.

SUBJECT: Purchase of Control Panels for Rarity Ridge Wastewater Lift Stations

#### **Introduction**

An item for Council's consideration is a resolution authorizing the City to purchase control panels for the Rarity Ridge wastewater lift stations from Nedrow & Associates, Inc., Murfreesboro, Tennessee in an amount not to exceed \$136,000.

#### Funding

Funding is available through the American Recovery Plan Act (ARPA) funds previously allocated by City Council Resolution 6-69-2022.

#### **Background**

The lift stations in the west end of the City were originally installed during the Rarity Ridge subdivision construction in the mid to late 2000's. The development eventually became the Preserve and is continuing to expand. The original lift station control panels have reached the end of their useful life and need to be replaced. New pump controls can be utilized with the existing equipment in the lift stations to avoid having to replace both the pumps and control panels. This requires the purchase of control panels specific to the already installed KSB pumps. These control panels are available from Nedrow & Associates, Inc. at cost of \$136,000 to replace three control panels. Purchase of different control panels would necessitate changing the pumps as well as the control panel and would incur significant additional costs.

Part of the ARPA funding received by the City came from the distribution to Roane County. These funds are expected to be expended in Roane County and replacement of the control panels in the Preserve development will meet this expectation while making necessary upgrades to City equipment.

#### Recommendation

Staff recommends approval of the resolution as attached. Please note that this is a wave of competitive bids and requires a unanimous vote of Council.
