SUBJECT: TEMPORARY EVENTS WORKSHOP (For Public Hearing and Possible Commission Action at the Meeting of June 13 – 16, 2000)

In May 1993, the California Coastal Commission adopted its "Guidelines for the Exclusion of Temporary Events from Coastal Commission Permit Requirements" pursuant to PRC Section 30610 (i) of the Coastal Act. In previous years and continuing to date, temporary events on California's beaches and adjacent parklands have become the subject of substantial concern. The identified concerns relate to the nature and frequency of such events, their impact on coastal resources and nearby neighborhoods, as well as the public's ability to access and utilize public beaches and parks during such events. However, most of these events do not raise such issues and are part of the history of many coastal communities. For that reason, the guidelines were drafted and adopted to provide direction on the regulation of temporary events for local government representatives, other involved public agency staff, members of the public and the Commission itself. The Commission-adopted guidelines only apply to areas where the Coastal Commission retains permit authority, including public trust lands and areas without certified local coastal programs.

For your reference, the adopted guidelines are enclosed. "Temporary event(s)" are defined as "an activity or use that constitutes development as defined in Section 30106 of the Coastal Act; and is an activity or function of limited duration; and involves the placement of non-permanent structures; and/or involves exclusive use of a sandy beach, parkland, filled tidelands, water, streets or parking area which is otherwise open and available for general public use." Generally, under the guidelines, events may be excluded if they do not occur in the summer, do not occupy sandy beach and do not involve a fee. However, discretion is provided to waive an event meeting all of the criteria under specified conditions and the Executive Director or the Commission may still require a coastal development permit if significant impacts to coastal access or resources is anticipated.

Since their adoption in 1993, the Coastal Commission has conducted a number of special hearings and workshops on temporary events. Although the guidelines have not been modified since their adoption, the Commission did identify specific concerns about charging a fee for paid admission to volleyball tournaments or other events in 1998. In addition to admission fees, other identified issues are the commercialization of such events, the cumulative impacts of multiple events on one weekend or consecutive weekends and the provision of public notices and opportunities for public participation at the local level. Last year, in August, staff provided the Commission with a briefing on temporary events. While no revisions were made to the guidelines at that time, the Commission also requested that a formal workshop be conducted this year on temporary events. In preparation for this workshop, a memorandum was distributed to coastal communities, specifically to planning directors, city managers and special event coordinators, soliciting both information on their community's temporary event calendars and their input on the regulation of temporary events. In addition, a separate public notice was again distributed to local governments and any known interested parties. To date, we have received written responses for ten local governments and two responses from the Orange Coast District/State Dept. of Parks and Recreation. All of the responses are attached for your review.

With the exception of the comments from the City of Manhattan Beach, the respondents either fully support the continuation of the guidelines as presently drafted or they do not cite any specific problems and they do not suggest the need for any revisions. In general, based on a review of the local government/public agency comments and the temporary event calendars, the following observations can be made:

- Vast majority of the events are free to the general public;
- Most of the calendars reflect annual and historical community-based events;
- Although temporary events may occupy prime destination spots, alternate beach locations still remain open and accessible to the general public in close proximity;
- Looking at the peak summer season between Memorial Day and Labor Day, over half of the identified events involve less than 500 attendees, with another quarter of the events ranging from 500-1,000 attendees and a remaining quarter reporting 5,000+ attendees;
- Many of the highest attended events occur outside the peak summer season;
- Most of the local governments agendize these event schedules for City Council, Planning Commission or Parks & Recreation Committee review and approval;
- Most of the local governments also require public notice to surrounding property owners, residents or patrons, as well as noticing at community billboards; and
- All of the local governments require beach clean-up, security or policing services and liability insurance for the larger events.

As mentioned above, we have received one response from the City of Manhattan Beach expressing concern about how the guidelines are used in non-certified areas versus communities with certified local coastal programs. As noted, the Commission's guidelines only pertain where it retains permit authority. For certified areas, the Commission has encouraged local governments to incorporate the guidelines into their implementation plans. The City of Manhattan Beach sought to incorporate the guidelines in 1997 and could not reach agreement with the Commission on how to accomplish that change. While the Commission will certainly continue to work with local governments to incorporate the guidelines into their LCPs, each situation will present its own set of challenges due to the nature of the land use administration system and planning requirements in each community. The City also expressed a concern that the Commission had failed to adequately acknowledge the urban nature of Southern California beaches and should recognize those distinctions and allow greater flexibility.

In summary, while there is certainly a broad array of temporary events occurring, there does not appear to be any discernable trend of usurption or pre-occupation of substantial areas from the

general public. Although temporary events are clearly situated at key destinations along the shoreline, they do not appear to be cumulatively pre-empting those areas and may indeed attract new interests and visitors to the coast. In most communities, there remain ample areas for the general beach visitor to still go and recreate. Finally, while the respondents to date are few and some commissioners have previously expressed a concern that many events are not being reported or monitored, contacts with each Commission office have failed to identify any history of complaints or substantial calls from members of the public expressing any concerns. Although there are certainly some interested parties who have repeatedly expressed concerns over temporary events in a couple of communities, the agency, as a whole, has received little in the way of public opposition to these events. Therefore, at this time, staff would not recommend any changes be made to the adopted guidelines and the Commission continue to monitor temporary events on a regular basis.

SUBJECT: Guidelines For the Exclusion of Temporary Events from Coastal Commission Permit Requirements - Adopted 5/12/93

I. Purpose and Authority.

The purpose of these guidelines is to identify the standards the Coastal Commission staff, under the direction of the Executive Director, will use in determining whether a temporary event is excluded from coastal development permit requirements pursuant to Public Resources Code Section 30610 (i) (as amended by SB 1578, Ch. 1088, Stats. 1992). The guidelines are for use in areas where the Coastal Commission retains coastal development permit authority. These guidelines may be utilized by local governments for reference in developing Local Coastal Programs or in processing LCP amendments, if required, to address coastal development permit jurisdiction over temporary events.

II. Criteria for Exclusion from Permit Requirements.

Except as provided in Section III. below, the Executive Director shall exclude from coastal development permit requirements all temporary events except those which meet all of the following criteria:

- a) Are held between Memorial Day weekend and Labor Day; and,
- b) Occupy all or a portion of a sandy beach area; and,
- c) Involve a charge for general public admission or seating where no fee is currently charged for use of the same area (not including booth or entry fees).

Only temporary events meeting all of the above criteria shall require coastal development permit review, however,

The Executive Director may also exclude from permit requirements temporary events meeting all of the above criteria when:

d) The fee is for preferred seating only and more than 75% of the provided seating capacity is available free of charge for general public use; or,

e) The event is held on sandy beach area in a remote location with minimal demand for public use, and there is no potential for adverse effect on sensitive coastal resources; or,

f) The event is less than one day in duration; or,

g) The event has previously received a coastal development permit and will be held in the same location, at a similar season, and for the same duration, with operating and environmental conditions substantially the same as those associated with the previously-approved event.

III. Executive Director or Commission Discretion to Require a Permit.

The Executive Director, or the Commission through direction to the Executive Director, may determine that a temporary event shall be subject to Commission coastal development permit review, even if the criteria in Section II. are not met, if the Executive Director or the Commission determines that unique or changing circumstances exist relative to a particular temporary event that have the potential for significant adverse impacts on coastal resources. Such circumstances may include the following:

a) The event, either individually or together with other temporary events scheduled before or after the particular event, precludes the general public from use of a public recreational area for a significant period of time;

b) The event and its associated activities or access requirements will either directly or indirectly impact environmentally sensitive habitat areas, rare or endangered species, significant scenic resources, or other coastal resources as defined in Section V. of these guidelines;

c) The event is scheduled between Memorial Day weekend and Labor Day and would restrict public use of roadways or parking areas or otherwise significantly impact public use or access to coastal waters;

d) The event has historically required a coastal development permit to address and monitor associated impacts to coastal resources.

IV. Modifications to Guidelines by the Commission.

The Commission may amend these guidelines at any time if it is determined such modification is necessary to more effectively implement Section 30610(i) of the Coastal Act, and provide Coastal Commission coastal development permit review of any category of temporary events having the potential for significant impacts to coastal resources; or, eliminate such review of any category of temporary events having no such potential.

V. Definitions.

Temporary Events Guidelines Page 3

For purposes of these guidelines, the following definitions shall apply:

a) "Temporary event(s)" means an activity or use that constitutes development as defined in Section 30106 of the Coastal Act; and is an activity or function of limited duration; and involves the placement of non-permanent structures; and/or involves exclusive use of a sandy beach, parkland, filled tidelands, water, streets or parking area which is otherwise open and available for general public use;

b) "Limited duration" means a period of time which does not exceed a two week period on a continual basis, or does not exceed a consecutive four month period on an intermittent basis;

c) "Non-permanent structures" include, but are not limited to, bleachers, perimeter fencing, vendor tents/canopies, judging stands, trailers, portable toilets, sound/video equipment, stages, platforms, movie/film sets, etc., which do not involve grading or landform alteration for installation.

d) "Exclusive use" means a use that precludes use in the area of the event for public recreation, beach access or access to coastal waters other than for or through the event itself.

e) "Coastal resources" include, but are not limited to, public access opportunities, visitor and recreational facilities, water-oriented activities, marine resources, biological resources, environmentally sensitive habitat areas, agricultural lands, and archaeological or paleontological resources.

f) "Sandy beach area" includes publicly owned and privately owned sandy areas fronting on coastal waters, regardless of the existence of potential prescriptive rights or a public trust interest.

Re: REGULATION OF TEMPORARY EVENTS IN THE COASTAL ZONE

Over the past several years, temporary events on California's beaches and adjacent areas have become a subject of substantial concern. The concerns relate to the nature and frequency of such events, their impact on coastal resources and nearby residential neighborhoods, and the general public's ability to get to and utilize coastal recreational lands during such events. Temporary events, such as volleyball tournaments, visual arts and music festivals, surfing contests, boat and auto races, farmers markets, etc. have a long-standing tradition and history in California's coastal communities. As the State's population grows and competition for limited coastal space intensifies and fiscally strapped local governments search for supplemental sources of revenue, conflicts among different coastal users and uses become more significant. Exacerbating the problem is the fact that many event sponsors, whether for profit or charitable purposes, seek to charge entrance fees that, by their nature, result in the exclusion from the event site non-paying members of the public. The Commission recently denied approval of a volleyball tournament that proposed 100% paid seating on the beach in the summer.

While some temporary events raise substantial concerns about adverse impacts on coastal resources, most events of this type are de minimis and raise no such concerns. In order to minimize permitting burdens for the vast majority of temporary events that do not raise Coastal Act concerns, the Commission sought and received legislative approval to utilize procedures to <u>exclude</u> such events from coastal permit requirements. The attached guidelines were adopted by the Commission in 1993 to identify those types of temporary events which have the potential for significant adverse effect on public access and/or coastal resources and which, as a result, require a coastal development permit.

The Commission recently held a workshop and received public testimony on whether the guidelines should be changed. Subsequent to the hearing, Commission staff, based on Commission direction, determined <u>not</u> to amend the guidelines <u>at this time</u>. However, testimony at the hearing did suggest that the guidelines fail to address the cumulative impacts these kinds of events are having on public access to and recreational use of the shoreline. Concerns were raised about the number and size of events, impacts on public parking, noise, advertising, etc. The Commission heard from citizens that these concerns are not being adequately addressed at the local level and that there may be inadequate opportunities for the public to raise these concerns through a public hearing process.

The Coastal Act gives both the Coastal Commission and local governments the responsibility to implement coastal protection policies through the planning and regulatory processes established by the Act. The Commission believes that most of the concerns raised in connection with the impacts of temporary events can best be addressed at the local government level. Obviously in doing so, Coastal Act policies designed to protect coastal resources need to be addressed. The Commission-adopted guidelines relative to temporary events <u>only</u> apply to areas where the Coastal Commission retains permit authority, including public trust lands and areas for which there is no certified Local Coastal Program (LCP).

The Commission has asked that staff contact its local government partners in coastal stewardship to request that you review your local regulations affecting temporary events. The intent is to ensure that every LCP contains implementable land use policies that specifically address the protection of coastal resources consistent with Coastal Act policies. These policies should, for example, deal with potential impacts on parking and traffic affecting public beach access, visual amenities, the recreational and free use of public beaches, impacts on environmentally sensitive habitat, and the cumulative affects of multiple events, especially during the high-use summer season. Coastal development permits should be required for those temporary events having the potential of significant adverse effects on coastal resources. In addition to the range of issues your jurisdiction deals with as a matter of primarily local concern , Coastal Act policies and the Commission's guidelines should be used to help shape your approach.

We realize that many local governments have dealt with temporary events long before the Coastal Act was enacted. It is our intent to work in cooperation and coordination with you so as to avoid duplication of effort, to reduce regulatory burdens for event sponsors, and to minimize conflicts in policy direction. As you consider our request, we would also appreciate it if you would assist the Commission in meeting its responsibilities by notifying promoters of temporary events that a coastal development permit may be required from the Commission for certain types of events, and that they should contact the appropriate Commission office for guidance on whether a coastal permit or permit exemption is required. To the extent possible, Commission staff is available to provide any assistance you may deem helpful and appropriate. SUBJECT:

Request for information on annual or special temporary events traditionally occurring without issuance of Coastal Development Permit in unincorporated San Mateo County area's Coastal Zone.

Your memo dated April 24, 2000 requested any information on special, temporary events that occur within the Coastal Zone that have not traditionally required Coastal Development Permits. While you will need to contact the City of Half Moon Bay about their annual and well-attended Pumpkin Festival which happens in their downtown area, we know of only two such events in unincorporated areas (see attached map):

- Annual Mavericks Surf Event This annual surfing event occurs in early March out near Pillar Point (which forms the southern boundary of the Fitzgerald Marine Reserve), with the actual date of the event being never the same and wholly dependent on the weather conditions and their impact on the surf & wave height elements. This event can draw anywhere from a 200 to 2000 people, who assemble near the surf and on top of the bluffs to view the 1-2 day surfing competition. This event probably carries the greatest potential adverse impact to coastal resources, due to the assemblage of the crowds at the shoreline and on the upper bluffs. However, we've not received any complaints from neighbors regarding impacts.
- 2. <u>Pacific Coast Dream Machines</u> This annual event occurs generally on the last weekend (Saturday/Sunday) of April and is held at the Half Moon Bay Airport. It generally draws 3,000 10,000 people throughout the weekend. Due to its containment on the airport grounds and distance from any coastal resources, we doubt that it presents any risk for adverse environmental impacts.

I hope this information is helpful to you. While I'll likely not have more time for any additional research, I am available for questions at 650/363-1837.





Dear Ms. Lee,

Thank you for the opportunity to provide comment for the upcoming workshop. As expressed in past correspondence on this issue, the City of Manhattan Beach does not have any strong objections to the Commission's existing guidelines. We realize that the guidelines only apply to areas without certified coastal programs, however we feel that the Commission's approach to temporary events has been inconsistent. The manner in which these events have been regulated between LCP certified cities, and those communities that don't have certified coastal programs, has been quite varied.

The City of Manhattan Beach LCP does not adequately address the issue of temporary events. In an effort to correct this, and to streamline the permit process for the annual Manhattan Beach Open Volleyball Tournament, the City attempted to incorporate the Commission's guidelines into the certified LCP in 1997. The suggested modifications ultimately approved by the Coastal Commission comprised six and a half pages of regulation. The implementation of these regulations would have created an impossibly long process for the most benign events, and had an inordinate impact upon staff resources. The City elected not to pursue this amendment. In contrast the City of Hermosa Beach, without a certified LCP, was able to step up and process a Coastal Commission issued permit for the same event with little or no controversy. If the Commission feels that the guidelines, as adopted, are sufficient for non-LCP areas then why is there debate as to their effectiveness in areas with certified coastal programs?

The Commission, as evidenced in past discussion (Santa Barbara, June 1999), does not seem to recognize the difference in beach usage between Northern, Central and Southern California. Volleyball, as well as other recreational games and activities, are part of the history and normal activity of the South Bay beaches (Santa Monica, Manhattan, Hermosa, and Redondo). These are urban beaches located adjacent to the most populous county in the State. These are not rural, underutilized stretches of Marin County that seem to serve as certain Commissioner's prototype of what constitutes a public beach. For this reason, the City strongly believes that regulating

temporary events is a local issue and the role of the Coastal Commission should be limited to that of oversight. Each community supports different types of temporary events depending upon the environment and demands of its citizens. What is appropriate and acceptable in Manhattan Beach may not be in Monterey. Therefore any guidelines adopted by the Commission should recognize these differences, and provide the necessary flexibility.

The Commission and staff continue to create a separation between temporary events and members of the "public". In your correspondence you refer to the issue of temporary events impacting the "public's ability to access and utilize public beaches". It has always been the City's belief that temporary events actually encourage the "public" to visit and utilize beach resources. The Commission's assumption appears to be that temporary events have the opposite effect of displacing beach visitors.

It was brought to our attention that at the Coastal Commission meeting of August, 1999, during a discussion of temporary events (Item 6 c under "South Coast District"), the City of Manhattan Beach comprised the majority of all scheduled temporary beach events submitted to the Commission. With coastal cities such as Los Angeles, San Diego, San Francisco, Huntington Beach, Santa Cruz, etc....we find it difficult to believe that, with a total population of approximately 33,000, the City of Manhattan Beach is the State's foremost location for temporary beach events. We find it much more likely that other communities are not as forthcoming with this information.

In closing, the City strongly feels that the regulation of temporary activities should be left to the determination of local jurisdictions. The overwhelming majority of temporary activities are private social functions which have no impact on our Coastal resources. Should the Commission choose to adopt revised guidelines it is our hope that the exercise of local discretion is built into these revisions. The usage of inflexible and strict guidelines for a State as large and varied as California does not appear to be a workable solution.

- All events are strictly monitored via Community Resources, Police and Fire Department staff who attend each event for the duration. Pre and post event meetings are conducted to address all operation and safety issues.

The following are events that have applied to the city and will likely receive Specific Event Permits during the year 2000. These are annual events. While additional events may be added during the year, these are typically the larger events that take place on the city beach. The Beach Division of the Community Services Department also issues permits for small events throughout the year, which are primarily surfing and volleyball events. I have attached a list of those events.

In terms of the relationship between public services in the community and events, the smaller events typically do not require any additional public facilities or services. When an event is of a larger scale, the event organizers are required to make provisions for public services such as by providing additional restrooms. All events are free to the public.

We are confident that all temporary events are being reported and monitored.

California Fitness Challenge

Date: May 7, 2000 Participants: 150 Spectators: 100 Description: Fitness competition including a three mile run, pull up contest, push up contest and obstacle course to benefit Challenged Athletes Foundation.

Duck a Thon

Date: May 20, 2000 Participants: 50 Spectators: 3000 Description: 3000 rubber ducks are launched from the Huntington Beach Pier to race back to shore. Benefit for the Huntington Beach Community Clinic.

Pro Beach Hockey

Date: Weekends, May 20 – June 11, 2000 Participants: 100

Spectators: 1000 per day

Description: 3rd annual exhibition roller hockey located on the north side of the Huntington Beach Pier. Six competing league teams play a ten-game regular season followed by semifinal and final playoffs. Free to the public, complete with grandstands and demonstration areas.

Panasonic Beach Games

Date: July 19-23,2000 Participants: 250 Spectators: 15,000 per day Description: Surfing, skateboarding, BMX and in-line skating competitions, vendors, music and grandstands.

Bluetorch Pro



APPENDIX A

POLICY I.5

ADVERTISING, ENDORSEMENTS, AND SPONSORSHIPS (Amended 5-4-94)

The Commission and the Department shall actively solicit endorsements and sponsorships for parks, facilities, publications and services from businesses, individuals, and other entities. Such endorsements and sponsorships will cover all present and future costs and provide revenue to the Department. Sponsorship of special events shall entail sufficient funds to cover the costs of the events. Generally, units of the State Park System are not considered venues for advertising. However, acknowledgment of sponsorship may include display of corporate logos, products/services, or other identifying signage.

Display of corporate logos, products/services, or other identifying signage shall not degrade the natural and cultural resources of the unit or interfere with the visitors' enjoyment of the parks' aesthetic values. The Director shall have developed guidelines which prevent such degradation and interference.

No advertising or sponsorship of tobacco products or alcoholic beverages is permitted without the express approval of the Director.

The Director shall report to the Commission at regular Commission meetings on the status of existing and potential sponsorships.

PURPOSE: The Orange Coast District recognizes the desire of various organized groups to hold surfing competitions at specific surfing breaks within units of the District. It is within the authority of the California Park Service to allow special events that are compatible with the recreational resource. Such events are permitted through a process that defines the scope of all activity related to the event. A special event permit must be approved for every surf competition held on any beach within the Orange Coast District.

HOW: APPLICATION PROCESS: Applications for contest dates will be accepted on a calendar year basis beginning on the first business day of January, at 9 AM. Contests will be assigned on a first come, first served basis priority, except that individuals applying for the same month/time will be allocated by lottery if alternatives can not be agreed upon between the parties involved.

Events at TRESTLES will be assigned with primary consideration given to one Amateur, one Pro/Am, and one Professional event. Events in each category will be assigned on the basis of greatest financial benefit to the State. If two or more groups propose equivalent scale events, those groups will be required to submit sealed bids detailing revenue enhancements guaranteed to the State if selected. The event will be awarded to the highest bidder-

EXCLUSIVE USE: Events requesting EXCLUSIVE USE of the water area will require a State Park Peace Officer on scene during contest hours. The cost of this service will be added to applicable permit fees. All contests at TRESTLES are exclusive use and permit fees include peace officer costs. The water area will be cleared of non-competitors 5 minutes prior to the scheduled start of the first heat at exclusive use events.

EVENT SITE: Event organizers must submit an event layout plan detailing scaffolding, seating, tents, fencing, etc. Public address systems must be maintained at low volume such that announcements do not carry more than 100 yards beyond the contest perimeter. Advertisement and sponsor banners must be attached to event structures. No free standing advertisements (inflatable signs) are permitted. Organizers are responsible for overnight security. The boundary of the

184

designated surfing area must be marked with clearly visible flags on the beach in a manner prescribed by the State's representative. Events at TRESTLES require boundary buoys outside the surfline. No amplified music is permitted.

HOURS:

may be permitted at any break except TRESTLES, which shall be no more than 9 hours per day, from 8:00 AM to 5:00 PM only. No event will be longer than five (5) consecutive days at any location. Events at TRESTLES may occupy only on day of any weekend.

A maximum of 11 hours per day

Access for the purpose of erecting

ACCESS:

event apparatus may be granted 24 hours before event startup. All apparatus must be removed within 24 hours of event completion. A maximum of three vehicles may be permitted at the CHURCH or LOWERS contest sites. Events at LOWERS may use a shuttle to transport event staff and provide handicapped access. The shuttle may make no more than two trips per hour during the event. Speed limit on the beach access road is 5 MPH.

FREQUENCY OF EVENTS: Generally, events are held at any beach when they do not adversely impact the general public's access or use except as noted below:

1. San Onofre State Beach:

Trails: One event per month, 12 per year, no back to back

weekends.

Surf Beach: No events between July 1 and Labor Day, otherwise one per month, 10 per year, minimum two weekends between consecutive events.

Church: Same as Surf Beach. May not run events on same days as any event at Trestles.

Trestles: No events between July 1 and Labor Day. Maximum of three events per year. Minimum of two weekends interval between consecutive events

2. All other units:

Contests will be permitted in accordance with the Department's general guidelines for special events as well as any limitations, restrictions, or regulations imposed by the California Coastal Commission. Such conditions will also apply to events at San Onofre State Beach.

PERMIT FEES:

Trails: Amateur \$250 per day. Pro/Am -Pro \$500 per day. Surf Beach: Same as above.

Church: Same as above

Trestles: Amateur \$1,500 per day. Pro/Am \$2,000 per day. Professional \$3,000 per day.

All other locations/units: Amateur \$200 per day. Pro/Am \$300 per day. Professional \$500 per day. These are minimum rates which are subject to higher negotiated charges.

PARKING:

Parking fees will be charged to contestants and event visitors. Parking fees for event promoters are waived as it is included in the permit fees. Each event promoter will be limited to the number of passes for his/her crew based upon the size, nature and location of the event. The parking lot for Trestles events will open 90 minutes before a contest begins and close at dusk. A minimum of three event staff will be on duty in the lot at all times to coordinate parking, provide security and direct visitors.

MODIFICATIONS: Modifications to any provision of this policy may only be granted in writing by the District Superintendent after consultation with the appropriate section supervisor. Modifications will be incorporated into the special event permit for the event and require the District Superintendent approval.

The policy for sale of alcoholic beverages at special events in units of the Off Highway Motor Vehicle Recreation Division (OHMVR) requires different procedures established by the California Off-Highway Motor Vehicle Recreation Commission. See Sample I, OHMVR Commission Policy Number 6, for guidelines.

PERMITS FOR HAZARDOUS EVENTS

For special events of a hazardous nature (e.g., OHV event, boat races, moto-cross races, fireworks shows, etc.) the permittee must carry liability insurance for a minimum amount of \$500,000 Combined Single Limit, or \$1,000,000 Combined Single Limit, depending on the type of activity. District Superintendents should consider "hazard to general public" when determining if an event is "hazardous" as opposed to "hazard to participant" (e.g., moto-cross races with large number of spectators).

Since all special event permits for hazardous events must be approved by both the Regional Director and the Department of General Services, the permittee must allow sufficient lead time for processing to be completed.

- 10. Any other considerations as appropriate.

The District Superintendent will charge the permittee a percentage of the gross profit from 10-25% for events designed to generate revenue with a profit-making incentive. Fees charged will be dependent upon the category of the event listed below:

- 1. Department or co-sponsored Department absorbs cost.
- 2. <u>Charitable nonprofit</u> Department recoups operating costs.
- 3. Nonprofit (non-charitable) Sliding scale 10-25% of gross profit.
- 4. <u>Commercial</u> Sliding scale charging between 10-25% of gross profits evaluated on a case-by-case basis considering factors listed above.

Fees may be waived for nonprofit events that are compatible with and contribute to the Department's community involvement goals.

DAMAGE DEPOSIT

The District Superintendent may charge the permittee a damage deposit in an amount at his/her discretion based on the activity and probability of occurrence. Costs for damage repair and any fines or penalties for noncompliance with permit conditions will be deducted from this deposit. The District Superintendent (or designee) may authorize refund of all or a portion of the damage deposit.

REPORTING PROCEDURES

Any fees collected in connection with the permits are reported on a Report of Collections, DPR 197, with the source properly identified. The DPR 197 is sent directly to the Accounting Section's Cashiering Unit accompanied by either the remittance itself or a Report of Deposit (STD. 442 or 443).

- 3. Provide Written Guidance—Provide a letter well in advance of the event, including details such as time, location, directions, and/or a map, where to park, the expected role for the elected officials, an event schedule, the name of the contact person at the special event, and how they are to find the contact person upon arriving at the event.
- <u>Confirm Attendance</u>—As practical, call a few days ahead of the event and confirm attendance. Discuss any last minute details.

D. Day of the Event

- <u>Contact Person</u>—Have a DPR employee assigned to meet elected officials. This should be the contact person previously named. If possible, this person should not be assigned other duties which could interfere with being available to assist the elected officials.
- <u>Contact Station</u>—Be sure that the contact station operator is briefed and has a list of those who are to be provided free entrance to the event. The contact station operator (if applicable) can guide the legislators and officials to the contact person.
- <u>Refresh Roles</u>—Upon meeting the elected officials, the contact person should brief them on the status of the event, refresh understandings of their roles in the event, provide name tags, and take care of any special needs.

E. Event Follow-up

1. Write thank you letters and also invite the elected officials to come and visit the parks in the area later.

As shown, most of the events occur during the non-summer months. They are relatively small and are mostly sponsored by non-profit organizations. The primary goal of the City has been to promote our beaches for the public's enjoyment. None of the events require a fee to attend and they are all open to the general public.

It is the City's policy to present proposed events, that may be of public concern, to the City Council for their action in order to provide the public with the opportunity to give input on proposed special beach events. Small events, such as a small scholastic surf contest are approved administratively. The cumulative impact of the events is considered as part of the review/approval process.

In regard to your question: "the relationship of temporary events to the provision of public services in you community", none of the events require City assistance or public service, other than customary permitting, public safety, and beach cleaning services.

While a representative from San Clemente will not be attending the Commission's meeting in June 2000, we appreciate the opportunity to assist with this information and comments.

This letter is in response to your request for information regarding temporary events. The City of Encinitas Municipal Code includes a section that addresses the production of special events within the City. In addition, the Community Services Department has a policy related to special events held at Moonlight Beach. A copy of these documents are attached for your reference.

The Community Services Department of the City of Encinitas is responsible for providing quality recreation and leisure services to its citizens. Part of that responsibility is to produce certain special events at Moonlight Beach. Each year, the Department holds a summer concert series at the beach, usually during July and August. This is a series of four concerts, featuring entertainment that is enjoyed by a broad spectrum of Encinitas citizens. In addition to the concert series, the Department produces the annual Encinitas Day Celebration each October, celebrating the anniversary of the City's incorporation. All events are free to the public.

The City Council is the issuing authority for all special event permits, and reviews and approves each application after review and recommendations by affected City departments. This includes permits submitted by both the public and by City departments.

As of this date, there has been one special event held at Moonlight Beach during 2000, with applications pending for an additional seven events. A list of these events is attached. The list includes either historical or projected attendance at these events.

CHAPTER 6.16

OPERATIONS PERMIT: OUTDOOR ASSEMBLAGES

6.16.010 Purpose.

A. It is the purpose of this chapter to subject outdoor assemblages to reasonable regulations designed to permit such assemblages to be held while assuring the safety and well-being of the participants, persons attending, neighbors and the general public. (Ord. 87-29)

B. It is unlawful for any person to commence, conduct, manage, participate in, advertise or sponsor an outdoor assemblage without first having obtained an Operations Permit: Outdoor Assemblage.

C. Notwithstanding the provisions of this Chapter, proposed activities shall be subject to Zoning Regulations and Coastal Development requirements, pursuant to Title 30 of this Code. (Ord. 94-06)

6.16.020 Definitions

A. "Outdoor Assemblage" means any outdoor event to which members of the public are invited or admitted for a charge or free of cost and which is attended or expected to be attended by more than 500 persons other than:

1. An event which is held in a permanent facility for which a use permit has been issued pursuant to the appropriate sections of this Code for the operation of an amusement park, open air theater, racetrack, commercial sport or recreational enterprise, circus, carnival or fairground; or

2. An event which is held on property owned by or under the control of a public agency and which is held pursuant to a permit, license, or lease approved by the governing board of said public agency, which permit, license or lease contains specific authorization for said event.

B. A "public agency" includes counties, cities, municipal corporations, political subdivisions, public districts and public agencies of the State of California.

C. "An automobile parking space" when required by this Chapter means any prepared space with not less than 144 square feet of usable area, and not less than 8 feet on any side; located on or contiguous to the land on which the outdoor assemblage is conducted.

<u>6.16.030</u> Issuing Authority. The City Manager is the issuing authority for Operations Permit: Outdoor Assemblages.

6.16.040 Application. An application shall be filed no less than 25 working days prior to the proposed date for the outdoor assemblage.

6.16.050 Regulations

A. The permittee shall be required to provide:

1. Adequate lighting;

2. Provisions for cleaning up the premises after termination of the outdoor assemblage;

3. An emergency communications system sufficient to meet the reasonable, emergency requirements of the sheriff and the fire chief;

4. A means for assuring that the number attending the outdoor assemblage does not exceed the number allowed by the permit;

5. Such other conditions as the City Manager finds necessary for reasons of health, sanitation, supply of food, supply of water, prevention of unreasonable noise, or the promotion of the general welfare.

B. The permittee shall provide drinking water which shall be wholesome, potable and from a source holding a valid permit from the California State Department of Public Health or the San Diego Department of Public Health Services. The permittee shall provide:

1. One drinking fountain for the first 100 persons;

2. Two drinking fountains for more than 200 but less than 500 persons;

3. One additional drinking fountain for each additional 500 persons or fraction thereof;

4. Each drinking fountain shall be equipped with a guarded angle jet orifice;

5. If the Health Officer finds that lesser or different facilities are sufficient instead of the above, the permittee shall provide such facilities.

C. The permittee shall provide at least the number of water closets, urinals and lavatories determined by the issuing authority to be sufficient for meeting the demands of the proposed event.

D. The permittee shall provide the number and type of garbage and trash containers determined by the issuing authority to be necessary to satisfy the demand created by the proposed event.

E. The permittee shall provide parking spaces on-site or adjacent to the premises in a number equal to one-fifth of the number of persons which the permit authorizes to attend the event unless the issuing authority finds that a smaller number of parking spaces is sufficient. The automobile parking spaces shall be graded, marked and separated by a physical barrier from the area where the patrons will attend the event. At all times between one hour before the beginning of the event and one hour after its termination, the permittee shall provide parking attendants at all entrances, exits and within the parking lots.

F. The permittee shall provide at every outdoor assemblage one security guard approved by the sheriff for each 200 persons which the permit allows to attend, whether actually present or not. The required security guards shall be constantly in attendance during the entire time the event is in progress and shall devote their entire time and attention to keeping order, and observing and enforcing all applicable statutes and ordinances to include the conditions in the permit. The sheriff shall approve a security guard unless the sheriff finds that the individual is unable to perform the duties specified in this Chapter.

G. The permittee shall provide all fire protection and fire safety measures found necessary to protect those attending the event by the fire chief.

H. Within 72 hours after the end of the event, the permittee shall clean up the premises and remove all trash and debris therefrom.

I. The permittee shall operate the event only on those days and during the hours specified in the permit.

J. The permittee shall prevent the entrance of and shall not admit to the premises on which the event is held any person who does not possess a ticket except a peace officer or other public officer in the performance of the public officer's duties. Admission shall be by ticket only. The permittee shall not sell, give or distribute a greater number of tickets than the number which the permit allows to attend. The permittee shall not admit any person to any event if such admission would result in a greater number of persons present than allowed by the permit.

K. The permittee shall not allow a person to enter, be or remain on any part of the premises on which the event is conducted if such person is in the possession of, consuming, using or under the influence of any alcoholic beverage or drug.

L. The permittee shall use such methods of dust control as are required by the permit to prevent the arising of dust to an extent that may endanger the public health or safety.

M. The permittee shall provide all exterior and interior access ways which the City Manager finds necessary for the use of participants at the event. All exterior and interior access ways shall be clearly delineated by means of curbs or buffers on the ground. The permittee shall insure that no person occupies any such access way except for the purpose of access or to cross the same.

N. In selling, preparing, delivering and serving food or beverages or both, the permittee shall comply with all applicable health regulations.

I. POLICY STATEMENT

Moonlight Beach may be used as a venue for Special Events, as defined below, subject to conditions set forth in this policy.

II. <u>PURPOSE</u>

To develop and implement policies and procedures for use of Moonlight Beach as a Special Event Facility.

III. <u>DEFINITION</u>

A Special Event is defined by at least one of the following criteria:

- 1. Greater than 500 expected attendees;
- 2. Greater than 30% usage of the Moonlight Beach facilities area;
- 3. Any use of live or recorded amplified music;
- 4. The inclusion of five or more activity booths; and/or
- 5. Use of a stage.

IV. <u>METHOD</u>

The use of Moonlight Beach as a site for Special Events is subject to the following conditions:

Applications for Special Events scheduled during peak use months (Memorial Day weekend through Labor Day weekend) are required to be submitted no later than December 1 for reservations for the following year. A listing of events scheduled within peak use time shall be sent by the Community Services Department to residents within 300 feet of the perimeter of the site on or around April 15 of that year. Any citizen requesting notification in writing may also receive the listing of events. In addition, a schedule of events will be posted at Moonlight Beach on the display board. (Effective December 1, 2000)

1.

- 2. Applications for Special Events scheduled during non-peak use months must be submitted no later than 60 days prior to the event, but no more than 6 months prior to the event.
- 3. No generators shall be used for any purpose. Any requested amplification for music shall be powered by existing outlets through available circuits only and subject to the City's noise ordinance requirements (Ordinance #90-22).
- 4. Amplification for Special Events shall not be allowed earlier than 10a.m. nor later than 5p.m.
- 5. All permitted events shall pay for maintenance required to accommodate the production. A \$300 deposit in the form of a cashier's check payable to the City of Encinitas will be required prior to issuance of a permit. Any funds not used will be returned to the producer. In addition, an itemized statement of expenses for event maintenance requirements will be provided.
- 6. All applicants will be responsible for costs associated with security and compliance monitoring. Security and compliance monitoring requirements will be established during the permit application process.
- 7. In addition to these conditions, all applicable procedures set forth in Community Services Department Policy CS A021 remain in force and must be adhered to when making an application for a Special Event at Moonlight Beach.
- 8. The Parks and Recreation Commission shall conduct an annual review at their September meeting of the number and type of events, their impact on the neighborhood and effects on public access. The Commission will determine if event impacts suggest the need to limit the number and types of events to be approved in the following year. The Commission recognizes that the use of Moonlight Beach as an event venue impacts the surrounding neighborhood and public access to the beach for recreational use. Therefore, a noticed public hearing will be held annually to review

events and neighborhood impacts. Public input from citizens and event sponsors will be solicited as part of their annual review.

Dear Ms. Lee Deborah

The City of Coronado is responding to your request for information regarding future temporary permits expected to be processed within the community within the Coastal zone as well as past permits.

Over the past nine years the City has processed at least one or two special event permits during the summer months for the Hotel del Coronado. These special event permit requests are typically large in scale (over 800 attendees), are for a short duration (less than one week), involve temporary structures on private and public property, and are received on very short notice prior to the event. In the past, we have processed coastal permit exemptions for these special events and have notified the Coastal Commission of the determinations.

The City of Coronado ensures that the public's lateral access of the beach will not be impacted with the activity and that permanent barriers are not installed to preclude access along the beach as well as for safety vehicles. We have in the past required additional trash facilities on the beach and private property as well as additional security personnel (if activities go into the night). Grade changes are not permitted. Notification is sent to surrounding properties, and if music is involved, requests have been made for hours of limitation, certain locations for music, etc. We also require information on guest/bus arrivals, occupancy levels, etc. to ensure the event does not result in deficient on-site parking, or if necessary, additional provisions for off-site parking impacts to minimize parking on surrounding properties. We would anticipate at least one or two major events for the Hotel del this year as in past years. The City of Coronado Recreation Department also issues permits for wedding ceremonies on the beach and Public Park. These events are small scale, last approximately 3 hours maximum (including set-up and take-down) and occur throughout the year. If necessary, those numbers and an estimate of numbers can be obtained.

Unfortunately, the City of San Diego/Park and Recreation Department is unable to send someone to the June 13-16, 2000 Temporary Events workshop. Please accept this as our input that we have found the May, 1993 Guidelines to be very workable and we would like to see them continued, unchanged.

Attached is our list of calender year 2000 temporary events at the City of San Diego's beaches, shoreline parks and Mission Bay Park. As you can see, we permit hundreds of special events, from free concerts to beach community street fairs, and from over-the-line tournaments to marathons. You will note from the "Event Fee" column, that direct revenue from special events is very minor and offsets little of the \$8 million cost to the City's General Fund for the Park and Recreation Department to maintain these park and beach areas. However, the City of San Diego's tourism economy benefits greatly from coastal area special events, both directly in terms of hotel room taxes and sales taxes from visitors to the large, national and international events, and indirectly because these events contribute to the reputation of San Diego as a capital of year-round, outdoor sports and recreation.


