ORDINANCE NO. 2643 OF 2019

AN ORDINANCE OF THE MUNICIPALITY OF PENN HILLS, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA, AMENDING CHAPTER 1042 OF THE CODIFIED ORDINANCES OF THE MUNICIPALITY OF PENN HILLS, ESTABLISHING A REVISED RATE SCHEDULE FOR SEWER USAGE SERVICES AND THE CUSTOMER SERVICE CHARGE.

WHEREAS, The Municipality of Penn Hills desires to amend The Sewer User Rates and The Quarterly Customer Service Charges on all Sanitary Sewer Users; and,

NOW, THEREFORE, THE MUNICIPALITY OF PENN HILLS HEREBY ORDAINS, IN A MEETING DULY CONVENED. THE FOLLOWING:

Section 1: Chapter 1042, Section 1042.02 and 1042.16 of The Codified Ordinances of The Municipality of Penn Hills is amended to read as follows:

THE CUSTOMER SEWER CHARGE SHALL BE IMPOSED FOR EVERY THREE MONTH PERIODS THEREAFTER (QUARTERLY).

If any court of competent jurisdiction shall declare any words, sentences, sections or provisions of this Ordinance to be invalid, such a ruling shall not affect any other words, sentences, sections or provisions of this Ordinance not specifically included in said ruling.

Section 3: Repealer. All Ordinances, or parts of Ordinances, in conflict with the provisions of this Ordinance, are hereby repealed to the extent of such conflict.
