

I, Steve W. Chriss, being duly sworn on oath, depose and say:



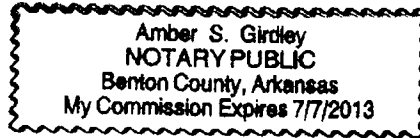


