ABSTRACT

This directory provides information on 56 state units on aging and 599 Area Agencies on Aging, listed alphabetically by state. A map of each state is provided so that users can determine the planning and service areas (PSAs) covering their communities or counties. A director's name, address, phone number, description of area agency structure, and whether or not it controls nutrition funds under the Older Americans Act is provided for each Area Agency on Aging. The listing for each state also specifies which of the 10 Federal regions the State belongs to; in a separate listing information about each of the Federal regions is provided.

PREFACE

Requests come in each week from members of the Select Committee on Aging, other Members of Congress and the general public about whom to contact in a particular State or community about aging programs.

Under the Older Americans Act, each State has established an office on aging, and most States have in turn designated Area Agencies on Aging to serve older people in specific communities. These are the agencies to which the Committee refers most of these inquiries.

Until now, no easy reference tool existed to permit the identification of these agencies and the people in charge of them. That is the purpose of this directory.

The publication of this document owes much to many individuals. Yvonne Alston and, in the crucial early stages of the work, Nancy Smythe, handled the bulk of the Aging Committee's compilation of accurate and timely information. State agencies were surveyed twice by mail, and followup calls made, in a very professional manner. Ed Howard, also of the Committee staff, coordinated their work. We are indebted to two others. Kay Samec, liaison officer for the National Association of Area Agencies on Aging, contributed a great deal of time and expertise to the project, and much of the final document's usefulness is directly attributable to her and her organization. Robert Bostick of the Congressional Research Service directed the graphics work, and I believe that the individual State maps are as well executed as any I have seen in any project of this type.

Nor would the directory have been possible without the full and prompt cooperation of State and Area Agencies on Aging across the country, who provided much of the initial information and reviewed an early draft of the directory.

The directory lists 56 "State" units on aging and 599 Area Agencies on Aging. The listings are, to the best of our ability, accurate as of November 1, 1978. With that many entries, it is inevitable that many changes will be necessary in a relatively short time. It is our hope that another organization, perhaps the National Association of Area Agencies on Aging, will undertake the task of keeping this information up-to-date in the future.

I trust that the directory will be a useful tool for all of us as we try to improve the lives of older Americans.

INTRODUCTION: HOW TO USE THIS DIRECTORY

The Select Committee on Aging is pleased to share the information contained in this Directory of State and Area Agencies on Aging.

To find the agencies and officials in a particular community, begin with the alphabetical listing of States in the Table of Contents. The Directory lists the name, address and phone number for the State office on aging and the name of its director. Also contained is a map of the State, from which you can determine the planning and service area ("PSA") covering the community or county in which you are interested. An Area Agency on Aging has been designated for most PSA's, and the directory lists the name, address and phone number of each Area Agency, along with the name of its director. Included for your reference is a description of the area agency's structure (government agency, council of governments, private non-profit group, etc.) and whether or not it controls nutrition funds under the Older Americans Act.

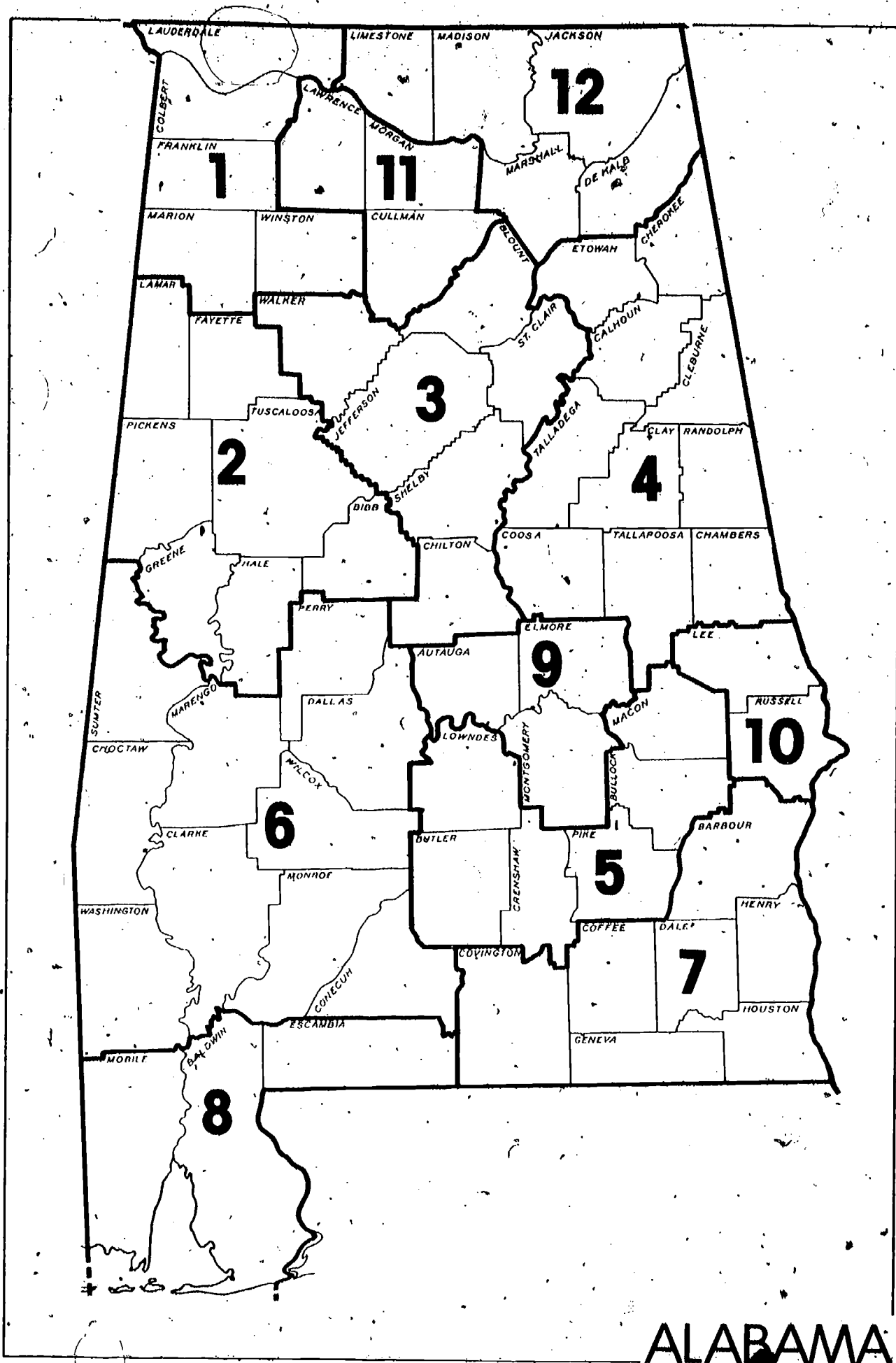
You will note that seven States have chosen not to divide themselves into PSA's; the entire State is a single planning and service area administered by the State office.

Each State's listing also tells you which of the 10 Federal regions the State belongs to. In a separate listing after the States, information about each of the Federal regions is provided.
