THE COTTON LINT AND SEED MARKETING  
ORDINANCE

## PRICE OF COTTON LINT

WHEREAS the Cotton Lint and Seed Marketing Board has made arrangements, in pursuance of the duty imposed upon the Board by paragraph (b) of subsection (1) of section 8 of the Cotton Lint and Seed Marketing Ordinance (Cap. 335), and by virtue of the provisions of subsection (2) of the said section, for the sale or disposal within the Colony and for the export from and sale or disposal outside of the Colony of cotton lint by the agency of the Uganda Lint Marketing Board.

Now, therefore, in exercise of the powers conferred by paragraph (a) of subsection (1) of section 8 of the said Ordinance, the Minister for Agriculture and Animal Husbandry, on the recommendation of the Board, hereby approves and fixes, as the price to be paid in respect of cotton lint to the ginner thereof for the cotton season 1962/63, the price for which provision is made in the standard contract governing the purchase and sale of cotton lint between the Uganda Lint Marketing Board and gidders, including the quality incentive scheme referred to in the said Ordinance, as amended, namely the price fixed under paragraph (a) of subsection (1) of section 4 of the Lint Marketing Ordinance, 1959, of Uganda, for the 1962/63 cotton season for cotton lint from rehabilitated ginneries and in respect of the Bukedi Zone, but modified in accordance with the decision recorded in Minute No. 45/56 of the Cotton Lint and Seed Marketing Board's meeting held on 12th June, 1956, as from time to time amended or revised.

THE INTERIM HORTICULTURAL DEVELOPMENT COUNCIL

IT IS notified for general information that the Minister for Agriculture and Animal Husbandry has established an Interim Horticultural Development Council.

2. The following persons shall be members:—  
 Chairman—to be elected by the Council subject to the approval of the Minister.

Three persons appointed by the Minister to represent growers of horticultural produce.

Two persons nominated by the Canning Crops Board, of whom one shall represent the canning industry.

One person nominated by the K.N.F.U.

One person nominated by the H.C.U. Ltd.

One person appointed by the Minister for his commercial or industrial knowledge and experience.

One representative of the Ministry of Land Settlement and Water Development.

One representative of the Ministry of Commerce and Industry.

One representative of the Department of Agriculture.

One representative of the Ministry of Agriculture and Animal Husbandry.

3. The primary function of the Interim Horticultural Development Council shall be to advise the Minister with respect to defining the role of, and preparing arrangements for, the creation of a statutory Horticultural Development Council, the functions of which shall be the promotion of horticultural production, of orderly marketing of horticultural produce, and of the food processing industry.

4. In pursuance of this primary function, the Interim Council shall—

(a) draw up draft legislation for the establishment of a statutory Horticultural Development Council, the functions of which shall include those of the Canning Crops Board;

(b) examine the methods of financing such a statutory council;

(c) consult with horticultural producers in all parts of Kenya in order to elicit the widest support for an understanding of the activities and objects of the Council;

5. Pending the establishment of a statutory council, the Interim Council shall in addition to the functions defined in paragraphs 3 and 4 above—

(a) develop and maintain a regular survey of the scope for horticultural development in Kenya with particular regard to the role played by the food processing industry as an outlet for horticultural produce;

(b) examine the part played by research in the horticultural industry, and advise the Minister on the future role of research in the promotion of the industry;

(c) ascertain from all available sources the market prospects for each type of horticultural produce;

(d) advise the Director of Agriculture and producers through their appropriate representative organizations, of the existing and potential demand for each type of horticultural produce;

(e) advise the Minister on the financial requirements and problems of the horticultural industry;

(f) advise the Minister on any special measures required for promoting the marketing of any particular type of horticultural produce;

(g) advise the Minister on the imposition and removal of restrictions and controls on imports and exports of any type of horticultural produce;

(h) advise the Minister on contributions from the industry to the financing of the Interim Council.

6. The Interim Council, in the exercise of its functions, shall pay due regard to any recommendations made to the Minister by the Canning Crops Board in respect of the report of the Food Processing Working Party appointed by G.N. 5501 of 1962.

7. The Interim Council shall advise the Minister on the definition of "horticultural produce" in relation to its functions.

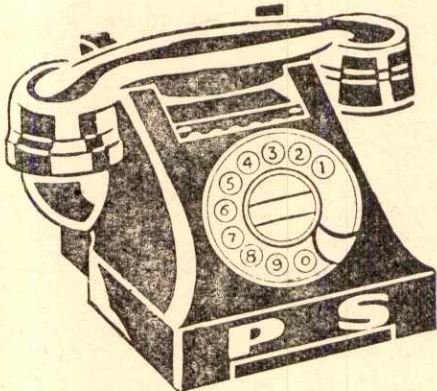

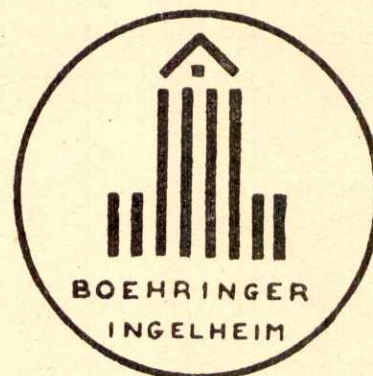

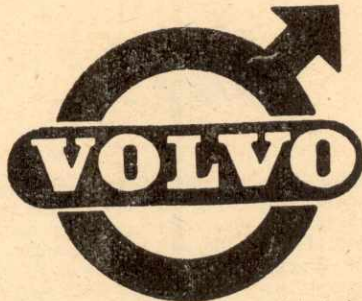
