II. Nature and/or description of the action being processed.

The contracting activity is requesting approval of a brand name justification to purchase two Dell EMC Data Domain 6900s in support of the Robins Enterprise Data Center (REDC) backup infrastructure. This requirement will be awarded as a new Firm Fixed Price (FFP) delivery order on the GSA 2GIT (2nd Generation Information Technology) Blanket Purchase Agreement (BPA) Schedule #33411. The delivery schedule is 6-weeks After Receipt of Order (ARO). This requirement will be competed among authorized GSA scheduled small business vendors listed at the following web link:

III. Description of the supplies/services required to meet the agency's needs.

This requirement is for purchase of two Dell EMC Data Domain 6900s storage arrays that meet the following characteristics:

- Simultaneous access to Common Internet File System (CIFS) and Network File System (NFS) protocols
- Source based, self-tuning, and variable length deduplication for maximum compression and performance (Fixed-Block deduplication will not meet this requirement)
- Support data integrity checks through inline write/read verifications, continuous fault detection, and self-healing algorithms that can repair bit errors
- In-flight encryption, utilizing AES 256 bit or better algorithms, of backup data from client to the backup target
- Support Federal Information Processing Standard (FIPS) 140-2 certified encrypted replication between sites
- Integrate with Avamar replication technologies
- Storage must be protected through dual parity such as RAID 6 and support hot spares

The Dell EMC Data Domain 6900s storage arrays will include a 5-year warranty of hardware and software. The delivery schedule is 6-weeks ARO. The total price of this requirement is

IV. Identification of the justification/rationale for limiting sources and demonstration of the contractor's unique qualifications to provide the required supply/service.

FAR 8.405-6 requires an ordering activity to justify its actions when restricting consideration of schedule contractors to fewer than required in FAR 8.405-1 or 8.405-2.

FAR 8.405-6(b) (1), "The item is peculiar to one manufacturer. A brand name item, whether available on one or more schedule contracts, is an item peculiar to one manufacturer."

Purchasing the Dell EMC Data Domain 6900 storage array will right-size the REDC environment. It will lower the total cost of ownership over the next five years and provide a compatible and efficient replication target for off-site backups to be stored. Cost are anticipated to be lower because the annual cost of maintenance for the current system continues to increase

every year at a rate of 10% percent and the current system will reach end of service life in July 2022. Systems that are end of service life no longer receive hardware or software support from the manufacturer and therefore exponentially increase the risk and cost associated with maintaining them in a production environment. The storage array servers will provide higher performance as the current equipment is close to its end of life and server performance erodes by 14% annually on average.

The Dell EMC Data Domain 6900 meets all the requirements listed in Section III while being a market leader for deduplicated storage. The compatibility of these storage arrays into the REDC will build efficiencies. Compatibility of storage arrays is critical and proven to provide higher deduplication/compression rates of data by 2.94 times over other commercial products. In effect, the Data Domain 6900 is shown to provide almost 3-times the storage capacity at the same cost of other commercial arrays. Additionally, the compatibility with the current Data Domain provides a streamlined and efficient process to migrate all the existing data to the new storage array saving man-hours during the implementation of the replacement systems.

If the Dell EMC Data Domain 6900 are not utilized the Government is at risk of loss of the efficient source based, self-tuning, and variable length deduplication, WAN optimized replication with the Avamar software, and a multi-faceted data invulnerability architecture. Use of an alternate product may lead to increased time and cost associated with training personnel on a different system.

Technical configurations were researched and compiled to assess other products that could potentially meet the replacement requirements of the existing data array storage equipment. Other products were evaluated and it was determined the Dell EMC Data Domain 6900 is the only equipment that meets the Government's requirement due to the compatibility with the existing equipment and software in the REDC. The Dell EMC Data Domain 6900 will ensure the REDC continues to meet all Service Level Agreements with customers, provide a simple replacement process, and enables off-site replication that is optimized for WAN circuits.

V. Determination by the ordering activity Contracting Officer that the order represents the best value consistent with FAR 8.404(d).

The Government will ensure that the price is fair and reasonable in accordance with FAR 8.404 (d) Pricing. It is anticipated that a best value determination will be achieved through competition among GSA 2GIT small business vendors. Price analysis will be conducted and other than cost or pricing data may be obtained, if necessary.

VI. Description of the market research conducted and the results, or explain why market research was not conducted.

Market research was conducted 20 Apr 2021 through 26 Apr 2021 in accordance with FAR Part 10.001 and 10.002. The market research report was completed on 06 May 2021. Market research techniques used were Internet searches, GSA 2GIT searches, input from Government

subject matter experts (SMEs) in the market, and one-on-one industry sessions with various vendors and their offerings.

Query of GSA 2GIT indicated 58 potential small business vendors.

Nothing was returned by searching "EMC" on the AbilityOne.gov product list.

The Dell EMC Data Domain 6900 is a commercial-off-the-shelf product that is sold to the Government and commercial sector. It is not being manufactured to meet special Government specifications, therefore the item meets the definition of a commercial product.

These techniques resulted in a limited source brand name selection being made of the Dell EMC Data Domain 6900 system. The Dell EMC Data Domain 6900 system offers many efficiencies and compatibility with the existing technologies at Robins AFB that are lost when purchasing different systems.

VII. Other facts supporting the justification.

VIII. Actions the agency may take to remove or overcome any barriers that led to the restricted consideration before any subsequent acquisition for the supplies or services.

The acquisition is expected to result in limited competition among GSA 2GIT vendors. The plan to remove or overcome barriers to competition is for the 78 ABW/SCOO to continually look for new technologies and tools to address the REDC's needs. They will continue to scour the market and host vendors to present their new technologies and solutions for consideration of future requirements. In addition, they will continue to monitor findings and take advantage of innovated and cost saving solutions that can meet the Government's future requirements.

There was no previous justification, therefore higher level approval of this justification in accordance with DFARS PGI 208.405-6(2) does not apply.
