


4.1 AUTHORIZED CHANGES BY THE CONTRACTING OFFICER

- 4.1.1 The CO is the only person authorized to approve changes in any of the requirements of this contract.

5.2 It is understood and agreed that the CA shall not have the authority to make changes in the specifications/scope of work or terms and conditions of the contract.

5.3 Contractor shall be held fully responsible for any changes not authorized in advance, in writing, by the Contracting Officer, may be denied compensation or other relief for any additional work performed that is not so authorized, and may also be required, at no additional cost to the District, to take all corrective action necessitated by reason of the unauthorized changes.

6. ORDERING

Products and services to be furnished under this contract will be ordered by the Contracts Administrator specified in Section 5 above. Such products and services may be provided for one year from the date of award.

7. COMPENSATION AND PAYMENT

- a) The District will make payments to the Contractor, upon the submission of proper invoices, at the prices stipulated in this contract, for supplies delivered and accepted or services performed and accepted, less any discounts, allowances or adjustments provided for in this contract.
- b) The District will pay the Contractor on or before the 30th day after receiving a proper invoice from the Contractor.
- c) The District follows a specific policy for services related to software/hardware (SW/HW) maintenance/licenses and support services. These services must be provided and billed with in the District's fiscal year (10/1 to 09/30). Invoices should only cover one fiscal year and the District cannot be held liable for any such services not billed and paid with in the same fiscal year (October 1 to September 30). The District issues separate payment for each fiscal year for accounting and budgetary reasons.
- d) By accepting this contract, for SW/HW maintenance/licenses and support services, you agree that a proper invoice constitutes a service period that covers ONLY October 1 thru September 30.

A.1 Scope

A.2 Background

DC-Net is the provider of voice and data services for the District of Columbia and is in the process of upgrading the network distribution infrastructure within the District's FEMS (fire stations) facilities. The switches requested are needed to terminate optical network connectivity to the various FEMS facilities and provide local voice and data distribution within each facility. The switches must integrate seamlessly with the existing Cisco based optical Ethernet network. The WAPs must integrate and register with the installed Cisco Wireless Controllers currently in use by the District. The WebEx endpoints are required to function on the District's deployed Cisco WebEx platform. Control telemetry must be consistent with the equipment currently deployed throughout the District to facilitate network surveillance, management and control. This equipment is being installed in integrated expansions of existing equipment currently deployed.
