## STATEMENT OF PURPOSE

## RS28809 / S1181

This is the FY 2022 original appropriation bill for the Department of Health and Welfare for the Programs of Indirect Support Services, Licensing and Certification, Domestic Violence Council, and the Developmental Disabilities Council. It appropriates a total of \$70,097,300 and caps the number of authorized full-time equivalent positions at 372.50. For benefit costs, the bill maintains the current appropriated amount for health insurance at \$11,650 per eligible FTP, extends the holiday for the employer's sick leave contribution rate for another year, and restores funding for the employer's unemployment insurance contribution rate. The bill also provides funding for the equivalent of a 2% change in employee compensation for permanent state employees. The bill funds one line item, which provides 1.00 FTP and \$85,900 from federal funds for a Grant Supervisor position at the Domestic Violence Council.
