The City of Clovis is requesting proposals from interested and qualified vendors who are approved as a "Licensing Solution Provider" under the Microsoft Enterprise Agreement with the County of Riverside (Master Agreement Number: 8084445). The proposal shall contain the following required items.

2. GENERAL REQUIREMENTS

- A. The vendor shall certify that they are an approved "Licensing Solution Provider" under the Microsoft Enterprise Agreement with the County of Riverside (Master Agreement Number: 8084445). "Licensing Solution Provider" as of the date of the submission of their offer, and that they have the certification/specialization level required by Microsoft Enterprise to support both the product sale and product pricing.
- B. Proposals must contain the following:
 - i. All requested items, quantities, and term length.
 - ii. Any shipping/handling fees that may apply.
 - iii. Availability of items and estimated time of arrival.
 - iv. Standard Quote on Vendor's letterhead.
- **C.** The line items in the proposal must be completely filled out. Check your proposal before submitting; City of Clovis will not be responsible for vendor miscalculations.
- **D.** Vendors are to bid what is specified only; substitutions will not be accepted.
- **E.** All items shall be new, of merchantable grade, free from defect and carry full manufacturer's warranty.
- **F.** Quotes shall include a copy of the manufactures warranty.
- **G.** City of Clovis is subject to California sales and/or use tax for tangible items at a rate of 7.975%. Please indicate as a separate line item if applicable.
- **H.** City of Clovis is subject to the California electronic waste recycling fee; please indicate as a separate line item if applicable.
- **I.** All shipments shall be made F.O.B. destination, Clovis, California. F.O.B. destination indicates that the seller is responsible for shipment until it is tendered to the City of Clovis, even if the City of Clovis agrees to pay for shipping and handling.
- **J.** Proposals must only be electronically submitted through the PlanetBids system. Proposal Pricing file must be uploaded on to the PlanetBids system.
- **K.** Proposals received after the closing time will **NOT** be considered.
- L. Upon award, the vendor shall submit a completed W-9 Request for Taxpayer Identification Number and Certification if not already a current vendor with the City of Clovis. This form is available from the IRS at https://www.irs.gov/pub/irs-pub/fw9.pdf.
- **M.** Proposal shall be valid for a period of sixty (60) days following submission to the City.
- **N.** Verification of coverage for all listed items shall be provided upon completion of the order.

3. SELECTION CRITERIA

The selection criteria to be used to select the successful vendor may include, but is not limited to, the following:

- A. Electronic line items.
- **B.** Written Proposal (standard quote on the Vendors letterhead).
- **C.** Price of equipment, licensing and/or services.
- D. Availability of equipment, licensing and/or services and estimated time of delivery.
- E. Established record of consistent professional service and reputation within the industry.
- **F.** The quality of references from public entities, particularly full-service municipalities.

All inquiries and answers will be available to all prospective bidders on or before **Tuesday February 20**, **2024 at 4:00 p.m. PST**.

6. AWARD

- **A.** The Clovis City Council will award the proposal to the most responsive responsible vendor.
- **B.** Unless vendor gives notice of all-or-none award in proposal, City of Clovis may accept any item, group of items or on the basis of total proposal.
- **C.** City of Clovis reserves the right to reject any and all proposals and to waive informalities or irregularities in proposals.
- **D.** After award, all proposals shall be publicly posted on the E-procurement website. City of Clovis assumes no responsibility for the confidentiality of information offered in a proposal.
