Instruction for e-bidding:

1. The bidder must have Digital Signature Certificate (Class-III).
2. The bidders who already have valid SRM User ID:
 - a) Login the SRM Portal and click on RFx and Auction button.
 - b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.
 - c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.
 - d) Tender document fee should be submitted on line/offline (Demand Draft / Pay Order / Banker's Cheque only except exemption document and EMD also may be submitted online/offline.
 - e) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.
3. New Bidders which are not having SAP/ERP Vendor Code and or SRM User ID:
 - a) In case a new bidder wants to participate for a particular Bid invitation in SRM portal, the bidder first of all has to submit the filled Registration Form & NEFT Form along with required supporting documents e.g. as specified in forms, till **22/05/2021** to C&M department, NSPCL Bhilai in hard copy or scanned copy through e-mail at: rashmikumari@nspcl.co.in
 - b) C&M department will initiate the process for vendor ID creation in SAP & send the bidders SRM Credentials (User ID along with initial Password)
 - c) After creation of SRM Credentials the step 2 (above) shall be followed by the bidder.

QUALIFYING REQUIREMENT

Name of Works: “**BMC FOR BOILER & AUX AND OFFSITE (FOR TWO YEARS) AT NSPCL DURGAPUR PP2**”.

1.0 Financial Criteria:

1.1 Turnover: The average annual turnover of the Bidder, in the preceding three (3) financial years as on date of Techno-Commercial bid opening shall not be less than INR **181.10** Lakh (Indian Rupees One Crore Eighty One Lakhs Ten Thousand only).

2.0 Technical Criteria:

2.1 The bidder must have successfully Executed the works of overhauling or Maintenance or Erection of Boiler and/or Boiler Auxiliaries, in a Thermal Power Plant. Boiler Auxiliaries shall include Rotary parts or Air Pre-heater or ESP or Milling System or Coal & Oil Burner System or any combination of any of above equipment's or all the equipment's. Boiler shall mean Pressure Parts and along with its different components of Boiler.

2.2 The bidder should have **executed** similar works mentioned under 2.1 during preceding 7 (Seven) years reckoned as on the date of Techno-commercial Bid opening, having executed value as under-

- a) Single Work Order of value not less than Rs. **144.88** Lakhs
- OR**
- b) Two Work Order of value not less than Rs. **90.55** Lakhs each
- OR**
- c) Three Work Order of value not less than Rs. **72.44** lakhs each.

NOTES:

- (1) The word “**executed**” means that the bidder should have achieved the Progress specified in the Techno-Commercial bid even if total Contract/Order is not completed/closed. The same shall be supported by documentary evidence issued by the Owner/Employer such as completion certificate/Joint Protocol/ Running Final Bills etc.
- (2) For Financial Selection Criteria, QR para 1.0, Bidder must submit copy of Audited Balance Sheet and Profit & Loss Account for the specified period. In case, where audited results for the Last Financial year as on the Last date of Submission of Application, are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from the practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year, shall be considered for evaluating the financial parameters.
- (3) All values mentioned in 2.2 shall be inclusive of all taxes and duties.
- (4) Other income shall not be considered for calculation the Annual Turnover.
- (5) Necessary documentary evidence in support requirements of QR are to be furnished by the bidder.

NIT Conditions

1. Bid documents will be issued to all the parties on their request (cost of tender document to be made by **a crossed demand draft / pay order / banker's cheque in favour of NTPC SAIL POWER COMPANY LIMITED payable at Bhilai**) for issue of bid documents without prima-facie examination of their qualification status. However, issue of bid documents shall not mean that bidders are considered qualified. Tender document fee will not be refunded. Request for tender documents received after the last date as mentioned above due to delays postal/courier services shall not be entertained.
2. NSPCL reserves the right to reject any or all bids or cancel / withdraw the Invitation for bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
3. Agencies are advised to visit the site to familiarize themselves with the nature of work and the site conditions.
4. **Bidder has to submit the Bid Security Declaration Form in lieu of EMD.**
NOTE: Bidder may note that in case they do not submit the aforesaid declaration or no Confirmation is indicated by them or statement/any declaration like 'later', 'to be Furnished later', 'NA' etc. are indicated against the declaration, then the bid shall be Rejected by EMPLOYER as being non-responsive and shall not be opened.
5. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.

Other terms and conditions will be intimated in tender documents.
