Instruction for e-bidding:

- 1. The bidder must have Digital Signature Certificate (Class-III).
- 2. The bidders who already have valid SRM User ID:
 - a) Login the SRM Portal and click on RFX and Auction button.
 - b) RFX will be available to view for all the bidders which are already having valid SRM User ID's.
 - c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into RFX header segment.
 - d) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.
- 3. New Bidders who are not having SAP/ERP Vendor Code and / or SRM User ID:

(inclusive of taxes) OR ii) 02 (two) similar orders of value not less than **Rs.39.67 Lakhs each.** (inclusive of taxes) OR iii) 03 (Three) similar orders of value not less than Rs.31.73 Lakhs each. II) Completed works means: The executed / completed portion of BOQ, even if the work has not been completed in totality (Subject to furnishing Proof of executed value of the work in the form of copies of RA Bills, Relevant PO Copy and clients completion certificate/RA bill/Final Deviation Statement).

III) Values as per clause 2.1 shall be considered inclusive of taxes and duties.

- IV) Other income shall not be considered for arriving at annual turnover.
- V) In case where audited results for the last financial year as on the first scheduled date of Techno commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from a practicing Chartered Account certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a certificate would be required from the CEO/CFO/ Proprietor/Partners as per the format enclosed in the bidding documents stating the financial result of the company are under audit as on the date of Techno-commercial bid opening and the certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

NIT Conditions
