

Use the SD card reader

To access the data stored on your SD card or cards, complete the following:

- 1. Hold the SD card so that the label is facing up and insert your SD card into **Slot 1** on the 2SD4FCRU3.
- 2. If necessary, insert a second SD card into **Slot 2** on the 2SD4FCRU3.
- 3. Connect the integrated **USB Type-A connector** on the 2SD4FCRU3 to the USB port on your host device.
- 4. Access the data that's stored on the SD card or cards.

Connect an auxiliary power source

If you require additional power when you use the 2SD4FCRU3, connect the USB cable on your power source to the **AUX Micro B power port** on the 2SD4FCRU3.
