- 1. <u>Purpose</u>. This notice announces the Fiscal Year 2024 (FY24) training requirements and schedule for Naval Legal Service Command (NLSC) personnel attached to NLSC Headquarters (HQ) and subordinate commands.
- 2. <u>Background</u>. Reference (a) issues general military training (GMT) policies for uniformed Navy personnel. Reference (b) promulgates specific FY24 GMT requirements for uniformed Navy personnel. References (c) and (d) outline mandatory training requirements for all civilian employees paid from appropriated and non-appropriated funds, as well as military personnel who supervise Department of Navy civilian employees.
- 3. <u>Policy</u>. Recognizing the value of a well-informed and motivated workforce, enclosures (1) through (4) detail the training requirements for uniformed Navy personnel, civilian employees, and supervisors of civilian employees as set forth in references (a) through (d), and provide a timeline for completion. All NLSC HQ personnel are expected to complete their applicable requirements in accordance with enclosure (1). All NLSC personnel are expected to complete the applicable courses outlined in enclosures (2) through (4) by the end of FY24.
- 4. <u>Reporting Completion</u>. All courses will be completed as directed either (1) during quarterly in-person training sessions or (2) online via the Total Workforce Management System (TWMS) or Navy eLearning (NeL). Enclosures (1) through (4) indicate which methods of delivery are

available for required training. Personnel attached to NLSC HQ must report attendance at inperson training sessions to the NLSC HQ Training point of contact, LCDR Andrea Liou, to ensure their training jackets are updated to reflect course completion. Personnel outside of NLSC HQ shall report their training completion to their chain of command in accordance with locally issued guidance.

- 5. <u>Personnel outside of NLSC HQ</u>. NLSC personnel outside of NLSC HQ shall follow their locally issued guidance as promulgated by their command; however, local training plans must include the requirements listed in enclosures (2) through (4). Marine Corps personnel are subject to their own Service and unit requirements. Contractors are subject to the requirements established by their employers.
- 6. <u>Records Management</u>. Records created as a result of this notice, regardless of media or format, shall be managed in accordance with reference (e).
